MODIFICATIONS TO MASTER AGREEMENT

Add the following sections

"Authorized Users. "Authorized Users" are:

Persons Affiliated with the University of California, San Diego. Full and part time employees (including faculty, staff, and independent contractors) and students of Licensee and the institution of which it is a part, regardless of the physical location of such persons.

Walk-ins. Patrons not affiliated with Licensee who are physically present at Licensee's site(s) ("walk-ins").

Permitted uses

Customer and Authorized Users may make all use of the Licensed Materials as is consistent with the Fair Use Provisions of United States and international copyright laws. In addition, the Licensed Materials may be used for purposes of research, education or other non-commercial use as follows:

Display. Customer and Authorized Users shall have the right to electronically display the Licensed Materials.

Digitally Copy. Customer and Authorized Users may download and digitally copy a reasonable portion of the Licensed Materials.

Print Copy. Customer and Authorized Users may print a reasonable portion of the Licensed Materials.

Recover Copying Costs. Customer may charge a reasonable fee to cover costs of copying or printing portions of Licensed Materials for Authorized Users.

Caching. Customer and Authorized Users may make local digital copies of the Licensed materials in order to ensure efficient use by Authorized Users by appropriate browser or other software.

Collections of Information. Customer and Authorized Users shall be permitted to extract or use information contained in the Licensed Materials for educational, scientific, or research purposes, including extraction and manipulation of information for the purpose of illustration, explanation, example, comment, criticism, teaching, research, or analysis.

Course Reserves (Print and Electronic). Customer and Authorized Users may use a reasonable portion of the Licensed Materials for use in connection with specific courses of instruction offered by the University of California, San Diego.

If Licensor does not use the OpenURL standard, Licensor staff will provide information to Licensee upon request to assist the Licensee in creating links directly from UCSD's library catalogs and licensed resources to the content at the journal, issue and article levels.

Scholarly Sharing. Authorized Users may transmit to a third party in hard copy or electronically, minimal, insubstantial amounts of the Licensed Materials for personal use or scholarly, educational, or scientific research or professional use but in no case for resale or commercial purposes.

Interlibrary Loan. Using secure electronic, paper, or intermediated means such as Ariel, Customer may fulfill occasional requests from other institutions, a practice commonly called Interlibrary Loan. Customer agrees to fulfill such requests in compliance with Section 108 of the United States Copyright Law (17 USC §108, "Limitations on exclusive rights: Reproduction by libraries and archives") and the Guidelines for the Proviso of Subsection 108(2g)(2) prepared by the National Commission on New Technological Uses of Copyrighted Works."

Modify the following paragraph:

"Restrictions

Except as otherwise listed under 'Permitted Uses', Customer may not, directly or indirectly: (a) sell, modify, edit, rent, translate, copy, display, perform, publish, transmit, distribute or otherwise disseminate the contents of any or all email news stories or stories accessed via the www.BNamericas.com website or received from Business News Americas or the www.BNamericas.com website (collectively Content); (b) remove, conceal or obliterate any copyright or other proprietary notice or any credit-line or date-line included on Content."

ENTIRE AGREEMENT


