The following License Agreement provides the University of California, San Diego, Library ("The User") Musical America Web Site network access for five users at a total cost of ... for the period June 21, 1999 to July 1, 2000.

We ask that you review and sign the agreement and return it by fax, as well as mail, in order to process your order in a timely manner.

This agreement covers the PRIMEDIA Information Inc./Musical America Web Site ("The Product") and all material contained on the Web Site. PRIMEDIA Information Inc. grants to The User a non-exclusive, non-transferable, limited license to use The Product according to the terms of this License Agreement.

PRIMEDIA Information Inc. agrees to provide The User network access to The Product covered by this license Agreement from The User's public IP Address range assigned to The User's Domain Name. The User's public IP address range along with The User's Domain Name (if available) must be provided to PRIMEDIA Information Inc. by The User prior to enabling network access to The Product. The Product may be accessed by multiple locations within The User's business organization providing these locations use The User's public IP address range reported to PRIMEDIA Information Inc. All users must be registered users of The User's Library.

The User is authorized to use The Product during the term of the Agreement. The Product is automatically renewed as a convenience to The User. The User will be notified of renewal prior to expire date. The User may request termination by writing, "please cancel" on the renewal notice and returning it to PRIMEDIA Information Inc. The terms and restrictions of the License Agreement shall remain in effect through subsequent renewal cycles of the same order.
