License Agreement

A. Licensed Items

- 1. Upon the signing of this Agreement, the Lieberman Institute of The Jewish Theological Seminary of America ("Licensor") grants a non-exclusive license to the Social Sciences and Humanities Library, University of California, San Diego, (hereafter to be known as the "Licensee"), to use the following software (hereafter to be known, collectively, as the "Software"):
- a. The Sol and Evelyn Henkind Talmud Text Databank, Standardized Text Version with Search Capability;
- b. The Sol and Evelyn Henkind Talmud Text Databank, Text Only version.
- 2. The method of installation of the Software is by means of 1.2 megabyte diskettes, which will be provided to Licensee upon execution and return of this contract.
- 3. The diskettes belong to the Licensor and will be returned to the Licensor by the Licensee immediately after installation.

B. Conditions of Assignment

- 1. The Software is for the use of the Licensee alone and the Licensee has no right to copy or distribute the Software or any part of it.
- 2. The Licensee will have only one copy of each Software Program on one hard disk, in existence, at one time.
- 3. The Licensee may not copy the Software program from the distribution diskettes to any other diskettes, or allow it to be copied.
- 4. A network license is not being conveyed with this agreement.

C. Terms of Assignment.

- 1. The Licensor will supply to the Licensee, upon the signing of this contract, the following Programs:
- a. one copy of the Standardized version of the Talmud Text Databank, including all manuscript texts contained therein. Licensor further agrees to distribute any updates that may be prepared for this

Program, but does not commit itself to preparation of those updates. The Licensee will pay such shipping and handling charges as Licensor may assess in connection with delivery of the updates.

b. one copy of the Text only version of the Talmud Text Databank, including all manuscript texts contained therein. Licensor further agrees to distribute any updates that may be prepared for this Program, but does not commit itself to preparation of those updates. The Licensee will pay such shipping and handling charges as Licensor may assess in connection with delivery of the updates.

- 2. In connection with the assignment of the Standardized Text Version Software, Licensor agrees to provide a search program Hasp to be installed by Licensee: Licensor's sole responsibility is to provide the Hasp once. Its installation, manner of use and maintenance are the responsibility of Licensee.
- 3. Payment of \$... is hereby acknowledged.

D. Computer Hardware and Software

- 1. The Programs run on the IBM PC/Xt/AT family of computers and close compatibles.
- 2. The ability to generate the Israeli ASCII standard on the Licensee's computer and/or printer will be the responsibility of the Licensee.
- 3. Any costs involved in the installation of the Software Programs or the Hasp on the Licensee's computer will be borne by the Licensee.
- **E.** Licensee's violation of the above terms and conditions will constitute a breach of this agreement. Upon notification by Licensor that such a breach has occurred, the license to Licensee to use the Software will terminate.
- **F.** If this agreement is signed by an individual, on behalf of an institution, the individual represents and warrants that he/she has full power to enter into this agreement on behalf of the institution.
