Library Site License Agreement

By executing this Agreement, the Subscribing Institution ("Licensee") accepts the following terms and conditions:

1. Scope of License

- a) This Agreement applies to all University of Wisconsin Press journals (the "Journals") for which the Subscribing Institution shall have paid the applicable site license and subscription fee to the University of Wisconsin Press (the "Publisher"). The Publisher agrees to grant to the Licensee the non-exclusive and non-transferable right to give Authorized Users access to the applicable Journals via a secure network or a secure proxy server for the purposes of research, teaching and private study, subject to the terms and conditions of this License.
- b) "Authorized Users" are the current faculty, students, and staff of the Subscribing Institution who are permitted to access the institution's secure network from within the physical premises of the library or libraries operated by the Licensee, or from such other places where Authorized Users work or study. The Licensee's secure network must be only accessible to Authorized Users approved by the Licensee whose identity is authenticated at the time of log-in and periodically thereafter consistent with current best practice, and whose conduct is subject to regulation by the Licensee and who have been issued by the Licensee with a password or other authentication. Walk-ins are also deemed Authorized Users of the site license, but do not have remote access privileges. Alumni of the Subscribing Institution who are not currently faculty, students, or staff are not considered Authorized Users.
- c) If the Subscribing Institution has locations in more than one city, each location is considered to be a separate site and requires a separate license agreement.

2. Authorized Use and Term of Access

- a) Authorized Users may download, save, and print individual articles from the Journals for their own noncommercial educational and research use, provided that the Publisher's copyright notice and Journal identifying information (which appears on the opening page of every article) is included on the copy, but may not further disseminate these articles in their electronic form without express written permission from the Publisher. Bulk downloading is expressly forbidden as is serial or cumulative downloading that results in the user reproducing on his or her computer, in effect, all or any substantial subset of any issue of any Journal. Bulk printing and serial printing that results in the user reproducing all or any substantial part of any Journal issue are not allowed.

- b) Authorized Users will have access to the current year of the Journal(s) and whatever backfiles may exist on the same server as the current content. At the end of the subscription period, the Publisher shall provide continuing access for Authorized Users to that part of the Journal(s) that was published and paid for within the subscription period except where such termination is due to a breach of the License by the Licensee. Backfile access will not continue beyond the subscription period unless the content was purchased during the year of original publication.
- c) *Interlibrary Loan*: Print copies of articles from the Journals may be supplied to another institution by mail or fax. The supply of such copies must conform to CONTU (National Commission on New Technological Uses of Copyright Works) guidelines or similar restrictions to "fair use" provisions under copyright law. The copies must retain the Publisher's original copyright notice and identifying information.
- d) *Coursepacks*: Authorized Users may print copies of articles for noncommercial course or research use. Copies to be provided to the end user for a fee may not be made without the express written consent of the Publisher and payment of associated permission fees. All such copies must retain the Publisher's original copyright notice and identifying information.
- e) *Electronic Reserves*: The Subscribing Institution is granted the right to include occasional articles from the Journals in E-Reserves, as long as the content is posted on a secure site accessible to class members only, and articles are purged from the e-reserve system at the end of each semester. The articles must retain the Publisher's original copyright notice and identifying information.
- f) *Mounting on Other Networks*: Authorized Users may not mount or distribute any part of the licensed material on any electronic network other than the institution's own secure network, including without limitation the Internet and the World Wide Web.

3. Withdrawal of Content

The Publisher reserves the right at any time to withdraw from the licensed materials any item, or part of an item, for which it no longer retains the right to publish, or which it has reasonable grounds to believe infringes copyright or is defamatory, obscene, unlawful or otherwise objectionable.

4. Licensee's Responsibilities

The Licensee agrees to (1) make reasonable efforts to notify Authorized Users of the terms and conditions of this License and take steps to protect the Journals from unauthorized use or other breach of this License; (2) make reasonable efforts to ensure that only Authorized Users are permitted access to the Journals. (3) issue passwords or other access information only to Authorized Users and use all reasonable efforts to ensure that Authorized Users do not divulge their passwords or other access information to any third party; (4) make reasonable efforts to monitor compliance and immediately upon becoming aware of any unauthorized use or other breach, inform the Publisher and take all reasonable and appropriate steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence.

5. Licensor's Responsibilities

The Publisher warrants that it is fully authorized to use, in accordance with the terms and conditions hereof, the Journals; and that the Journals, if used as contemplated in this License, would not in any known way infringe any copyright or other proprietary or intellectual property rights of any natural or legal person. Some Journals are available electronically through third-party vendors as well as from the Publisher, and this Agreement does not license access through those vendors. Cases where the author retains copyright or the copyright is owned by an entity other than the publisher will be indicated on the journal article, and this Agreement conveys no right to copy or transmit such articles without permission from the copyright owner(s).

6. Term and Termination

- a) In addition to automatic termination unless the term of subscription is renewed, this License shall be terminated: (1) if the Publisher commits a material or persistent breach of any term of this License and fails to remedy the breach (if capable of remedy) within thirty (30) days of notification in writing by the Licensee; (2) if the Licensee commits a willful material and persistent breach of the Publisher's copyright or other intellectual property rights and does not remedy such breach within thirty (30) days of notification in writing by the Licensor. On termination all rights and obligations of the parties automatically terminate except as specified in clause 2(b).
- b) The Publisher retains the right to revise this Agreement at any time giving notice to the Licensee sixty (60) days prior to the effective date of such revisions. If the Subscribing Institutions chooses to terminate then, the Publisher will refund a pro rata share of the subscription fee for the remaining term of the subscription.
