### **Read & Publish Open Access Agreement**

### PARTIES

Publisher John Benjamins Publishing Company (JB)

AND

University of California San Diego

### **OBJECT OF AGREEMENT**

University of California San Diego is an independent, non-profit research organization. Authors of University of California San Diego in conformity with this Agreement are scientists that are affiliated to University of California San Diego as members of one of its institutes (each, an "Authorized Author"). The University of California San Diego institutes are listed in Schedule 1. University of California San Diego Library has the aim to pay the Read fee concerning journal subscriptions and the Publish fee for articles ("Articles") published in JB journals if the *corresponding author* is affiliated to University of California San Diego. The object of this Agreement is to set out the terms and conditions relating to publication of such articles.

JB is a publisher and publishes journals at www.jbe-platform.com.

#### **CONTRACT PERIOD AND TERMINATION**

This arrangement shall come into effect on January 1, 2024.

The term of this Agreement shall commence on the date first set forth above and shall automatically renew on the date which is one (1) year thereafter, subject to successive one year renewals of this Agreement on the terms contained herein unless either party hereto provides written notice to the other party at least ninety (days) days in advance of any renewal date of its intention not to renew this Agreement.

The Read part of the arrangement includes subscriber access to the relevant year volumes of the journals selected by University of California San Diego Library; this includes perpetual archival rights to the subscribed volumes.

The Publish part of the arrangement concerns articles accepted for publication from corresponding Authors at University of California San Diego, and to be published Open Access in JB journals. All articles submitted during the term of the agreement from eligible corresponding authors will be published Open Access if these articles are accepted as a result of the journal review process. A further specification: if articles submitted during the term of the agreement are accepted after this term these articles will still be published Open Access if it concerns submissions from eligible corresponding authors.

### **IDENTIFICATION OF AUTHORIZED ARTICLES**

Both parties agree to work together to develop a workflow by mutual agreement to identify JB Open Access approved Articles that have been submitted by University of California San Diego corresponding Authorized Authors. JB will strive to clearly indicate the availability of an institutional funding agreement to University of California San Diego affiliates both within their submitting process and on their website.

University of California San Diego Authorized Authors can be identified through:

• the affiliation as stated in the article to be published. The corresponding author is requested to provide this information

In addition, the corresponding author may supply the following parameters which may be used if that is necessary for further identification:

- e-mail domain: ucsd.edu
- persistent researcher identifier, such as Ringgold, ORCID or other recognized institutional identifier as provided by the Authorized Author and published in the article metadata.

### **Definitions**

A "corresponding author" is defined for this agreement as the author who is listed as the corresponding author in the article.

"Articles" as used throughout this agreement are of the article type: research articles, reviews, and introductory articles.

Communication on Articles accepted for publication for the purpose of checking eligibility of Open Access publication will include per article the following details:

- Name and email address of the corresponding Author <u>who is affiliated to University of California</u> <u>San Diego</u>
- Full name of corresponding Author's affiliation (e.g. institute, department)
- Submission Date
- Journal Title
- Manuscript ID (if applicable)
- Article title
- Article type

JB shall label Open Access Articles as funded by University of California San Diego in the JB Publication itself.

All submitted and accepted articles of corresponding authors will be checked by the Publisher on eligibility for Open Access before these articles are published. The Publisher takes two following actions:

- 1. To publish these articles eligible for Open Access as Open Access.
- 2. To send a notification to the Institution to inform them of the eligibility of the article for Open Access.

There is no need for an approval per article by the Institution after a notification.

Instead, the Institution and the Publisher will review once per year, in the first quarter of the calendar year, the complete listing of articles published Open Access during the previous calendar year.

Based on this evaluation three matters are concluded:

- 1. Is this listing correct all articles were published Open Access
- 2. Are articles not included in this listing so these articles should still be made OpenAccess
- 3. Are articles included which should be taken off the listing and consequently their Open Access status should be changed to subscribed content.

The final reviewed and agreed listing of Open Access articles is used for the calculation of next year's Publish fees as described in the section "Annual Fees".

#### **ANNUAL FEES**

This arrangement involves a gradual migration from a journal acquisitions budget to an article publications budget. This arrangement includes journals subscriptions and Articles published by the corresponding Authors at University of California San Diego. Fees under this arrangement are set on a yearly basis as with the journal subscription process. The annual fee is based on a Read fee and a Publish Fee.

#### READ FEE

The Read Fee is calculated based on the spend on journal subscriptions x (100% – share of OA articles published in all JB journals).

The Institute can decide on a yearly basis, like in the current subscription process, which subscriptions or e-collections to purchase.

#### PUBLISH FEE

The Publish Fee is calculated based on the average number of articles published in the past 3 completed calendar years x APC x share of OA articles published in all JB journals.

The average number of Articles published is always calculated based on past actual Article publications in a 3-year period of completed calendar years. Even if in the upcoming year the number of articles is higher or lower than the calculated average there will be no correction applied during the year on the publish fee. Instead, for any new publish fee, as part of the total fee, the new average of the past 3 years article publications will be calculated.

JB will inform University of California San Diego Library at least before June 1 ahead of the following calendar year about any changes in pricing. The current fees applicable are stated in Schedule 2.

Authors of University of California San Diego publishing Open Access in journals of JB retain copyright and the authors licenses these articles under the Creative Commons Attribution license CC-BY or CC-BY-NC (https://creativecommons.org/licenses/by/4.0/).

### **ANNUAL REPORTS**

JB shall provide annual reports of the Articles published in conformity with this Agreement. This list shall be provided both in machine readable form in a structured format as comma separated value file format (csv) and in human readable format and shall include the following details:

- Name of the publisher
- Bibliographic metadata (Journal title, journal abbreviation, journal ISSN, volume, issue, pages, article title, authors' names) or DOI
- Affiliated author, incl. ORCID when available
- Affiliated author's institution
- Publication date

The reports will be online accessible for University of California San Diego Library through the OASwitchboard application.

### LIABILITY

Neither party excludes or limits liability to the other party for death or personal injury caused by its own negligence or any other liability the exclusion or limitation of which is expressly prohibited by law.

### **GOVERNING LAW**

This Agreement shall be construed and interpreted pursuant to the laws of the State of California, United States of America, applicable to contracts wholly entered into and performed in the State of California. Any legal action, suit or proceeding arising out of or relating to this Agreement or the breach thereof shall be instituted in a court of competent jurisdiction in the State of California and each party hereby consents and submits to the personal jurisdiction of such court, waives any objection to venue in such court and consents to the service of process by registered or certified mail, return receipt requested, at the last known address of such party.

### SEVERABILITY

In the event that any one or more of the provisions contained herein shall, for any reason, be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision of this Agreement, but, to the extent permitted by law, this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein.
