NINTH AMENDMENT TO KINOKUNIYA BOOK STORE LICENSE AGREEMENT

Should there be conflict between this agreement and any other vendor-generated, web accessible terms and conditions, whether now known or hereinaster generated, then this Amendment and Agreement (as defined above) controls

This Agreement may only be modified in a writing signed by both parties.
