Dear Colonel:

Since my pleasant visit to your city I have given considerable thought to the studio proposition and have gone into the matter further with people here who would be interested in producing in San Diego and they all tell me that if the proposition is carried through as I have outlined it to them they will be very glad to avail themselves of the opportunity to make pictures in the proposed new studios.

I am enclosing a few clippings I have gathered together showing the attitude of other communities in regard to the securing of studio propositions for their respective cities. Many Boards of Trade throughout the country have awakened to the fact that a properly handled studio means big things for the community and means a large circulation of new money as well as proving a big magnet for tourists and possible land holders.

I realize of course that you, personally, fully realize these possibilities and I feel that you must have a very wide vision otherwise you would not have under your control the vast amount of real estate. In relation to the land development possibility that would occur in connection with a studio plan I can see where a plant requiring hundreds of employees would have to figure on housing facilities that would be tremendous and I can see in and around the studio grounds, a real village simply to handle the people directly connected with the studio. I can see where a housing company could be engineered to build and rent suitable homes for employees including stars, executives and the numerous people directly concerned.

My plan would be to make the San Diego Studios the most beautiful as well as the most efficient in this country and with the natural facilities available that would be an easy matter. The beauty could be supplied in the planning and construction and all the beauty spots would be so arranged that they would be used for locations and scenes to be used in the productions. Then when visitors came to San Diego, the whole city would be able to point with pride to their own studios as the real show place of Southern California.

Colonel Ed Fletcher-

In addition to the value to the city and its merchants, the returns on the investment would be very large. The arranging of this important end would be something to consider very carefully and I sincerely hope you may be able to associate together a small group of representative men who not only will see the advantages to the city and its future growth but who also will be keen enough business men to realize the tremendous profits probable in this proposition.

I have at my command some of the best men in the mechanical and business end of this game and a studio built under our supervision would embody the results of many years of experience in establishing and handling such a studio. Like most all other businesses that have grown from nothing overnight to big industries, there has of necessity been much waste due to there having been no established standards to adhere to. The industry is now out of its swaddling clothes and a new studio proposition such as this would profit by the experiences of many minds who have passed through the earlier stages of the game.

The general plan for financing such a studio as we are considering needs careful consideration and I think the quickest and best way would be along the lines we discussed the other day. If a syndicate of five or six men could be gotten together who would underwrite either a bond or stock issue, agreeing to meet payments as required, the proposition would then become a reality and if it was desired to place the stock or bonds on general sale, it could be done while the actual building was going on. Personally I would like to see some of your progressive men realize what a big money-making proposition it would be and so make it a close corporation or syndicate.

I figure the studios would cost about five hundred thousand dollars, completely equipped ready for action. If contractors, supply houses, architects etc could be induced to take a large part of their costs in stock or bonds, it seems to me that the balance could be handled very easily with the equity the company would then have.

I realize how busy you are and I am planning to be in San Diego next week for a few days and I trust by that time you will have taken this matter up further so that I can save your time by doing as much missionary work as possible.




Yours of the 19th inst. at hand and contents noted. Am much

MOVIE COMPANY PLANS PLANT HERE

vice president of the chamber and the industrial bureau, have had the matter in charge to date, and now turn it over to the Sullivan committee.

According to Thompson, the present proposition is the best yet made here for establishment of the motion picture industry. That the Los Angeles men came here is said to be in line with a more or less general movement among motion picture companies to break away from Los Angeles, the great western center of the industry. Several cities are said to be maintaining lobbies in Los Angeles to entice companies to move and are having measurable success.

The investment asked of San Diego by the company contemplating establishment here is \$50,000, with which the Los Angeles backers will place \$150,000 and form a \$200,000 corporation. To begin with, use of the exposition buildings is said to be desired, but the company intends to erect its own plant at a site yet to be chosen. The chamber of commerce committee on the matter will make a canvass of business men and investors to determine whether there is \$50,000 here for investment in the motion picture production business.



Dear Colonel:

In answer to your inquiry regarding progress on the S L Studios I am glad to say that I expect to commence building the first unit within the next two or three weeks.

The parties here who undertook to sell the stock for this first unit have not been as successful as they had hoped. They have misled me very much on the proposition, but not intentionally. They entered into a contract with me to sell \$30,000 worth of Preferred Stock and agreed to do this within thirty days.

My plan was to continue my production activities in Los Angeles until such time as this \$50,000 was raised and then to come to San Diego, build the first unit and start my first picture. The sale of this stock has been going so slowly, however, that I felt I must put my shoulder to the wheel and push it through. With this in view I have rented a suite of offices in the Spreckels Building and have installed some of my organization there.

The stock subscriptions to date amount to approximately \$25,000 and there are more than enough good prospects in sight to cover the other \$25,000 necessary to start the first unit. It will take a little time, however, to close these prospects up and in the meantime I am exerting every effort to secure all the subscriptions I can in order to hasten the beginning of activities.

Unfortunately, I have been placed in the position of a promoter and I presume the people of San Diego consider me as such, but I have asked several of the business men to investigate my statements and have asked them to communicate with Metro Pictures Corporation in Los Angeles and with our bankers in the East. If they had done this they would find that S L Pictures is a high class producing organization which has a long list of successful pictures to its credit. I have been forced to take an active part in the promotion of funds for the S L Studios-San Diego simply through the inability of the stock sellers to carry out their agreement, and now that I have spent the time and money that I have on the proposition I am going to see it through.

When this plant is finally completed you are going to see the finest Moving Picture Studio in the world and I am positive the most successful. As I have outlined to you on several occasions, there is a tremendous profit in the operation of the unit studios such as we are building and not only will our stockholders receive big returns on their investment but the hundreds of thousands of dollars that the production companies will bring to San Diego will prove of tremendous benefit to the merchants, property owners and all other residents of the county.

You asked me a few days ago if the Material Mens Association had done anything to assist in the subscriptions to the first unit. I attended a meeting of that Association the other day at which the members seemed very much impressed, but up to date I have received no assistance from them.

You also spoke to me about the quantity of materials used, and you asked me regarding the lumber. Lumber is the largest item in our costs. Figures given me by my amiter show me that in the studios in which I made my last five pictures that the lumber bill on a production capacity of about one third of what I plan for the S L Studios here amounted to \$104,000 over a period of twelve months. This \$104,000 represents the cost of lumber for sets and does not include any studio construction costs.

With these facts before us, facts which can be easily verified, I naturally look to the local lumber companies to become interested in this first unit and thus make it possible for us to bring the tremendous amount of money necessary for production to San Diego.

I have just received a wire from my company in New York that the United States Mortgage Company of Chicago are holding for us practically \$300,000 to be used by me on my next three S L pictures. I am naturally very anxious to start off the new studios with these pictures and thus show the business men and banks of San Diego quick, practical results.

You spoke to me about your friend Mr. White, Manager of the Benson Lumber Company, furnishing the lumber. In answer to that I must say that I am naturally going to stay by those who help make this studio possible. It seems to me that Mr. White and the Benson Lumber Company would be the logical people to help us and I am ready to say right now that if Mr. White would subscribe \$5,000 towards our first unit I would appreciate it and feel that he was my partner and I would not solicit subscriptions from any other lumber company. Further than that, all things being equal, there is no reason why the Benson Lumber Company should not get all of our business.

In order to comply with the Californian laws and with the requirements of the State Corporation Commissioner, we must deposit in the bank the first \$50,000 in subscriptions before we can start operation. But if Mr. White comes into this organization he can be assured that our first order for lumber will be many times more than the \$5,000 he might subscribe.

If the Benson Lumber Company and other material men only knew it and would take time to investigate my records and accomplishments in the picture business, they would, I am sure, see what a golden opportunity for securing future business they are missing by not playing the game with us at this time.

I have been advised in Los Angeles that the San Diego Credit Mens Association has been making inquiries regarding me and S L Pictures and knowing our standing there, I think if Mr. Hite or any of your other friends would get in touch with the Credit Mens Association they will get a first hand and first class report.

Understand, Colonel Fletcher, I appreciate the fact that you have shown tremendous vision in realizing what the studio will mean to the county of San Diego, which is evidenced by your gift of the property. And I want to tell you that up to date you are the only real live wire that I have met in this city, and if they had more men like you San Diego would very rapidly become the busy, prosperous city that it should be.

I am not asking you for any favors and I don't want you to think that I am asking you to go out and boost my game, because without your assistance or the material men's assistance I am going to put this proposition over and in a very short time. But I must say I am very much disappointed at the apathy and lack of material assistance I have met with in this city. If your friends, such as Mr. White and Mr. Jones of the Electric Company, only realized what a bet they are overlooking they would get busy and not only help us clean up this small balance but would also help interest their friends.

I have offered the Material Mens Association to give them records of purchase of material including the cost of lumber, electrical fixtures and the dozens of other items that enter into production costs, and these figures I am sure would make them all sit up and take notice if they would take the time to investigate.

Again I want to thank you for your interest in this matter, but I assure you that if I had known that I would have to become a promoter in order to provide facilities and inducements to bring in a matter of two or three million dollars of outside capital to this city, you may be sure I never would have touched it. However, as I have said before, my blood is up; I have spent considerable money on this proposition and in spite of the lack of assistance and cooperation of the people who should rally to this cause, you are going to see the most beautiful studios in the world located in Grossmont, and that within a very short time.

I would be very glad to report to you progress within the next week, and if in the meantime you can bring a little light to your friends I will most certainly appreciate it. Thanks for your many courtesies, and with best regards, I am







After that I expect to move to San Diego and clean up all the details necessary towards getting the first producing Company working.

It has been a pretty slow proposition, as the response from the business men and the public has been very slow and I have had to do practically everything myself.

As soon as I finish my present producing contract here I will be able to clean up affairs down there quickly.

I regret very much that you were not able to be present at the occasion of the corner stone laying, but you have probably learned what an impressive affair it was. I think the turn out gave the people of San Diego a little better idea of the magnitude of our ideas for Grossmont and the S-L Studios.
