

My understanding is that Gross and I acquired through the Villa Caro ranch ten inches of water right; that I sold limit to Webster and limit to Schumann-Heink. Have you been collecting Schumann Heink's water right from her direct? If so, since what date? Also Webster's water right?

I also have 3° of Hawley water right. Now, up to what date did I pay for the 3° of Hawley water right? Also the Grossmont water right? I want to pay for all the water rights up to date of January 1, 1915, on the basis of the Railroad Commission's rates, and I want a rebate on the books during the time that there was a shortage of water, and for the water that I did not use. This also applies to Mr. Murray's case in a spearate statement.

I then want a credit for all the moneys that have been collected by the Water Co. for domestic water from the Brossmont or Hawley Heights system. After I have received these two credits, I want to know what the balance is that should be charged to my personal account.

I want you to attach all of my water, including the Hawley Heights 3" to Grossmont, Mt. Helix and Brier Tracts.

Gentlemen: -

I am the owner of a water contract from the San Diego Flume Company dated June 15th, 1895 covering Lot 8, Lemon Villa which is near San Diego in your state. I paid \$400.00 for this and was granted in return a perpetual water right from that company.

During these 19 years I have paid a good deal of money to the said company as rental and for the last ten years have not used the water at all. Much of the time they can not furnish it and some of the time have not compelled me to pay it. The fact is they destroyed the connection some years ago and are continually changing their pipes. Now they are calling on me to pay \$2.95 a month when they are able to furnish water and at times when water is generally not needed.


I now see that they are proposing to sell to the city the entire system, hence I would like to know my status on this contract which represents actual money paid. They have changed it as to time of payment and amount without my knowledge or consent. This called for semiannual payments of \$15.00 each, some of these \$2.95 a month demands I have paid under protest but am getting tired of a rotting system that does not keep any of its covenants.

If it is proper for me to ask my present status under your state law, I would like to know what it is - and particularly in the event I do not pay where I am not using and whether my right is forfeited or they can compel me to pay further, or hold any lien against the land.
