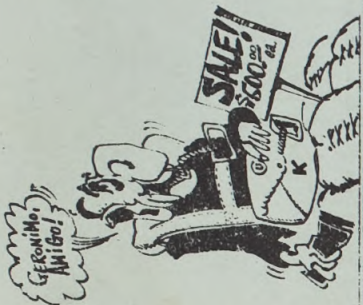

- (4) By our open stance on the issues, the men and women we attract to our Movement are not cowards or hypocrites, but are willing to boldly face the tasks before us and fight until victory.
- (5) The Klan has a reputation of victory, it is well known that the Klan saved the White South from the minorities.
- (6) The KKK has its emphasis on action, and is not merely a "publishing organization."
- (7) The Klan is youth oriented. The young people of today will determine the kind of nation we will have tomorrow. Any Movement that wants to make history, must win the young. We are!
- (8) The Klan is world-wide in scope. Where ever there are White people — we are. Our Communist and Zionist enemies are all over the world, and we are there to meet and defeat them.

### AN INTRODUCTION TO THE KNIGHTS OF THE KU KLUX KLAN

After the cannon fell silent and peace descended upon the battlefields of the civil war, there came an infamous chapter of American History called "The Reconstruction". From this era, an abyss of human misery and despair, there arose like the morning sun the Ku Klux Klan. The KKK movement provided for the people of the south the leadership and rallying point to begin their arduous struggle to regain their lost dignity and indeed, the values of Western Civilization.

The glorious ride of the Ku Klux Klan of the "Reconstruction" era is immortalized by its achievements. No misrepresentations by prejudiced historians or by the aliens who control America's mass media can dim the lustre of its deeds, or rob it of its rightful place in history as the savior of the White south, and thereby, the preserver of the purity of the White race for all of America.

The Knights of the Ku Klux Klan keeps alive the memory of the original Klansmen and the principles and traditions for which they risked their lives. However, the Klan today does not exist just as a memorial to past accomplishments, but as a living instrument for the ideals of Western, Christian Civilization and the one element that makes them possible: the White Race. Not a mere political association, the Klan is indeed a brotherhood, a new White racial community that actually LIVES and functions by the ideas it promotes.

### WHAT THE KLAN STANDS FOR

1. **THE WHITE RACE:** The irreplaceable hub of our Nation, our Christian Faith, and the high levels of Western Culture and technology.
2. **AMERICA FIRST:** First before any foreign or alien influence or interest.
3. **THE CONSTITUTION:** As originally written and intended. The finest system of government ever conceived by man.
4. **FREE ENTERPRISE:** Private property and ownership of business, but an end to high-finance exploitation.
5. **POSITIVE CHRISTIANITY:** The right of the American people to practice their faith — including prayers in schools.

### WHAT THE KLAN IS

The Knights of the Ku Klux Klan is a fraternal, patriotic movement promoting the ideals of Western Christian Civilization. It is not merely a "social association", but a dynamic, crusading White movement of world-historical perspective seeking the establishment of a new order upon the earth. It is a duly incorporated, non-profit, legally recognized institution, working to rebuild our collapsing society on the basis of the principles: Honor, Honesty, Duty, Courage, Brotherhood, and Patriotism. The Klan is sometimes referred to as the Invisible Empire because it is indeed a whole new community in itself. As the Ku Klux Klan strives toward the ideals it wants for the nation tomorrow, it lives by those ideals today. We are the generation of tomorrow, today.

### THE ORIGIN OF THE NAME KU KLUX KLAN

The name Ku Klux Klan comes from the Greek word KUKLOS, meaning circle, wheel, or band. This name was chosen because in it is contained some of the unique characteristics of the White (or Aryan) race. The wheel is certainly the best symbol of creativity; hence the crea-

tivity of the White race, and the circle is the oldest symbol of unity.

### THE KLAN SYMBOL: THE CROSS WHEEL

The crosswheel is the Klan symbol. It is simply a cross in a circle. It was directly derived from the Klan name and from White history as the crosswheel is found in every White civilization.

In the crosswheel, we can see the Christian cross, the wheel of creativity, the circle of unity, motion, and also the ancient Aryan symbol for the sun or light. Over the centuries no symbol has come to represent the totality of the White race better than the crosswheel. The traditional Klan red, white, and black patch called the blood drop is a form of the crosswheel.

The Firey Cross is used as a Klan symbol representing the ideals of Christian civilization. In no way does it represent a desecration of the cross, for it actually represents the lighting of the cross that is, the truth and the light of our sacred doctrine: the blazing spirit of Western, Christian civilization. It must also be said that the Firey Cross was used in Scottish history as a signal of opposition to tyranny and obedience to God.

### PREREQUISITES OF CITIZENSHIP IN THE INVISIBLE EMPIRE

The Knights of the Ku Klux Klan Movement is not an "open membership" organization. Only those who meet our qualifications 100% are allowed into our ranks.

No person is allowed in this movement who hasn't enough honor to assume a real oath and keep it inviolate.

No person is allowed in our ranks who cannot swear an unqualified allegiance to the Constitution of the United States.

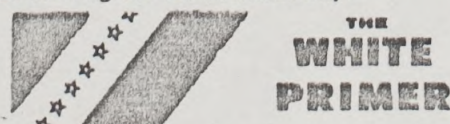
No person is allowed in this movement who cannot pledge themselves to the protection, preservation, and advancement of the White Race.

No person is allowed in this movement who cannot practice real brotherhood towards all of his fellow citizens.

Only White, Gentile American citizens at least seventeen years old, who pledge to dedicate their lives to this Cause, can enter the Knights of the Ku Klux Klan.

The Knights of the Ku Klux Klan is a strictly law-abiding organization, and every citizen is sworn to uphold the law and the principles of justice, and that he will not conspire with other Klansmen to commit any illegal or violent acts.

The Knights of the Ku Klux Klan concedes the right of every citizen the right to worship God as he sees fit, and will not tolerate any denominational dissention of any nature. All White Christians must at this juncture in history — unite and work together against our common Marxist enemy which would utterly destroy the Christian faith. Catholics as well as Protestants who believe sincerely in our doctrines are eligible for membership.

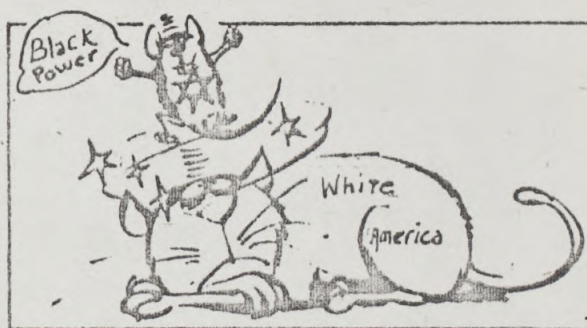

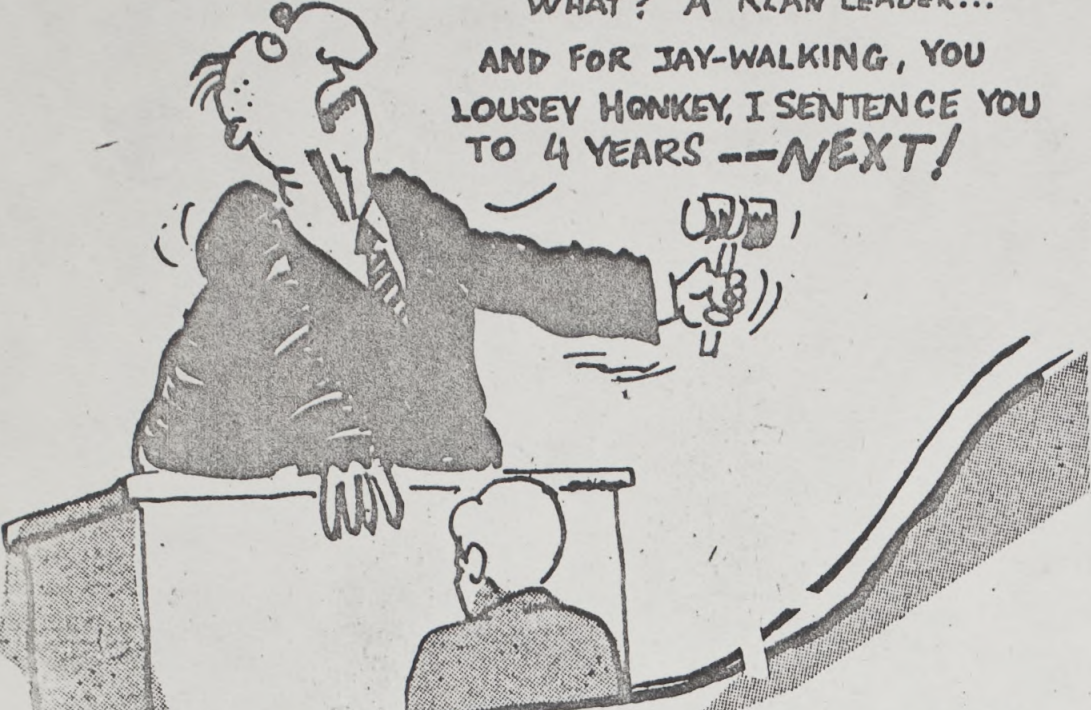

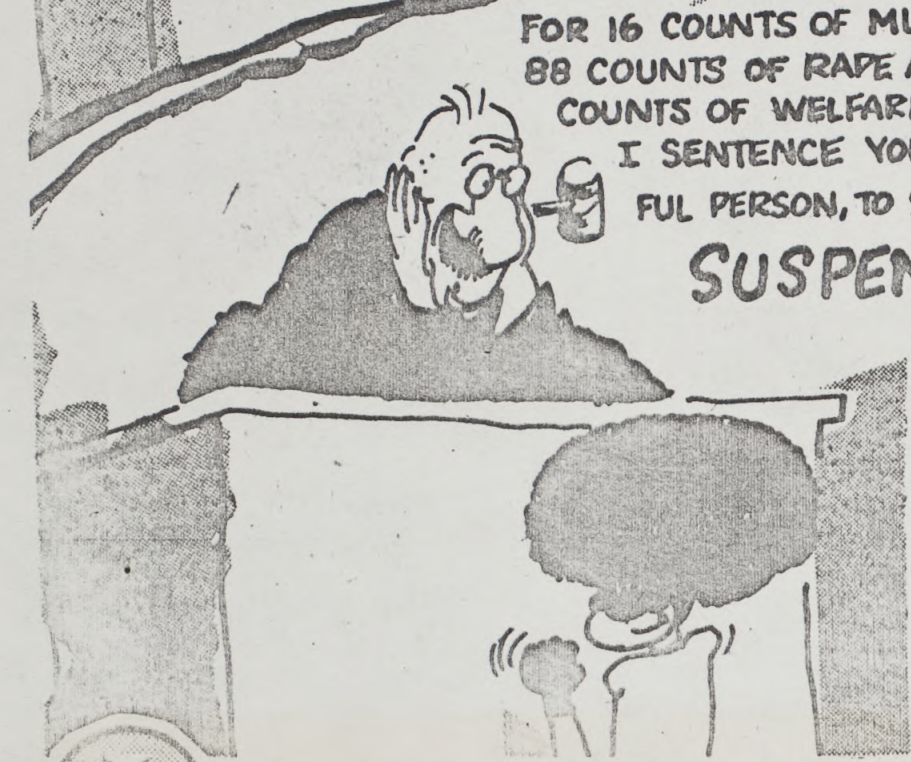

## RESOLUTION NO. \_\_\_\_\_

WHEREAS, on Sunday, October 16, 1977, members of the Klu Klux Klan attracted news media attention by visiting the San Diego border area and announcing their intentions to patrol the border to prevent illegal aliens from entering the United States; and

WHEREAS, Immigration and Naturalization officials in this area were reported to "welcome information" from any citizen and in effect appeared to be condoning the patrol activity by members of the Klu Klux Klan; and

WHEREAS, such a patrol by the Klu Klux Klan can only exacerbate an already extremely grave problem along the border involving the entry of illegal aliens and the violent crimes attendant thereto about which the Mayor of The City of San Diego has already informed the President of the United States on two prior occasions; and

WHEREAS, the Council of The City of San Diego strongly believes that vigilante action of any kind by a private organization, particularly the Klu Klux Klan, is unacceptable because it poses dangers beyond those involved in the illegal alien entry problem; and

WHEREAS, any such patrol by the Klu Klux Klan is particularly offensive and involves the distinct probability of igniting dangerous reactions and, indeed, did provoke a violent <sup>and equally popular</sup> response on the part of some protestors last Sunday, October 16; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the government of the United States and particularly officials of the Immigration and Naturalization Service are strongly urged to discourage any repetition of the kind of media event involving the Klu Klux Klan which took place as aforesaid on October 16, 1977 and, in addition, to emphatically denounce any such patrolling of the United States border as <sup>by the KKK</sup> has been proposed by the Klu Klux Klan as being incompatible with the basic principles that a democratic society must be governed by law, not by violence.



# Secuestro de Chicanos por el KKK

WASHINGTON 6 de Abril (EXCELSIOR).—Patrullas de la siniestra organización fascista Ku Klux Klan secuestran y en algunos casos "desaparecen" a mexicanos y chicanos en el sur de California, en la frontera con México, según denuncias presentadas hoy aquí por la Comisión de Derechos Chicanos (CDCH).

Herman Baca, director de la CDCH, informó en conferencia de prensa que el caso más reciente de secuestro de un mexicano ocurrió el martes por la noche en San Onofre California.

Baca dijo que cuatro Ku Klux Klanes —que vestían camisas con la leyenda "Shite Power" (Poder Blanco), hicieron entrega de un mexicano a la patrulla fronteriza del Servicio de Inmigración y Naturalización (SIN), de Estados Unidos, informando que lo habían "interceptado" al cruzar ilegalmente la frontera.

La víctima hizo notar Baca comprobó que se encuentra legalmente en Estados Unidos; pero el SIN no tuvo a los Ku Klux Klanes sino al contrario, les agradeció su colaboración.

"Estamos profundamente preocupados por estos hechos", declaró Baca.

Y, añadió:

"Los miembros del KKK, son pretexto de cumplir con sus deberes ciudadanos, ha desatado el terror entre chicanos y mexicanos, a lo largo de la frontera con México".

Baca, que es de San Diego, California, viajó a Washington con el propósito de denunciar en el congreso el terror desatado por el KKK entre chicanos y mexicanos mediante secuestro y "desapariciones".

Baca será recibido en lunas por los senadores Alan Cranston, de California, y Edward M. Kennedy, de Massachusetts.

Respecto a las actividades del KKK en la frontera, Baca entregó a la prensa documentos relativos a los secuestros y desaparición de mexicanos y chicanos.

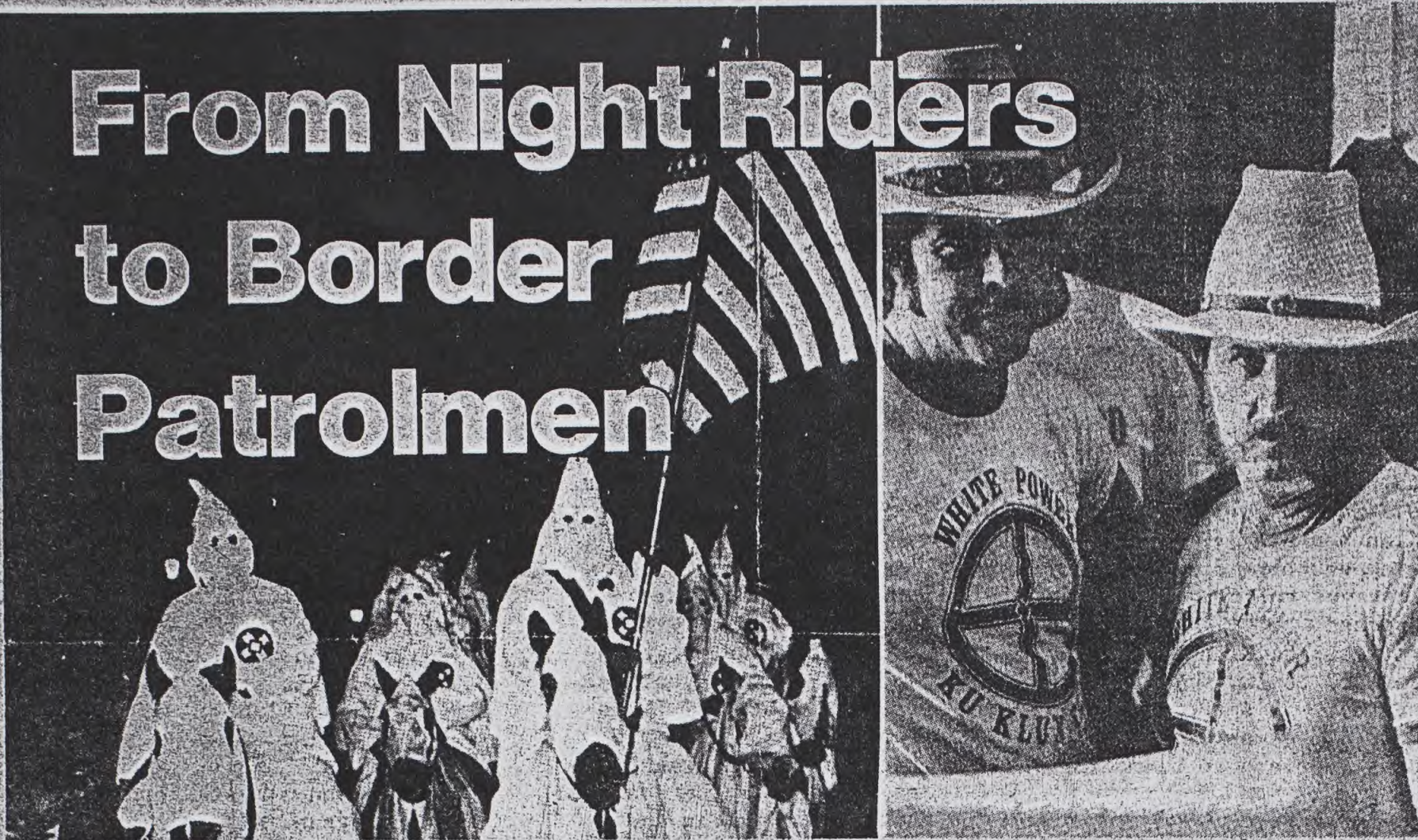

the story and the racist motives for the picture were all wrapped up in what was at the time the most technically advanced motion picture in history. The National Association for the Advancement of Colored People and other Blacks as well as progressive whites protested wherever The Birth of a Nation was to be shown, and in fact, were successful in having it banned in many Northern and Western cities. Then in a coup de grace, the producer, D.W. Griffith, arranged for a private screening before no less than the President of the United States, Woodrow Wilson. Wilson loved every minute of the movie and censorship around the country relaxed.

Colonel William J. Simmons, a KKK leader broadened the scope of the racial hatred beyond Blacks to include Catholics, Jews and other minority people. His speaking engagements drew much attention and, particularly after WWI, served the ruling class by pointing the finger at the victims of the political and economic crisis and calling them the source of all evil. Hundreds of thousands of troops returning from Europe could find no work, the worldwide system of capitalism was in ruin from the war and the workers in the Soviet Union had risen up and taken power, pointing to a whole new future for man.

The workers' movement was growing. On January 2, 1920, the U.S. government struck back with the infamous Palmer Raids, 10,000 workers were

## Brief History Of Ku Klux Klan

To hear the Imperial Wizard David Duke tell it, one would think that the KKK's history has been written by the sensationalists in Hollywood and in reality, the Klan has always been a "decent law-abiding organization." In 1900, the beginning maintained that the KKK is dedicated to the lofty principles of "chivalry, humanity, mercy and patriotism." This is a bunch of garbage. The KKK was born in decadence and reaction and has held to a disgusting road of racism and terror, in service to the ruling class, for over 100 years.

The Ku Klux Klan was formed in Pulaski, Tennessee in 1865 during the turbulent period of Reconstruction. The Southern aristocracy had been defeated in the Civil War and the Northern industrialists wanted to make sure they didn't make a comeback.

They helped to set up new state governments in which freed slaves and poor whites had an equal voice. The democratic movement led by Blacks, poor whites and urban middle classes began seizing land, and the planter struck back.

General Nathan Forest, a former plantation owner, organized the KKK.

The Klan launched a reign of terror that crippled the young Black political movement. Burning homes, lynchings and beatings were rampant and hit particularly hard at organizers in groups like the Union League who were heading voter registration drives.

Although laws aimed at the KKK were passed that made it illegal to belong to secret organizations, the Klan went underground in 1868 and enforcement of these laws became impossible. Most sheriffs were so terrified of the Klan that they would not arrest them. When these laws were passed

claim. It was openly betrayed by the northern capitalists. The struggle between the democratic forces and the planters, threatened investment opportunities so the capitalists struck a deal with the planters. They pulled the Army out of the South, and the planters through the Klan, position of share croppers and tenant farmers. In that way, the northern industrialists got cotton production, railroads and industrial development going in the south,

and the planters got their land worked by Blacks for their own profits.

The next great surge of growth of the Ku Klux Klan began in 1915. The "new, improved" KKK was still in service to a reactionary class of masters, however they were the capitalists now instead of the Southern Aristocracy. A big boost to the rise of the Klan was in the motion picture, The Birth of a Nation, based on two novels about the KKK. The racist story, the racist heroes of

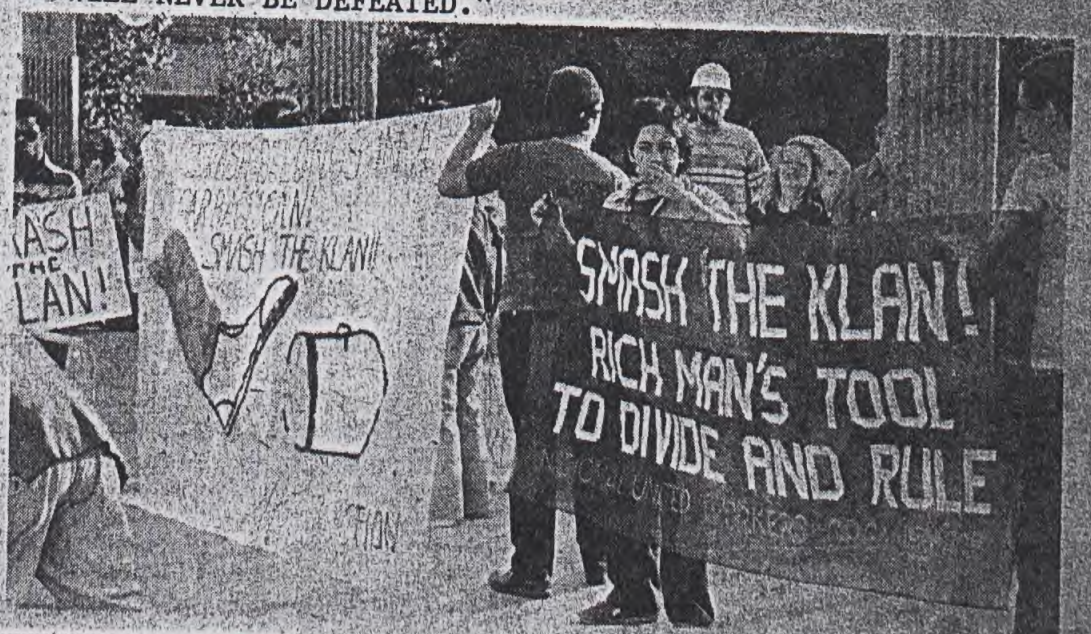
The action was organized in a matter of hours by National

¿Es que el Ka Ka Klan representa no más un idea? ¿No es que el Klan actúa? Y más importante - cuando actúa ¿cuáles intereses promueve el Klan? En una entrevista con el Orange County Register, David Duke dijo que el Klan es non-violento y que todos los cuentos de violencia y terror Klanista son debido a una "imagen de Hollywood." Con un rasgo, Duke borra la historia. El Klan nunca hizo estallar esa iglesia en Birmingham, Alabama según él...nunca mató a esos cuatro niños negros. El Klan no fue responsable por

la muerte de esos tres organizadores para derechos civiles en Mississippi. Todos los asesinatos y linchamientos - toda el legado sobre cual fue construida el Ku Klux Klan nunca ocurrió!

Más recientemente, después de que una junta Klanista fue parada en Ohio, otro líder del KKK Dale Reusch dió el mensaje: "El Klan luchará - si mataremos... vamos a reconstruirnos."

Entretanto los periódicos más grandes dijeron que "la patrulla de la frontera" no era más que un truco para atraer la publicidad. ¿Cuántas páginas y cuánta atención por los medios comunicativos en general han sido reservadas para esta organización terrorista? Parece que este "truco" (que no era nada de estafa sino una amenaza actual y directa a todos latinos) le sirvió al Klan. Hasta el programa de TV Canal 2 (CBS) "To Tell the Truth" ("Decir la Verdad") figuró recientemente un miembro del Klan. Después de que éste "dijo la verdad" mostraron una película sobre una escuela Klanista. ¡Todo esto ha sido publicidad que tendría celoso hasta Cal Worthington!

Algunas voces han sido oídas hablando en contra del Klan. La Unión Americana de Libertades Civiles con algunas otras organizaciones fueron a la corte para obtener un mandato contra el Klan y sus patrullas fronterizas. Algunas personas quienes buscan adelantar a sí mismos como líderes de la comunidad blanca están diciendo: "Quédense calmados... no se preocupe del Klan."

El juez contestó al ACLU que se olvidara de un mandato contra el Klan. Un editorial del Canal 7 (ABC) hizo eco a sus palabras: "...un juez federal en San Diego decretó que el KKK no violaba las leyes federales. A menos o hasta que un accidente sea creado - o que el Klan tome la ley en sus propias manos...ese juez no podría hacer otra decisión."

¿Cuán rápido actúan las cortes para entregar mandatos contra los trabajadores cuando ellos se declaran en huelga? El gobierno y su sistema judicial que esa gente desea confiar recientemente condenó a Buddy Cochran por manejar su carro através de una reunión Klanista en Plains, Georgia. El primer juez en el caso, un miembro del Ku Klux Klan, dijo que Cochran debería de ser electrocutado por lo que había hecho! En Ohio, varias personas están bajo acusación del Gran Jurado por romper una reunión del Klan el verano pasado. En San Diego, los del Pendleton 14 han sido encarcelados y algunos sentenciados a labor pesada por tomar acción contra el Klan.

De hecho, el caso Pendleton ha sido una lucha organizada y militante y como resultado de esta lucha, grandes números de gente ha escuchado esto, apoyando a los 14, lo cual ha frenado a los militares a pasar sentencias largas.

tuvieron presentes, aquella noche y el día siguiente estuvieron reportando acerca del KKK mientras que anunciaron la demostración por 15 segundos en una sola estación.

Dejan al KKK que vaya através del país predicando supremacía blanca y cosas que ayudan a este sistema, y fijese a quienes promuevan los medios comunicativos. # Klan Dragon Fears an Invasion

FALLBROOK — Tom Metzger lives here on Sunbeam Road in the rich, green hills of northern San Diego County. All around him wild flowers are bursting and avocados ripening.

Toddlers romp in an orange blossom breeze and their giggles carry a block. In the supermarket, carts roll slowly and neighbors chat.

Yet here, for Metzger, there is no peace.

He fears that the "black hell" may jump him from ambush or that the "brown hordes" may swarm northward.

A closed-circuit TV peers constantly at his doorway and an elaborate sound system listens. His coffee table books include "Race War in High Schools," and he has a wall lined with volumes extolling the good points of Hitler, the animalistic sex habits of blacks, and one book which tells how God warned Caucasians to "exterminate" Jews before the white race became "as badly polluted."

In his shirt pocket, Metzger keeps a fat pen, like those sold by mail order for \$4, filled with "powerful, military-type tear gas."

And there is a rough-hewn cross in his house. He burns it now and then to celebrate the "blazing spirit of the white race."

Tom Metzger, 39, a wide-smiling, soft-spoken TV repairman, is like an aging John Boy from the Waltons in his open-collared shirt and navy blue cords.

He is also the leader of the Ku Klux Klan in California. As such, he is a militant segregationist who believes minorities should not stand equal with whites in America.

Minorities to him are blacks, browns, yellows, Jews, Arabs or even Southern Italians — any, in fact, who are not

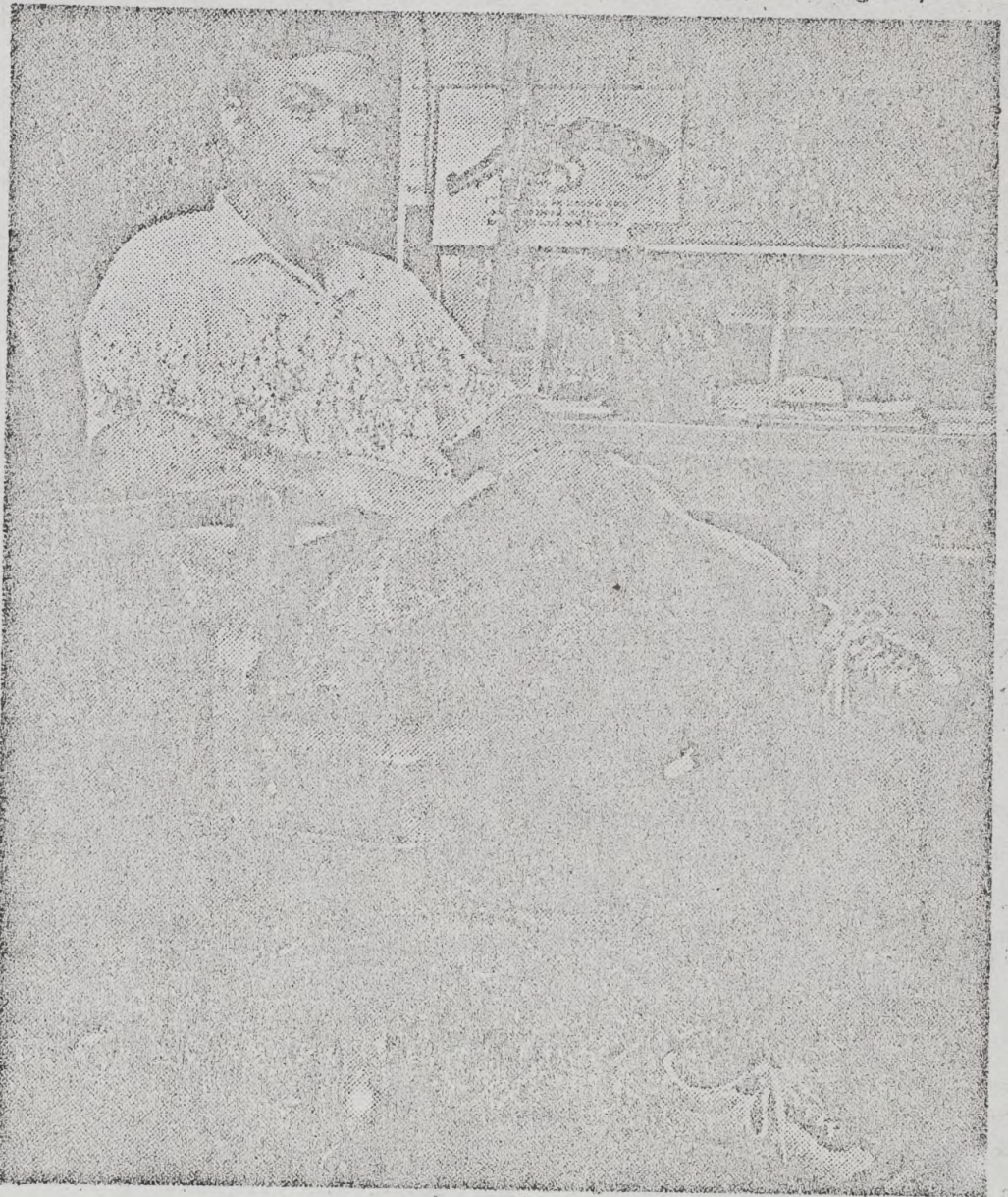
"Anglo-Saxon, Celtic, Germanic or Scandinavian."

Four hundred and fifty-nine voters in Fallbrook last month figured Metzger would make a good community planner. He came in last in a field of 27 candidates, but 20% of those voting

put a mark by Metzger's name.

In June, he will be on the ballot for county supervisor in the 5th District. He does not expect to win, but that is not his point. He is the only candidate running for high county office in the

state with a thick KKK belt slung around his middle. The klan is down-playing night raids this decade and up-playing involvement in government. Any number of votes the Fallbrook white supremacist garners June 6 will be rhetoric in the bank for the klan. Metzger claims "a tremendous amount of support" in the San Diego area.

It was a little past 10 a.m. on a fragrant Fallbrook morning when Metzger sat down in the combination house-TV repair shop-KKK headquarters to talk about his life and current cause.

The state's grand dragon is a man who snaps his fingers — one, two, three, four — to make his points. He snaps and smiles, snaps and talks.

**'My parents, in fact, are somewhat down on me,' Metzger admits.**

And when the phone rings, he paces the kitchen linoleum — left, right, left, right — stretching the cord one way, then the other in an exacting cadence.

"We have to protect our people," he tells a caller this morning. "We have to protect our women. Our people will be there. I wanted to let you know."

Metzger has the police on the line — "the intelligence unit," he says. The klan has to appear in court in a few days to testify against a Chicano accused of throwing a rock at a klan car during the KKK's abortive "border surveillance" last fall. Metzger tells the officer he would "appreciate" having police on hand because during the fall melee — when a few klansmen attempted to launch their border watch and Mexican-Americans came to challenge them — Metzger "didn't see many police at first."

Metzger is speaking sternly into the telephone. "We'll be in civilian clothes," he says. "We'll be law abiding, but as an organization, we can't be looking terrible all the time, like we're afraid."

"We'll be taking precautions," Metzger says, keeping the steady, Pattonesque pace.

How many klansmen would be there? "Oh, 10 or 15," Metzger tells the officer.

The conversation did not last long, but Metzger appeared pleased it occurred. "We always like to let them know where we'll be."

Most observers agree there are about enough bona fide, card-bearing KKK members in the San Diego area to fill the dugout at Padres stadium. But Metzger would be happy should you believe he could fill the stands.

"Just watch us," he says. "Just listen. Imagine anything you want. Imagine we're just a few, super-dedicated people who are going to get what they want. Imagine we're a massive movement. What's the difference? No one's going to stop us. We're professional. We're very determined. We're up-to-date. We have youth."

Metzger is the dragon and his wife is the "genie" (secretary) of the California klan. His four kids are into the klan youth brigade.

Metzger does not use words like "nigger" or "yid," preferring to leave such openness to the literature he

mails from Sunbeam Road for a small profit.

The klan and Metzger have developed talk-show manners for the '70s. It is a "new klan," he says. Just as the hooded robes are now available in permanent press polyester, "coon" and "greaser" have been replaced with media-gear buzzwords like "black hell" and "white flight." You can dial a Yellow Pages number in San Diego and hear how white men must rally to drive the "brown hordes" back over the border.

Metzger ticks off those he considers to be substandard human beings as if it were a list of his favorite foods. It is a cataloging he appears to savor.

"I don't believe many of these minorities have the straight-out ability to compete with whites (in American industry)," he says, "although obviously there is some of what I call overlap."

It is lack of ability "and not just exploitation" that causes Third World nations to lag behind in commerce, he says. He says: "White America should wake up to this."

The "overlap" theory is what accounts for a Thurgood Marshall on the Supreme Court and a white person flunking out of high school, "but to judge an entire race by overlap is not right," Metzger says.

He believes integrated living and white and nonwhite children sharing the same schools is "idiocy." He says the only way to integrate "San Diego's 36% nonwhite schools (without causing a race war) is to give total frontal lobotomies so you have everyone walking around like zombies."

Metzger also is sickened by the migration out of the inner cities, his oft-repeated "white flight to the suburbs." Some are coming to his idyllic Fallbrook. "We're out here like fleas standing in the way of a herd of elephants." Worse, for Metzger, some minorities also are coming his way — "taking away low-income housing from our elderly people."

"Why, down the street they must have two or three families all living in the same house."

"Mexicans," he laughs, sardonically.

Metzger relishes the notoriety his klan skirmishes and forays into the

political arena have given him. No longer is he a TV repairman who was bored with the Midwest way of life. He has microphones in front of him on occasion and, now and then, a reporter in his kitchen.

Men raise their arms, Nazi-style, on his command and salute a fiery cross. He likens himself to a "general in an operation."

The exposure, in recent months, he says, has been "great."

Although most organizations opt to exclude Metzger from their candidates' nights, he claims, "when I do get invited, I get the best reception. Once they get to know my feelings, whenever I am able to present my views, the majority of people say, 'Hey, wait a minute, that's the way I feel!'"

Metzger tells them he is "100%" for the passage of the Jarvis-Gann initiative (Proposition 13) and "completely supports" the Sundesert nuclear power plant. He says it would be "suicide" to locate a coal-burning plant in Baja-California, not only because of potential pollution but because of the "upheaval and incompetency" among Mexican workers.

In Metzger's living room is a two-foot high statue of an ancient warrior in full battle dress. "I'm into collecting statues," he says, yet he is somewhat reluctant to discuss this one.

He got hoodwinked.

"When I got it, I thought it was a Viking, but a neighbor pointed out it was a Moor — Moors were a mixed-blood people," he says. "The odd thing about this one, though, is that he is obviously Nordic. You can tell by the shape of his head."

So the statue stays.

For a reasonable price, Metzger can put into your library such books as "Did Six Million Really Die?" or "The Hitler We Loved and Why," "Race and Sex" or "German Psychological Warfare." Or he can furnish handbooks on "Unconventional Warfare Devices," "Incendiaries," and "Boobytraps," each for \$3 a copy.

He will sell, too, out of his basement store, "Kigys," which are miniature plastic versions of a klansman in his robes, suitable for mounting on a dashboard as some do St. Christopher or the Virgin Mary.

Get Metzger sipping a glass of iced tea, let him settle into his easy chair, and he will tell you he wasn't always grand dragon material.

"As a matter of fact I was a flaming liberal when I was 9, 10, 11 years old. I even got my face punched in — that was in Zephyr Hills, Fla., in 1950 — for speaking up for blacks. Yeah, I used to think blacks were downtrodden and all that. We moved down from Indiana and I believed all that propaganda that Southern people hated blacks. I brought up a couple of things in junior high and I got pounced. It was no big deal. When you're only taught one thing all your life, what are you going to believe? In Warsaw (Ind.), we had only a few black families and they were hard working and I don't remember any of them going to jail. My parents, in fact, are somewhat down on me now. Not really down on me, but they just don't understand about the klan. We never talked much about race at home."

It was while he was in the Army, Metzger says, that he began to see "there was quite a basic difference between races." He returned to Indiana, got tired of "feeling like Sinclair Lewis on Main Street" and headed west. The dragon remembers seeing "lots of anti-Communist films while working at Douglas Aircraft in the early 1960s."

When the 1964 presidential election came along — Metzger laughs about it now — "I really debated between supporting Nelson Rockefeller and Barry Goldwater." He chose the Arizona conservative and after Goldwater lost, Metzger began rising to leadership positions in the John Birch Society.

"I thought THAT was really something," he recalls.

But after 10 years, that group lost

its charm for Metzger." There was a certain amount of mind control. You can have the best libraries in the world, but it does no good unless you translate knowledge into action. I used to say we were going to be the best educated guys in the concentration camp."

"You have to put words into actions," Metzger says, his words beginning to come now in hushed, almost reverent tones.

Of the TV series "Roots," he says: "They tried to show those slaves as intelligent college graduate types, with clean loincloths and all. They left out the savagery of Africans in those days. 'Birth of a Nation' didn't have one-tenth the exaggeration of "Roots."

Metzger on Catholicism: "I was a Catholic, a convert, but I became very disillusioned when they started mickey-mousing around with tradition." He and his wife now attend a

klan-type church, which meets in private homes and studies, among other things, selected Bible tracts to show that "Jesus Christ was never a Jew."

On Lt. Gov. Mervyn Dymally: "He would make a good dictator on some Caribbean island."

On Students for a Democratic Society: "We've recruited several into the klan. All they had to do was get their head straight on race and they had all the rest of the qualifications."

Metzger didn't vote for President in the last election; no candidate was "worth it." For six years he refused to file federal income tax returns and at one point had the sheriff and five others at his door, he says, with guns. Now that he is California grand dragon, he has refiled, but he still thinks the Internal Revenue Service is nothing more than a "Mafia" styled enforcer for the big-money interests of

the country. "Freedom is nothing unless you are willing to lose everything material that you have for it," Metzger says.

"My parents were mad because I did this with the IRS and here I was fighting for everything they taught me about rights and freedom," Metzger shrugs.

The cross the klan burns in northern San Diego County rests idly against a wall of books, downstairs on Sunbeam Road. A little to the left is a large cartoon depicting a Mexican in an oversized sombrero, riding a donkey. "My heart ees yours but my ass ees the government's," the caption reads.

"All I ask is to be quoted accurately," Metzger says. "But no matter what, win or lose, I'll never quit. These other politicians lose and they go home. To me, it's just another day. We in the klan look on things a little differently."

Dear Herman:

Some time ago you wrote me concerning the egregious conduct of a member of the Ku Klux Klan in apprehending a legal resident alien, discarding his local passport, and turning him over to officials of the United States Border Patrol for deportation as an illegal alien.

This office instituted a full-scale investigation of the matter, which required extensive efforts by the Federal Bureau of Investigation to identify and locate the resident alien involved and to identify and locate the subjects of the investigation.

On November 3, 1978, a Grand Jury in the Southern District of California indicted two individuals, Carl Leroy Shipton, Jr., and Robert L. Cole for, among other things, interfering with the civil rights of a lawful resident alien (18 U.S.C. 245(b)(2)(E)) as a result of the activities which took place on April 3, 1978, involving Juan Mendez-Ruiz.

I thought you might be pleased to know that on January 29, 1979, Carl Leroy Shipton entered a guilty plea to Count Two of the indictment before the Honorable Howard B. Turrentine, admitting all the basic allegations supporting the civil rights prosecution. Mr. Shipton, who as a result of his plea, is exposed to one year in jail and/or a fine of up to \$1,000, will appear for sentencing before the Honorable Judge Turrentine on March 12, 1979,



at 9:00 a.m. At that time, the Government will in all probability urge the Court that Mr. Shipton be incarcerated for the maximum term prescribed by law.

The case against the second defendant, Robert L. Cole, was dismissed for lack of sufficient evidence, upon the Government's motion at the time of the January 29 proceeding. A copy of the press release resulting from the guilty plea is enclosed for your information.

United States Attorney Michael H. Walsh announced today that CARL LEROY SHIPTON, JR., entered a guilty plea before the Honorable Howard B. Turrentine to violating the civil rights of a lawful alien, Juan Mendez-Ruiz, in a widely reported incident in North San Diego County on April 6, 1978.

Shipton, picked up Mendez-Ruiz, who was then hitchhiking along Interstate 5 north of San Clemente, California, returning to his home in the Los Angeles area.

Once in the van, Mendez-Ruiz was asked by Shipton, who was wearing a white power T-shirt, to produce his "papers". Mendez-Ruiz passed his resident alien documents, showing him to be a legal resident alien, to Shipton. Shipton said the papers were no good, and threw them out the window of his moving van. He then proceeded to verbally abuse Mendez-Ruiz.

Shipton then returned Mendez-Ruiz south, to the Border Patrol Checkpoint at San Clemente. He then turned Mendez-Ruiz over to agents of the United States Border Patrol, falsely claiming that Mendez-Ruiz was an illegal alien.

Mendez-Ruiz, while frightened, was sufficiently composed to inform the Border Patrol that he had "papers" but that Shipton had thrown them away. This was denied by Shipton. Nevertheless, the Border Patrol officers proceeded

to the area in which Mendez-Ruiz claimed his papers had been thrown away, and found the papers alongside Interstate 5.

On the night in question, Mendez-Ruiz stated he did not wish to prosecute the case and Shipton was allowed to leave.

When the matter was brought to the attention of United States Attorney Michael H. Walsh, he commenced a four-month investigation, which ultimately located Mendez-Ruiz in Los Angeles and ultimately correctly identified Shipton and the other occupants of the vehicle.

Initially, a second individual, ROBERT L. COLE, was indicted along with Shipton. The case against COLE was dismissed.

As a result of Shipton's plea, he is exposed to a maximum of one year imprisonment and a thousand dollar fine.

After the matter came to Walsh's attention, he publicly warned members of the Ku Klux Klan that no interference with the rights of lawful residents would be tolerated. Walsh expressed substantial satisfaction in the conclusion of the case and commended the Federal Bureau of Investigation and the Border Patrol for their efforts in successfully concluding the investigation leading to Shipton's plea.

Sentencing will be held on March 12 at 9:00 a.m.

## 2 Men Indicted On Charges Of Violating Alien's Rights

Two men were indicted by a federal grand jury yesterday on allegations that they violated a resident alien's civil rights in an alleged abduction on April 3.

Tom Metzger of Fallbrook, state director of the Ku Klux Klan, said he could not say "at this time" whether the two named in the indictment are Klan members. Metzger, who was called as a witness during the grand jury proceedings, also declined comment on whether he knew the men.

But the Klan leader described the grand jury proceeding as a continuing "witch-hunt" by U.S. Attorney Michael Walsh to discredit the Klan.

The two San Bernardino-area men named in the indictment are Carl Leroy Shipton Jr., 36, and Robert L. Cole, 28.

Assistant U.S. Attorney Stephen A. Mayo, chief of Walsh's criminal division, said neither of the men is in custody. They are charged with violating the civil rights of Juan Mendez Ruiz, a legally documented resident Mexican alien; conspiracy to defraud the government of its proper administration of laws, and with providing false information.

The indictment charges that Shipton and Cole picked up Mendez Ruiz as a hitchhiker on April 3 and, by threats of force, returned

him to the border checkpoint at San Clemente, reporting him to the Border Patrol as an illegal alien.

Walsh's office said Mendez Ruiz is a legally documented alien and showed his papers to the two men at the time he was picked up in San Clemente.

The indictment alleges that Shipton threw the victim's passport out the window of their moving car before he was turned over to the Border Patrol. Cole is described as the driver of the car.

Cole, according to the indictment, allegedly told a Border Patrol agent that Mendez Ruiz was "wet," that is, an alien who had entered the country illegally.

The Border Patrol, after questioning Mendez Ruiz, retraced his route and found his discarded passport.

Metzger appeared before the grand jury on Sept. 22, where he invoked the Fifth Amendment against self-incrimination when questioned. Stepping out of the grand jury chambers, he described proceedings as a tactic to "harrass" the Klan.

When contacted after the indictment yesterday, Metzger was again critical.

"As far as I'm

concerned," he said, "this is simply an extension of the U.S. attorney's witch-hunt against people trying to do something about our illegal Mexican alien problem. He (Walsh) is out to do anything he can to smear the organization, the same as his predecessor (Terry Knoepp)."

The Klan leader accused law enforcement of "promoting a program to get cheap labor in to the fat cats ... Anyone who interferes with this, they're out to get. The entire Border Patrol setup is one giant put-on. Any border patrolman who could talk would tell you that."

Metzger said he would have to have more information on the indictment before he could comment on whether the two men charged are Klan members.

Walsh said he did not believe Metzger's remarks were worthy of response. His office said that at the time of the April 3 incident the two men identified themselves as members of the Klan.

Your letter of April 13, 1978, to the Attorney General has been referred to this Service for reply.

The incident referred to in your letter occurred on April 3, 1978, when Juan Mendez-Ruiz, a national of Mexico and a legal permanent resident alien of the United States, was hitchhiking near San Clemente, California. Mr. Mendez-Ruiz was picked up by four persons in a Van and delivered by them to the Border Patrol Station at San Clemente, at which time they advised the Border Patrol Agents that Mendez-Ruiz was an illegal alien. Subsequent questioning of Mendez-Ruiz by Border Patrol officers revealed that he is a lawful permanent resident alien. Mendez-Ruiz informed the Border Patrol that the persons who gave him a ride had thrown away his documents. He was transported by Border Patrol officers to the site where this had occurred and the documents recovered and returned to him.

Mr. Mendez-Ruiz was advised by the Border Patrol Agents that he possibly could file legal charges against the individuals who picked him up; however, he declined to do so.

This matter was reported to the appropriate Investigative Agency for their appropriate action. Inasmuch as there was no violation of Immigration and Nationality laws stemming from the above described incident, this Service does not contemplate taking any further action.

I am sure you are aware that the Department of Justice has attempted to discourage activities of the Ku Klux Klan and other similar groups from interfering with the enforcement of our Immigration laws. In this latest incident there was extensive press coverage reflecting our rejection of the tactics employed by the Ku Klux Klan.




A serious recent incident has come to our attention. We have been advised that a citizen of the United States who is of Spanish or Mexican origin was represented as an illegal alien and turned over to the Border Patrol by a group of Ku Klux Klan members.

According to news sources, a victim had been forcibly divested of his proof of citizenship.

The San Diego Urban League requests a full scale investigation into the reported incident. We further request that charges be pressed against the involved individuals, if any laws have been violated; and that the victim be made apprised of his civil rights, if they have been violated.

The Ku Klux Klan's "help" at the border cannot overshadow their record of violence throughout their long history of terror and murder. We ask your office to give serious consideration as to whether the Border Patrol needs the assistance of such disruptive groups.


We request that your office conduct a full scale investigation of the reported incident.
