On April 3rd, a letter was sent you from this office in regard to the above numbered applications of Susie B. Albright and the Estate of Harrison Albright. However, no reply thereto has been rec ived as yet.

In that letter, it was stated that a report on the project by a competent consulting engineer would be a necessary prerequisite for a further consideration of extension of time for
filing of anseers to protests on these applications. This report
should cover (1), the feasibility of the project; (2), data on
the available water supply; (3), information necessary to prepare
a reply to the several protests filed against these applications.

The names of several consulting engineers qualified to make such a report were given you by Mr. Baker, of this office. It is desired to know at this time who has been retained to draw up this report. A statement from this engineer is also desired informing this office when the report will be submitted. This should be at an early date as considerable time has already been allowed for the preparation of this report.

On June 7, 1921, at a conference held in the office of the Division of Water Rights, at which Messrs. Albright, Huber, Poole, Fletcher and others were present, Mr. Albright designated Mr. W. L. Huber as his sole and only representative before the Division of Water Rights, in matters pertaining to the above numbered applications. This designation was witnessed by other interested parties. Susie B. Albright, however, did not designate anyone as her representative.

Because of recent developments in Mr. Albright's affairs, it would now seem advisable to have your law firm appointed with power of attorney as the sole representative before this office of all parties holding an equity in these applications.

Please inform us if there are parties other than Harrison and Susie B. Albright who hold an equity in these applications.

Receipt of your letter of July 5, requesting extension to July 1, 1924, on project bearing the above number before this office, is acknowledged.

Your application for this project seems to have reached a peculiar situation before this office and the Federal Power Commission and there has been considerable correspondence concerning it.

Under date of May 22, you advised this office that you were not depending on your old rights alone on the Santa Ysobel and Black Canyon streams for power purposes, and requested advice as to whether you should submit your application No. 567 to the Federal Power Commission as an exhibit showing that you had complied with the State Law as to water rights in your application before the Federal Power Commission for a preliminary permit.

In reply thereto, under date of May 29, you were advised that the above numbered application should be included in your applications before the Power Commission and it is also understood that you were requested by the Federal Power Commission to include this application.

In your letter of July 5, it is stated that the Federal Power Commission is withholding issuance of permit untilapplication No. 567 is made a part of your applications before that body. The information that you have not filed your application 567 comes as a surprise to this office inasmuch as it was assumed that in order to clear matters before this office and the Federal Power Commission, you would immediately file a copy of that application with that body upon receipt of our letter of May 29.

The reason for not so filing is not clear to this office inasmuch as not doing so not only creates an irregularity in your priority but embarrasses the work of both offices

before which your application has been filed. It is unfortunate that the situation as it now stands does not justify this office in granting the extension requested and it is hoped that you will clear the matter at an early date.

For your information you are advised that the filing of application 567 does not vitiate to any degree the value of your old rights under the State Law. On the contrary it strengthens the aggregate value of your total rights on the River. To that extent also, it will strengthen the value of your showing as to water rights before the Federal Power Commission.

Exemination of the above numbered application shows the following deficiencies to which your attention is invited:

Paragraph 5 shows a pipe line 10 miles long. This pipe line should also be shown on a map.

Paragraph 17. The vicinity wherein the water is to be used is stated, but the acreage to be irrigated is not shown.

Paragraph 18 should be consistent in total with Paragraph 17.

Paragraph 20. The only map in connection with this application on file with this office is a contour map of the reservoir which shows the area in 20-foot contours. The Rules and Regulations are very plain on this point and state contour maps of the reservoir sites should show the area in 5 or 10foot contours. Besides this contour map, a map should be submitted showing the location of the ditch and also the location in detail of the land to be irrigated.

One copy of your application is herewith returned to you and, as provided in Section 17 of the Water Commission Act, you are allowed sixty days after this notice in which to file an amended and perfected application.

My dear Major Kleugel:

Replying to your letter of July the 8th. It is indeed unfortunate that the peculiar condition that you refer to on the Sutherland-Black Canyon Power Application has arisen as we were under the impression that we had complied with all the requirements of both the State Water Cormission and Federal Power Commission.

Exhibit E of the application to the Federal Power Commission was an enumeration of the water rights held on the Santa Ysabel and Black Canyon Creeks at the points in quastion. The application before the State Water Commission was referred to in this exhibit along with the enumeration of the other water rights. There was no copy of any of the water rights submitted nor did the Federal Power Commission ask for any such copies.

The reason no copy of the Application No. 567 was originally submitted in the Federal Power Commission Application was that as no copy of any other water right was required we naturally assumed that the enumeration of this application was all that was necessary. Furthermore we did not know or feel that we had the right to submit a copy of our application to the State Water Commission to the Federal Power Commission prior to the granting of the permit from the State Water Commission.

On July 1st. however, a copy of Application No. 567 was forwarded to the Federal Power Commission with a lotter explaining to them why it had not been filed before. A copy of the letter to the Federal Power Commission is inclosed herewith.

There has been a great deal of money spent on this project in road building to make the project accessible, core recovery borings to determine bed rock conditions at the damsite, and the fimil location and benching of three miles of the pipe line practically completed. In view of these facts in addition to those enumerated in my letter of July the 5th, I feel that the State Water Commission would be justified in granting an extension of time on this work.

This is to acknowledge receipt of your letter of August 14, 1922 relative to the omission of the storage features in Permit of above number.

We are unable at this time to determine why the storage features of this application have escaped notice and attention since the date of the original filing of the application. However, it would appear that such right to storage as may have been initiated by the filing has not lapsed.

In order that the situation may be cleared up it is recommended that the following steps be taken:

- (1) The permit fees on the permit as approved on August 2, and for which you have been billed, should be paid at once in order that the filing of the permit may be made with the County Recorder. Should these fees not be paid the law is specific that all priority of right under the application shall cease and determine. It is understood, of course, that this permit will for the timebeing be considered only a partial permit and that at a future date supplemental permit may be issued.
- (2) The Engineering data necessary in order to complete the application for storage should be filed at once. This data includes a tracing and print of a contour map of the reservoir and an area capacity curve. The proposed inclusive dates of diversion into storage should also be noted.
- (3) When the application has been completed in these respects advertisement will then be made.
- (4) At the expiration of the advertising period consideration will be given to any protests which may have been

filed and to the matter of issuance of a permit.

(5) If no objections develop the supplemental permit may then be issued allowing the storage as applied for.

Under paragraph 2 it is stated that 44,225 acre
feet or the total capacity of the reservoir is to be stored
and later applied to beneficial use. It was not my understanding that this was intended to convey the idea that
44,225 acre feet or the total capacity of the reservoir
should be taken as the amual yield of the said reservoir.

The yield of this reservoir will depend greatly upon the other development on the river above. I have made not safe yield studies of this reservoir and these seem to indicate that with the Cuyamaca Water Company developed as at present, the Mission Gorge will be capable of delivering, as a municipal supply, 8800 acre feet annually. With increased development by the Cuyamaca Water Company above the yield of the reservoir will be reduced. Assuming the complete development of the Cuyamaca Water Company, Mission Corge Reservoir would probably be able to deliver 6300 acre feet annually.

Assuming the gross area to be irrigated remains as at present contemplated at 5000 acres, the net irrigated area would be, in round figures, 3500 acres. It has been quite well established that the average duty of water in this territory can be assumed at one acre foot per acre of land actually irrigated. This 5000 acres would, therefore, require an annual delivery of 3500 acre feet. Assuming this all to be delivered in eight months, the capacity of the pipe line would be 7.2 second feet. Allowing 10% for transmission lesses gives us, in round figures, a capacity of 8.0 second feet for the pipe line. Bulletin No. 376 of the U.S. Department of Agriculture, by Fred C. Scobey.

gives the capacity of a 24" woodstave pipe, laid on the grade of one foot per thousand at eight second feet.

Assuming the yield of the reservoir to be 8800 acre feet annually there would remain 4300 acre feet for municipal use within the City of San Diego, or assuming the complete development of the Cuyamaca Water Company there would be 2800 acre feet for the municipal use within the City of San Diego. These figures are well on the safe side since it is manifestly unfair to an irrigation project to limit the yield of a reservoir to the municipal yield as an agricultural development can get by in case of an emergency on a two-thirds or even one-half supply. The safe yield studies quoted above, however, are my studies based on a municipal supply without shortage.

It is my understanding that the Application No. 2989 was merely supplemental to and really a part of the original Application No. 2695. It would be difficult at this time to definitely state the exact amount of water which would be available for the municipal supply within the City of San Diego for the reason that the yield of the Mission Gorge Reservoir will depend upon the extent of the development of the Cuyamaca Water Company.as has been shown above.

It is somewhat difficult to bring out all of these conditions in the form of application. Will you be kind enough to advise me how I should amend the applications Nos. 2695 and 2989 to cover this condition according to your regulations.

(1) Between what dates will water be diverted to storage. Ans. Throughout the entire year.

I am not quite clear as to the proper answer to this question. The Santa Ysabel River at this point flows through—out the year although at certain periods during the latter part of the summer the flow is extremely low. If it is the intention that it be stated during what period of the year the inflow into the river is greater than the draft, the question raised is quite intricate as in Southern California the runoff period fluctuates in duration and time very widely. Generally speaking, the months of December, January, Pebruary, March, and April are the months during which the greatest runoff occurs although during certain years the runoff persists as late as July, in some years is over during April.

(2) Since this application was made the U. S. Reclamation Service mede a very thorough study of this reservoir site and their determinations were that the economic storage was 60,000 acre feet, flooding to the 2111 foot contour U.S.G.S. Mr. J. B. Lippincott has recently made an independent study and arrived at the same conclusion. If it is possible, therefore, Colonel Fletcher would like to change this application to include a possible storage to the 2123 contour U.S. G.S. datum. If he can so amend his application, will you be kind enough to return to me the tracing of the contour map of the Sutherland Reservoir, and I will have another tracing prepared showing the reservoir to the above contour. If it is not parmissible to so change the application, the map you now have shows in a heavy dotted line the contour of the reservoir as proposed in the original application and while some additional topography is shown, the top contour of the proposed storage is clearly defined.




