Our attorney, Judge Sloane, says that there is no question but what we can maintain that forever as is, but I realize that there is some equity in your claim of having your property all together, and I believe the above suggestion is the solution of the problem.

An early reply will be appreciated, and if accepted, I will instruct my son immediately to do the work.

I ordered the fence torn down and my son did tear it down. I understand it has been put up again.

If it is necessary to go into court, I will immediately do so. Please let me have an answer from you by return mail. I hope we will have no trouble.

This leaves the rest of the land intact and a good road in front of your property. It is my intention shortly to make all those roads county roads, and maintained by the county, in which case I would want you to quitclaim to the county.
