the many Voter Education Projects set up in the South to help teach Blacks which lever to pull on their voting machines. "I wish — Lord, how I wish — Martin Luther King were alive today. He would be very, very happy." An understatement, to say the least.

Empowered with his Black mandate, President Carter began at once to prove that next to peanuts he liked niggers. He appointed Congressman Andrew Young, a long time Black friend, to the post of Ambassador to the United Nations. Then he placed Patricia Harris, a high yellow at best, but Black enough to count, in office as Secretary of Housing and Urban Development. Finally he began appointing many Blacks to various deputy and assistant positions on his new Washington "team."

Having made America's Blacks the happiest they have been since Lyndon Johnson and the "Great Society" of the 60's, Mr. Carter then turned his full attention to his real source of power, his Jew buddies. Anxious to show his gratitude, he began at once to end Jewish unemployment forever in America.

Here is a partial list of his many kosher appointees:

- **Harold Brown, Secretary of Defense.** A member of the Jewish Anti-Defamation League of B'nai B'rith, Brown has long been considered a hawk on the subject of Israel. Feared by many present Washington officials to be "consistently soft" on both Communism and the Soviet Union, he is known to be against the cruise missile system and the new B-1 bomber program. All this at a time when many European leaders are warning the U.S. that Russia is "on a war footing."
- **Werner Michael Blumenthal, Secretary of the Treasury.** Born in Berlin, this 50-year-old Jew only became a naturalized American in 1952. He

favors the selling off of more of America's gold reserves and relinquishing our control over the Panama Canal. A professional gambler in his early days, Blumenthal now looks forward to playing for the really high stakes—Zionist control of all American monies.

- **Lawrence R. Klein, Top Economic Advisor.** A genuine, honest-to-God, former member of the American Communist Party, Klein has an extensive history of participation with many Communist-front organizations. Among these are the "Jewish Peoples Fraternal Order" and the "International Workers Order," both certified Communist by former Atty. General J. Howard McGrath. Klein has stated that he left the American Communist Party because the meetings were "dull." In the last year he has made little-publicized trips to Poland and Russia and is "very involved in Jewish affairs." Here is a Jew to watch. Perhaps a future Secretary of State, should Cyrus Vance come down with a guilty conscience.
- **Robert Lipshutz, Top White House Council.** An active leader in Atlanta's Jewish Community for the last 30 years, Lipshutz has been holding Jimmy Carter's hand since his political career began in 1966. This Jew was Carter's campaign treasurer during the presidential election. It was during this campaign that Lipshutz was able to do such a masterful job of losing \$150,000 of Carter's election money that no one has found it yet. Probably they never will.
- **Stuart Eizenstat, Domestic Affairs Council.** Eizenstat, a 33-year-old young Jew on the make, has previously worked for both Humphrey and Lyndon Johnson. He was a vital part of Carter's 1970 Georgia gubernatorial campaign and was later loaned out to help elect Black Andrew Young to Congress and Black Maynard Jackson as Atlanta's first Black mayor. A

tough Jew to deal with, Eizenstat feels the future belongs to him.

- **Morris Dees, Democratic fundraiser and Carter confidant.** Dees, long a money man for the Democratic Party, raised \$20,000,000 for George McGovern in 1972. He later raised money to pay for the Jewish defense of Black revolutionist Jo Ann Little, the North Carolina Negress who was charged with murdering her White jailer. Dees is a well-known enemy of the NRA and favors strict gun control. A behind the scenes man who carries a big stick. Some have mentioned him as a possible replacement for the FBI's Clarence Kelley.

These are only a few of the many Jews Jimmy Carter is repaying with high positions in the American government. Others include Sol Linowitz, a co-negotiator for the Panama Canal sell-out, and Jerome Cohen, an economic policy advisor.

Carter's non-Jewish appointees are just as bad. Case in point is Cyrus R. Vance, our new Secretary of State. On the delicate subject of Israel, Vance has publicly stated, "We are committed to the survival of Israel. There isn't any question about this." In regard to the Panama Canal Treaty, "We should reopen negotiations at a very early point." And concerning the very desperate situation of the White people of southern Africa, "We must firmly support majority (Black) rule, and assist in helping this come into being as rapidly as possible." Would Kissinger have put any of these

any differently? No. A liberal of any nationality is at heart a Jew.

Riding into the White House on the Black steed of Carter's election victory is Vice-President and Chief Staff Advisor Walter F. Mondale. While Mondale is White, his record doesn't show it. One of the most liberal members of the U.S. Senate, he was hand-picked and breast-fed by his fellow Minnesota Senator, Hubert Humphrey. His place on the Carter ticket was part of the deal which kept Hubert out of the primaries. Everything a National Socialist is, Mr. Mondale isn't. In the entire rogues' gallery of pimps, stooges, and subversives whom Jimmy Carter has brought with him to power, none is as potentially dangerous to the fundamentals of American liberty as this man, Fritz Mondale.

In the very short time since he has taken office, Mr. Carter has already found time to pardon the Vietnam draft-dodgers (a majority of whom were Jewish), begin the preparations for a U.S. forces pull-out in Korea, and stand to one side while his henchmen hand southern Africa over to the Communist equipped Black terrorists.

Needless to say the Jews are very pleased with "their boy." To date the media is still treating him as if his initials J.C. meant more than just Jimmy Carter. Although he has washed his hands of the unemployment issue, after taking strong stands on it during his campaign, he has received no criticism. He is John Kennedy, "born again," and by the time America realizes her grave mistake it may well be past the point of political salvation.

Black Terror Spreads in Africa

The long anticipated nightmare is beginning in southern Africa. Both Rhodesia and South Africa have experienced wave after wave of Black terrorist violence in the last few months, each wave closer to the last.

Rhodesia especially, has been hard hit. Recently seven White Catholic missionaries were cut down in cold blood by invading Black butchers from nearby Communist Mozambique. Hundreds of spent cartridges from Soviet-made machine guns were discovered at the scene of the massacre.

Elsewhere in Rhodesia it's the same. White women and children murdered. Sympathetic Rhodesian Blacks mowed down by the dozen, or else kidnapped and tortured, by Cuban-trained guerrillas armed with sophisticated Russian and East German arms, operating from Mozambique and Zambia.

America's reaction to the largest Communist offensive since Vietnam has been brutal and brief. Rhodesian Prime Minister Ian Smith's recent appeal to the United States for help to prevent terrorists from seizing Rhodesia "on behalf of Russian imperialism" was answered by Andrew Young, America's first Black Ambassador to the United Nations.

In a terse, pointed statement, Young,

long a close personal friend of Jimmy Carter, was quick to dash Ian Smith's hopes for the lives of 275,000 White Rhodesians. With precise implication, America's high-yellow foreign diplomat warned Smith that any efforts to gain U.S. support by invoking the Red menace "would not succeed."

Young went even further, implying that it was Smith, himself, who was "luring" Cuban-trained killers into Rhodesia in the hope of involving the United States and Western Europe in his fight for an "internal Rhodesian solution." As Mr. Young puts it, "Ian Smith is playing for time."

Meanwhile, President Carter's newly appointed Secretary of State, Cyrus R. Vance, has begun an all-out drive to repeal a law that has allowed the United States to import Rhodesian chrome since 1971. Chrome is Rhodesia's most valuable export. Before the 1971 law was enacted, Russia would buy Rhodesian chrome and then sell it to the United States for three times the price they had originally paid. The American steel industry must have chrome as it is essential to the manufacture of stainless steel. Classified as a strategic material, America can produce only 1 percent of the chrome she requires.

... Meet the Scalawag Goy From Georgia

WASHINGTON (NSNS) — The first thing Jimmy Carter did in 1971 after becoming the new governor of Georgia was to hang a huge portrait of Martin Luther King Jr. in a prominent place at the State Capitol. Both men had something in common. Each had a scheme.

For Jimmy Carter, six years later, the scheme paid off. After gathering over 94 percent of the Black vote across the nation, he was elected the 39th President of the United States. The fact that he received less than 49 percent of the total White vote was of no consequence.

Guided by his Jew advisors, Robert Lipshutz, Stu Eizenstat and Gerald Rafshoon, to name only a few, Jimmy Carter out-niggered and out-Jewed Gerald Ford in enough states so that he could go to bed early on election eve night. It was no contest once the New York City vote was counted.

It had taken Mr. Carter only a few short years to convince America's Jewish media power bosses that he was their goy. Early in his Georgia political career, he opposed the White Citizens Council and help break the power of Lester Maddox. He said the right things, had the right friends and could find every synagogue in Atlanta blindfolded.

He knew which side of the bread his butter was on.

When the final vote came in last November, Carter could boast a larger percentage of the Black vote than either "Gentle" George McGovern in 1972 (87 percent) or Hubert "I'm a Soul Brother, too" Humphrey in 1968 (85 percent). Add to this over 89 percent of the Jewish ballots and America has herself a President elected by the "majority." Jerry Ford might as well have been running for office in Kenya.

The feeling of the Black community at their stroke of good fortune was summed up best by Atlanta's John Lewis, the Black executive director of one of

EVOLUTION BY EXTENSION CITIES AND CULTURE

If what is known about animals when they are crowded or moved to an unfamiliar biotope is at all relevant to mankind, we are now facing some terrible consequences our urban "sinks" ("Jungles"). ("Ghettos").

The adjustment of these people (Negroes) is not just economic, but involves an entire way of life.

The lower class of Negro in the United States poses very special problems in their adjustments to "Sink" living which if those problems are not solved may well destroy us by making our cities uninhabitable.

An often overlooked fact is that lower class Negroes and middle class whites are culturally distinct from each other.

Some Negro spckemen have gone so far to say that no white man could possible understand the Negro.

They are right if they are referring to the lower class Negro. Only those we have trained do we understand.

THE NEED FOR CONTROLS

Our studies show the relationship of man to the city is the need for enforced laws to replace tribe custom. Laws and Law Enforcement Agencies are presently in cities all over the world, but at times they find it difficult to cope with problem among them and need help. An aid to law and order that has not been good in the fullest extent possible, is the power of custom public opinion in the ethnic "Enclaves," Cooperating preachers, politicians, teachers, etc.

These "Enclaves" perform many useful purposes, one of the most important is that the "enclaves" act as life time reception areas in which the second generation can learn to make the transition to the "sink" (jungle) (ghetto) life.

The main problem for us with the "enclaves" as it is now placed in the "Sink" is that its size is limited. When the Negro population increases at a rate the enclaves is unable to convert them- only two choices remain.

1. Territorial growth (more land) or
2. overcrowding

If the enclave cannot expand and fails to maintain a healthy "density", (overcrowding) a sink develops.

The normal capacities of law and order enforcement agencies are not able to deal with "sinks."

Apart from letting "sinks" run its course "more land" and destroy the city, there is an alternative solution.

Prepack or introduce design features that will counteract our undesired affects of the sink. But most important not destroy the enclave in the process.

A study by Pathologist Charles Southwick discovered that peromyscus mice could tolerate high cage densities.

In animal populations, the solution is simple enough and frighteningly like what we see in our Urban Renewal Programs or sinks.

CONCLUSION 1

To increase density in a rat population and maintain healthy specimen. (a) Put them in boxes so they can't see each. (b) Clean their box (c) and give them enough to eat.

Then you can pile them in boxes up as many stories as you wish. Note: Caged Animals become stupid, from states of flux boredom or fusion which is a risky price to pay for our super filing system of the people.

The question we must ask ourselves is how far can we afford travel down the road of sensory deprivation in order to file these people away in these public housing projects?

CONCLUSION 2

You can't shed culture in the briefest possible sense, the message of this book is that now matter how hard man tries, it is impossible for him to divest himself of his own culture, for it has penetrated to the roots of his nervous system and determines how he perceives the world.

Most culture lies hidden and is outside voluntary control, making up the warp and weft of human existence even when small fragments of culture are elevated to awareness they are difficult to change, not only because they are so personally experienced but because people cannot act or

Political interests of Negro community power are best indicated in the talk and actions of Negro leaders.

Of course it is not always easy to know who is a Negro leader and who is not, for rarely do leaders lead everything, or as rarely as community itself is utterly in a singular direction.

Further, yesterday, a leader may not be today's leader.

However with close observation and sympathetic objectivity you can identify present Negro leaders with community power or influence or respect of the people.

The only major precaution which must be taken is to avoid the easy mistake of superiority or authority approach when seeking their leaders. In other words act and show exceptional concern, respect, and friendliness to them ask questions, unsuspectily and listen.

Our enclave or those in the Negro community with whom we would prefer to deal, and whose influence is already established with our power structure, may not be leaders at all.

And if they are leaders, then they may be leaders of interests other than that of the community interests. This is why they must be watched very close and deep thru our enclaves as well as the many laws which we have at our need.

A Negro leader is one who moves his community, rather than establish legal authority in the country.

The popular leadership of the Negro community is almost unknown to those in authority outside the community.

Without the involvement of legitimate office the true Negro leaders are unnoticed by the media and by public opinions.

When in danger from us they are carefully guarded by the Negro community itself. The undisputable fact remains that there are thousands of such leaders, each one moving the local community with a powerful potent force.

Our wisest and most urgent move now should be to put them in "New Towns in Towns" and let them have "Community Control" so they will have a feeling of security. Thus creating self containment.

CHAPTER X

Conclusion

Once the ghetto is sealed off, and depending upon the violence being perpetrated by the guerrillas, the following actions could be taken by the authorities:

- (1) A curfew would be imposed in the enclosed isolated area. No one would be allowed out of or into the area after sundown.
- (2) During the night the authorities would not only patrol the boundary liner but would also attempt to control the streets and if necessary, send out foot patrols through the entire area. If the guerrillas attempted to either break out of the area or to engage the authorities in open combat they would be readily suppressed.
- (3) During a guerrilla uprising most civil liberties would have to be suspended, search and seizure operations would be instituted during the daylight hours, and anyone found armed or without proper identification would immediately be arrested. Most of the people of the ghetto would not be involved in the guerrilla operation and under conditions of police and military control, some would help in ferreting out the guerrillas. Their help would be invaluable.
- (4) If the guerrillas were able to hold out for a period of time then the population of the ghetto would be classified through an officer for the "control and organization of the inhabitants." This office would distribute census cards which would bear a photograph of the individual,

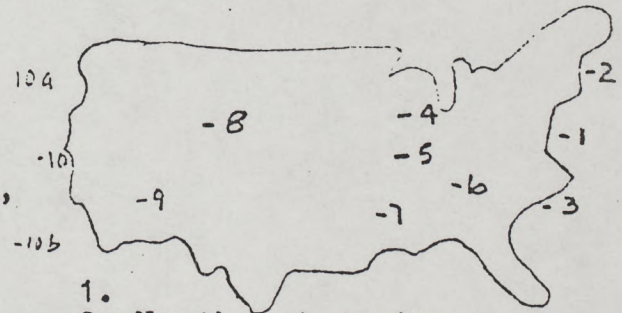

Even before 1954 when the Supreme Court of the United States of America declared unconstitutional separate educational and recreational facilities, racial unrest and discord had become very nearly a part of the American way of life. But that way of life was repugnant to most Americans. Since 1964 however, that unrest and discord have broken out into widespread violence which increasingly have placed the peace and stability of the nation in dire jeopardy. This violence has resulted in loss of life, limb, and property, and has cost the taxpayers of this nation billions of dollars. And the end is not yet in sight. This same violence has raised the tremendously grave question as to whether the races can ever live in peace among each other. Each passing month has brought new intelligence that, despite new laws passed to alleviate the condition of minority, the Minority still is not satisfied. Demonstrations and noting have become a part of the familiar scene. Troops have been called out in city after city across the land, and our image as a world leader severely damaged. Our enemies press closer, seeking the

time during one of these outbreaks of violence. The Min has adopted an almost militant posture to gain its objectives which are not clear to most Americans. It is expected, therefore, that, when those objectives are denied the Minority, racial war must be considered inevitable. When that Emergency comes, we must expect the total involvement of all 22 million members of the Minority, men, women and children, for once this project is launched, its goal is to terminate, once and for all, the Minority threat to the whole of the American society, and, indeed, the Free World....

There are 12 major Minority organizations and all are familiar to the 2 million. Dossier have been compiled on the leaders of the organizations, and can be studied in Washington. The material contained in many of the dossiers, and our threat to reveal that material, has considerably held in check the activities of some of their leaders. Leaders who do not have such valuable material in their dossiers have been approached to take Government posts, mostly as ambassadors and primarily in African countries. The promise of these positions also has materially contributed to a temporary slowdown of Minority activities. However, we do not expect these show-downs to be of long duration, because there are always new and dissident elements joining these organizations with the potential power to replace the old leaders. All organizations and their leaders are under constant, 24-hour surveillance. The organizations are:

- The Black Muslims
- Student Nonviolent Coordinating Committee (SNCC)
- Congress of Racial Equality
- Uhuro Movement
- Group on Advanced Leadership (GOAL)
- Freedom Now Party (FNP)
- United Black Nationalists of America (UBNA)
- The New Pan-African Movement (INPAM)
- The National Urban League (NUL)
- 0- Southern Christian Leadership Conference (SCLC)
- 1- The National Association for the Advancement of Colored People (NAACP)
- 2- Committee on Racial and Religious Progress (CORARP)

NOTE: At the appropriate time; to be designated by the President, the leaders of some of these organizations are to be detained ONLY WHEN IT IS CLEAR THAT THEY CANNOT PREVENT THE EMERGENCY, working with local public officials during the first critical hours. All other leaders are to be detained at once. Compiled lists of Minority leaders have been readied at the National Data Computer Center. It is necessary to use the Minority leaders designated by the President in much the same manner in which we use Minority members who are agents with CENTRAL and FEDERAL and we cannot, until there is no alternative, reveal KING ALFRED in all its aspects. Minority members of Congress will be unseated at once. This move is not without precedent in American history.

ATTORNEY GENERAL

Preliminary Memo: Department of Defense

This memo is being submitted in lieu of a full report from the Joint Chiefs of Staff. That report is now in preparation. There will be many cities where the Minority will be able to put into the street a superior number of people with a desperate and dangerous will. He will be a formidable enemy, for here bound to the Continent by heritage and knows that political asylum will not be available to him in other countries. The greatest concentration of the Minority is in the Deep South, the Eastern seaboard, the Great Lakes region and the West Coast. While the national population exceeds that of the Minority by more than ten times, we most realistically take into account the following:

- 1- An estimated 40-50 percent of the white population will not, for various reasons, engage the Minority during an emergency.
- 2- American Armed Forces are spread around the world. A breakout of war abroad means fewer troops at home to handle the Emergency.

contain the Emergency until help arrives, though it may mean fighting a superior force New York City, for example, has a 25,000 man police force, but there are about one million Minority members in the city.

We are confident that the Minority could hold any city it took for only a few hours. The lack of weapons, facilities, logistics- all put the Minority at a final disadvantage. Since the Korean War, this Department has shifted Minority members of the Armed Forces to areas where combat is most likely to occur, with the aim of eliminating, through combat, as many combat-trained Minority servicemen as possible. Today the ratio of Minority member combat deaths in Vietnam, where they are serving as "advisers," is twice as high as the Minority population ratio to the rest of America. Below is the timetable for KIND ALFRED as tentatively suggested by the JCS who recommend that the operation be made over a period of eight hours:

1. Local police and Minority leaders in action to head off the Emergency.
2. Countdown to eight hours begins at the moment the President determines the Emergency to be:
 - A. National
 - B. Coordinated
 - C. Of Long Duration8th hour
3. County police join local police 6th hour
4. State police join county and local police 7th hour
5. Federal marshals join state, county, and local police 5th
6. National Guards federalized, held in readiness. 4th
7. Regular Armed Forces alerted, take up positions. Minority troops divided and detained, along with white sympathizers, under guard 3rd
8. All Minority leaders, national and local, detained. 2nd
9. President addresses Minority on radio-television, gives it one hour to end the Emergency. 1st
10. All units under regional commands into the Emergency. 0

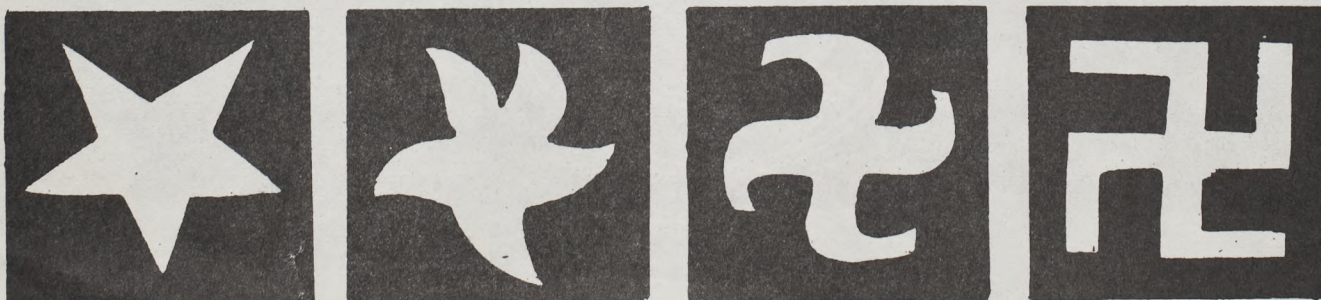

Terrifying study of our Nazis

"California Reich," which opened yesterday at the Cento Cedar Cinema, is a terrifying study of the National Socialist White People's Party, made by young film-makers Walter Parkes and Keith Critchlow.

The film, which was nominated this year for an Oscar as Best Documentary, is infinitely more chilling than those made about the German Nazis. For these are our own home-grown bully boys, our countrymen and even members of our own community, since most of the action was shot in San Francisco.

The film-makers provide no narration, exposition or voice-over. They let the semi-literate Nazis speak for themselves in displaying the awesome hate they feel for non-whites.

It is the sociological, rather than the political importance of the movement that fascinated Parkes and Critchlow. Actually, these ignorant neo-Nazis have no coherent political position. Their views are merely confused, shrill, mindless rhetoric that makes no sense whatsoever.

But their rabid reactions to the world around them are projected with sickening impact as we visit not only

their rallies and meeting halls, but their homes where they spew out their raging hate for Jews and blacks.

The leader of the San Francisco Party, Allen Vincent, who spent 20 of his 40 years in reformatories and penitentiaries, explains how he found an end to loneliness in the movement. A housewife, straight out of a baking products TV commercial, gives her recipe for a festive swastika cake, and a Santa Claus arrives at a Christmas party wearing the repellent arm-band.

But the most loathesome sequences are those in which we see the parents' indoctrination of pint-sized racists in the persons of their four- and five-year-old children.

One especially frightening scene shows a close-knit Nazi family spending a Sunday afternoon together in their home. The mother asks two toddlers: "Who don't we like?" "Jews! Niggers!" the children scream delightfully. "What do we do to them?" she asks. "Stomp them," shout the children with cherubic smiles.

The reason the film is so stunningly effective is that the film-makers do not set out to make cartoon-like

most... hands out thousands of high-paying government jobs to its key people regardless whether or not these people have any real ability to perform the duties these positions require. These fancy jobs are the "spoils" and no one expects the government to do any work anyway.

The best these Twentieth Century carpetbaggers can do is waste tax dollars on their excessive salaries and bureaucratic inefficiency. And the worst they can do is simply give it all away to the degenerates, loafers, and of course niggers on welfare who devour huge amounts of money... leaving little or nothing for the honest White worker down on his luck, sick or disabled and hence unable to work through no fault of his own.

These political parties never appeal to reason. "Image" sells them better than logic. But "Image" is expensive, even if their particular party is the darling of the Jewish-controlled mass media. They therefore need money. in plain clothes, passing out literature among the crowd.

This latest candidate said he is chief engineer aboard a sulfur carrying ship and has been a member of the Nazi party and a chief engineer aboard ships for 10 years.

Nazi aspires to Galveston mayoralty

GALVESTON— Michael Ange says he is an American NAZI. He also says he wants to be mayor of Galveston.

Ange has filed with the city secretary of Galveston to run for the mayor's office currently held by R.A. Apffel.

According to the city secretary, Ange's application is in order, but he may still not be able to run due to a long standing clause in the state election code that prohibits members of the Communist's, fascist, or Nazi party from running for public office in Texas.

Although the law may not still be valid, says city secretary Patsy Poole, it still has to be checked out by the city attorney.

Ange is not taking it so calmly.

"It appears City Council is going to try and block my running for mayor," says Ange who is a unit leader for the National

Socialist's Workers Party in Galveston County.

Ange says there will be a rally Monday in Galveston to protest the state code prohibiting his running on the Nazi party ticket. He says he has called the national leader of the Nazi party, Allen Vincent—who with lawyers and bail bondsmen—will attend.

Ange admits the National Socialist White Power Party is a racist party dedicated to the preservation of the white race.

He says he is not for killing Jews or Blacks, but only wishes to see a separation of the races to "preserve the purity of the white race," and blames misconception of the Nazi party on "Jewish propaganda."

"We have 500 members and several thousand supporters in Galveston County," according to Ange. He claims many people support the Nazi party but are afraid to do so openly for fear of per-

White supremacy speech given on Isle

GALVESTON — The National Socialist White Workers Party, also sometimes known as the American Nazi Party or the White Power Party, presented its white supremacy message from the steps of city hall Monday.

National party leader Allen Vincent of San Francisco appeared at city hall with mayor candidate Michael B. Ange and four other party members to confront City Atty. Robert V. Shattuck in the question of Ange's candidacy in the April 2 city election.

But it was the noon hour and the city attorney was out to lunch so the six left a party membership card with Ange's name on it with Shattuck's secretary.

The city attorney said later Ange is to be treated "exactly the same as any other candidate who files for office," and he assumes Ange meets the candidacy qualifications.

When Vincent arrived at the airport Monday morning, the group departed in a station wagon on a round-about route to Ange's apartment, including a drive through the parking lot of a supermarket.

People entering or leaving city hall did not even slow up as Vincent delivered his brief speech in front of several police officers and four reporters. One passerby stopped, listened briefly, then wandered off shaking his head.

Isle's Nazi leader files mayoral bid

Galveston — The avowed leader of the American Nazi party (ANP) here, Michael B. Ange, 38, filed for mayor in the April 2 city election, but City Atty. Robert V. Shattuck said state law prohibits his name being on the ballot.

Ange, chief engineer on a sulfur tanker which operates from here, sent his application by certified mail in an envelope adorned with swastikas, the slogan "White Power" and a telephone number.

A resident here 10 years, Ange said in a phone interview he joined the ANP in Virginia 10 years ago. He said the Galveston unit has 500 members.

Shattuck cited the Texas Election Code, which says no candidate of the Nazi party "shall ever be allowed a place on the official ballot at any election in the state."

With the filing deadline March 2, six persons, including Ange, have filed for mayor, not including incumbent R. A. Appfel. Fourteen have filed for seven at-large City Council seats, including Councilwoman Edna Fuller.

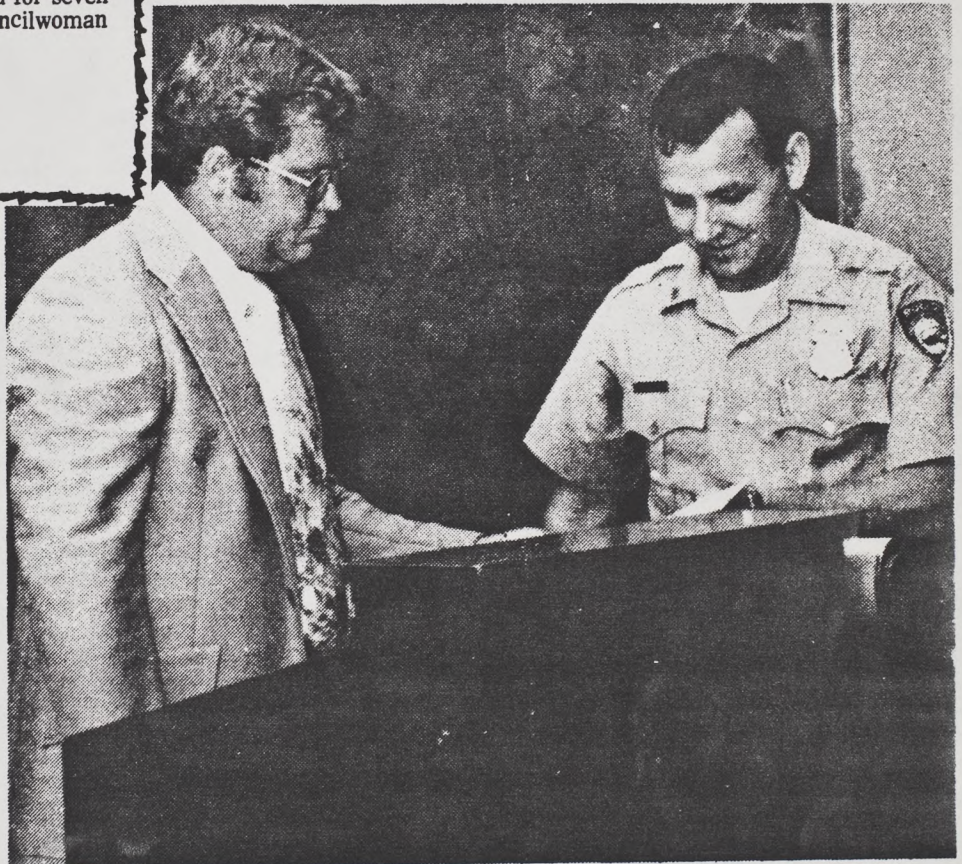

Nazi parents dislike the way public school are run.

"A lot of things get taken out of the parent's hands," NSWWP women's organizer Margaret Herler said. "Teachers override the parents' desires. Debbie almost got spanked just because she refused to play with blacks."

The Nazis said they are considering building their own school.

"In public schools, we learn mostly about blacks, about Africa and Asia," Victoria von Wagmann said. "They barely teach about Europe. We've got to do something about this. That's why we're trying to establish our own white school."

A nearby Nazi smiled proudly.

"Adolf Hitler said 'Give me a child until he's seven and he'll be a Nazi for the rest of his life,'" she said. "If it's true, this party is going to be around an awful long time."

And when Vincent organized the National Socialist White Workers' Party in 1976, all of us felt a wave of reassurance sweep over us that the movement was truly secure and bound for ultimate success.

"I really admire Hitler," Jim, a 20-year-old Berkeley resident whispered. "He was a great man. He pulled his people together. He made a few mistakes — like attacking Russia and not arming Normandy enough — but besides that he was a good leader."

Jim was talking during a recent meeting of the San Francisco branch of the National Socialist White Worker's Party (NSWWP), the American offshoot of Adolf Hitler's Nazi party.

"It's about time whites got together in an organization like this," he said after the meeting. "Just look at what's happening around us. Blacks are taking over. I think that guy Bakke is absolutely right. Federal law is beginning to build up blacks and put down whites."

Over a dozen Nazis under the age of 30 attended the meeting. Like Jim, they expressed admiration for Adolf Hitler.

"Hitler was a great man," Bob, a 19-year-old college student from the central valley said. "He brought his country out of the Depression and created one of the finest military forces in the world."

Although Jim and his young friends wore long hair and talked about their favorite rock groups (Hitler denounced any music having "a savage jungle beat"), that did not seem to matter to the older Nazis around them.

"We're looking for a new brand of Nazi," one forty-ish party member said. "We don't care if they use cuss words, just as long as they fight for their race."

The attraction of young people to Nazi-like

groups is not new. Young people formed the bulk of the American Nazi Party during the early 1960s and have provided the leadership for other Hitlerite organizations.

Ku Klux Klan grand dragon David Duke, 26, has said his college recruitment program is doing "extraordinarily well" while J. B. Stoner, leader of the neo-Nazi National States' Rights Party, said, "Young people are among my most active supporters."

There seems to be a growing ambivalence to the memory of Adolph Hitler even among young people outside the Hitlerite movements. In a recent San Francisco Chronicle "Question Man" column, five people were asked which historical figure fascinated them the most. Two, both in their early twenties, answered "Adolf Hitler."

"He united his country," Dan MacArthur, a business administration student, said, "and started a really big head trip — making them think they were the Master Race."

Legal messenger Larry Lopez said he "liked the way Hitler mobilized his military forces" and "especially admired the SS."

"This is a new generation," Jim Ruderman, San Francisco regional director of the Anti-Defamation League, told The Daily Californian. "Young people today just don't know that much about recent history. There's a general dearth of knowledge about the Nazi era."

Ruderman cited a 1976 trial of two American Nazis in Milwaukee in which potential jurors were questioned about their knowledge of Hitler to determine whether they were prejudiced against Nazis. None of the 23 people questioned said they were aware of Hitler's death-camp persecutions of the Jews.

"I've heard of Nazis," one juror said, "but I don't listen to the news all that much." Another juror said he knew little more about the Nazis other than the

Nazi Party thriving in Bay Area

"I pledge allegiance to Adolf Hitler," the people in the hall recite, their arms thrust forward in a Nazi salute, "the immortal leader of our race...."

A huge swastika banner hangs in front of them, flanked by several smaller flags and the black and silver thunderbolt standard of the Gestapo.

This article is the first in a three-part series examining the American Nazi Party. Part One profiles the leaders of the movement in San Francisco.

"and to the new order for which he stands...."

The room is decked with portraits of Hitler. In an alcove to the rear, an elderly man sells Nazi armbands and gold-plated swastika bracelets.

"one great cause, sacred and invincible...."

A knaki-clad stormtrooper watches over the crowd, a pistol at his hip and a slight sneer rolling over his mouth.

"White Power!"

The scene described above did not happen in Germany in the 1930s. It happened in San Francisco recently, during a meeting of the local branch of the American Nazi Party.

The American Nazi Party was formed in 1958 by George Lincoln Rockwell. At that time, as he

wrote in his autobiography, he "proclaimed his intention to do for the white people of this country what Adolf Hitler had done for the Germans — rescue them from the international Jewish conspiracy."

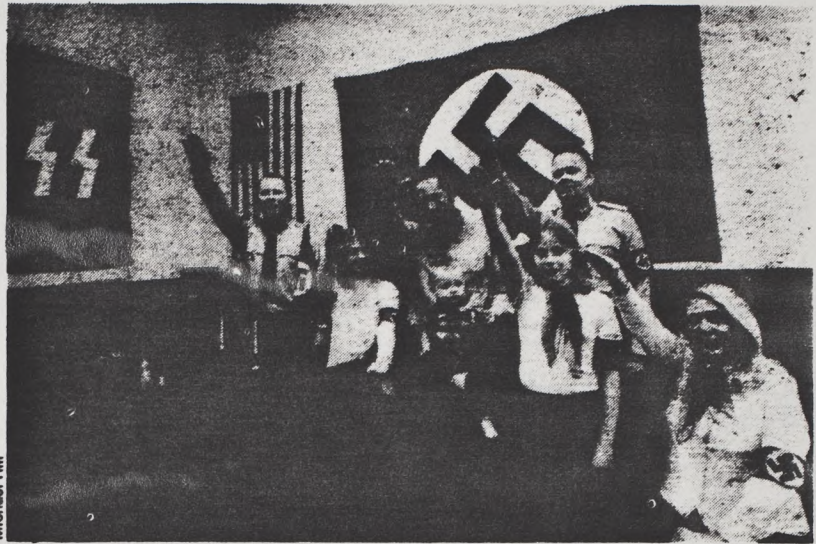
Rockwell explained that he had found "abundant mental sunshine" in Hitler's book "Mein Kampf." "Word after word stabbed into the darkness," he wrote, "like thunderclaps and lightning bolts."

Rockwell molded his party after Hitler's German movement, hoping he and his followers could create "an all-white America, dedicated to the principles which made our Western civilization great." Before he could see that come to pass, though, Rockwell died. He was shot to death in August, 1967, by fellow Nazi John Patler.

Patler, a former editor of Stormtrooper Magazine, had been expelled from the party four months earlier when he caused dissension among party members by saying dark-haired Aryans are superior to light-haired ones. He shot Rockwell to revenge the incident.

After Rockwell's death, the party split into two wings. The most active branch is the National Socialist White Workers' Party (NSWWP), led by Allen Vincent of San Francisco.

Allen Vincent is a self-described "graduate of California's penal institutions." He spent

much of his life travelling from one reformatory to another and he has been locked up in the psychiatric wards of San Quentin and Folsom prisons.

"I don't think there's anything genetically criminal about me," Vincent told The Daily Californian recently. "I honestly think I'm a victim of the system — a system which discriminates against the white race."

Vincent met Rockwell in the early 1960s. Rockwell appointed him head of the National Socialist Youth Corps, a position he held until Rockwell's death. After the murder Vincent organized his own party on the West Coast.

The basis for much of Vincent's political action is his hatred for the Jews.

"I really down deep in my heart

hate Jews. I hate them more than anyone can describe," Vincent said.

"Jews spend their whole lives trying to pervert, subvert and destroy the laws of nature. I don't really hate blacks — they're just pawns and savages. It's the Jews that are guilty of the whole busing system and forced integration.

They're guilty of an outright plot to destroy the white race through mongrelization. After we come to power, they'll have to answer for this criminally insane conspiracy."

NSWWP national coordinator Joseph von Wagmann shares his comrade's hatred of Jews.

"Jews are the masters of race-poisoning and brain corruption," he said. "Their ultimate goal is the promiscuous bastardization of Gentiles. The Jew is worse than a disease. He is the deadliest poison ever brought from the gates of hell."

Von Wagmann said his family "will never fall prey to the Jew-brought idea of race-mixing."

"I would kill my daughter before she slept with a nigger," he said.

Von Wagmann was raised on the idea of racial purity. He was born in Germany in 1935 and spent much of his childhood in the Hitler Youth Corps. Four years

ago, Allen Vincent introduced him to the American brand of Nazism.

Von Wagmann predicted that a Hitlerian battle between Aryans (championed by the NSWWP) and non-Aryans will soon put an end to racial conflict in America.

"In such a struggle, one side must be abolished," he said.

"If we win, we will destroy Jews and Jewish sympathizers down to their roots. There will be no toleration. The last Communist shall either be converted or eradicated. There is no middle ground. The spirit of Adolf Hitler will guide us in that last reckoning, the final judgment day of the Jews and their cohorts."

It would be easy to discount Vincent and von Wagmann as a pair of isolated fanatics if they were alone in their beliefs. It appears, though, that they are not.

More than a hundred people regularly attend Nazi meetings in San Francisco and, according to Vincent, "they are only the tip of the iceberg."

Vincent said large segments of the San Francisco and San Jose police departments belong to his group. A Nazi offshoot, known as the Aryan Brotherhood, is drawing recruits from local prisons, particularly Folsom and San Quentin.

Hitlerism seems to be on the rise elsewhere in the country as well.

In Georgia, neo-Nazi J.B. Stoner, a self-avowed racist who told The Daily Californian that "Adolf Hitler was the greatest guy since Christ and all the apostles," won nearly 70,000 votes in a 1974 gubernatorial election.

Nazi candidate Frank Collins won 16 per cent of the vote in a Chicago alderman election, while a Nazi in another ward won 10 per cent of the vote, placing third in an election with six candidates.

"We're gaining strength all the time in our march towards victory," von Wagmann said. "When we do win, the world will be amazed at what we will do."

PORTRAIT OF AN AMERICAN PATRIOT

In October, 1974, the Charleston, W.Va., police were baffled by two murders, so they instituted what is commonly known as a "round-up of suspects". Among the people arrested was Richard Bradley. The police later admitted that the only reason that Bradley was arrested was that he was a White racist who was known to carry a gun to defend himself. Bradley was later ex-

a couple of times for raping young White boys and several times for robbing old and weak White prisoners - and he was always trying to get his "tough brothers" moved into the bullpen with him so they could terrorize all the "honkies" as he referred to the White prisoners.

This nigger was twenty-two years old and weighed two hundred and twenty-five pounds. Richard Bradley is age thirty-eight and weighs about a hundred

immediately end this sub-human's life. It seemed that this "poor colored boy" - as the Jew-press called him - had made a fatal mistake.

If the fight had gone the other way and the nigger had killed Richard, he probably would have gotten one to five years in the pen and that would have been after all sorts of "civil rights" groups had protested, raised defense funds, demonstrated and raised general hell. But Richard is White, his name isn't Hurricane Carter, Angela Davis, Joanne Little or Gary Tyler, there wasn't any defense fund. Bradley is a Nazi, not a Communist. There were no demonstrations. Richard was forced to accept a court-appointed Jew lawyer who barely made any effort to offer a defense.

Nigger cops were allowed to handle the case. Two known petty thieves had their charges dropped to testify against Bradley (The same two disgraces to our Race incidentally that the same nigger had robbed and raped.) Bradley was crucified by the Jew-owned papers and television. The prosecuting attorney even made the statement to the Charleston Gazette that this was the only case that he had ever handled that made him sorry there was no death penalty in West Virginia.

The nigger was made into a martyr and the defense wasn't allowed to present any evidence about this "fine, young colored boy" or his record. There was no real trial but a travesty of justice perpetrated by a Jew-

But while he was in jail, Richard met the plague that every White man who is arrested these days must face: The "bull-pen nigger". This particular nigger had been moved in and out of every bull-pen in the Kanawha County Jail - once for almost beating a White epileptic to death,

and sixty-five pounds at his peak. So the nigger thought he had another weak "honkie" to bully and rob. But that was one nigger who made a sad mistake.

Richard, due to his case in appeals court, declines to make any statements, but two traitor White rats said that after the nigger started to try to intimidate Bradley, Richard proceeded to

Civil rights case rejected

Nazi store charges dropped

No federal charges will be filed in connection with the ransacking of a Nazi bookstore here last April 1.

Federal prosecution had been requested by the head of the local Nazi Party whose 3608 Taraval St. bookstore was attacked and burned by a crowd armed with sledgehammers and crowbars.

In a letter yesterday to Allen Vincent, housepainter, who operated the Rudolf Hess bookstore, Asst. U.S. Atty. David Bancroft said, "Applicable federal statutes do not cover the alleged misconduct."

Vincent complained last April 12 that the assault on the store "was obviously a premeditated criminal conspiracy to violate my civil rights."

He accused Morris Weiss and his son, Allan, of committing 11 felonies, including "intent to commit premeditated murder."

The father and son were arrested by police the night of the raid and charged with malicious mischief, Morris Weiss was also charged with aggravated assault.

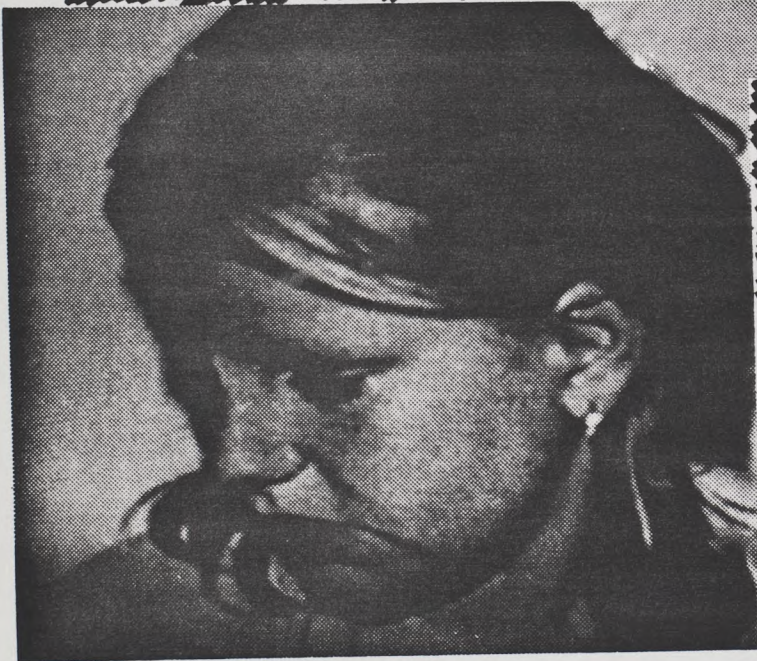
Charges were dropped later, however, "because of substantial evidentiary problems and in the interests of justice," said San Francisco Dist. Atty. Joseph Freitas.

Bancroft, who declined prosecution under civil rights laws after reviewing a report of a "limited" FBI investigation covering police and media reports and witnesses, told the head of the National Socialist White Workers Party here:

• One section of the law covers only civil rights deprivations at the hands of public officials or by other state action. "There is no allegation or known evidence that the perpetrators of the mob action alleged were acting other than as private citizens."

• Another pertinent section covers only civil rights deprivation when the perpetrators "go in disguise on a highway . . ." or when they act in a conspiracy. "There is no allegation that the perpetrators were in disguise or that the mob action was pre-planned or consciously coordinated as opposed to being a spontaneous action by a number of individuals acting simultaneously."

The alleged misconduct of the Weisses, Bancroft said, does not come under federal law.

U.S. Won't Prosecute

Nazi Bookstore Case

The U.S. attorney's office formally declined yesterday to prosecute the group that vandalized and burned a Nazi bookstore in the Sunset district on April 1.

David P. Bancroft, an assistant U.S. attorney, sent a letter declining prosecution to Allen Vincent, head of the National Socialist White Workers party.

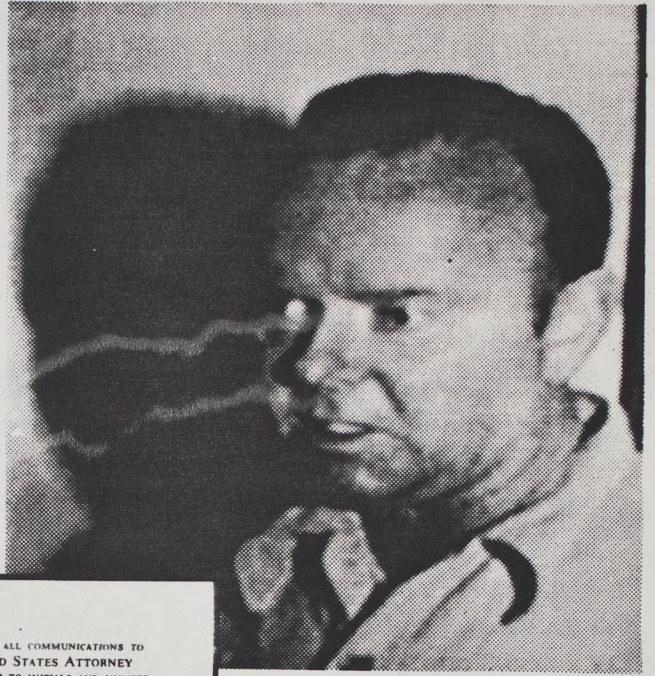
Vincent's group opened the Rudolf Hess bookstore, flaunting Nazi emblems and literature, at 46th avenue and Taraval street. The store later closed.

Vincent, in a letter to the U.S. attorney, claimed his group's civil rights were violated by a mob action.

Bancroft yesterday wrote Vincent, "There is no allegation or known evidence that the mob action was preplanned or consciously coordinated as opposed to being a spontaneous action by a number of individuals acting simultaneously."

The local district attorney had also declined to prosecute.

Dear Mr. Vincent:

Federal prosecution of the matters the subject of your complaint of April 5, 1977, must be declined. Applicable federal statutes do not cover the alleged misconduct.

18 USC 242 reaches only civil rights deprivations at the hands of public officials or by other state action. There is no allegation or known evidence that the perpetrators of the mob action alleged were acting other than as private citizens.

18 USC 241 (the other pertinent statute) covers only civil rights deprivation when the perpetrators "go in disguise on a highway" or when they act in a conspiracy. There is no allegation or any known evidence that the perpetrators were in disguise. There is no allegation or known evidence that the mob action was pre-planned or consciously coordinated as opposed to being a spontaneous action by a number of individuals acting simultaneously.

The individual actions of Allan Weiss, in allegedly committing malicious mischief, and of Morris Weiss, in later allegedly assaulting you, are not cognizable under federal law. Accordingly, the foregoing comments do not reflect on the merits of those allegations.

The location was purely coincidental. The store plus living quarters combination plus the reasonable rent that determined the location. We chose the name of Rudolf Hess because he was a National Socialist and a man of peace. For this he is still in solitary confinement after thirty-six years.

Surely, to have honored such a man could not have provoked this attack.

We chose the Swastika not only because it is the sign of National Socialism but also because it is the symbol of the Aryan Race and has been since the days of the Vikings. It has even been used as a good luck symbol by American Presidents. So surely there is nothing "un-American" about it, contrary to the ravings of the attackers and their leaders. The Aryan Cross did not provoke this insane attack and destruction. If it had been the symbol alone then the destruction of the Swastika alone would have been enough.

But, no, since inside this bookstore were people who distributed books and other publications that proved with documented evidence that there is a Jewish conspiracy, lies and decept, this organized mob of Jews had to get inside to destroy these publications and, if possible, also

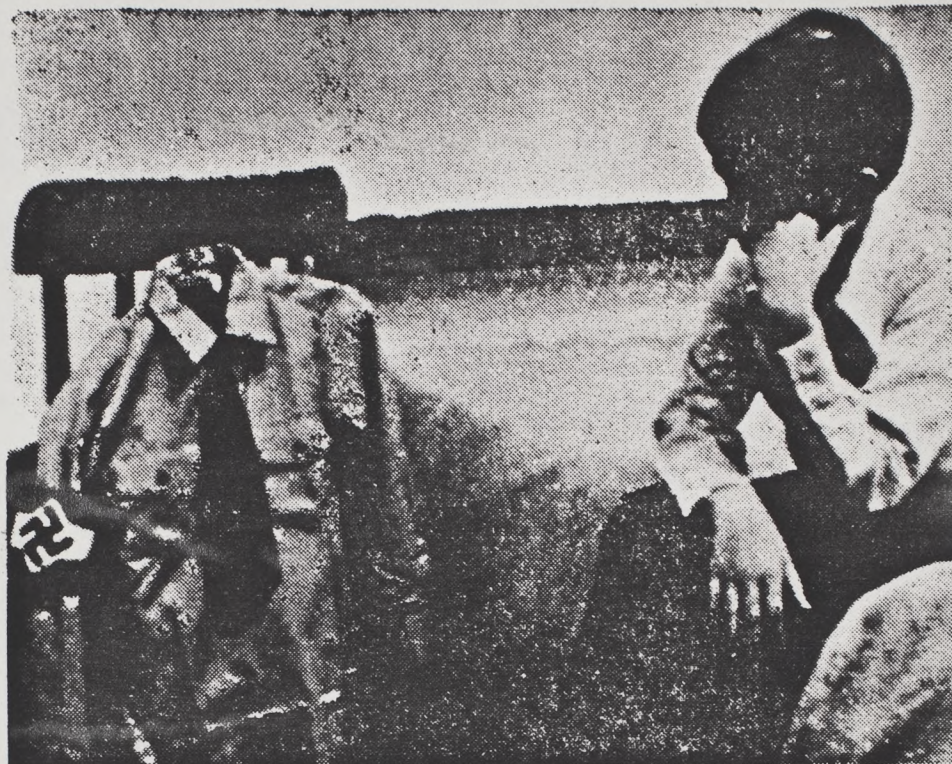

Atlanta Seeks Blast's Backer

ATLANTA, Ga. Oct. 15 (AP) — A high-up "fat cat" backer of anti-Semitic terrorism figured today in police investigation of the \$700,000 destruction of the Jewish temple here.

This financial angle of a fanatic hate-mongering mob was mentioned in one of two letters seized as police raided the homes of five persons held for questioning about the dynamiting, which occurred early Sunday.

Detective Capt. R. E. Little described the other paper as a pencilled draft of a letter addressed to an Atlanta Jewish leader before the temple blast.

It said: "You will soon witness a terrifying experience."

Details Withheld

The detective did not say precisely where either letter was seized, whether the one to the Jewish leader was ever mailed or what the leader's name is.

The other letter, Capt. Little said, was mailed from Arlington, Va., but before five men were arrested here in July for an anti-Jewish demonstration in front of the Atlanta Journal-Constitution Building.

"Thanks to one man, one 'fat cat' financier, we can now do the things we've been planning to do," it said.

The letter did not identify the "fat cat" but Capt. Little said the name of a man who promised to provide a large amount of money to the bombing investigation.

The letter referred to the wealthy banker as having "put his dollars where his mouth is — God bless him." It also mentioned a "big blast" and added:

The blast from New York will be coming down. There's no guts in the local citizens.

Five Others Are Bought

The officer said they are seeking five men other than the five already named. They said an unidentified fifth man, a resident of Detroit, Mich., was subjected to a "torture" which led to his arrest while in jail on another count.

Capt. Little said a "series of statements" evident at the start of the questioning of those held is beginning to wear off. "We are getting down to business now," he reported.

The detective captain listed the fifth man arrested in questioning as Wallace H. Allen. He said Mr. Allen, said George Michael Wright, 35, also held, helped plot the bombing of the Temple at a meeting in May.



most of Europe to Communism, they would be allowed to fall into total collapse.

After the War, Churchill is well-known for having made the comment - too late - that, "We killed the wrong pig."

And, after the War, Hess was brought from prison in England and put on trial in Nuremburg as having been a "War Criminal" after having been himself a prisoner of war throughout most of the Second World War. Hess was convicted on the charge of having "Conspired Against Peace".

Hess was sentenced to life imprisonment and locked up in Spandau Prison where he has remained to this day.

Other ranking "War Criminals", also sentenced originally to serve the rest of their lives, have long since been released. Hess is the sole prisoner left at Spandau, a place designed to hold six hundred men. Why?

All of the Western governments have stated their willingness to release Hess. As the job of "guarding" this elderly

man is shared jointly by four nations: England, France, the U.S., and Russia; each taking its turn for one month, it would be simple for them to just let Hess go during their turn as his jailer. They have not and will not do this.

The reason is because of a statement Hess made in 1934: That he would not betray Hitler ever, at any time, "come what may". All the rest, to secure their personal freedom, did renounce Hitler. Hess never has and never will. Therefore, as far as the Western "democracies" are concerned, he can die in jail.

As far as the Russians are concerned, had Hess been successful in 1941, there would today in all probability, be no Russia. Instead, only a series of smaller colonies dominated and controlled by Germany. Not only will they not allow Hess to leave Spandau alive, they have also sworn never to allow his ashes leave the prison.

But in the nearly forty years that Hess has been imprisoned, the world picture has changed dramatically. This is not one more sob story for Hess on the part of helpless fighters for justice or humanity.

We have no reason to pity Hess. For to do so belittles the man and the full understanding he has always had for his place in world history. We need not worry about Hess. We only should honor him.

Year by year, his lot in prison has improved. He is at last seeing his family, etc. He is not forgotten and he has been fully vindicated. He most likely will never see freedom because the rotten world order

that is on its way out still maintains superficial control.

But what memories the man has! His past contains more meaning than a thousand futures in terms of average human existence. And this he knows also.

The world may have made a mistake but Hess has not compounded it by betraying the man who still has the future of the world in his hands.

And he lives still in the same world with us. Hard to believe.

He is there reading about us and even watching us on television. Think about it.

One of the greatest men who ever lived is still alive today: Imprisoned by a rotten world. Hess is the last of the great men of the old school who stands in super-human magnitude. The Greatest Man Alive is a prisoner.

AMERICAN REVOLUTION TOMMASI STYLE

This summer marks the third anniversary of the death of Joe Tommasi in El Monte, California. I can honestly say that not a day passes in which I don't think of Tommasi.

It's easy to wish for the return of a dead comrade and



to imagine how things might be going if he were still with us.

But if I knew Joe correctly, even had he escaped death in August, 1975, he'd have already managed to have gotten himself killed a dozen times over by now.

So how do we look at his death? As a set-back to the Revolution? Or as the incident that got it started off in earnest?

Tommasi was only twenty-four at the time of his death and his work had hardly begun. But he left us something decisive: He made us feel comfortable as radicals.

Radicalism and revolution come easy now whereas before the American Nazis were actually just conservatives.

Things have changed dramatically because of Tommasi. If you're old enough to recall back ten years, the radicals then in the U.S. were all Leftists and Blacks.

I fairly and objectively ask anyone to come up with a group more revolutionary in America today than the Nazis.

This didn't happen by accident either. It took a lot of work and strain. It took, first of all, a revolution of the mind.

What exactly is this revolution of the mind that Tommasi knew so well? It is the single common-denominator possessed by all movements who succeeded at revolution for, without it, all power would be meaningless.

It is more than passion: It is the ability to become larger than the forces around one and thereby the ability to mas-

ter and control any situation.

It is the freedom to rid oneself of the poisons of doubt and reaction.

It is the strength of mind, character and purpose to view all existing society as the enemy of revolution.

It is the responsibility and challenge accepted of revolution by choice rather than by necessity.

It is the skill and cunning to successfully use every obstacle to one's own advantage.

It is the philosophy of victory.

It is the new morality of that which works is good and that which doesn't work is bad.

It is the new loyalty to that which is correct.

With this revolution of the mind, disillusionment and discouragement are out of the question.

Those with this attitude cannot be used, tricked or misled.

It is the Rockwell concept of the one-man army come full circle.

Without such an inner re-enforcement, revolution in this country would be impossible for to play the game the way one is supposed to is to acknowledge and try to deal with hopeless odds.

Like a direct extract from "The Emperor's New Clothes", the "in" crowd must believe that, this time, there's no way out because Big Brother has learned from all his mistakes over the centuries and today has all loopholes plugged.

But the whole Big Brother System trembles when just one fanatic stands up wearing a Swastika and declares he is

going to strike the System down!

The tens of millions of those who say it "can't be done" amount to just part of the scenery.

The war is between us and the Big Brother Jews holding power. The war is strictly between those in the know.

I wish Joe were here today not so that we could turn over the job for him to do but so that he could know that he was RIGHT in his ideas!

Big Brother is SCREAMING in his press, radio and television about the fanatical Nazis. Again, it is no accident. Something is being done right!

Instead of the tightest hold over any nation in history, it could be that here it is the biggest bluff in history. Big Brother doesn't panic often or over nothing.

The revolution of the mind succeeded in spite of Joe's untimely death.

Thanks to Joe, it's only a question of a short time before we spot the gaping holes in Big Brother's defences and realize our own strength.

Police May Have Description Of Cleveland Bomber

CLEVELAND (AP) — Police probing the bombing of Martin Luther King Jr. Vocational High School say they may have a description of the man who has planted bombs there and at six other schools in the past 11 months.

The bomb that exploded outside the school, located in a predominantly black area on E. 71st St.,

early Wednesday was the police said. It was described as a pipe bomb with an explosive force equivalent to 40 to 50 sticks of dynamite.

Shooting, Bomb Link Suspected

ELYRIA, Ohio (AP) — Police say they do not know if there is connection between the May 22 shooting death of an Elyria youth and a bomb found under his brother's truck.

Five sticks of dynamite were found Tuesday wired to the undercarriage of a truck at the home of Al Hershberger.

HERSHBERGER'S brother, James, 18, was found slain two weeks ago in Russia Township.

Elyria police Lt. Anthony Logar, who is heading the investigation, said the bomb was not set to go off. However, he said the device had the potential to destroy the truck and heavily damage nearby homes.

IT BLEW A door off its hinges, dug a crater in the ground and ripped a two-foot wide hole through a cinderblock wall.

Police said the blast was channeled down the hallway, tearing down sections of ceiling, shattering windows and tossing furniture around.

As in the previous bombings, there were no injuries.

SCHOOL OFFICIALS, already hard-pressed for cash, estimated the loss at \$500,000 and said school buildings are not insured.

Residents of the area gave police the description of a husky, white man in his 40s, with gray hair who they said was seen near the school about the

time of the explosion.

Investigators declined to discuss the case in detail but said they believe they will be able to identify the man soon. They said they know where the dynamite and pipe used in making the bomb were obtained.

POLICE AND federal agents say they believe the man is responsible for a total of 13 bombings or attempted bombings since last June, including adult movie houses and a Xerox Corp. storage building as well as the seven schools.

In all but one case the bombs were left in plastic gym bags, according to investigators. In some cases the bombs failed to explode, and in other cases the investigators found scraps of materials used.

The bomber has left no notes and has contacted no one. However, police theorize that he is a west side resident who is highly conservative, hates blacks and opposes school busing. Investigators say that profile is based in part on interviews with psychiatrists.

CLASSES WERE canceled at King Vocational Wednesday, but the school was reopened Thursday.

Joseph Broz, acting business manager for the school system, said the schools were "desperately in need of money, and here we have to divert it."

Charles V. Romcea, principal, said the school board "could have used this money to buy textbooks. All the children will suffer."

SHOOTING, Cont.

Police said they do not know a motive for the incident.

HERSHBERGER WAS unavailable for comment, but police say he told them he did not know who might have placed the bomb.

The body of James Hershberger was found in his car on a road west of Oberlin May 22. He had been shot once in the head.

Lorain County sheriff's deputies said there were few clues to the slaying and added that they have no suspects.

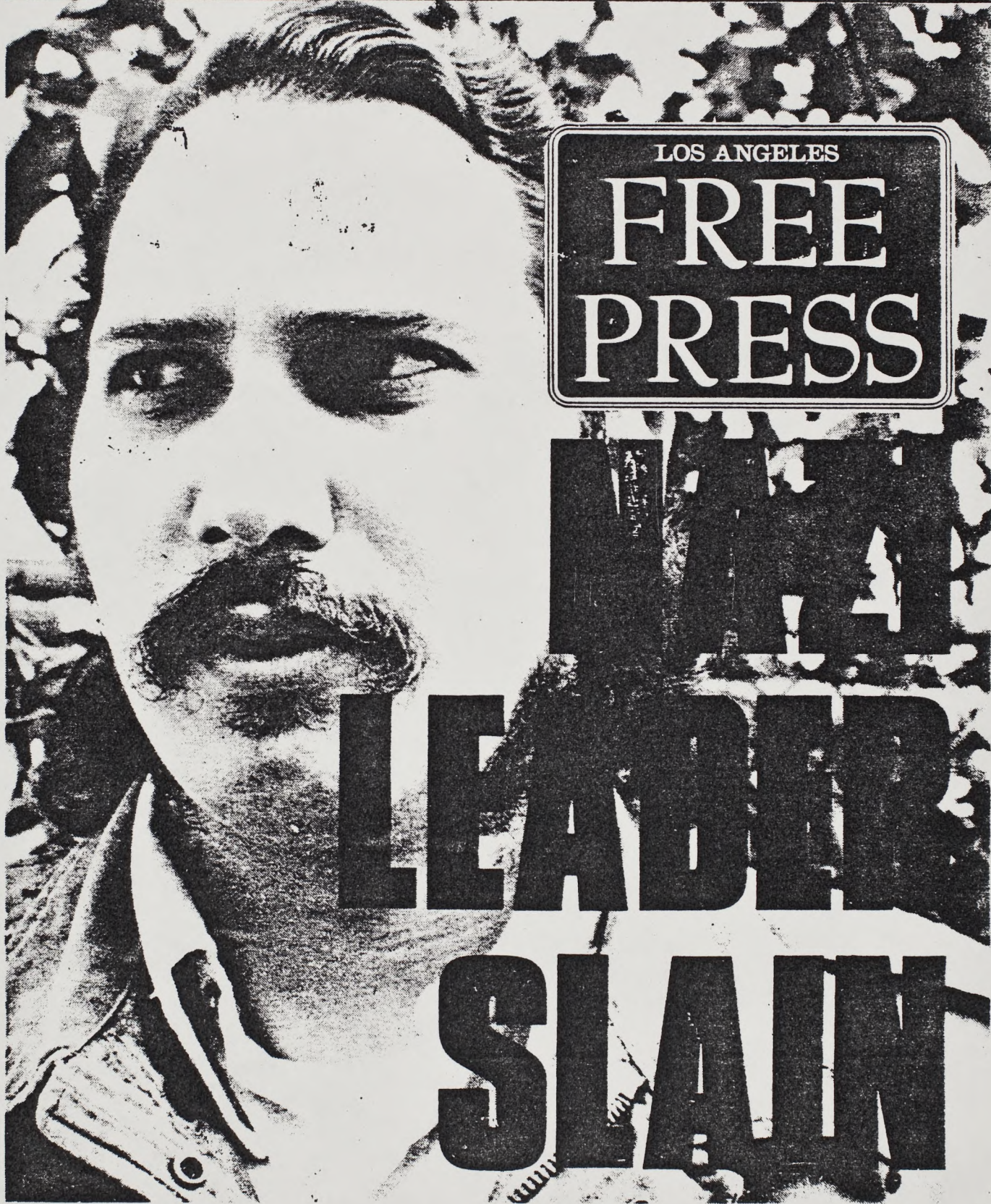
"**IT SEEMS LIKE** too much to be a coincidence," Logar said.

Police found the bomb after receiving a call, but Logar declined to name the person who called.

Logar said the bomb, made of dynamite, a blasting cap and detonating wires, appeared to be "a fairly professional job."

Cleveland bomb experts disposed of the bomb.

'Cops are political soldiers'

In our first exclusive interview (March 21) with Joe Tommasi, the Nazi leader claimed the provisional wing of his group (National Socialist Liberation Front) was responsible for the Feb. 2 teargassing of the Rosenberg rally and the Feb. 4 bombing of the headquarters of the Socialist Worker's Party.

Our second much-delayed interview with Joe Tommasi took place in an innocuous coffeeshop in El Monte. In March Tommasi canceled the second half of a scheduled two-part interview because he was under heavy surveillance by the LAPD and the Criminal Conspiracy Section following the bombings. This time he declined to meet at the *Free Press* office because he didn't want to "run-into any political enemies."

Understandably more cautious, the Nazi leader refused further comment on the SWP and Rosenberg incidents, noting, "You can't be too careful . . . you know the Grand Jury is in town." (Grand juries can subpoena and force testimony without specific criminal evidence.)

Asked what "projects" his group was currently pursuing, Tommasi referred to the April attempted bombing of the Midnight Special Bookstore as "interesting." Speculating that "someone probably just wanted to practice" (bombmaking?), Tommasi quickly moved conversation to our scheduled

topic, "The Nazis and the Police."

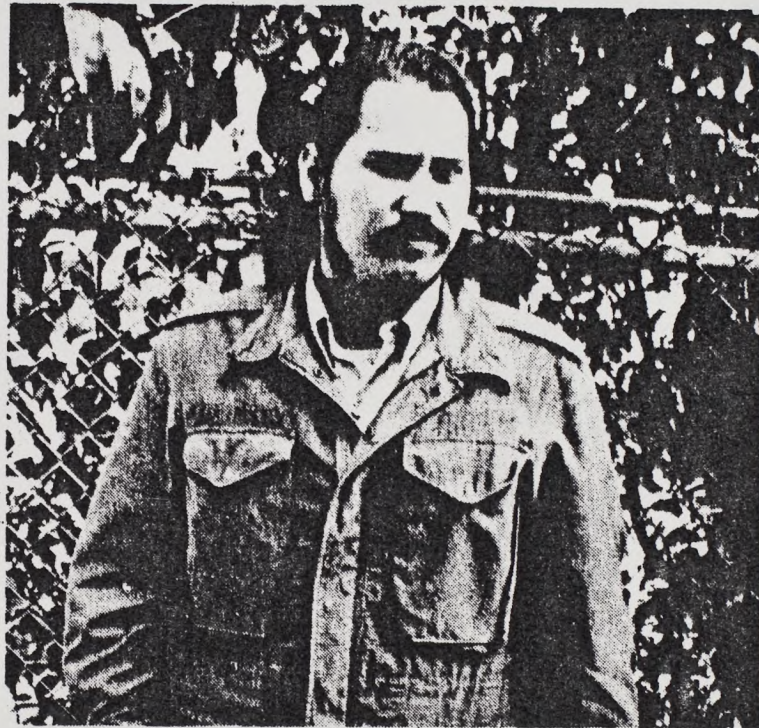
'Average Cop Digs Us'

Tommasi says the Left's charge that the police don't want to bust him for the February bombings is "bullshit." "They want to bust me like mad," the Nazi laughed, referring specifically to Sgt. Ray Callahan (Criminal Conspiracy Section) who has "hassled" him several times. CCS says it has put "thousands of man hours" on the SWP bombing case but has been unable to uncover any real clues leading to the bombers. Tommasi confirmed, "They (CCS) don't have a thing to go on."

I asked him about his group's general relationship with the police. Tommasi drew distinctions between the cop on the street and the bureaucracy. "The average cop, I think, digs us," he admitted. "The higher-ups, anything above a Lieutenant, especially CCS, wants to nail our ass to the wall. They're political soldiers."

Illustrating the difference, the Nazi leader recounted a recent story of one of his party members being picked up with a shotgun in his car by the Hollenbeck P.D. According to Tommasi, when the Hollenbeck station found the individual belonged to NSLF, they "got friendly and asked, 'How's Joe?'"

Continuing his classification, Tommasi explained, "The average cop who has to do the dirty work feels just like us; he

doesn't see himself as part of the system. But you have a government and a power structure, and that power structure has an army, the others (CCS, higher officers) are the generals.

In his high school days Tommasi wanted to be a police officer. He turned from this peace-keeping vocation after politically maturing and realizing, "You can't be against the system and be one of her soldiers."

Conversely, Tommasi described the relationship

between his former affiliate, the American Nazi Party, and the police as "very good." Tommasi's group originally split with its mother organization in January of 1974 because of a power struggle between himself and the ANP national leadership.

According to Tommasi, they also disagreed on a number of political points: "They (ANP) feel they can come to power through legal means, so they never do anything illegal, they want the police on their side." Splitting from this philosophy,

the NSLF believes an armed revolution is inevitable, and they are not remiss in taking up arms toward that end.

Tommasi says when he was the captain of the El Monte branch of the ANP, they had an "understanding" with the local police force. The agreement was, "I wouldn't provoke trouble in El Monte and they wouldn't go out of their way to look for us."

Tommasi verifies there "probably were" a number of party members who worked for the police. Six weeks ago East Coast news sources reported that Roy Frankhauser, a former associate of ANP founder George Lincoln Rockwell, was an FBI informant. After leaving Rockwell in 1964, Frankhauser joined the Minutemen and later the Ku Klux Klan. His long-time role as an infiltrator in right- and left-wing groups was discovered in June when Frankhauser was arrested for possession of dynamite and attempted to get off by calling upon his employer for help.

According to Tommasi, Frankhauser "had a clearance pass from the Internal Security Commission or some high intelligence operation" to go into Canada and spy on Arab guerrilla groups suspected of plotting assassinations of Zionist leaders in America. Most recently Frankhauser had been infiltrating left-wing groups. Tommasi also blamed Frankhauser for the 1965 murder (officially labeled

sulicide) of Dan Burros, former Nazi Party member whom the New York Times exposed as a Jew.

Most recently, it was Frankhauser, says Tommasi, who informed the New Jersey police that John Duffy, former ANP national organizer and now member of the NSLF, was carrying weapons out of Delaware into New Jersey. Duffy, who arranged the Free Press's first interview with Tommasi, was arrested in January of this year. The charge has since been reduced. Duffy is out on bail and here working with NSLF.

On the international level, the Nazi leader went on to deny charges that former Gestapo officers are associated with the international police organization, INTERPOL. "I was flabbergasted to hear that." Tommasi spoke incredulously of Senator Joseph Montoya's January 1975 request for congressional hearings on the issue: "If you want to know the truth, we're scared shitless of INTERPOL."

Noting that ANP's attitude toward the international police was also one of "continual concern," Tommasi maintained INTERPOL has arrested and deported party members in Germany for nothing more than wearing swastika pins.

The Nazi leader says INTERPOL backs the controversial United Nations "genocide" proposal which, if passed, would give INTERPOL a mandate to arrest all persons who advocate any kind of genocide. Versions of this bill have been passed in Canada and England. Collin Jordan, head of the Nazi Party in England in the early sixties, was jailed for two years under Britain's race relations act.

Speaking of the grand jury

and growing police power in this country, Tommasi analyzed: "We used to have police repression. What we're seeing now is the development of a computerized police state. In the war movies they make a big deal out of Germans asking for identification: 'Your papers, please.' Now we're stopped on the street and asked for two or three pieces of I.D., and we're not even in a war.

"What you're seeing now is a system that is aware that the possibility of revolution exists. The sixties taught them what can happen when people get their shit together, no matter if those people are from the Right or Left. So now the system's taking steps to insure their stability."

Demonstrating cooptative tactics in law-enforcement, Tommasi imitated a "Pancho Gonzalez" sheriff appealing to young Chicano men: "Eh, man, you join with us, help smash all these li-l-i-tle groups in your barrio." Sounding much like the revolutionary he claims he is, the Nazi leader concluded, "You don't have to be a black or Mexican to see what's going on in this country. The system's in big trouble."

Summarizing his relationship with law-enforcement, Tommasi clarified; "I wish INTERPOL was on our side; I wish we were being bought off by the police; we wouldn't be having all these money problems. I hear they pay pretty good."

Money is the big problem for NSLF now. Tommasi was forced to close his El Monte headquarters, The New Order Bookstore, last May because the landlord wouldn't renew the lease when he found out who the lessees were. This closure has made reorganizing and establishing a new home top

priority. They are looking to open a national headquarters in El Monte and a second branch in Venice.

Why Venice, home of a thousand leftist labels and groups?

"We view Venice as a hard-core red area culturally and politically," Tommasi explained. "It's bound to stir our enemies, but we know there's a lot of sympathy out there hidden within the white female population mostly." Second-in-Command David Rust verified: "The white girls are tired of getting raped."

Asked if they wouldn't be happier moving to Glendale, where they'd be neighbors with the local KKK which makes its base in the redneck suburb, Tommasi pointed out, "We think it better to go into an area where a lot of people hate us and a lot will love us, rather than go where no one gives a shit."

In NSLF's analysis, Glendale doesn't know or care if you're a Communist or a Bircher, just as long as you don't rock the boat and disturb their business community. Evidently the Nazis think they will be busier and more successful recruiting in a town where the boat is rocked

so often no one is unshakable. Tommasi pictorialized the Venice Branch: "We'll have a 24-hour armed guard and a half-dozen of us living on the premises."

'Corner Drug Store Gang'

A move to Venice brings the Nazis closer to the Fairfax home of the Jewish Defense League. Tommasi, however, denied the new proximity to their traditional foe had any bearing on NSLF's move. The Nazi likened JDL to a "corner drug store gang" and called them "politically insignificant."

Referring to Meir Kahane's recent more moderate positions

(see JDL story, this issue), Tommasi said, "Even their founder has abandoned them. They wouldn't be alive today if Dylan hadn't given them money."

JDL spokesperson Barry Krugal confirmed that folksinger Bob (Paul Zimmerman) Dylan, "Texas Jew Boy" Kinky Friedman and comedian Don Rickles have all made contributions to his organization. Krugal clarified that Dylan's contribution, made to their New York headquarters, was received several years ago.

But NSLF's move to the beach will wait until next summer. Right now Tommasi is "importing" followers from across the country to El Monte to raise money for a new "very professional" national headquarters. Almost a dozen such imports are working and giving 75 per cent of their salaries to the new building which they hope to open this fall.

[ED. NOTE: The following was originally scheduled to run as Part II of the Joe Tommasi interview. Due to Tommasi's untimely death, however, we have decided to run the entire interview in this issue.]

Taking their cue from the left, white power groups in Los Angeles and other countries are beginning to actualize the principle of strength in numbers. Joe Tommasi explains how and why he is building alliances among extreme right groups.

On May 17, Tommasi's NSLF and the local KKK formed a "united front" and counter demonstrated against a Boston pro-integration rally held in downtown Los Angeles. Calling themselves "The Boston Revolutionary Union" (the labels are all beginning to sound alike these days), the two groups joined to express "solidarity with the white resistance in

Boston."

Asked if this alliance marked an ongoing relationship, Tommasi explained the KKK in Glendale was not a significant political organization (scratch one). "They're just a bunch of guys who know what they like and what they don't like... but not really political," the Nazi said, criticizing the small motorcycle gang that operates out of Bart's Cycle Shop in Glendale. Tommasi described KKK leader Bart West as "a real good friend."

Canadian Racists

Of more significance,

perhaps, are NSLF's prospective coalitions with Canadian and Australian white power organizations. The Western Guard Party (WGP) of Canada has invited our locals to join their fall 1975 white power clam-bake in Cleveland, Ohio. Trying to form a broad right wing, "White Nationalist Confederacy of Understanding" (now there's a new one), the Canadian racists are trying to promote good vibes among right-wingers, national socialists (Nazis) and independent Fascists.

Although Tommasi questions "some of their reactionary aims" (most right groups love apple pie, the flag and the cops; NSLF doesn't), Tommasi sees a bigger pie and has offered conditional support for the WGP's racist and white power politics. He plans to attend the national conference in Ohio. Our local leader's personal aim is, of course, to build a white state "of some sort."

Meanwhile, he is most concerned about the "tremendous amount of splinter groups" and divisive "ego trips" that now threaten his movement. "We have all the problems of the Left." Tommasi is honest. "Ex-

cept when the Left has a splinter, that splinter has enough strength to go out and put a newspaper together. A splinter on the Right is lucky if they're strong enough to go to the Post Office and buy a roll of stamps." Humbly, the Nazi admits that NSLF is the only right splinter group in this country that has stood alone and grown stronger.

Trying to right this sad state of internal affairs, the WGP's National Conference will direct itself to "setting up places of asylum, Rhodesia or South Africa, for outlaws, establishing contacts for guns and weaponry, (and) building understanding and coalition among Right and white power groups."

On the international white scene, a second successful splinter from Australia has this month offered Tommasi the hand of a friend. The Australian National Socialist Party, for many years one of the strongest members of the World Union of National Socialists, split from their mother group last year.

Disagreeing, as does Tommasi, with the "stagnation" of the National Socialist White People's Party, Australian Nazi Neil Garland has sent our locals an "invitational letter." Tommasi said he had already responded to the overture of political friendship and expects a "very good" future relationship with the Australians.

The L.A. Nazi also indicated dissatisfaction with the recent "inactive" role of the World Union of National Socialists. "It was supposed to be our answer to the Left's International, but it's not much more than a publication exchange network now." Tommasi would like to rebuild that or another world white-power forum into a "hard

In Memoriam

Captain Joseph Charles Tommasi

1951-August 15, 1975

At 1 p.m. at the National Socialist White People's Party headquarters, Captain Joseph C. Tommasi, leader of the National Socialist Liberation Front, was martyred by a cowardly yes man of NSWPP bureaucracy.

The bullet that martyred our leader was not aimed at the Captain but at the very heart of the revolutionary movement that was his life's work. Words can never replace but only emulate the revolutionary racial idealist dedication that burned inside Joseph Tommasi the man, the fighter and the leader.

The bright flame that flared in the soul of Joseph Tommasi, that shines in the hearts of his adherents, will never be extinguished. A thousand reactionary bullets can never stop the dedication of the NSLF to the coming armed struggle.

Ironically, Captain Tommasi was martyred almost eight years to the day that Commander George Lincoln Rockwell was taken from our midst. Both cut down by "national socialists." Both for their steadfast hatred of the reactionary

interference that undermines the national socialist revolution.

Let the fire and power of Captain Tommasi breathe into our souls and find expression in the destruction of his enemies. The bricks and mortar of the movement are the blood and bones of its martyrs. Tragically, this afternoon, another brick was laid. And so we, the living followers of Captain Tommasi, must attempt to pick up the pieces and continue to build on the dreams he harbored within him . . .

Lieutenant David Rust, chosen successor to Captain Tommasi, has taken over command of NSLF operations. We must all at this time give our maximum support to Lt. Rust, to insure the survival of NSLF, and not to allow the Captain to have died in vain. We must all pull together out of love, dedication and respect. He who may have wavered in the past must now rededicate his efforts to the struggle. We will build his organization into a living and breathing incarnation of our fallen Captain.

core" organization which would meet annually and plan international political strategy, weaponry workshops, etc.

Alliance With Cubans

On the home front, NSLF also maintains loose contact with Aldo Rosado's *Commandos Libres Nacionistas*. Rosado's El Monte-based right-wing Cuban organization is a splinter from *Alpa 66*, the national anti-Communist/Castro Cuban organization. The two groups have not yet engaged in joint action, but the alliance is based on what Tommasi described as "a strong white power strain in their (CLN) political posture."

The NSLF is also planning "field trips" to Taft, Calif., this summer (presumably to support white racists of that oil town who earlier this year drove blacks out of their schools) and

to Boston when school opens this fall. According to Tommasi, the National Socialist White People's Party (official name of the ANP) "blew" its leadership in the Boston busing riots last year because its members "couldn't identify with the revolutionary (white) youth there."

"You don't tell kids they can't become a Nazi or join us (against busing) until they cut their hair and stop smoking dope," said Tommasi, criticizing the approach of his former organization.

The white, racist, long-haired, dope-smoking youngsters in Boston should have little trouble identifying with the NSLF.

Assimilation Means Cultural Regression
What motivates the 24-year-

old boy-leader who (surprisingly to some) fears "I'll never reach my 30th birthday"? What "faith" pushes Catholic-born David Rust who "dabbled in the left" before becoming co-conspirator in white power terror tactics?

Both believe assimilation of the white race will lead to nothing less than "global cultural regression," the Dark Ages revisited. "As whites we should be concerned with the destruction of our culture and race," says David, a voice crying in an apathetic white wilderness. Tommasi reiterates, "The white race is responsible for Western Civilization . . . progress."

Fundamentally, there are only three possible conclusions for the white or any other race: assimilation, separation,

genocide. Obviously opposed to assimilation, Tommasi and Rust were asked if they as Nazis would settle for separation of the races, or if they were really calling for eugenic control of all other races.

Tommasi considers the question: "Separation is unrealistic, don't you think? The Third World population is already so large . . ."

It's hard to pin him down. He doesn't want to come right out and say it. Here in liberal America, it's not tactically smart to say that behind the facade of nationalism, Nazism means — as it always has — nothing less than global white control. □

A GRIM PREDICTION:

'I'll never reach my 30th birthday'

Joe Tommasi was supposed to call Friday morning, Aug. 15 to check final details on our interview of Aug. 1. Ironically, he had answered most of my questions in a phone conversation two days before and all I had to ask him was his age.

A 2 p.m. Aug. 15, a friend of Joe's called and told me Joseph Charles Tommasi was 24 and he was dead.

The NSLF leader was gunned down on the front steps of the headquarters of the National Socialist White People's Party, an organization he had built and once led.

(The NSWPP was founded in 1959 by George Lincoln Rockwell, and had been known as The American Nazi Party until its name was changed in 1967.)

Eyewitnesses report the fatal shooting was done by Jerry Jones, an 18-year-old probationary member of the NSWPP who was standing guard duty at the 4375 N. Peck Road location.

Angered By Insult

According to witness David Rust, he and Tommasi were out buying auto parts when the incident occurred. They were driving south on Peck past the NSWPP headquarters when Clyde Bingham, 19-year-old NSWPP member who was standing guard at the door, "flipped Joe the finger." Angered by the insult, Tommasi stopped the car and charged through the gate toward Bingham shouting, "Come and say that to my face

you . . ."

Rust had also left the car and approached the NSWPP compound gate steps behind Tommasi but "stopped where I was" when he saw Bingham and Jones (who was also standing guard) draw their guns. (NSWPP spokespersons later confirmed their guards were routinely armed.)

According to Rust, Jones twice told Tommasi to get off the premises. "He (Jones) kept shouting, 'I've got orders to keep you off the property!'" As Tommasi approached and "pushed" Bingham, Bingham returned his gun to his holster and Jones shot Tommasi in the head. Police later confirmed Tommasi was killed with a .45 revolver.

Three youngsters passing on bicycles and "a man across the street" apparently witnessed all or part of the incident. They and Rust were questioned by police. NSWPP Captain Dan Stewart and Gregg Hubbard, another member on duty in the headquarters, were also questioned and later released.

At their Saturday press conference, NSWPP spokesperson Martin Kerr said, "Joe Tommasi got exactly what he deserved . . . his death is the

result of two years of effort by Tommasi to destroy the White People's Party." (Tommasi was expelled from the NSWPP in September 1973). NSWPP national headquarters in Arlington, Va., are claiming Jones and Bingham acted in self-defense. "These two

men . . . are guilty of no crime other than the 'crime' of trying to protect their lives and Party property."

Hours after the shooting, Kerr alleged that Tommasi was trying to enter their headquarters, but Rust claims his leader was unarmed and shot before reaching the steps of the building.

Police report finding a large stick next to Tommasi's body; however, NSLF member John Duffy claims the stick "was planted" by NSWPP members to make the shooting look like self-defense. El Monte Police Capt. Wiles said investigators had not yet established whether Tommasi was armed but said that claim seemed "negative." Duffy later maintained he had known and lived with his former leader for several months and had never known Tommasi to carry "any weapon . . . not even a knife."

Duffy likened Tommasi's death to the assassination of George L. Rockwell (Aug. 25, 1967) and accused NSWPP of engineering his leader's death. "We know Joe was on their (national NSWPP) list since he was expelled. We know Dan Stewart had issued orders recently that if Capt. Tommasi showed up within the perimeter of the yard . . . he was to be shot, and shoot to kill."

Death Predicted

That Joseph Charles Tommasi is dead at 24 is probably of little surprise to those who knew him closely. That the Nazi met his death at the gunpoint of the NSWPP is also not surprising. Speaking of his semi-

underground life two weeks ago, Tommasi prophesied, "Hell . . . I don't know if I'll reach my 30th birthday." Meeting in a little-known El Monte restaurant, he seemed far more apprehensive than he had been during our February interviews.

Declining to come to the *Free Press* offices because he feared "political enemies," he directed his innuendos more to right-wing rather than leftist foes. Although he was seldom specific, constant references to "hassles" with his former organization indicated his continual concern with the long-running feud he alternately fueled and tried to quell.

In February, Tommasi led a NSLF raiding party to the NSWPP headquarters on Peck Rd. and, in Tommasi's words, "beat the shit out of" everyone they found at the location. Since that time members of both groups had clashed on an individual basis, NSWPP was always afraid Tommasi was out to destroy or regain control; Tommasi apparently was unwilling or unable to turn his personal attentions away from his mother organization.

'Politically Dead'

In our interviews, Tommasi never indicated any desire to regain power in NSWPP, but he lost few opportunities to point out their political "errors." Politically and personally, he saw them as a "politically dead . . . paper . . . organization."

Duffy denied Tommasi was looking for a way back into the organization but confirmed his

leader was always "very hurt" by the unresolved conflict. "Joe would never have left the NSLF, but we wanted to come to an understanding with them (NSWPP). He wrote Cmdr. Koehl several times . . . I think he really wanted NSLF to be some kind of militant arm to them."

Asked why Tommasi disregarded the drawn guns in his attempt to settle with Bingham, Rust was perplexed. "It (Bingham's insult) seemed to get to Joe personally . . . I don't know . . . Joe never was afraid of guns . . ." Rust explained that a similar incident between Bingham and Tommasi had taken place months before and speculated the antagonism annoyed his former leader personally because it came from "the place Joe built . . . headquarters."

(Tommasi joined the almost defunct El Monte branch when he was 17. He built the organization into national prominence and reportedly even once owned the building he died in front of. Having purchased it for his organization, Tommasi turned the deed over to the national NSWPP during the internal power struggle which led to his expulsion.)

'He Was Nice To Joe'

The shooting seemed even more ironic considering Jones and Tommasi had a "friendly" relationship. In partial shock hours after her husband's death, Rose Tommasi referred to a recent sidewalk conversation between Jones and Tom-

Myth of the "Six Million"

"The three or four people chiefly involved in drawing up the plan for total extermination are dead, and no documents survive."

All of this is very convenient for the liberal intellectual establishment perpetrating this legend but it only means that the "plan" and the "three or four people" are nothing but very nebulous assumptions on the part of all these writers and are completely unprovable.

Since the documents which do survive make no mention whatsoever of extermination, the various "experts" perpetuating the myth conveniently assume that such orders were generally verbal.

Otto Ohlendorf, chief of the Einsatzgruppen D unit in southern Russia had originally been "persuaded" to sign a statement to the effect that ninety thousand Jews had been murdered under his command. When Ohlendorf finally came to trial in 1948 he insisted that his earlier statement had been extorted from him by torture.

During his speech in his own behalf at the 1948 trial,

Ohlendorf denounced Mr. Philip Auerbach, the Jewish Attorney-General of the Bavarian State Office for Restitution, for having stated that he was seeking compensation for an alleged "eleven million Jews" who had suffered in concentration camps.

Ohlendorf stated that "not the minutest part" of the people for whom Auerbach was seeking compensation had ever seen a concentration camp.

Eventually Auerbach was convicted for embezzlement and fraud directly related to his attempt to get money for his phantom victims.

Ohlendorf told the Tribunal that his formations often had to take vigorous action to prevent pogroms against Jews organized by various Russian nationalists behind the German front.

Ohlendorf denied that the Einsatzgruppen as a whole inflicted even one quarter of the alleged one million casualties claimed by the prosecution. He stated that the illegal (under international law) partisan warfare in Russia, which the

Einsatzgruppen were combating, had taken a far higher toll of German Army lives - at least five hundred thousand German soldiers were killed, a figure confirmed by the Soviet Government.

The brilliant English jurist R.T. Paget, in his book, "Mannstein: His Campaign and his Trial" (London, 1951), concluded that the Allied prosecution at Nuremberg in accepting Soviet figures, had exaggerated the number of casualties inflicted by the Einsatzgruppen by more than one thousand per cent! In addition, the Allied prosecution had distorted much further the actual situation in which these casualties occurred.

This is a very key issue in the whole extermination legend. This is the popular mythology that the physical liquidation of European Jewry began with the action of the Einsatzgruppen against their Soviet adversaries in 1941. The whole extermination legend was built on just such bits and pieces of calculated falsehood.

masi. "He (Jones) was nice to Joe... Jerry was just a little fat kid... I don't know."
Duffy said Tommasi had even invited Jones and Hubbard to join NSLF. Mrs. Tommasi indicated her husband had never spoken of any official NSWPP plan to kill him. Active in the NSLF herself, she and Tommasi were married two years ago. Tommasi is survived by his father and two younger sisters.
Though there is speculation that the NSLF will not survive the death of its charismatic leader, "his designate, 26-year-old David Rust, now assumes group leadership. Rust is also a former NSWPP member; he resigned in November 1973 to join Tommasi. Duffy, formerly with the NSWPP in Delaware, now succeeds Rust as second in command.
NSWPP Held Responsible
Rust and Duffy deny comment on possible retaliation but

hold NSWPP responsible for their leader's death. "They (NSWPP) and particularly Cmdr. Matt Koehl are responsible for ousting Joe and using propaganda to incite their members against him to this degree," Rust explained.
NSLF's image may be due for some changes under Rust's leadership. Unlike his former leader, Rust is reflective and somewhat withdrawn. Personally shocked by his friend's death, Rust admitted the loss would be "pretty rugged" on NSLF. "On an individual level, Joe had more talent than most of us put together... but we're just going to need that much more dedication from all of us."
As monastic as Tommasi was impulsive, as careful as his leader was provoking, Rust may be expected to think long and hard before setting direction for future NSLF action.

Nazis shove, punch church leader in their new bookstore

The leader of the Detroit Roundtable of Christians and Jews was punched and shoved bodily out of a bookstore opened yesterday by the same neo-Nazi group which was evicted in March from a West Vernor store.

Charles C. Benham, 61, said he was punched in the chest by one of three uniformed men in their 20's who then shoved him out the door of the Nazi group's new bookstore headquarters in a former bar-

bershop at 20807 Fenkell, near Burt on the city's northwest side.

Benham, director of the Detroit branch of the national organization dedicated to improve interracial understanding was apparently unhurt and made a complaint to police of the 16th (Northwest) Precinct. He said later he did not know whether he would prosecute any of the trio for assault.

The bookstore was opened at 8:30 a.m. yesterday by the group led by Bill Russell, 25, who describes himself as the

Michigan "captain" of the National Socialist Movement.

It was Russell's group which was ordered evicted March 16 by a Detroit Common Pleas Court judge from its leased West Vernor location, which for four months was the scene of numerous community and group protests.

Within an hour of the reopening on Fenkell, a picket line of neighborhood protesters was organized by Leonard Green,

Guard As Nazis Settle On Fenkell! (STORY ON PAGE 3)



Cops Guard Nazis As People Protest

National Socialism, the innocuous - sounding disease that spread over Germany, erupted into a world war, and attempted to exterminate an entire race located a small festering sore in Northwest Detroit and nearby residents and businessmen reacted in a predictable manner. Throw them out. A small group of nazis rented a building at 20807 Fenkell rd just east of Burt and opened a book store May 20. The same group had been dispossessed from another location in Detroit a few weeks earlier. Several hundred angry residents and businessmen gathered at Brightmoor Community Center Tuesday night to discuss the neighborhood problem and make plans to have the group evicted. For several days, loudly chanting pickets had walked the block in front of the building with several dozen police standing by to maintain order.

About 17 residents were arrested for what the police termed "unpeaceful protests" at the location, and Five Mile rd was blocked off several times for several hours.

Police from the 16th precinct and Tactical Mobile Section from downtown have arrested or ticketed 54 adults or juveniles May 20 through May 22 in connection with demonstrations opposing the opening of a Nazi bookstore on May 20 at 20807 Fenkell av and Pierson. Minor injuries were inflicted upon four police officers when rocks and bottles were thrown the night of May 20.

Lt. Raleigh Gresham of the 16th precinct estimates that there were approximately 1,000 people on the scene the night of May 21. About 700 were east of the store and 300 people to the west. It was necessary for police to reroute traffic.

In addition to a coalition of protestors, there are independent demonstrators, people from the area, plus individuals and groups from other parts of town adding to the confusion and emotion of the crowd.

The job of the police is to maintain the peace, but it is difficult with so many varied groups being represented. Their biggest problem is onlookers.

Insp. Alf Nelson of the 16th precinct suggests, "Stay out of the area." He added that there is sometimes a fine line between freedom of assembly and riot.

Head of the 16th precinct, Commander Charles Sherrill states, "If you have feelings one way or another, pursue those feelings in a legal way."

Walter Roesler, president of the Brightmoor businessmen's group, said that the city could act in 72

hours under a nuisance ordinance if ten businessmen and 20 residents would sign petitions protesting the operation.

Detroit Councilman Jack Kelly backed the group up and said that the Council would take immediate action when the petitions were received.

One spokesman at the Brightmoor meeting claimed that it cost the city \$20,000 a week for police security in front of the book store.

The nazis' swastika emblem was hung in the windows, and residents countered by parading in front with American flags.

As this publication went to press the pickets were still marching and a cordon of police guarding the whole melee.

The residents didn't hesitate to state their views at the meeting at the Brightmoor Community Center Tuesday night.

"The main thing is to picket in an orderly way," said Wally Roesler, president of the Brightmoor Community Council. "We will get the Nazis out and we'll try to get rid of the police so we can give Brightmoor back to the community."

"We aim to keep them off of our streets, to keep their poison from our children," he said.

According to Paul Boatin, president of the Inter-faith Council Against the Nazis, which he said represents 'over one million people,' 75-year-old Guy Scavone, owner of the store, did not realize that he was renting to Nazis. Scavone said he was led to believe that

- THE NAZI BOOKSTORE on Fenkell may be getting some new neighbors — the Detroit Police. Locals had petitioned for a mini-station before the Nazis arrived, and recently police found a location in a former public library about ten doors away from the controversial store. If cops get their expected approval from City Council, they could move in by August.

the group wanted to sell surplus merchandise.

"They tricked us the same way over on West Vernor," Boatin said. According to him the group was able to set up their bookstore on Detroit's Southwest side by claiming they were opening a print shop.

"We got them evicted on West Vernor on the basis of falsifying their lease application," said Boatin.

Some residents who said they had been roughed up by the Nazis talked about bombing or burning the bookstore down.

"Without organization nothing is done," Boatin shouted at the crowd. "Don't say burn. Burn is a Nazi word."

Boatin explained that his group has already accomplished a great deal in convincing the 75-year-old owner not to accept any more rent from the Nazis. According to Boatin, the Nazis paid \$150 cash in advance for two months' rent.

"We have contacted the landlord for an injunction to get

the Nazis out in 30 days," Roesler said.

"Thirty days is too long," one angered resident shouted.

"Legal action has been sought and the owner has been provided with a free lawyer," Boatin said, "but these things take time."

"People are doing everything legally to get them out," he said. "The only way it can be done is through organized united peaceful pressure."

Pickets are more orderly now but according to police, officers will remain for the protection of all involved.

Nazi signs hanging in the bookstore window read, "Niggers Beware," "Hey Jews There's An Oven In Your Future," "A Nigger Works Standing In Line For A Welfare Check," and "Heil Hitler." In order to enter the store patrons must remove a picket sign, "We wiped you out in Germany - we'll wipe you out here, too."

"Violence is what the Nazis want to see," Boatin said. "We must use a peaceful means to solve our problem."

Council orders team to calm protests at Nazi bookstore

The Detroit City Council yesterday ordered a team of city officials be sent to the city's troubled Brightmoor district to try to calm the fears of residents and discourage them from demonstrating against a Nazi bookstore.

There were five more arrests yesterday near the controversial bookstore on Fenkell. Police said they involved curiosity-seekers who tussled with police officers when told to leave the area. They will be charged with assault and battery, said police officer Charles Sherrill, whose 16th (North-

west) Precinct policemen are trying to cope with the nightly disturbances.

The Council discussed the bookstore issue at length, but concluded there was little legally to be done about it.

Councilman Jack Kelley bitterly called the Nazis "dirty pukes" and said he would like to rip off their swastikas.

IN AGREEMENT, Councilman Kenneth Cockrel, the black socialist lawyer who generally is on the opposite end of the political spectrum from Kelley, slapped hands with Kelley, soul-brother style.

But Cockrel and George

Matish, deputy corporation counsel, said it would be illegal and improper to run the Nazis out of business.

Kelley, Councilman David Eberhard and others said the bookstore should be declared a public nuisance under city ordinance and closed down.

"No matter how reprehensible the philosophy of the Nazis is to me, nonetheless they are entitled to express their views," Matish said. "No evidence has been presented to me that they have breached the peace. Thus, we can't move them out on the public nuisance theory."

Eberhard suggested that the city flood the bookstore

with inspectors from the Health Department, Buildings and Safety Engineering Department and the Fire Marshal's office to find some code violation to shut them down.

COCKREL SAID — and Matish agreed — that it would be improper selective law enforcement to single out the bookstore. Inspectors should be used against the bookstore, Matish added, only when the city had some specific reason to believe it was in violation of an ordinance.

Council President Erma Henderson suggested that the city's legislative body invite the FBI to investigate the Nazis. That idea died for lack of enthusiasm.

Mrs. Henderson and Kelley also suggested the daily papers, radio and television stations be asked to impose a news blackout on the situation. They said the demonstrators are seeking publicity and that attracts the trouble-seekers.

"We've passed resolutions before saying that we didn't like Nazis," Cockrel said. "We are not political commissars to rule on ideas. It's not our role. I rest my confidence on our ability to combat these ideas."

Councilmen charged the Nazis are racist and anti-Semitic. Cockrel said these prejudices are found in other people, too.

Michigan department commander of the Jewish War Veterans.

The pickets, some carrying the same signs printed by a coalition of labor and community groups to protest the West Vernor bookstore, grew quickly from two to about 25, mostly young persons.

Six police cars from the precinct and Tactical Mobile Unit were sent to the scene to keep order.

The atmosphere remained tense as the Nazis, to counter the pickets, stationed three helmeted, black-shirted members with swastika armbands in the front entrance of the store, holding Nazi placards. A sporadic series of encounters occurred in which the Nazis at one point knocked an American flag being carried by a protestor to the sidewalk.

Guy Scavone, 74, owner of the building in which the storefront is located, said Russell rented the store from him last Tuesday, paying \$150 for two months' rent in advance, and stating that he needed the store to sell some "surplus goods."

Scavone, who said Russell did not tell him he was with the Nazi movement, said

he offered Russell a full cash refund of his rent and asked him to leave the store, but Russell refused.

"He said they would stay for two months," Scavone said. "I don't want any Nazis in my building."

Russell claimed he gave Scavone his true name and the name of his party.

Benham, the Detroit Roundtable director, said he entered the store to obtain samples of the literature being offered by the Nazi group.

"I wanted to see whether they were going to disseminate the same kind of literature they did on Vernor," said Benham, who added that he participated in several rallies protesting the Vernor bookstore.

"I had a brief exchange of words, was told to get out, and was then pushed out of the store. As they shoved me, someone came up with a punch."

Asked about the incident, Russell said, "That must be the one who started ranting and raving. He began attacking our literature and went into a mad rave. We had to restrain him and stick him outside."

regulation, no other nation could have been heard to complain."

Of course, in point of fact, Germany was bombarded with invective and economic sanctions for doing precisely these things. Germany's internal measures against the Jews were certainly a very crucial pre-War propaganda "cause celebre" which eventually steered their respective countries into war against Germany. Senator Joseph R. McCarthy (R., Wisc) pointed out that Pohl had signed some incriminating statements after being subjected to severe torture, including a bogus admission that he had seen a gas chamber at Auschwitz in the summer of 1944. Pohl successfully repudiated this particular charge.

Eventually, enough firsthand reports were brought forward by American and British observers after the War. These reports established the complete fraudulence of the claims concerning alleged "gas chambers" in the various

camps in Germany such as Dachau, Buchenwald, Bergen-Belsen, Ravensbrueck, Sachsenhausen, Flossenburg, Theresienstadt, Gross-Rosen, Mauthausen, Neugamme and Natzweiler.

Consequently, the supporters of the extermination legend shifted their focus of these allegations to the eastern camps in what by then was a Communist-controlled Poland. The Jewish historian, Gerald Reitlinger, admits that all the "information" concerning Auschwitz and the other eastern camps comes from the post-War Communist regimes of Eastern Europe. However, no living authentic eyewitness of any of these "gassings" has ever been produced and affirmed.

These "gassings" were alleged to have occurred between March 1942 and October 1944, supposedly taking some three million lives in the process. This would have been equivalent to exterminating three thousand three hundred

and fifty people every day, day and night literally non-stop, for over two and one-half years.

Considering the acute wartime manpower shortage in German-occupied Europe and the enormous logistical problems that would be involved in such an undertaking, the claims of mass exterminations appear to be wild fantasy.

In his excellent book, "The Drama of European Jews", the late Professor Paul Rassinier of France showed that due to the extreme shortages of the War, the Germans had nowhere near the actual train capacity to haul the vast, enormous numbers claimed by the perpetrators of the holocaust legend. It took at least twenty-five to thirty train cars to haul three thousand persons and this included a tremendous expense in armed security and personnel to guard the trains.

Rassinier was a French Left-anarchist who was a member of the anti-Nazi French resistance and spent over two

years at Buchenwald and Dora concentration camps. His work is a very masterful, detailed analysis and refutation of the usual "gas chamber", "mass extermination" claims spewed forth endlessly by our propaganda media since 1945.

To give just one more example of the sort of nonsense very typically put forward by supposedly reputable writers, let no review overlook Olga Lengyel's "Five Chimneys" (London, 1959). Lengyel asserts that at Auschwitz, the ovens cremated no less than seven hundred and twenty per hour, or seventeen-thousand two hundred and eighty corpses per twenty-four hour shift." She also claimed that eight thousand persons were burned every day in the "death pits" and therefore, "in round numbers, about twenty-four thousand corpses were handled every day" (from pages 80 and 81.)

This would have meant a death rate of over twenty-one million Jews: Six million more than the entire world Jewish population. Is any comment necessary?

I myself had an experience which clearly shows that many people have no conception of what is even meant by "gas chambers" and confuse it with crematoriums. Cremation is an old and widely accepted method of disposal of the dead in Germany and much of Europe. Naturally in a concentration camp which contained several thousand or several hundred thousand persons, there would necessarily have to be some efficient, practical method of the disposal of the deceased.

Due to the Allied bombing raids, the overcrowding, and the declining economic situation in Central Europe the last two years (particularly the last six months) of the War, there occurred a far higher than normal mortality. This would be reflected in any honest statistics on the Nazi concentration camps.

I was telling this to a rather prominent conservative author of English origin, who had served with the RAF during the War. This gentleman was at first quite insistent that there were "gas chambers" at Buchenwald. He had even "seen them with his own eyes", etc. I pointed out that Rassinier thoroughly exploded the Buchenwald "gas chamber" fallacy in David Rousset's work, "The Other Kingdom", and that even the Jewish Agency in Tel Aviv flatly stated several years ago that there were no "gas chambers" in Buchenwald, Dachau or any other camps in Germany proper. This individual was somewhat taken aback by this information and then he conceded that he saw crematoriums and not "gas chambers". I honestly think that he did not believe there was a difference until it was pointed out to him.

Although according to popular mythology, anywhere from three to five million persons were supposed to have been exterminated at Auschwitz alone (these figures make up the bulk of the "six million" myth), Reitlinger admits that only three hundred and sixty-three thousand persons were registered at Auschwitz from January 1940 to February 1945. Of course a large percentage

were not Jews either. It is thus claimed by the proponents of the myth that many people were not registered. But this has in no manner been proved. Even if we give these people the undeserved benefit of the doubt and assume there were as many unregistered as registered it would still be only seven hundred and fifty-thousand persons - nowhere near the three or five million "exterminated"!

Also, over eighty thousand prisoners at Auschwitz were evacuated westward in January 1945 before the Soviet advance. Large numbers of the Auschwitz camp population were released or transported elsewhere during the War years. At least one hundred and fifty thousand were still alive in Auschwitz at the time of the Russian "liberation".

At Auschwitz today, visitors are shown small furnaces which are claimed to be "faithful replicas" of the same type where "millions were exterminated".

To have transported the alleged "six million Jews" and countless other nationalities to internment camps would simply have paralyzed the German military operations. A transportation of a reasonable number of prisoners such as the three hundred and sixty-three thousand at Auschwitz, would make sense in terms of the compulsory labor they supplied the vast industrial complex at Auschwitz.

KINSHASA, Zaire (AP) — Bill Starkey still isn't sure why he survived Kolwezi, where he took a bullet through the side after a nightmare ride with rebel soldiers through town.

The 33-year-old native of Boise, Idaho, is doing a stint in Zaire with the Morrison-Knudson construction company. He was living in a

es for some reason. Another guy took a box of golf balls.

"They took all these things and carried them to the car. The five rebel soldiers and myself got into the car with all the stuff and they drove me around town.

"I sensed I was in extreme danger because they didn't seem to know where they were going.

"They found a deserted, bombed-out section of town and told me to get out and run. I tried to stall by talking but they told me to run and they shot me."

The bullet pierced the side and came out the other side narrowly missing his legs. He felt a sear pain and dived into a ditch.

"I don't understand why I'm still alive. I don't understand why God didn't kill me. But I understand why they offered no resistance. They took everything from me.

"I'm sure many kids in Zaire were like mine, except they didn't have to die."

Paratroops rescue 2,500 —full Zaire horror unfolds

'I saw people with bayonets sticking out'

PARIS — Hundreds of white survivors from the war in Zaire flooded refugee centers in France and Belgium today, relating stories of pillage and massacre both by rebels high on drugs and by Zairean government troops.

"The rebels came at 4 in the morning," Mrs. Daniel Nortier said. "We heard shots. The rebels were kids, just 13 and 14, like my boys," gesturing to her two sons.

Nortier's family were among 86 French nationals who arrived in Paris today, rescued by French paratroopers from rebels who invaded Zaire's southern Shaba province almost two weeks ago.

Her voice rose and she talked faster: "They threw grenades into houses of whites. I saw people dead on the sidewalk with bayonets sticking out of their stomachs."

She broke into sobs and started babbling. Red Cross nurses put her into a wheelchair and held her hands. "I am afraid ... I am afraid," she gasped. Then she screamed.

In Brussels, three other planes arrived from Kinshasa late yesterday carrying 560 refugees. In all, 2,500 whites were evacuated.

Many told UPI reporter Michael Dennigan of anti-white savagery by both the invading rebels and the Zairean government troops supposedly defending the town.

Some feared the government troops more than the rebels, said

Nelly Van Hevel, wife of a Belgian teacher.

She said Kolwezi refugees were saying that government troops high

on marijuana — not the rebels — massacred 34 whites in one house.

Almost all told of rebels coming to their homes again and again, stealing everything at gunpoint. They often preferred to shoot their way in and, refugees said. Their looting techniques were copied by government soldiers and the local civilian population.

"The rebels went into Motoshi hospital and knifed every patient, black or white," said Jean-Marie Lallemand, 31. "I saw 40 dead whites heaped in one spot, 25 bodies in a house, a guy who fell dead against a wall.

"I saw entire families shot and dogs eating them. When I saw those kids dead . . ."

Tears filled his blue eyes and his voice cracked.

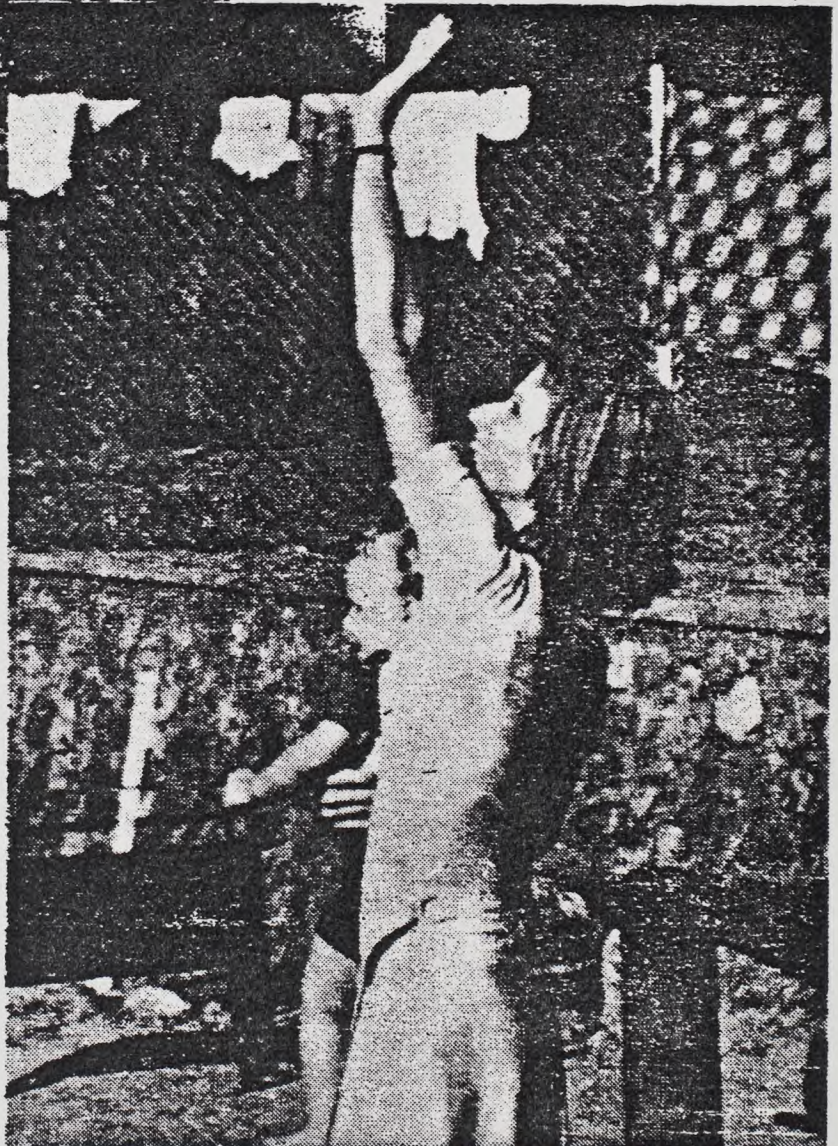
"They held peoples' courts to try white people. They looted five stores near my home and killed the European owners. Some of my pals were taken hostage back to Angola. They came to my house and asked for my watch, I gave it to them — if you didn't give things you were shot."

10 Americans missing, one feared dead

KOLWEZI, Zaire — French and Belgian paratroopers captured the mining center of Kolwezi yesterday, rescuing 2,500 trapped Westerners but finding the bodies of about 150 whites massacred by rebels in a bloodbath of terror.

In one attack, the rebels who held the southern Zairean town for nine days mowed down 34 men, women and children in a tiny room, witnesses said. Several of the cadavers were locked in poses of horror.

Staffers attend meeting Nazism flourishes in Bay Area

Even the weather seemed eager for confrontation. Shards of sunlight tried to stab their way through gangs of clouds, providing an aptly ominous setting for the meeting of the National Socialist White Workers Party (NSWWP).

The meeting itself was something of a media event in San Francisco, due partly to the egregious ego-tripping of Allen Vincent, commander of the San Francisco Nazi unit, and to the flap caused by the confirmation that the Nazis had been meeting regularly at the Wawona clubhouse with the necessary city permits having been granted by the S. F. Recreation Department. Both the NSWWP and the National Socialist White People's Party had paid the standard \$15 entry fee for occasional use of the clubhouse several times a year for the past two years, according to the recreation department supervisor who issues permits.

The meeting was billed by Vincent as an "open-house" event, but, in fact, presentation of an invitation to the March 4 meeting was necessary to gain admittance. I had requested, and received, an invitation to this meeting because for the past six months I had pursued a story whose full impact was still to be learned, since receiving at The Norseman office a



strangely oblique letter which included these passages:
"As loyal Americans, Tax-

payers and Law Abiding Citizens, we are certain that you must be alarmed at the breakdown of law, order and public morality in our country and would like to know what to do about it. The public is being brainwashed by the media to believe lies and the facts are either distorted or covered up for obvious reasons. We are living in a reign of terror, and most people are unaware of this, and will have no freedom left if we don't unite and take militant action very soon. Each Monday, we have a new message exposing what "they" are trying to keep you from learning. If you will call our number weekly, you'll know what it is and why "they" don't want you to know it!"

There followed a telephone number, and the closing sentence, "Ring our number — Let freedom ring!!!" Telephone calls to the number listed on the message yielded only an anti-Semitic tape-recorded message.

Because the message had been received at a community college

newspaper, I became curious to learn what other schools might have been so contacted, and for what purpose.

The envelope had borne a San Jose P.O. Box number, so I wrote a letter to the San Jose Unit Leader of the NSWWP, requesting an interview. Back came a crisp reply refusing an interview citing the "press as irresponsible, and injurious to the cause of National Socialism." I then wrote directly to Commander Vincent in San Francisco to request an interview, and to find out why schools were being solicited by mail by the NSWWP. Vincent replied by letter agreeing to an interview, but insisting that I first attend a meeting in San Francisco. Almost immediately, I began receiving by mail from Vincent a great deal of Nazi propaganda literature.

I was appalled to see the words "WHITE POWER" emblazoned not only on the inside material, but also on the outside of the envelope. Once, I received an official

member application form, which asked for the following information:

Must be White, of non-Jewish descent (underlining by sender), and in agreement with the aims and objectives of the NSWWP. I am not a drug addict, communist, or homosexual. Color of hair, eyes, skin, religion, family background, (country of origin) of father, mother, and whether or not born in U.S.

I was later to learn just how seriously were the answers to these questions considered by all members of the Nazi party. Although the phrase "WHITE POWER" appeared throughout all of the printed materials sent to me, the general theme, and very nearly only theme, was wildly anti-Semitic. One telephone call from Vincent yielded such reckless rhetoric as to be almost laughable. He repeatedly urged me to attend a meeting, saying that "there are lots of good white men who regularly attend meetings," giving me

the distinct impression that were I to attend, I would surely find for myself a pearl among the swine. Vincent invariably made it sound like a Nazi version of "The Dating Game."

Vincent soon arranged for me to interview the San Jose Unit Leader, much to the distress of the local NSWWP leader. He made his displeasure quite plain to me when he telephoned me to set up the time and place, grouching that he would never grant me an interview on his own, but that "his Commander had insisted" that he cooperate with me. So, the stage was set for the first face-to-face, one-on-one meeting with the local Nazi bigwig, who was making it clear that he was very unhappy about the entire situation. I was rapidly developing a bad case of nerves.

Our meeting place, a restaurant

in east San Jose, had been predetermined by the local leader. When I had asked him how I would identify him, he said that he would probably be the "only man in the place who was clean-cut, and had short hair." I dutifully described myself, and hoped that there wouldn't be too many short-haired men in that restaurant that particular day.

The meeting with Larry Stevens, local NSWWP unit leader, lasted three hours, and Stevens talked candidly about his group's activities. Stevens told me that his local membership ran from Palo Alto to Gilroy, with the card-carrying members "somewhere in the high hundreds." Stevens became interested in the Nazi party when still in high school, and continued his interest when a student at Foothill College. He was appointed

unit leader of San Jose by Vincent in 1974, and was a "leader" with no followers. He began to do door-to-door canvassing on the east side of San Jose, leaving leaflets on doorknobs. Stevens noted that he generally received more inquiries for information when the leaflets did not show the swastika or other Nazi-related symbols on them.

Stevens said that he had about "10 students at Stanford" and others at unnamed schools and colleges canvassing and performing other work for the "party." He expressed interest in West Valley College, and wanted to know "the racial make-up" of the student population. Stevens expressed special interest in today's youth, explaining that the NSWWP and its

Youth Corps membership were of particular interest to him. He said that "reaching the minds of the young was a job that he hoped to be able to spend more time on in the future." At the present time, Stevens said, party members occasionally take Youth Corps members to the mountains for "orientation" periods. Older party members take trips to the desert "somewhere near Arnold, California," for maneuvers and encampments. "We get out and drill with weapons," Stevens said. Party members must drill regularly, using National Rifle Association targets. The targets are scored, and members must practice at distances of "15, 20, 25 yards with hand weapons, shooting

about 50 rounds," Stevens said. Party members are always armed with standard 45's and rifles during these maneuvers, and outfit themselves in their stormtrooper uniforms.

Stevens refused to allow me to attend a San Jose NSWWP meeting, so the meeting with Allen Vincent in San Francisco was becoming inevitable.

I had been informed that some of the Nazi members would be armed at the March 4 meeting, and that there would be protesters gathered outside the Wawona clubhouse. Vincent had called the TV and print media, and alerted the S.F. police of possible violence. If Vincent accomplished anything by this maneuver, it was only to gain more personal press coverage for himself. The press greatly outnumbered party members, supporters, or sympathizers, and

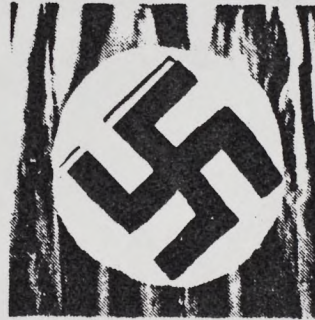
the police outnumbered everyone by about three to one. Four mounted policemen lined up their horses four abreast just inside the gate leading to the entrance of the clubhouse.

More than 20 police cruised leisurely up and down the street, while several plainclothes police sat in unmarked cars silently observing the outside activities.

Some of the uniformed stormtroopers, greatly emboldened by the presence of so many police, ventured outside the clubhouse and taunted the protesters on the other side of the mesh fence by shouting "Heil Hitler" and giving the extended arm salute.

Inside the clubhouse, chaos reigned as TV cameramen continually panned the faces of the group gathered inside. At one point, I stepped inside the clubhouse only to be met by the

glare of TV camera lights directed at me. I quickly stepped aside, and busied myself with my tape recorder, waiting for Vincent to begin his meeting. When he was satisfied that all cameras were pointing to him, and all tape recorders open and recording, he began his speech. Vincent railed on about the "Jew-controlled media; shipping Blacks back to Africa; closing down the borders to keep out all aliens," and the continual use of the phrase "WHITE POWER."



When Vincent conducts his meetings he is flanked by armed and uniformed stormtroopers, standing stiffly, legs apart, arms behind their backs. It is a frightening and unnerving spectacle to be amid a group of swastika armbanded, booted, gun-carrying men saluting and pledging allegiance to Adolf Hitler.

These men are not just playing dress-up on the weekends. They are for real. The ruthless rhetoric they spout is truly what they

believe. Their hatred is genuine. Their fear is real. Sources have told me that their numbers are indeed increasing.

I cannot forget what one stormtrooper told me. "If we continue to grow in members as I hope we will, we will almost surely be outlawed, and then we will be forced to defend ourselves at any cost." This man was not kidding. He is actively recruiting at schools and colleges right now.

The NSWWP is opening its membership to the KKK and to the Hell's Angels. It is only to attend a Nazi meeting, see the fusion of these three groups, and experience a stomach-grinding presentiment of fear that refuses to go away.

Voters set stage

COLUMBUS, Ohio (AP) — Gov. James A. Rhodes easily won renomination in Ohio's Tuesday primary while Democratic Lt. Gov. Richard F. Celeste sailed into his party's November gubernatorial spot over token opposition.

The 68-year-old governor, after an almost nonexistent campaign, solidly defeated his only challenger, House Minority Leader Charles F. Kurfess, 391,801 to 187,892, based on complete but unofficial returns from the unusually low turnout primary.

Celeste, 40, moved into an early lead and swept every county in defeating Ku Klux Klansman Dale Reusch of Lodi, 490,563 to 91,146.

Celeste, who ignored Reusch, the imperial wizard of the Knights of the KKK, mostly campaigned against Rhodes in the primary, charging him, among other things, with failure to provide leadership in Ohio's school funding crisis and in numerous other areas.

The turnout apparently fell significantly below the 1.62 million which had been predicted. As of early Wednesday, about 1.2 million votes had been cast in the races for governor, which led tickets. Lack of interesting issues and contested candidate races were cited as the reason. About 1.6 million voted in the 1974 primary.

Reusch, a 38-year-old engine tester at a Cleveland auto plant, could not be reached for comment. His running mate was Robert Strittmatter, a print shop employee at Lakemore in Summit County. They based their meagerly financed and almost invisible campaign on anti-busing and anti-gun registration.

Celeste said earlier he wanted to raise about \$1.5 million. He had spent \$343,431 as of May 25, pre-primary expense reports showed, but had debts as of then of \$15,708. The Democrat purchased \$65,000 worth of television spots in mid-May, but they were intended to help keep his name before the public, and not out of concern about Reusch's campaign.

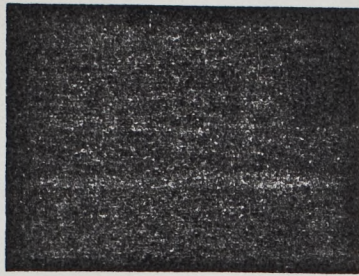

It was wonderful to talk to you on the phone! Made me realize how feeble and uninformed most of the so-called "hard-core" is, just by contrast.

I can't stand still long enough to write a long and detailed letter, as I'd like to; I want to get some material off to you right away and some more info on what's up. So please forgive the lack of amenities and proper narratives of how all this happened. Suffice to say that we are finally beginning to DO what we have all so long talked about. Most thanks to ONE man, --the ONE "Fat Cat", --as Wes used to call them, --who is putting his \$\$\$ where his mouth is. God bless him.

The enclosed "hate-mongering" will give you an idea of the calibre of material we are preparing to roast the Jews alive in the fire of truth, as it were. [redacted] is all-out on the stickers, which are the ultimate weapon against the Jew, because he can't see where he's getting hit from, --the amount he himself has been using to knock us all off. People are beginning to publicly admit that there are such things as Jews have been coming up to get a supply of these "communism is Jewish" stickers to get them ready for the right places.

The Big Blast is all set for Friday or Saturday if there is a local ordinance for no picketing, etc., on Sunday. We will have to know, and will keep you informed. But we want to do it Sunday, if possible, because the boys are coming down from New York for work here, --no hits to the local citizens, --and we want to have Saturday to pass out thousands of hand-bills and letters to get steam things up for the Big Blow itself. You'll have to get a local ordinance in Atlanta against Sunday picketing, and, if there isn't, your boys, just as mine, will not be free. In all probability, on Saturday, and can use that whole day to distribute the "pamphlet" we will get down to you in quantity by Thursday or Friday.

There are three items for handbills: (1) An informative explanation of WHY we seem to be being "smothered" in the Middle East, etc., with an announcement of the picketing and invitation to come and meet at the Jew's door, etc.; (2) a documented, damning INFORMATION sheet to hand-out at the "ceremonies" to establish exactly what Israel has done and is doing, and, generally, to piss off the citizenry at the traducers of our Country and traditions, etc.; and, (3) Membership applications for The American National Committee to Free America from Jewish

Two "official" dates stand as the birthdate of the American Nazi Party: October, 1958, and March, 1959. The National Socialist White Worker's Party recognizes the former date as 1958 was the year in which George Lincoln Rockwell crossed his own personal Rubicon.

That July, twenty years ago, Rockwell had led the first openly anti-Jewish demonstration in the United States since 1941 in front of the White House.

Had he not been certain at the time of the significance of his action, then the Jews themselves were to remind him later that fall when the Atlanta, Georgia, synagogue was bombed and Rockwell only narrowly escaped the huge frame that had been carefully engineered for him and his few followers over the preceding months.

The demonstration itself had been innocent enough. At the time, Rockwell was calling his group the Committee to

Free America From Jewish Domination and they were using no uniforms of any kind and certainly no Swastikas. The cause for the protest that day was - believe it or not - the dangers of U.S. involvement in the Middle East on behalf of the Jews.

However, to the Jews themselves, this could not go ignored as it was the first sign of any active resistance to their control over the U.S. government since they had succeeded in silencing their opposition in 1941 through the monumentally stage-managed incident known as "Pearl Harbor".

A so-called "sneak attack" designed to silence a huge and well-financed American anti-Semitic movement and to "make the world safe for Communism" in the forties corresponds well to the dynamiting of a synagogue in an attempt to silence one man in 1958.

But Rockwell was a different kind of man than the rest. He would not be silenced. In his autobiography he outlined the half-dozen or so standard methods used by the Jews for silencing their opposition: Loss of financial security; Slander in the press; Physical terror; Murder, etc., with varying shades and degrees in between.

They tried them all out on Rockwell and none of them worked. Not even the famed "Last Resort": Death by Assassination was successful in his case.

Just as there are two dates accepted for the foundation of the A.N.P., there are two quotes from Rockwell wherein

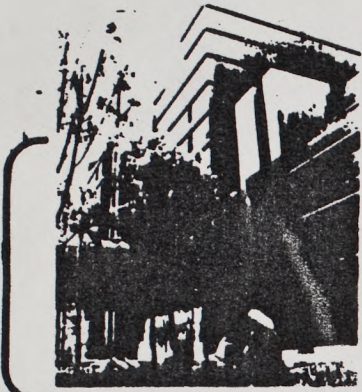

Beattie—racist running for mayor

John Beattie is a self-proclaimed racist and a candidate for mayor of Toronto in the upcoming municipal elections.

Beattie wants to be respectable (right now he calls himself semi-respectable), he wants to shake the Nazi label he claims the media pinned on him back in the early '60s at a time when he was making use of the swastika as a scare tactic against communist organizations in Toronto.

He also distributed hate mail and spoke out against both racial mixing and the Jewish community.

Beattie's platform for mayor is based on racial purity and restriction of religious freedoms, though he does have other plans that do not involve race or religion. He wants to construct a national sports stadium, prohibit pornographic movies, limit salaries of city employees and teachers and expand mass transit.

Article II of his campaign newsletter asks for: "Prohibition of Hindu,

Mohammedan, Sikh, or any non-Christian proselytizing, and the denial of permits to erect or establish places of assembly for such heathen worship."

Article I reads: "Housing priority to native Canadians—immigrants (of all colors) at the bottom of the list."

Beattie belongs to the British People's League and is editor of their right-wing newsletter, Northern Lights. He has recently achieved the minimum credits towards entrance to law school.

His living room is graced with a Union Jack, a picture of Queen Victoria (representing an historical period he has a great appreciation of) and a bust of John A. Macdonald. In the front hall of his house is a picture of Queen Elizabeth II. "Queen Elizabeth I was the first to stop race mixing," he says appreciatively.

"All through history, when the garbage starts to gather, to the point where we have to toss some of it out—and I'm not calling people garbage, I'm just saying it's a confusing

situation . . . when you confuse too many tongues, too many religions, too many races, it's just too confusing for anyone to set any kind of standard to go on."

Beattie believes he may have triggered Metro's action against body-rub parlors.

"I was walking up Church Street with my wife," he says, "when some creep invites me in. I got a little bit

angry and I did quite a bit of damage to that building.

"The day after I did that Paul Godfrey (Metro Chairman) comes out and says we've got to stop the body-rub shops; Mel Lastman says we've got to stop the body-rub shops.

"I've been personally told by a very senior person in Metro that my action put a lot of fear into the liberals."

The heading on Beattie's campaign newsletter says "Keep Toronto clean and prosperous . . ." For Beattie clean comes first.

Beattie feels there are two other reasons why he might do well in the coming elections. First, he says, people are voting against incumbent governments nationwide. Secondly, Jim Beattie won the World Series. (Jim Beattie pitched for the New York Yankees.)

"I think it's ironical," he says, "that I got all that publicity last month. A lot of wives are going to see Beattie on the list and the name's going to ring a bell."

The fight is on: Record 616 seek election in Metro

A record 616 civic candidates have filed nomination papers for the Nov. 13 municipal election in Metro, attracted in part by three close mayoralty races and many wide-open aldermanic battles.

With nominations closed last night, the City of Toronto leads the way with 192 candidates, including a record 12 for the \$50,000-a-year job as mayor. Others are seeking council, school board and public utilities seats.

North York has 132 candidates and a bang-up board of control race with 10 candidates, including two former controllers. Scarborough is next with a record 95 nominations, including five for the mayoralty and nine for the four-member board of control.

York weighs in with a record 60 candidates and a three-way battle for mayor. The borough also has Metro's only board of control acclamations: Alan Tonks and Fergie Brown.

Mayor acclaimed

Etobicoke has 88 candidates this time around, and incumbent Mayor Dennis Flynn faces two challengers. Board of control has five candidates for four spots, with the remainder of the races aldermanic or for board of education.

Tiny East York has Metro's only acclaimed mayor, Alan Redway, who will begin a second two-year term. But the borough has 48 other candidates seeking election or re-election.

The city's many mayoralty nominations are a surprise because only three main candidates — Aldermen John Sewell,

cluding former controller Ken Morrish, who took over when Paul Cosgrove resigned to run for the Liberals in the Oct. 16 federal by-election in York Scarborough.

Opposing Morrish are veteran Controller Gus Harris, Alderman Ron Watson, businessman Donald Lunny and community worker Lois James, who lost to Cosgrove in 1976.

The borough has nine candidates seeking four board of control seats, and the favorites are incumbents Brian Harrison, Joyce Trimmer, Frank Faubert and Alderman Carol Ruddell. Another is John Tsopelas, who gave up the federal Liberal nomination in Scarborough Centre to Maurice Strong, former chairman of PetroCanada.

In North York, incumbent Mayor Mel Lastman faces little challenge from two fringe candidates as he goes for his fourth term. He's opposed by Helen Obadia of the North American Labor Party and businessman Perry Dane.

But the borough has 11 people running for four board of control positions, including incumbents Barbara Greene, Esther Shiner, Bob Yuill and Ron Summers.

Back to try for controller again is Irving Paisley, who resigned from the job in 1974, and Alex McGivern, who lost the post in 1976 after holding it for one year.

Trying again

York Mayor Phil White is trying for a fifth term, challenged by veteran Controller Doug Saunders, a 14-year member of council and the borough's budget chief, and Alderman Gayle Christie, who has

They may be eccentric but they want top job

What makes Andrejs Murnieks run? And why?

Murnieks is one of nine pretenders to the throne vacated by former Toronto mayor David Crombie — 20,000 leagues (and as many votes) under the three major candidates, aldermen Tony O'Donohue, John Sewell and David Smith.

In the 1970s, the fringe candidates — sometimes called "the crazies" — have shown up at every municipal election in the city, whether there's a real race, as in 1972 and this year, or no race, in 1974 and 1976.

Murnieks, 45, is running again this year because he got "so mad" that people did not listen to him two years ago. "My main concern is public washrooms for every subway station. People urinate and vomit on the floor. I've slipped myself a number of times."

His platform drew 961 votes in 1976, 111,000 fewer than the winner, Crombie.

Murnieks typifies the candidate who "has a platform that wouldn't get publicity any other way," says Toronto psychiatrist Dr. Jerry Cooper.

"Fringe candidates run the gamut from those people who may be mentally disturbed to those who simply have views they want to get across."

Murnieks is simply one of the latter, with personal views that shouldn't bother anybody.

Others have more global concerns, and filing nomination papers for mayor allows them to express them.

Here's a sample of some Toronto mayoral candidates and their views:

□ John Beattie, 36, former leader of the Canadian Nazi Party. His first priority is housing for native Canadians, with "immigrants of all colors at the bottom of the list."

□ Richard Sanders, 36, North American Labor Party, who wants to "educate the population on the crimes committed by the Guelph monarchy in Canada. Narcotics and ruinous speculation are the only benefits of the British system."

□ Zoltan Szoboszloi, 64, a "traffic summons consultant," whose slogan is "God 'Shave' The Queen." He insists "the only queens Canada has are bikini queens and Dairy Queens."

Book seller Joe Martin, also running for mayor, is the 45-year-old leader of the Canadian Just Society, which wants legalized marijuana, prostitution and gambling to create jobs.

Nazi chief wants to bring race 'fight' here

Allen Vincent's ruddy face grew intense as he spoke, the swastika on his sleeve moving slowly with each punctuating breath.

"We're here to organize white people for their own survival purposes," he said.

With that the 46-year-old "national leader" of the National Socialist White Workers Party kicked off what he hinted may be an intensified effort to bring Sonoma County residents into the American Nazi movement.

Vincent, a San Francisco resident whose profession is leading and organizing for the NSWWP, suggested his brown shirts may hold a rally sometime next month in Santa Rosa's Old Courthouse Square.

But that wasn't the primary rea-

son the Nazi leader was in Sonoma County this weekend.

Saturday, Vincent's main concern was a session at 7 p.m. tonight at the Community Baptist Church at which Herbert Aptheker, the noted scholar of black history, is to discuss "Should the Nazis and Ku Klux Klan Have Freedom of Speech?"

What the Nazis' response to that meeting will be is still undecided, Vincent said. The original plan had been to hold a counter rally in Old Courthouse Square today. But the group had not counted on the red tape at City Hall and were told by city officials that it would take a week to process the paperwork which must be done prior to issuing a permit.

A permitted rally, therefore, became impossible. But Vincent didn't rule out the possibility of some other action, perhaps including Nazis already active in Sonoma County.

It was through the action of Sonoma County Nazis that Vincent first became aware of the Aptheker speech.

According to Vincent, a cell of about 10 Sonoma County Nazis has been meeting for about a year. And while he admits the group is small, he says with satisfaction that it is "solid," without "infiltrators or provocateurs."

Furthermore, Vincent feels, Sonoma County is fertile recruiting ground for the Nazi movement, mainly because of the many "honest white working people" living here.

Vincent believes Sonoma County residents are watching an epidemic of crime against whites in the Bay Area and are ready to make sure it doesn't move north.

"This area is right on the verge of something like that itself," he said with conviction.

Vincent's particular opposition to the theories of Aptheker may stem in part from experiences he had with another member of the historian's family.

In 1964, Aptheker's daughter, Bettina, was one of the leaders of Berkeley's growing Free Speech Movement. It was at precisely that time that Vincent came under the spell of American Nazi Movement leader George Lincoln Rockwell and began organizing for the group.

Vincent said that before that time he "didn't really have a political viewpoint" but was looking for something which would give substance to his "instincts." That he found in Rockwell's Nazi movement, and when Rockwell was assassinated Vincent followed in the leader's footsteps.

Vincent heads only one of three

major American Nazi parties, however, and there seems to be little love lost between the groups.

In addition to Vincent's National Socialist White Workers Party, there is the National Socialist White People's Party and the Nationalist Socialist Party of America, the latter of which recently made headlines with its plan to march through Skokie, Ill.

But Vincent feels his organization is the only legitimate American Nazi group, if for no other reason than his contention that the leadership of the other groups is tainted.

The head of the NSPA is a "half-Jew," according to Vincent, "and we don't want under any circumstances a half-Jew as a leader."

The leader of the NSWPP, Vincent contends, has in his lineage "Pakistani blood."

Vincent saves most of his rancor, however, for Jews, blacks and Mexicans, and Aptheker, as a Jewish scholar specializing in black history, comes in for his share.

Aptheker, Vincent says, is a "rabid anti-white fanatic" who has been "agitating against white people for years." He is a "leading Communist theoretician and spokesman," says the Nazi.

Vincent is as vehement in his general philosophy.

"The white race is in trouble to-

day because they've allowed their affairs to be managed by Jews who really don't have their best interest at heart," he said.

What are the ultimate goals of the National Socialist White Workers Party?

"We want the North American continent to be a white people's land," he said. "This is the last area of the earth where the white man has a chance.

"Actually, we don't want to hurt blacks or Mexicans but we sure want an all-100-percent pure white neighborhood for our people to live in."

But something Vincent said when he left seems to belie this last statement. He commented on the security at The Press Democrat building:

"This is a good, secure building," he said. "This is the kind of building we'll need when the real race war starts."

Council blasts Nazis, u

The Santa Rosa City Council Tuesday condemned the American Nazi movement for "bigotry, intolerance and stupidity" and called on Santa Rosans to boycott a rally of the group set for Saturday in Old Courthouse Square.

The resolution condemning "extremism in general and the Nazi party in particular," prepared by Councilman Jack Healy, was approved 4-0, with Councilman Jerry Wilhelm absent.

Healy's resolution came four

days before a planned rally of the National Socialist White Workers Party, permitted by the city under Constitutional guarantees of freedom of speech.

Healy opined the right-wing group was "rightfully" granted permission to speak in Old Courthouse Square, but then presented his resolution condemning extremism of all kinds and specifically the Nazis.

"Now, therefore, be it resolved that the City Council of the City of Santa Rosa, while recognizing i

Nazis get permit for rally

The City of Santa Rosa has granted the National Socialist White Workers Party a permit for a rally in Old Courthouse Square September 30.

City Manager Kenneth Blackman told The Press Democrat Friday the permit had been routinely processed and a letter had been forwarded to the Nazi group informing them their request to hold a recruitment rally between 2 and 5 p.m. had been granted.

City officials — including Mayor Donna Born — had earlier predicted the rally would be approved since to do otherwise would be to abridge the right wing group's Constitutional guarantee of freedom of speech.

A coalition of citizens opposed to the Nazi group last week asked the City Council to deny the permit but were informed the request would be processed like any other and likely granted. Mayor Born suggested the best response to the Nazi rally would be to ignore it.

Blackman said Friday the Nazi group would face the same restrictions as others holding rallies on city property. Those restrictions, he said, deal with volume of amplification, blocking sidewalks and streets, clean up after the event and similar requirements.

Blackman also told The Press Democrat two other groups, Flower of the Dragon and the Sonoma County Alliance Against Racist and Political

Repression, had applied for permits to stage rallies at the same time. Their requests will be denied, however, because of city regulations limiting the number and location of simultaneous assemblies, Blackman said.

City Recreation and Parks Director Charles Hoefler told The Press Democrat Nazi leader Allen Vincent said he expects to bring about 10 of his brown shirts to the rally and draw between 80 and 100 listeners.

The academy will offer courses in Hebrew and Jewish history. Classes are open to the public.

Basic Hebrew will be offered Monday at 7:30 p.m. at the Petaluma Jewish Center, 740 Western Ave., followed by a history of Jewish civilization at 8:30 p.m. Rabbi David Kopstein will teach both classes.

Courses in Hebrew and Jewish mysticism will be offered Tuesday at the Temple Beth Ami, 4676 Mayette St., Santa Rosa, beginning at 7:30 p.m.

Tuition is \$25 for each 12-week course. For more information call 762-0340.

Constitutional obligations to provide for the free expression of ideas, also does on record as deploring the actions of extremists of all kinds," the resolution read. "We specifically condemn the philosophy and actions of the Nazi party and the horrors it represents. We also speak out strongly against the idea that violent confrontation solves problems."

The council formally called on Santa Rosans to boycott the Nazi rally, indicating it would be the

"most effective way of handling the Nazi assembly."

As justification for its conclusions the council resolution noted that "bigotry, intolerance and stupidity are not in themselves illegal."

"The history of the Nazi party wherever it has existed clearly shows all of the traits of bigotry, intolerance and stupidity that result in the suppression of human rights," the resolution said.

Brando Plays U.S. Nazi in ABC Sequel to 'Roots'

Marlon Brando will make a brief appearance as late American Nazi leader George Lincoln Rockwell in "Roots: The Next Generations," ABC's 14-hour sequel to the Alex Haley family history saga due to begin Feb. 18. "As far as I know, this is Marlon's TV dramatic debut," said "Roots" producer Stan Margulies.

Brando on Monday filmed a scene re-creating a portion of a Playboy interview Haley conducted with Rockwell when the "Roots" author was a free-lance writer. The scene is expected to run 8-10 minutes.

"Marlon initiated this," said Margulies. "He called Alex several months ago and said he wanted to be in 'Roots.' We finally found something he wanted to do and something we wanted him to do."

The city council granted a permit to the National Socialist White Workers Party headed by Alan Vincent but urged citizens to boycott it.

Permits were also issued to the Sonoma County People for Human Justice and another to the American Coalition Against Facism, two groups opposed to the Nazi rally.

City struggles to assess Nazi rally violence

By SUSAN SWARTZ

Joe Rapoport from the Jewish Cultural Club expressed ambivalence over Saturday's attack on nine Nazis in Old Courthouse Square.

"As far as my sentiments are concerned, I rejoice.

"These guys are preaching violence and they got a taste of it.

"But as far as understanding the minds that produced the violence, I can't accept it. Violence of any kind is wrong and doesn't accomplish anything."

While Rapoport and his organization joined with others at a counter rally at Juilliard Park, an angry crowd attacked nine members of the American Nazi Party when they

arrived for a scheduled white power rally.

After a five-minute melee, squelched by the arrival of a riot control tactical squad, the Nazis were placed under protective arrest and driven off in a police van.

Eight protesters, most of them coming from outside Sonoma County, were arrested. Seven injured police officers were taken to hospitals for treatment, one with a broken shoulder.

City manager Ken Blackman, who watched as the rally turned into a riot from the second floor of a nearby office building, congratulated police officers for their professionalism.

"I was there for the entire thing and I think they did an outstanding job. I don't think they could be criticized for over-reacting or under-reacting."

However, Allen Vincent, Nazi organizer from San Francisco, has a different opinion. He called the Press Democrat this morning to say he was seeing his attorney, whom he refused to identify, to consider suing the city of Santa Rosa.

He charges that the city should have not allowed members of the "Jewish lead Communist" Progressive Labor Party to parade through the square prior to the arrival of his group, which held a city permit to rally.

"It is against the city's own rules to allow two groups to have a rally at the same time and at the same place."

About 45 minutes before the Nazis drove up in two cars, witnesses reported some 25 members of the PLP marched onto the square, chanting "Fight for Socialism. Death to the Nazis."

On Saturday, Santa Rosa Police Chief Sal Rosano said plain clothes officers had identified members of the PLP as "the single most identifiable group directing what should be done when the Nazis arrived."

Vincent said local police had "no control of the mob" and accused Rosano of "bungling" protection for

the Nazis "and planning to bungle it."

Still, despite the lack of hospitality, he repeated his vow made on Saturday to return to Santa Rosa. "There were white people at the square wanting to hear what we had to say."

Vincent said members of his group, who were all helmeted, escaped serious injury, but they all, like himself, received bruises.

Blackman said if the group applies for another permit to hold a rally, "Our legal advice has been that you cannot deny a permit based on something which you think might happen."

But, he added, the group could be

asked to post a bond, based on Saturday's experience, to cover the costs to the city.

Three of the protesters arrested Saturday remained in jail this morning, to be arraigned today. The other five were released on bail and will appear in court in two weeks.

Still incarcerated are Roland Angle, 36, Alameda, teacher, whose bail was set at \$15,000, on charges of inciting to riot, resisting arrest, assaulting an officer; Victor Coffield, 37, Berkeley, who listed his occupation as driver, \$3,000 bail, assaulting an officer; William Huntinton, 31, San Francisco, hospital worker, \$15,000, assault with a deadly weapon.

he sizes up his personal mission in life. The most common has it that he knew he would not die before he had made the victory of National Socialism a certainty. The other, more obscure but more from Rockwell the realist, told us that he would establish a Movement that would survive on its own before he could be killed.

Of course, he has since been proven right.

Nowadays it brings me to stark reality when I see such things as shingles hanging outside local businesses which read: "Established 1958". Twenty years is a long time in human terms.

Twenty years is a generation. The generation just passed since 1958 has brought more change - all of it bad - for this country and the world than any other comparable period of time in history.

What has the Party been able to achieve or to account for over the past twenty years?

In hard, tangible terms, very little. Real revolution is the hardest of businesses and the greater the stakes, the greater the risks, then the fewer the subsidies.

The twenty-year uphill climb we now look back on has been one of an almost imperceptibly slight upward grade. If ever there has been a long march, then this has surely been it.

It may be commented that all of the trials of the past may have been avoided as only now does there seem to be a general atmosphere favorable to a popularly supported revolution.

The awful expenses and sacrifices of the past might amount only to diversions we felt compelled to perform in order to get our minds off the awesome and irreversible slide of our former lives and culture into the present-day hell and oblivion. Also, at the same time, costly and thankless efforts to prove to ourselves and to the world that we at least were still men.

In truth, what really has happened in the past twenty years has been our own people catching up with us.

Today all of our people are radically alienated from the Big Brother System and are

thoroughly disenchanted with the status quo of economic slavery that they find themselves trapped in.

It's almost impossible to find anyone who isn't violently and emotionally anti-black.

Average people with no previous contact at all with the so-called "Lunatic Fringe" as we once may have classified tell me of things they have discovered for themselves that I first learned of long ago by reading in disreputable and yellowing Right Wing "extremist" tracts that had been passed hand-to-hand.

Most of them speak with an astoundingly calm resignation to the inevitability of violent struggle to rectify the impossible situation. They speak of revolution, civil war and the necessity for men who are ready to die for their beliefs in the face of the Big Brother System. And they are no longer afraid.

What is called for now is no longer "education" of the White masses of people nor is it a further "ripening" of the situation. LEADERSHIP is called for as never before and the SPARK of courage and sacrifice that will commence the

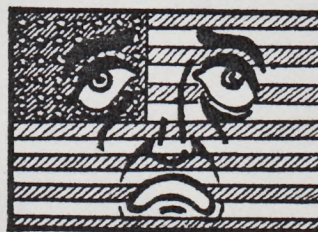

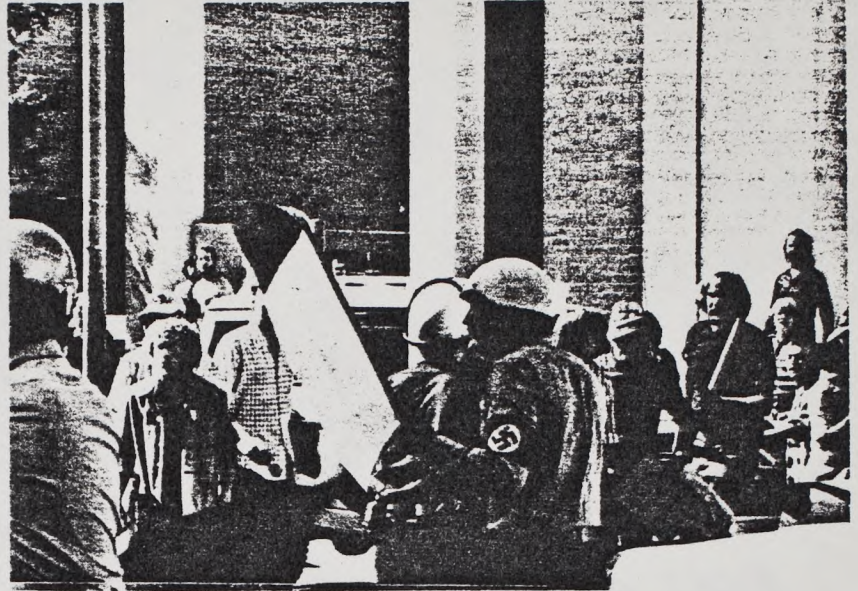

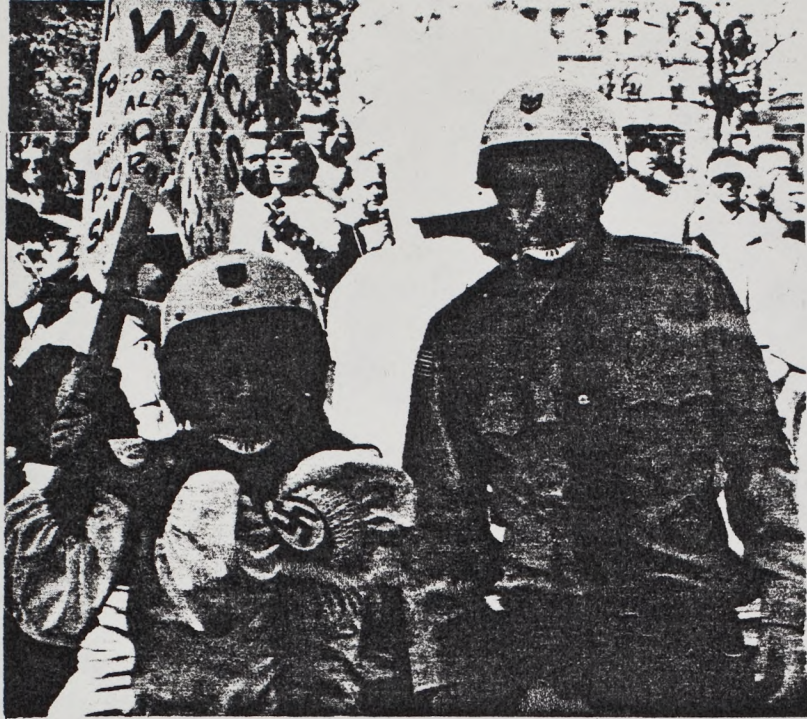

WOSU-TV Refuses To Air Documentary About Nazis

WOSU-TV (Channel 34) has chosen not to air what may be the most controversial program of the year — an Academy Award-nominated documentary on the Nazi party in California.

Channel 34 is one of as many as 30 of PBS' 279 stations that have refused to carry *The California Reich* on grounds that it promotes Nazism.

Cleveland's WVIZ-TV has turned thumbs down, too.

WHAT MAKES THE hour-long effort controversial is its form. The approach is cinema verite. It has no narration and no rebuttal to Nazi rhetoric except for opening and closing remarks by newsman Clete Roberts.

The California Reich is set for 8 p.m. Sunday, a time Channel 34 devotes to the simulcasting of a symphony show with WOSU-FM (90 on the dial).

Channel 34 Program Manager Mike Mottler explained the show is part of a series of documentaries that are regularly taped for broadcast at a later time.

HOWEVER, HE SAID, "It (*The California Reich*) will not see the light of day on our station."

William J. McCarter, president of Chicago's WTTW-TV, has described *The California Reich* as "almost a recruitment film."

Nazis are seen teaching their children to applaud Hitler and hate others. These scenes were shown recently on CBS' *60 Minutes* program.

Mottler detailed his opposition to the film by reading copies of letters sent to PBS President Larry Grossman by general managers of other network stations.

"THIS PROGRAM affronts audiences of all races and religious persuasions by providing media exposure to an organization whose avowed and practiced political philosophy includes the degradation of man and genocide," Mottler quoted Sheldon Siegel, general manager of WLVT-TV in Bethlehem, Pa., as writing.

"The offering of this program to the system

under the guise of 'exposing the Nazis' merely serves to nurture latent bigotry and hate and to propogandize their philosophy."

Frederick Breitenfeld, executive director of the Maryland Center for Public Broadcasting, wrote, "... including (the show) in the PBS schedule produces too many who lose: viewers, stations, PBS, white people, black people and Jewish people.

"THE ONLY 'WINNERS' are a few Nazis and the First Amendment, which in my opinion is not in need of a fresh victory just now."

To generate support for *The California Reich*, PBS sent telegrams to its stations on Sept. 16 urging each outlet to air the program.

Barry Chase, PBS director of current affair programming, has been quoted as saying, "I think it is important to let people know those groups exist

in California. There is a value in that, having people know there are people who regard Adolph Hitler as a great savior."

The documentary was produced by Keith Critchlow and Walter Parkes and was shown in theaters. The Academy Award nomination came in 1976.

Newsman Roberts notes in the opening segment the program is a "disturbing reality."

'Anti-Nazi' Raid On a Theater

New York

Terror revisited a theater director whose family died in concentration camps as ten marauders ripped apart a theater showing what they said was a "pro-Nazi" film.

Jack Garfein, artistic director of the Harold Clurman Theater, and about 50 people in the audience stood by horrified as the intruders destroyed a movie projector and stage sets Saturday night in the theater on Manhattan's West Side. One person was slightly injured.

"If I'd wanted to, I couldn't give them a better demonstration of fascism," said Garfein, whose daughter, actress Blanche Baker, won an Emmy for her performance in the NBC mini-series "Holocaust."

"It reminded me of when I was a kid and the Nazis broke in and took the rings off my mother's fingers. Then they pushed my father against the wall and broke the furniture because my father had dared stand up against them," said Garfein, 48.

Garfein said that his mother

and 8-year-old sister died in the gas chambers of Auschwitz and that his father died in the camp at Ordruf. He survived camps at Auschwitz and Bergen-Belsen, and was freed in 1944 at age 14, his weight having dropped to 48 pounds.

That was 34 years ago, but it all came back to Garfein when the marauders rushed into the theater during the showing of "California Reich," a documentary which some believe favorably portrays Nazi followers in California. The film was nominated for an Academy Award two years ago.

Theater workers said the intruders shoved an usher and a woman in the audience and began busting sets and tearing down the screen. They grabbed the stage manager by the throat and choked him until he opened the projection booth so they could destroy the projector and make off with the film.

An anonymous caller to the Associated Press said that the incident was the work of a group called the Revolutionary Socialist League and Committee Against Racism.

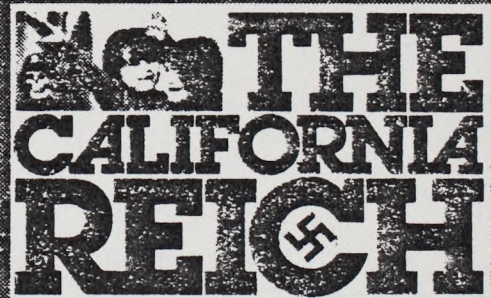

daddy ask the kids, "Who don't we like?" even the tiniest of the toddlers happily shout, "Jews and Niggers!" This documentary is full of unsettling things like that.

"But," you say, "there are only 2000 of them." Right. And, as the end of the picture dramatically points out, in 1923 the official German government evaluation of Adolph Hitler and his 1,000 followers was that they were harmless and of the "comic opera" variety of agitator.

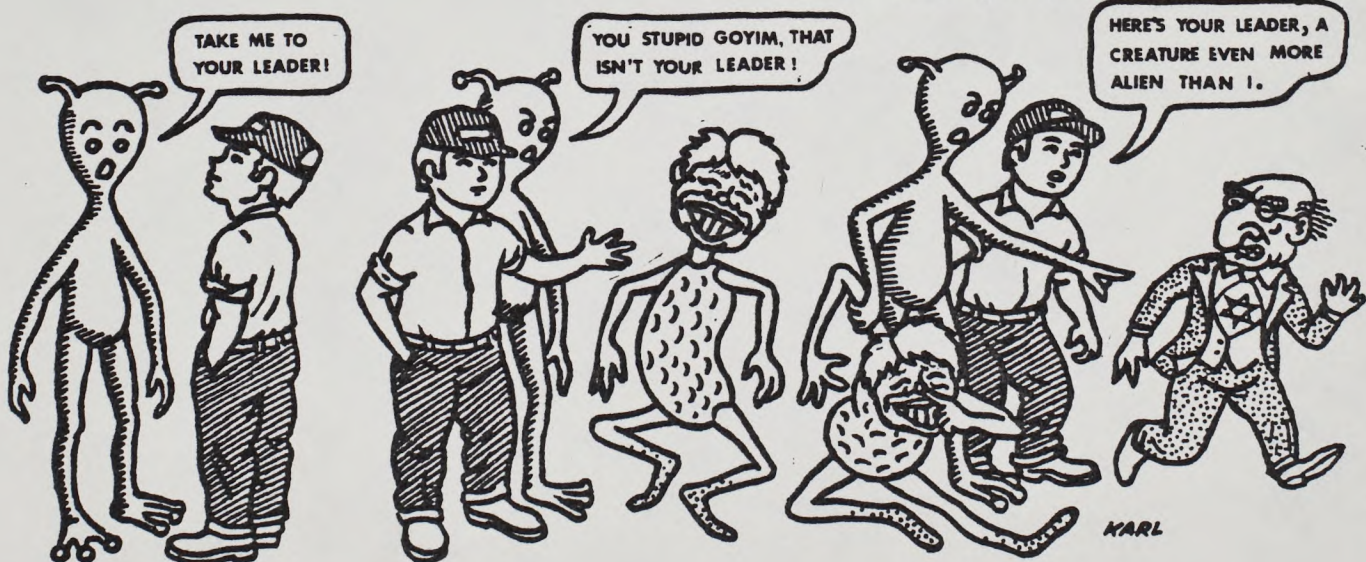
The power of the mere display of the swastika is explained by a Nazi spokesman. The very sight of it reduces the most rational individual to a raging animal who must destroy the image of the "crooked-cross." That was brought home to me at the screening.

There is a scene taken of Tracy, Calif., "stormtroopers" loading into a truck to join their comrades in San Francisco. They are the motliest, most misshapen, misbegotten misfits you can imagine. When given a "column right" command they very nearly trample each other. They are hilarious — ludicrous and hilarious.

I dared laugh at them and my colleagues of the press turned and glared at me in the darkness. The Nazis are right; they've got us running scared, in the movie house. Outside, ignore them and they'll go away.

If there's one thing we should have learned about the Nazi mentality in World War II and in all those Hollywood propaganda epics, it's that the one thing they can't tolerate is ridicule. Punch them out and they love it, but laugh at them and their ridiculous para-militarism and they are at a loss for a counter - weapon. Humor is not in their arsenal.

"The California Reich" was nominated for an Academy Award as Best Documentary. It didn't win. But the young men (24 and 30) who made the picture are not losers. They have done an illuminating and brave piece of work. If we ignore it, we may well be the ultimate losers. If you care what is just below the surface of your society, go and see it.

ackers Seize Jet, Release Of Hess

The name and the image of Rudolf Hess keep coming up regularly each year due to his unique spot in world history. Every now and then, his name is brought up in the news irregularly due to some protest or demonstration to gain his release from Spandau prison in Berlin. Then too, every time the man is ill (he is in his eighties) and has to be treated or removed to a hospital, that also makes world headlines.

So without question Rudolf Hess is the world's most famous prisoner. For present purposes however, that is a pretty dubious claim to fame.

Surprise could come to no one if Hess should die before these words about him can get into print.

For that very reason, this story about Rudolf Hess is not going to be another exercise of futile inveighing such as has been all others written previously by others favorable to Hess. This is the first time I have chosen to write about Hess though it is a story I have wanted to write for several years.

The hijacking incident reported here also is what prompted me to do it now. Finally, I

thought to myself, someone was doing something for Hess other than pitiously moaning and bewailing his situation and the injustice surrounding it. Now was my time to print something that corresponded to the man rather than to any abstract principles.

Hess, as many know, was Deputy Führer of Nazi Germany directly under Hitler. Hess finds himself in a unique place in history because he was a unique person, even among his fellow Nazi leaders.

Hess and Hitler were total contemporaries: About the same age; Intensely pro-German and anti-Communist; And equally mystical in their conviction of the special mission in this world of the Aryan Race of man.

Hess first met Hitler during the First World War while they were serving in the same regiment on the Western Front. Hitler was an Austrian and a non-commissioned officer. Hess was a German and an officer. It is reported that Hitler once told Hess he should avoid the dangerous flying missions he was undertaking as far bigger things were in store for him.

After the War, the two men found their ways independently

to Munich where Hitler remained in the German Army and Hess joined an early forerunner of the Nazi Party: The Thule Society. During the temporary takeover of Bavaria by Communists, Hess' life was in danger as a counter-revolutionary while Hitler's was equally in danger as an Army operative left behind enemy lines.

After the liberation of Munich from Red rule by the Freikorps shortly thereafter, the two men were again introduced by Dietrich Eckert, an early Nazi philosopher who died in 1923.

With the Nazi Party formally founded by 1920 and becoming a growing force in Bavaria by the time of general national collapse in Germany by 1923, the two men found themselves together during the Munich Putsch of November 9th.

The march, intended to seize power in the State of Bavaria, and with Hitler and Hess in the front rank, was able to push through an Army barricade but was halted by a fusilade by a detachment of police. Sixteen

members of the Party were killed. Hitler was wounded and later arrested. Hess turned himself into authorities.

Both men were sentenced to terms in Landsberg Prison and it was while they were there that Hitler and Hess collaborated on the writing of "Mein Kampf", with Hitler providing the story and the thoughts and Hess doing the actual writing and shaping of the chapters, etc.

They both were released in 1924 when the Party was re-organized and they were together all the way through to the assumption of national power in Germany in 1933 and, again, all the way through until May of 1941 where Hess' current story began.

Rudolf Hess, in his capacity as Deputy Führer, was privy to all the most intimate and top eschelon political and military plans of the Third Reich and, beyond that, to the most private thoughts of Adolf Hitler himself.

Hess was aware of Hitler's determination to attempt to destroy Communism by invading the Soviet Union in the summer

of 1941. Hess was also aware of Hitler's determination not to attempt an invasion of England.

Above all else, Hess desired to prevent further war between England and Germany and he wanted to see the military destruction of Communism succeed.

Many secrets about World War Two have only recently come to light. For example, the secret of the Pearl Harbor "back door to war" trick de-

signed by Franklin Roosevelt to get the United States into war to pull this country out of its economic depression and, primarily, to "make the world safe for Communism".

Though it has been brought to light, the secret involving Hess has been carefully obscured for reasons that would run contrary to the "Big Brother System" being established in the world.

Hess was chosen by Hitler to be his personal messenger to the British Government that Germany did not want war with England and that all Germany asked was a free hand in dealing with Communism in the East. Hess flew alone to England in May of 1941 with Hitler's full knowledge and consent.

Hess had told Hitler before the flight that, should his mission fail, Hitler could always claim that Hess had "lost his mind".

Hess flew to England and crash landed his plane nearly losing his life. He was arrested



by the British and interrogated. It is reported that Churchill came to see Hess in his cell disguised as a doctor.

Why such dramatics and ultra-secrecy between heads of state? What had been only suspected of the British Government by Hitler was now found out in its total degree.

While anti-Communism was strong in Parliament and while no one seemed to want to prosecute the war any further, there could be no stopping it. Why? Because of England's debt from the First World War that was still owed to the international Jewish bank-

ing houses and, more specifically, because Churchill himself had years ago been bought and paid for by the Jews.

As soon as he realized he had failed, Hess began acting the part of a crazy man and claiming total amnesia. And, in Germany, Hitler gave the official story that Hess had, indeed, "lost his mind".

The totally helpless plight of England as a nation was demonstrated to an even more ghastly degree when, in 1945, while Communism was devouring Europe and Germany was being defeated, the British - including Churchill - proposed

to the Americans that the still standing and still strong German Army be now rearmed and sent against the Communists aided and backed by the Western Allies in a plan that had been formulated by Heinrich Himmler, Hitler's SS Chief.

Dwight Eisenhower coldly informed the British that their nation was now totally bankrupt due to the war and that they were in debt to the United States to the point of complete dependency. If they did anything other than follow a set policy of total destruction of Germany and the surrender of
