My dear Hansen:

I understood the question of taking over, as a lane or an alley, the road up to Carrie Jacobs Bond was referred to the Planning Commission.

This should be done. Mrs. Bond feels very much agreved that it has not been taken over. She has been such a wonderful friend to San Diego. I hope you can see your way clear to take over the present road. There is no travel on it, there never will be, it can be taken over as an alley and I find it is absolutely impossible to get the road widened to 40 feet. The people will not sign the deeds.

I have been paying the taxes and maintaining it for 15 or 20 years but I am thru now. I am letting the property go for taxes.

Mrs. Bond, I understand, had refused to come down here again until the road is taken over and graded up. I have been assessed for a \$1000 or \$1500 an acre for that land for the last 10 or 15 years although I have never sold a lot in the last 10 years above the Inn even at \$300 a lot.

I hope you can do something to help the situation out.

I am referring to the dinky one way road called Summit Avenue right around the top of Grossmont. I will, at my own expense, widen the highway out from Sunset Boulevard to Summit Avenue to the necessary 40 feet in width on demand at any time. I hope you will get this matter straightened out.

Regarding another matter. I see they are staking out the highway to your property from Mt. Helix by going up the hill and down again. How come? Why should the road not follow along the crest from the bottom of the hill going to the east over the old road that I built.

I would appreciate your calling in and seeing me at your earliest convenience.

I have been extremely sorried that the city would attempt to transfer the funds from Sutherland to El Capitan. This question has recently been settled favorably. The city would have to officially declare the Sutherland-Lake Hodges project abandoned before they could ask the people to vote. I am sure no one wants to do this with the result that it is only a matter of time when the Sutherland funds will be used to purchase the lands and mater rights necessary to eventually complete the project. At that time the city should buy from funds now on hand the lands which we own. Our job now is to put over the bond issue for the completion of El Capitan pipe line which comes up at the next general election. I am sending you this letter simply as a matter of information.

If the First National Bank should file suit for the money that is owing them it will have to include all in the suit. My suggestion is that we let the matter drift along two or three months.

The City of San Diego have an option to buy this property at what it cost us plus 6% interest and taxes. If this sales goes thru everybody will get back their interest money that they paid and we will have rendered a service to the city. Some day this property is going to be one of the most attractive parking properties on the shores of any lake owned by the city and it forever prohibits building a home between the highway and the lake for nearly two miles along the lake shore.

we purchased this property at a ridiculously low figure, less than cost to the owner and at less than 10; on the dollar compared with the sales price of the subdivision property eight years ago.
