I have observed, in the majority of oases, that the modstore content of the soil around the trees is eneflolent encugh to keop them in a fairly thrifty conditica. I think the most serious mistake you have made has been in the colection of your trees. It is golng to be vary difficult to keeg the trees of poor guailty in a thrifty, groiding stato, and regardiass ©f the faot that you may uge supplicient fortiliser, and plenty of vater, you will ocntime to have "dio back" cocurriang both above and below grownd.

Another thing that I have observed is so many trees of large root atook, and a very apindley bod. As I reported to you sconotime age, I am of the same opinion that these treen nover will ampunt to axpthinge. I imitily belleve that you would
be moneg ahend if you would poll theoe trees cat of tho crevin and resot with a thritity tree.

For two geare, I have proven to you tho piluo of buying good cocd. The eigetral coot my be a trizo zors, but the recmite we have obtained prove ocraltely that is hae paid. The arcoado tree does not diffor strom the 1 cmi potatoo In this respect.

In concludinge I would like to ergeget that you buy the beat quallty tree obtaimable on the martiot, and then With a Little ocumongence care you ase bound to obtain savorable sesults.

The past Finter was a very soveso tent for the Arcoado tree in this ecoticn. conernily apentingyon $w 111$ ilvid the good quality tree has come threugh with bat a eat beok.
