Honorable Gerald P. Nye, Chairman Land Committee, House of Representatives, Washington, D. C.

My dear Mr. Nye:-

Eighty-five or ninety per cent of the citizens of San Diego County are desirous of the immediate completion of El Capitan Dam, a major development vital to the needs of the entire county.

As part owner and manager of the Cuyamaca System for fifteen years, I furnished water to the cities of El Cajon, La Mesa and the suburbs of San Diego and opposed the El Capitan bill for many years on account of certain litigation which I opposed, but which is now entirely eliminated, and I can say in all sincerity that those misunderstandings are eliminated. The agreement between the District and the City lately made and faithfully carried out allowing the District the water specified in its agreement with the City fully protects our suburban section within the boundaries of the La Mesa District, and it is only a question of time when nearly all of that territory will be annexed and become a part of the city of San Diego.

For the first time in twenty years harmony reighs on the San Diego River, with the exception of a few riparian owners, whose interests can be protected in the courts. In my opinion the greatest good for the greatest number demands a settlement of this water question and the granting to the city of San Diego of either the right to purchase the additional lands that will be flooded or an easement to flood.

Another issue might be the passing of a law giving San Diego the right to condemn the necessary lands in El Capitan Reservation between the 100 and the 217 foot contour. No farming lands, no homes, no improvements of any kind lie between the 160 and the 217 foot contour, all of the Indians of the El Capitan Reservation being eliminated with the original settlement between the city and the government, when \$364,000 was paid.

Nearly 200,000 people are directly and vitally interested in the early completion of El Capitan. Our reservoirs are less than 50% full. It will take two years to get this job completed.

By all means let there be no delay in granting San Diego its application for the right to buy or flood the lands between the 100 and the 217 foot contour within the El Capitan reservation.

The Chief Engineer of the U.S. Indian Service, W.S. Post, is theroughly familiar with every foot of this land in question, was our chief engineer for many years and can give valueble information supporting the statements above made by me if called upon so to do.
