

"EL FUEGO NUEVO" (THE NEW FIRE)-Many centuries ago, in pre-Columbian Mexico, the natives indulged in a special worry every 52 years; they joined in fear that the world was coming to an end. Basis for this fear was the closing of the astronomical cycle or, the Venus calendar, which was carefully charted by the scholars. Five days, called nemontemi, existed between each 52-year cycle and did not fit into the calendar's mathematical calculations. There was no scientific explanation for them; they were used for prayer, meditation and general suspense. Everything of ceremonial significance was destroyed. Temples were torn down and dishes broken: all in reaction to the uncharted interval between the OLD and NEW FIRES. Following nemontemi, when the world didn't end, a New Fire was lighted on the volcanoes. The instant it was sighted, other NEW FIRES were kindled throughout the land, welcoming a new era for man; an era to be used as a platform for a fuller life to gain greater knowledge and to enact greater deeds.


