
I would like to take this opportunity to thank you for your cooperation in our half hour documentary "Illegal Alien,' A Different Perspective."

## HOSPITAL REFUSALS

Two recent incidents at University Hospital may only be the tip of the iceberg in an appalling exercise of patient juggling throughout San Diego County hospitals. The incidents raised questions as to University Hospital's willingness to accept patients unable to pay for medical care.

The possibility that any critically injured person may be deprived of needed medical care is a serious indictment of the medical community. But University Hospital is too easy a target in this case. This facility and others must contend with so much red tape that the patients could conceivably become buried in it. Who picks up the patient? Where is he or she taken? Who is responsible for payment? These are questions that must be answered clearly and concisely and all catch 22's must be eliminated. Doctors must be allowed to practice medicine and administrators must be able to administrate free from political considerations.

39 Alive calls on the County to sit down and work out a clear and reasonable protocol agreement with all of the area's hospitals on the transfer, payment and emergency treatment of all patients in San Diego County to include aliens. Each of us has only one life to live. That life should not become a pawn in any community's political disputes.

## BORDER PATROL CUTBACKS

Immigration Commissioner Lionel Castillo last week told the Civil Rights Commission that it was unlikely the Border Patrol would be granted any increase in manpower. Castillo noted that the Border Patrol could actually be facing cutbacks in staff. Increasing controversy over a proposed border fence, attention to the exploitation of illegal aliens and a continuing flow of people across the border into the United States emphasize the magnitude of border problems for the people of Mexico and the United States. The manning of the Border Patrol is only one element in a much more complex crisis. With border violence continuing to victimize both Mexican and American citizens and with no immediate change in present border policy in sight, a cutback in the Border Patrol may only serve to aggravate a delicate problem.

39 Alive opposes any cutback in the Border Patrol. We call upon San Diego's congressional delegation to exercise their influence in Washington to prevent cutbacks in the Border Patrol staff at this time.
