Formula No. 1

600 pounds Ammonia Sulphate
400 pounds triple phosphate
175 pounds K2O Potash
325 pounds Cotton Seed meal
500 pounds finely ground sheep manure

Formula No. 2

The same as formula No. 1 with the exception that you substitute 425 pounds of cotton seed meal and reduce the ammonia sulphate to 500 pounds, the balance of the ingredients being the same quantities.

Trusting I may have an early reply from you quoting me both cash price on or before ten days from delivery and the best terms or whether or not you would take trade acceptances.
