My dear Mr. Hart:

I saw Mr. Holmes in Los Angeles lest Thursday, also had a talk with Mayor Walsh.

Mayor Walsh informs me that he thinks an irrigation district is the only solution, including Oceanside, South Oceanside and Carlsbad. Mr. Holmes feels likewise and suggested that I take up with you and Mr. Chase the matter of the first steps to start the organization of said district.

Mayor Walsh told me that he did not think it was wise from the standpoint of the success of the district, for the City of Oceanside to take the lead and was hoping the Oceanside Mutual Water Company would approach the city in this matter. Mr. Holmes thought the Oceanside Mutual Water Company should not take the lead for the same reason, but that an independent committee should be organized and invite Oceanside and the Oceanside Mutual Water Company into the conference with the committee.

How, Mr. Hart, I have a few friendly suggestions to make, as I have been identified with the organization of six irrigation districts and know the procedure.

You are aware that the City of Oceanside only has 40 acres of riparian land. They are exceeding, in my opinion, the use of water to which they are entitled at the present time. The Spaulding interests, which I represent, have 1400 acres of riparian lands, from the ocean almost up to the San Luis Rey Mission. I am holding back the Spaulding Estate from determining just what the City of Oceanside's rights are in court, hoping for an early solution of the problem without litigation.

It is true that the City of Oceanside can bring suit to condemn, but if they do they will have to put up the money or they will be enjoined from taking the water. As

the Railroad Commission of California has several times established a value of \$2,000 or \$3,000 an inch for water, in my opinion the valuation by a condemnation proceeding in court would be far in excess of any compromise settlement that can be made. The official records of the City of San Diego show that every drop of its water costs 21-1/2 cents a thousand gallons delivered to the city limits, and 7 cents more for distribution, so you can see how fortunate the City of Oceanside has been in getting its cheap water supply. Also the Oceanside Mutual Water Company.

Carlsbad should be in an irrigation district, and a permanent source of water supply secured. Their interests are identical. I would suggest that the boundaries of the irrigation district be determined, that the Oceanside Mutual Water Company and the City of Oceanside sell their distribution lines to the district and take bonds in payment which are readily sold. I am willing to recommend the acceptance of bonds for the sale of the Spaulding water interests, with a price of \$250,000 for approximately 1400 acres of riparian land, or \$200,000 including approximately 400 acres of valley lands. The rest of the land to go into the irrigation district and share its burden of the expense of putting water on the entire territory.

Company and the City of Oceanside have sold their systems to the district and possession given to the district, there should be additional bonds voted and sold to make the necessary extensions, under one control and management.

pendent committee of those who are willing to give their time for the good of the community. After organization my suggestion would be to invite the State Engineer of California down to check the feasibility of the project. No district can be organized without the approval of the state engineer first. No bonds can be voted without the approval of the State Bonding Commission of California, of which Commission the State Engineer is a member and his recommendation is generally accepted by the State Bonding Commission.

State Engineer to make an official report, furnishing him with a map of the proposed boundaries of the district and ask him to place a value on the City of Oceanside Water system and its water rights, the Oceanside Mutual Water Company's system and its water rights, together with the cost of the necessary extensions to put the water on each 10 acre tract, or 40 acres as the case may be. The State Engineer will also insist upon going into the question of a permanent and safe water supply,

and in his report he will place a value on the lands and water rights to be acquired by the district, including the Spaulding interests.

It is generally the custom to organize on irrigation district by a vote of the people and then have the Board of Directors lay plans for the future development of the district, but I believe the case can be handled either way, and in this particular case it strikes se that it would not be politic to ask for an election to organize a district until they know the following facts.

- 1. The value of the Oceanside Mutual Mater Company holdings as made by the state.
- 2. The value of the Oceanside Water System, as made by the state.
- 8. The value of the water rights it would be purchasing from the Spaulding Estate.
- 4. The total cost of the entire project.

I believe this information can be secured thru an arrangement with the State Engineer before any district is organized, and coming from the state it would be official.

I am writing this letter in confidence and at your suggestion, in order that you may have it to refer to, but I do think it better for me to keep out of the picture, unless at some future time the committee desires me as the project develops, but I think in any case it is unwise for many reasons. If I can be of any further service to you, let me know.

Unless you absolutely feel that this is the logical solution of the whole project there is no use considering doing anything further. By opinion is that it is the only thing to do for the good of the entire community, and where I can be of any service it will be a pleasure if you decide to go shead with the plan. There is a moral obligation until the let of July next with the City of Oceanside, in the matter of their acquiring a supply independent of any district, but the prespects are that nothing will be done by them within the time limit.


