Section 3408d of the Political Code as amended in 1923, Chapter 446, provides for the sale by the Surveyor General, Room 220, State Capitol, Sacramento, of Indemnity Certificates or scrip for cash, the price of the scrip to be fixed from time to time by the Surveyor General.

Scrip represents the right of the State of California to select an equal area of non-mineral government land of the United States in California in lieu of certain 16th and 36th sections or as indemnity for losses to the school land grant to the State. Scrip is not transferable.

Homestead and desert land entrymen can relinquish their entries through the Surveyor General's office and acquire title to the land by the purchase of scrip, provided the land is not withdrawn by the Federal Government for public purposes prior to the date the land is scripped and is not embraced in any other entry or filing. The applicant need not live on or improve the land.

A citizen of the United States or one who has filed his intention to become such, a resident of the State of California and of lawful age, is qualified to purchase 640 acres of scrip provided he has not entered that amount of State school land. State school land purchased at public auction from the Surveyor General will not be taken into account.

Scrip may be purchased at any time on and after August 17, 1923, at the office of the Surveyor General or through the mail. A person desiring to purchase scrip must file an affidavit with the Surveyor General showing that he is qualified to purchase State school land. Form for affidavit can be obtained from the Surveyor General.

Indemnity Certificates, scrip, will contain the number of acres, from 1 to 640, desired by the applicant, limited, though, to the amount the applicant is qualified to purchase.

Said certificates entitle the holders to have the United States land selected for them by surrendering the scrip to the Surveyor General and filing an application for the desired United States land under the provisions of Section 3495 of the Political Code, which is subject to the provisions of Section 3498 of the Political Code. The fee for filing the application is \$5.00 and the form for application can be obtained from the Surveyor General. The United States officials charge a fee of \$2.00 for EACH 160 acres or fraction selected, which fee must be paid to the Surveyor General by the applicant.

Township plats showing the Government lands of the United States that may be selected can be secured from the United States Land Office of the district in which the land is situated, the land offices being located in the following cities: Eureka, El Centro, Independence, Los Angeles, Sacramento, San Francisco, Susanville and Visalia.

The United States officials require a notice of the selection to be published in a newspaper published near the land and the fee for publication, amounting to approximately \$15.00, must be paid by the applicant and the applicant must, if requested, furnish certificates of the recorder of the county in which the scrip land described in the scrip certificate is located, that the said land to be offered to the United States in exchange for the United States land is unincumbered. The fee for each certificate, amounting to approximately \$5.00, must be paid by the applicant.

Upon payment of \$3.00 fee a certificate of purchase (which is prima facie evidence of title) can be issued in the name of the purchaser of the scrip for the land selected by him, at the expiration of ninety days from the date of filing his application, provided the selection of said land is accepted by the United States Land Office officials, but a patent for said land can not be issued under a minimum of fifteen months, and then only provided the selected land has been relinquished to the State of California by the United States. The fees for patents are \$5.00 plus \$1.00 for each 160 acres or fraction thereof.

One-sixteenth of all minerals in lands applied for is reserved to the State.

The grant of the selected lands will be subject to rights of way granted to the United States by an act of the Legislature, approved May 18, 1921 (Chapter 173, Statutes of California, 1921), for the uses prescribed in the act of Congress, approved June 17, 1902, relating to irrigation and reclamation, and a reservation in the people of the absolute right to fish thereupon as provided by Section 25 of Article 1 of the Constitution of the State of California.

The price of scrip is \$6.50 per acre.

The United States Land Office at Los Angeles advises that owing to pressure of current business it will not be able to furnish copies of township plats showing vacant lands, but that the books and maps are open for inspection to ascertain what lands are vacant or to make plats showing same.

CHAPTER 721.

An act to amend section 3498 of the Political Code, relating to approval of applications for state lands.

(Approved May 1, 1911; Stats. 1911, p. 1409.)

The people of the State of California, represented in senate and assembly, do enact as follows:

Section 1. Section 3498 of the Political Code is hereby amended so as to read as follows:

3498. All applications, under whatsoever act, filed in the office of the surveyor general, must be retained ninety days before approval. Before approval by the surveyor general, the applicant must appear before him in person, or before a deputy surveyor general, or before some person authorized to administer oaths, and designated by the surveyor general, at such time and place as he may fix, and answer, under oath, such interrogatories as may be put to him regarding his application, or the truth of the same, or any fact or circumstance connected therewith, and shall furnish such other or further evidence thereof as may be required by the surveyor general. The surveyor general shall mail to each applicant, addressed to the said applicant at the address given in the application, a letter or notice specifying the time and place of such hearing, which letter or notice shall be mailed at least ten days before such hearing. If it shall appear to the surveyor general that the application is made in good faith, and that all the facts stated in the application are true, and that the land applied for is subject to sale, he shall approve the application, otherwise he shall disapprove the same. All unapproved applications which have been on file over six months, wherein the applicant has not, before the expiration of said time, submitted himself for examination as above provided, and wherein proof has not been furnished as required by the surveyor general, or wherein a contest has not been referred to court or a demand made for an order of reference, as provided in section three thousand four hundred fourteen of the Political Code, shall be null and void; provided, however, that where applications are filed subject to the rights of a previous applicant, such subsequent applications shall not be approved until the rights of the first applicant shall have expired. No application shall be approved which describes land situated in more than one county, or land situated in

more than one United States land district. No application shall be approved by the surveyor general for any sixteenth or thirty-sixth section of school land belonging to the state which is situated within the exterior boundaries of a military, Indian or forest reservation created by authority of the United States, or of a national forest, national park or national monument, or within the exterior boundaries of lands withdrawn from public entry for forest purposes, or for swamp and overflowed land until the swamp and overflowed land is segregated by authority of the United States. Nothing herein contained shall be construed as a recognition that prior to the passage hereof, the said sixteenth or thirty-sixth sections, last above referred to, were offered for sale, or that applications therefor were to be approved or were subject to approval. The applicants in all applications filed but not approved, prior to the passage hereof, shall be allowed six months from the passage hereof within which to secure approvals under the provisions hereof.

SEC. 2. This act shall take effect immediately from and after its passage.
