Dear Mr. Marvel:

Having mislaid your address, I had some trouble getting it again. When I saw you in Princeton, I mentioned to you that we had some tentative plans of a conference to be held at the end of this month and the beginning of the next. In the meantime, we have abandoned these plans.

Within a few days, I should have a memorandum listing the considerations relating to the establishment of a "Citizens' Committee for Studying the Requirements of an Overall Settlement" which were submitted to the Emergency Committee at the Princeton meeting. At that meeting, the Emergency Committee decided to go ahead with the plans on the basis of these considerations, but the implementation of this decision is still under scrutiny by a subcommittee which we set up for that purpose. If I may, I shall let you know what progress we are making.
