This press conference is called by the African Liberation Support

Committee, Association of Black Attorneys, Baptist Ministers Union of

San Diego County and Vicinity, Black Federation, Committee on Chicano

Rights, NAACP, NIA Cultural Organization, Southeast Interdenominational

Ministerial Alliance, World Community of Islam in the West Masjid Muhammad #8 and People For Better Foods and Services: to announce the formation of the Coalition for Justice. One of the purposes of this coalition is the coordination of our collective efforts in our pursuit of justice in the murder of Tyrone Thomas.

We disagree with the findings of the District Attorney and Chief of Police in this matter as we believe their conclusion to be self-serving rather than reflecting unbiased objectivity.

The testimony of two eye-witnesses of the tragedy of May 30, 1978 contradicts much of what the police say occurred. (Example: Police report Officer Christensen had his baton in his left hand, revolver in his right and attempted to grab Tyrone by the Shoulder to keep him from fleeing; and because his left hand was losing it's grip, he decided to strike Tyrone with the revolver which was in his right hand. Both witnesses state Christensen had no baton and had full control of Tyrone by holding him by the waistband of his trousers in the small of his back with his left hand and holding the revolver in his right. Tyrone was seen to have both hands raised shoulder high and Christensen was heard to say several times 'Don't make me kill you")

Obviously someone is not telling the truth. During a meeting of the police, one of the witnesses and myself, the police requested the witness to take a polygraph to which I replied we would think about. When I was contacted by the police several days later for my reply, I stated if Christensen and Aguirre would submit to a polygraph by a qualified, independent Agency of my chosing, I would agree to the witness to undergo the same test under the same conditions. I was told they would get back to me. More than a week has passed and I have yet to hear from them.

The Firearms Policy of the San Diego Police Department #1.6 Administration, dated 7-11-77 states:

A. It is the policy of the San Diego Police Department that Officers shall use a firearm only as a last resort when it reasonably appears necessary:

1) To protect themselves from death or serious bodily injury, or:

2) To protect another officer or any other person from death or serious bodily injury, or;

3) To apprehend a fleeing felon believed to be armed with a deadly weapon for a felony involving great bodily injury or the threat of great bodily injury."

In the Pursuit Policy of the SDPD, Instruction

#1.12 Administration (revised 8-77) dated 11-9-77, Section C:

"Officers should not assume that all persons who flee from the police and refuse to yield are felons. Experience has shown that most pursuits involve misdemeanor violations only."

We believe Officer Christensen is in clear violation of these policies. We further believe the District Attorney and Chief of Police are aware of these violations, but are more concerned about potential civil ramifications than the criminality of this matter.

This coalition has called for a "Gathering of the Community" on Wednesday, evening, July 12, 1978, 7 p.m. at Christ Church of San Diego--3060 54th

Street to hear the facts available to us in this matter and to participate with us in a new genesis for progress throw cooperative efforts as we move together toward justice and the improvement of the well-being of our entire community.

This is not a rally, but the beginning of a spiritual, psychological, socialogical and economic metamorphosis of our community by our Community and for our Community.


On tomorrow evening this coalition will present a list of several demands to the community for information and later to the City Council for action.

Dear Community Organization:

This is an appeal to attend the morning session of the County Board of Supervisors meeting on February 6, 1979 to speak in opposition to County pension funds being invested in corporation with business holdings in South Africa.

Last August 1, 1978, with the exhortations of the Reinvestment Task Force and community groups, the County Board of Supervisors had the opportunity to divest County pension funds from companies with holdings in South Africa and to reinvest the monies in San Diego. However, the Board of Supervisors opted to continue investment in these companies but to request that the companies become signatories to Reverend Leon Sullivan's Principles for investments in South Africa.

The community organizations and the Reinvestment Task Force were opposed to the position taken by the Board of Supervisors for a variety of reasons including the facts that:

- 1. Compliance to Sullivan's Principles can not be realistically monitored by the County (Proof of this will be seen February 6, 1979);
- 2. Sullivan's Principles in full effect would only affect .4 of 1% of the Black work force in 350 corporations;
- 3. The South African Official Secrets Act prevents outside monitoring of U.S. corporate subsidiaries;
- 4. The Principles do not address the basic structure of Apartheid, nor do they challenge it; and

5. Companies who have proclaimed themselves signatories to the Principles have been caught in activities in opposition to their agreement. An example is Poloroid selling photographic equipment for the pass system.

On February 6, 1979 the Board of Supervisors will hear a report on the implementation of Sullivan's Principles in the companies in which the County pension funds have been invested. We hope you can attend this meeting to voice your concerns on the investment of County funds in corporations (whether or not they are signatories to Sullivan's Principles) with business operations in Apartheid, South Africa.

Enclosed you will also find an excerpt of the Treasurer's Report to the Board of Supervisors concerning South Africa.



While the legal constraint described above is sufficient reason for us to reject political considerations in investment decisions, there are other equally compelling reasons. The Task Force, in its report, provided a list of companies which do business in South Africa. Many of those companies also have operations in San Diego County, and contribute significantly to the local economy. If we accept disinvestment in South Africa and reinvestment in the local economy as objectives of our investment program, the conflict is apparent.

A decision must be made as to which one of these two social policies has priority over the other. Such a decision, because it is subjective and arbitrary, will not be satisfactory to all concerned. Whenever possible, the goals of public policy and investment policy should be clear and straightforward. The introduction of a disinvestment policy based on the actions of a foreign government needlessly over-complicates the public decision-making process.

The use of investment policy as the only focus of anti-apartheid action is very popular at this time. However, I suggest that your Board investigate other areas in which positive action might be taken. For example, the County's purchasing policy could be examined with a view to favoring those firms that have adopted the guidelines of the Sullivan principle.

This type of action, if taken by concerned groups everywhere, could, I believe, have a much greater effect than the lirection of investment dollars. At the same time, it is much less apt to face legal challenges.

As County Treasurer, I believe the implementation of the recommendations contained herein will provide the County of San Diego with the ability to continue our achievement of high interest earnings and growth in the local economy.


