

WE, THE UNDERSIGNED CITIZENS AND TAXPAYERS OF THE UNITED STATES OF AMERICA, DEMAND IMMEDIATE ACTION ON THE FOLLOWING:

LEGISLATION, WITH STRICT ENFORCEMENT, TO PREVENT FURTHER UNLAWFUL ENTRY OF ILLEGAL ALIENS INTO THIS COUNTRY, AND THAT THERE BE A RETURN TO A VERY LIMITED, STRICTLY ENFORCED, IMMIGRATION QUOTA SYSTEM;

THAT EXPENDITURE OF OUR TAX DOLLARS (INCLUDING, BUT NOT EXCLUSIVE OF, SOCIAL SECURITY, WELFARE, FOOD STAMPS, GIFTS, GRANTS, SCHOLARSHIPS, AND/OR SUPPORT OF ANY KIND) FOR THE BENEFIT OF ILLEGAL ALIENS CEASE DAMEDI-ATELY;

THAT ALL ILLEGAL ALIENS (INCLUDING, BUT NOT EXCLUSIVE OF, THE RECENT CUBAN INFLUX), WITHOUT EXCEPTION, BE IMMEDIATELY DEPORTED;

IMMEDIATE LEGISLATION, WITH FULL, COMPLETE, AND SWIFT ENFORCEMENT, TO FINE ANY COMPANY, CORPORATION, BUSINESS, AND/OR INDIVIDUAL NOT LESS THAN \$10,000 PER ALIEN EMPLOYEE, WITH EACH DAY OF EMPLOYMENT CONSIDERED A SEPARATE OFFENSE, TO STEM THE FLOW OF ILLEGAL ALIENS;

CEASE ISSUANCE OF SOCIAL SECURITY NUMBERS TO ALIENS, AND RECALL THOSE SOCIAL SECURITY CARDS ALREADY ISSUED TO ALIENS;

LIMIT FOREIGN STUDENTS TO FOUR (4) YEARS OF STUDY IN THIS COUNTRY, WITH NO SCHOLARSHIPS, GRANTS, ETC. AWARDED SUCH STUDENTS; ADMISSION ONLY UNDER QUOTA SYSTEM IN DIRECT RATIO TO A VERY LIMITED IMMIGRATION SYSTEM AND ONLY FROM COUNTRIES ON FRIENDLY TERMS WITH THE UNITED STATES; TO RETURN TO NATIVE COUNTRY FORTHWITH AT COMPLETION OF STUDIES;

LEGISLATION TO STOP RUNAWAY COMPANIES FROM MOVING OUTSIDE THE UNITED STATES, THUS TAKING AWAY AMERICAN JOBS, AND/OR APPLICATION OF HIGH IMPORT TARIFF ON THE PRODUCTS OF RUNAWAY COMPANIES TO DISCOURAGE THE IMPORT THEREOF.

## PETITION

WE, THE UNDERSIGNED CITIZEN TAXPAYERS OF THE UNITED STATES OF AMERICA, DEMAND LEGISLATION TO EFFECTUATE, PRIOR TO THE NOVEMBER 1980 ELECTION, THE FOLLOWING:

- 1. EXPUNGEMENT OF ENTIRE PRESENT GRADUATED TAX SYSTEM; TAX EVERY PERSON (WHETHER ON WELFARE, IN LOW, MEDIAN, HIGH, OR STRATOSPHERICAL INCOME LEVELS) AND EVERY BUSINESS, COMPANY, CORPORATION, ETC., AT A STRAIGHT PERCENTAGE ON EVERY DOLLAR INCOME ACROSS-THE-BOARD, WITH NO EXCEPTIONS, LOOPHOLES, AND/OR ABATEMENT, THEREEY TAXING ALL AT THEIR FAIR SHARE IN RELATION TO BENEFITS RECEIVED AND IN ACCORDANCE WITH INCOME AND ABILITY TO PAY, THUS RELIEVING THE MIDDLE-INCOME TAXPAYER FROM CARRYING THE MAJOR PART OF THE TAX BURDEN; RESULT: LOWER PERCENTAGE TAX RATE;
- 2. CONFINE PERCENTAGE OF ACROSS-THE-BOARD INCOME TAX ABOVE TO THAT NECESSARY TO MAINTAIN A BALANCED BUDGET;
- 3. REQUIRE ALL GOVERNMENTS (FEDERAL THROUGH LOCAL GOVERNMENTS) TO MAINTAIN BALANCED BUDGETS; TO REDUCE RATHER THAN CONSTANTLY EXPAND GOVERNMENT; TO WITHDRAW GOVERN-MENT REGULATIONS AND INTERVENTION IN PRODUCTION OF GOODS AND SERVICES BY PRIVATE INDUSTRY, SUCH AS ENERGY-RELATED BUSINESSES, WHICH CAUSE INCREASED PRICES AND NEGATE COMPETITION IN THE MARKET PLACE;
- 4. WITH EXCEPTION OF AGED, DISABLED, AND CHILDREN UNDER AGE OF 16, REQUIRE EVERY EVERY WELFARE RECIPIENT, AS A PREREQUISITE FOR RECEIVING WELFARE BENEFITS, TO WORK FORTY (40) HOURS PER WEEK, WITH A MAXIMUM OF SIX (6) MONTHS' WELFARE BENEFITS, DURING WHICH TIME THEY SHALL MAKE A DILIGENT EFFORT (WITH PROOF THEREOF) TO OBTAIN REGULAR EMPLOYMENT;
- 5. CHANGE SOCIAL SECURITY TAX TO STRAIGHT PERCENTAGE OF EVERY DOLLAR INCOME, THEREBY EFFECTING A REDUCTION IN THE PERCENTAGE RATE, WITH ALL WORKERS, INCLUDING GOVERN-MENT EMPLOYEES, REQUIRED TO PAY INTO SOCIAL SECURITY REGARDLESS OF ELIGIBILITY FOR ANY OTHER PENSION OR RETIREMENT FUND;
- 6. CEASE ALL GIFTS, GRANTS, GIVE-AWAYS, EXPORTS OF FREE FOOD AND MEDICINES, NUCLEAR MATERIALS AND TECHNOLOGY TO UNFRIENDLY FOREIGN NATIONS AND/OR HEADS OF FOREIGN GOVERNMENTS AND, IN PARTICULAR, FOREIGN AID TO OIL-RICH NATIONS WHICH ARE BLEEDING THIS COUNTRY FOR OIL. WE CANNOT BUY FRIENDS; WE MERELY BREED THEIR CONTEMPT.
