After consideration of your problem, I am willing to deed you the additional 45 feet on the west to approximately the power line as shown on your map. The north boundary to be the south line of the road and your east line 25 feet east of your present east line, extending from road to road. The price to be \$2000, payable \$200 down, \$200 a year for 5 years, and the 6th year \$1000; interest 7% on deferred payments, payable quarterly.

You may pay any amount at any time, thereby stopping interest. A condition of the agreement is that for a period of 25 years not to exceed two houses shall be built on the property; that the land be used only for residential purposes; the usual conditions put in all Grossmont deeds to apply, and you agree within a year to rock-face the garage, at least on its south and west exposures in a manner similar to what you have done on your house on its south exposure.
