Dear Sir:

I have been asked by some of the resident property owners at Rancho Santa Fe to submit to you a petition for your consideration calling for the redistricting of the Santa Fe Irrigation District. The district at present is divided into three zones or precincts and there are three directors, one representing each district. The directors are elected by the voters at large. Those circulating this petition are desirous of creating five precincts and a board of five directors, each director to be elected by the voters resident within the precinct from which he is to be chosen. It is planned to have three of the precincts within the boundaries of Rancho Santa Fe and two of the precincts outside of the boundaries of Rancho Santa Fe. At present, as you know, two of the precincts are in Rancho Santa Fe and one comprises all the properties in the district but outside of the boundaries of Rancho Santa Fe.

It is believed by those who are circulating the petition that five directors will be a better number than three and that the interests of the various precincts will be best served if they are represented by men who are unmistakably the choice of the people resident within that precinct.

If this plan is acceptable to you please sign the petition and forward direct to the Board of Directors of the Santa Fe Irrigation District.

Gentlemen:

The undersigned, whose names are hereunto subscribed, representing a majority of the holders of title and/or evidence of title to the lands within the exterior boundaries of the Santa Fe Irrigation District and representing a majority in value of all the lands within said District as shown by the assessment roll and also representing a majority of the actual value of said lands, do for the purpose of conferring upon the Board of Directors jurisdiction to make the changes herein petitioned for, respectfully represent and pray that the Board of Directors make its order, as provided by the California Irrigation District Act, increasing the number of Directors from three (3) to five (5), and in such order provide that each of said five (5) Directors shall be elected by the electors in each division separately and not by the vote of the electors of the District at large, so that each of said five (5) divisions shall be separately represented on said Board of Directors for the purpose of conducting the business and affairs of said District.

Your petitioners further pray that upon the making of said order herein prayed for the Board of Directors forth-with redivide said District into five (5) divisions corresponding to the number of Directors specified in said order.

Honorable Board of Directors of said District to take every act and to do every thing necessary in the premises as provided by law to increase the number of Directors of said Santa Fe Irrigation District from three (3) to five (5) and to redivide said District into five (5) separate divisions to the end that each of said five (5) divisions shall be separately represented by a Director on the Board of Directors which has in charge the management of the affairs of said Santa Fe Irrigation District.

My dear Mr. Nelson:

Regarding your telephone inquiry as to whether the State or County has or has not a right-of-way for a cut-off north of Solana Beach and west of the Santa Fe Reilroad, will say I am of the opinion the State on County have never acquired by deed or easement a right-of-way, but arbitrarily went shead and built it.

The Whitneys and Henshaws were at loggerheads at the time. I told Mr. Cortelyou when he applied for an easement for right-of-way that the matter would have to be taken up with the Henshaw people, and they in turn with the Whitneys.

I represented the Whitneys at the time and feel they would have taken the matter up with me before filing any essement, but perhaps this was an exception.

My suggestion is that you file with either Title Company, the survey made by Mr. King of the State highway recently built and ask them to give you a written opinion as to whether or not any easement has ever been granted and put on record. It should not cost over \$25 to make this search. If what I predict is true, you will get a letter from the Title Company stating that no such easement was over granted or at least not recorded. You are then in position to take the matter up direct with the California Highway Commission. It is my understanding that you are planning to make a permanent change of the location of that highway.

If I can be of any service in helping you, don't hesitate to call on me. I will have as my guest, Mr. B. B. Meek, Director of Public Works, State of California, also the Highway Commission of California for three days the first part of July. We are going into Mexico on a fishing trip, and I can take this matter up with them personally at that time, if it is your desire. They are all good scouts and friends of mine. I can arrange to show them on the ground just what your desires are. The fact is I can set a definite date and hour now when they will all be there, about 11 or 12 o'clock Sunday the 30th of June. Sunday afternoon we are leaving for Ensenada.
