Dear Mr. Szilard,

Please forgive my not having replied earlier to your letter of December 10th last with the accompanying draft recommending a policy of semi-neutrality for European countries. I was out of the country when the letter arrived, ski-ing in Switzerland. Unfortunately I sustained an injury which made my absence longer than I intended it to be, with the result that I have had much catching-up to do since my return.

I have read the draft with great interest. With much of the analysis I find myself in agreement, but I'm afraid I cannot bring myself to accept the recommendation of semi-neutrality. I agree that in the hands of a single European country or for any foreseeable time in the hands of any combination of European countries an independent deterrent can only be used as the sting of a bee. It might be effective in promoting security, but it might very well not, and it is this very uncertainty which drives one to a pooling with the U.S., despite the dangers that this brings with it. This may be a *démodé* approach, but I cannot get away from it. There is one thought which your draft brings out very clearly and for which I am very indebted to it - namely, the close inter-dependence of policy outside Europe and policy inside Europe, and the total failure of present arrangements to cope with this inter-dependence.
