Dear Colonel Ed:-

Upon my return from a trip a few minutes ago, I found in my private mail your several letters of the 12th, 13th and 14th with copies of letter to Mr. S. E. Lambert, etc.

I recall clearly the circumstances which caused me to reserve in your name 350 shares. I had talked to Mr. Stern about becoming interested in the syndicate but not as to the extent or number of shares. You subsequently authorized me to reserve for yourself the 150 shares which accrued to you because of your sales' commission and 100 for Frank Stern and also that you had spoken to both Mr. Thompson and Mr. Anderson about each taking 50 shares. As a result of which I reserved for your account 350 shares out of the 4,000 shares available, because at that time there was an over subscription and some of the other subscribers were cut down proportionately to accommodate this reservation.

I am not a lawyer and, unfortunately, I did not realize that the subscription blank was anything but an indication of the number of shares that each of us were willing to take when ready for delivery. But, unfortunately, Mr. Castle filed this subscription agreement with the Corporation Commissioner, and it now appears necessary to clear it up based on the merits of the situation. Your recitation of the facts to Mr. S. E. Lambert are substantially correct. Such changes that I would make in the phraseology of that letter would not effect the situation in any way and I have clearly recited that to the full board of directors on a number of previous occasions. This, then, can simply be a matter of clearing up the situation as it was intended to be and with the facts properly presented, I can not see where there is any liability involved on the part of anybody in connection with this subscription.

As a matter of fact, at the time this subscription list was made up in Mr. Castle's office, I communicated with you over the long distance telephone for the purpose of ascertaining

just how many shares you had arranged with Mr. Stern and Messrs. Thompson and Anderson to take, and you then stated that they had indicated their willingness to take their amounts previously discussed, but in your name, making your total subscription 350 shares, with the distinct understanding that you represented, in this matter, three other persons who were named at the time and who for personal reasons did not want to appear in the situation. For your further information, I subsequently called on Messrs. Anderson and Thompson and they both stated that it was against the policy of the institution they were affiliated with to participate in land syndicates and, hence, they would not be interested.

I am sending a copy of this letter to Mr. S. E. Lambert and expressing the personal opinion that the circumstances are such that except for clearing up the legal side of the situation as it may be required under the law, there should be no further liability as far as any individual is concerned.
