



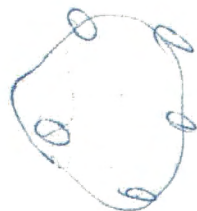

My associate also sent me a copy of the original application and a copy of the amendment as submitted.


Finally, you will find enclosed herewith my bill for obtaining these papers.
