Dear Mr. Davis:-

We have at last decided what we are going to do about the measuring of water in the Hodges Conduit about which we were talking when you were in San Diego. For the present we will try to get along with one gaging station and will require one No. 633 Gurley Graphic Water Stage Register.

Our maximum vertical range will be 3 feet and the time scale should be arranged to cover seven days. This meter is quoted in the Gurley catalogue at \$90.

The telegram I had from W. J. Rankin, Jr., quoted \$103 as I understand, delivered here. It seems to me this is a rather big boost over the \$90 price for delivery to San Diego and I hope you can get a better price for me. This should be billed to the San Dieguito Entual Water Co.

Kindly let me know how long it will take to get the meter to San Diego. There is no special rush as we have not started to build our concrete station yet.

I was very much surprised to receive a letter from Frederick Post Company regarding the Gurley Graphic Water Stage Registor which I ordered from you. The letter was signed by V.O.Post. It states that the Gurley people in Scattle have shipped a No. 633 Register, but with a 10 ft. range instead of a 3 ft. range as per my order.


I do not see how we can use this 10 ft. range. As I understand it, the only difference in the register of different ranges is in the gearing. For example, in a 10 ft. Range register, the drum carrying the chart is revolved one full revolution by a change of 10 ft. in the elevation of the float. In a 3 ft. range register, the drum will make one complete revolution by a change of 3 rt. in the elevation of the float. Thus you will see in the case of the 3 ft. register, slight fluctuations will be magnified to a much greater extent and will be much more easily read.

As we wish this register for use on the concrete lined canal which has to be rated with extreme care, you will see that we will want the fluctuations to be recorded with as great accuracy as is possible. It should not take more than 4 or 5 weeks, it seems to mo, to get a different set of gears and this will give us a meter in ample time.

Will you kindly take this matter up with the Gurley people and let me hear from you.

My dear Mr. Davis:---

This morning we unpacked the Gurley Water Stage Register we purchased from you, proparatory to sending it out on a job and to enable us to install the new set of gears which you sont us, bafore sending it into the field and to my surprise I find that it is not the Gurloy Register 633, which was purchased. The latest catalog does not show the register sent us at all, but it is shown in a monuel of Gurley's Hydraulic Engineering Instruments, page 129, in which the No. 634 Gurley Graphic Registor is shown installed in a sewer in Newark, N.J. It is evident that the Gurley factory has substituted the old Register 634, which, accorde ing to thoir new catalog they are no longor manufacturing. The goars which you sent for the new No. 633 Register are endutty all right, but will not fit on this old No. 634.

Sinco we have paid the advance price they demanded, of \$1.03. which is \$13 more than their newost catalog price on No. 633. I feel that we ought to get the instrument we bought. The old instrument is probably a good one, but the 655 is evidently an improvement or they would not have changed the design. On the new instrument the recording sheet is much more accessible.

I will not ship the instrument until I hear from you, as I do not know whether it would be best to ship the instrument to you or direct to the Gurley factory.

I hope you will force the issue on this proposition for me and get the thing straightened out and see that we get the proper meter at the earliest moment. I am sorry to bother you with this but we all like to get what we pay for especially when we pay an advance over the list price without argument. I am porfectly willing to keep the old meter provided they make a reduction in price and furnich gears 5 to 1 instead of 10 to 1, as our original crdor called for.

On June 26, 1919, I wrote you ordering a Gurley Graphic Water Stage Register, giving catalog number and very explicit directions as to the range of the instrument.

On July 2d, I received a letter from the Frederick Post Company telling no that the Garley branch factory at Seattle had made a direct shipment of this meter on June 30th, but that Gurley had informed them that they had shipped a 10-foot range instead of the three-foot range, as specified in the order.

On July 7th, I wrote you telling you we could not use the 10-foot range.

On August 19th, I received a letter from you telling me that a set of gears were being shipped from Gurloy.


On Soptember 25th, when we tried to install those gears, we found that they would not fit the instrument, as the water stage register which we had received was not the one illustrated as No. 633 in the catalog. I wrote you on this date explaining the situation and since then, in spite of a Long Distance call, I have heard nothing from you offering any rolief. Is this fair? The time is now at hand when we must measure our water. The instrument we have is absolutely useless to us and I have depended on you to make good. It does not seem to me that you are taking the proper interest in this matter. Can you not, in some way, strain a point and try to make good?
