The Case having been shipped at Leghorn in good condition & with the greatest Care we trust the Paintings will reach you without injury.

Respecting the Copy of the Purchase by Mr. Marchi informs us that it is in a state

of progress, therefore when finished, you may depend
on its being forwarded without delay.

We have not lost sight of your
claim for the loss of your Carriage & we have the
satisfaction to acquaint you that all the effects of
the liable person to receive payments, or for execution
of by appeal; the Post here has effected in accompa-
nied by an order to bring the affair to a prompt
conclusion, we therefore have reason to hope that
shortly we shall have it in our power to apprise
you of the sum we may receive.
