He had a contract to pay \$148 for a griddle iron on which he paid \$29.50. It was not anything that the Inn needed and was not fitted for the business. What we need in exchange is a different kind of a griddle iron that can be bought for \$60 or \$60.

I authorized your Oceanside agent to take back the griddle iron. It has only been in four or five months, as I understand it. I have never seen the contract!

I have now taken over the management of the Inn, put in my own manager and will pay cash for a small and much more economical size griddle iron. Would you kindly authorize your Oceanside representative to adjust this matter amicably.

Why I write is because I have received a telephone call from your Oceanside office saying that they were going to take out both the waffle iron and griddle iron if not paid for this afternoon. I Believe there must be some mistake in the matter.

I have sent a check to pay in full for the waffle iron and would like to make some equable arrangement

in the matter of the griddle iron that is fair to all parties in interest.

Please keep in mind that the creditors are going to lose three or four thousand dollars in this deal and we are trying to get out the best way we can.

I am sure you will play the game.

In answer to your letter of the 6th, I am returning the enclosures referred to.

You have asked me as to how you should answer. The Club has just closed its fiscal year and we are reorganizing for the coming year. If you do not already know it, I want to mention the fact that we failed to get our appropriation from the City for the coming year. This cuts off some \$10,000 from our funds. We were counting upon getting this appropriation. Without some assistance from the City it is going to be difficult to raise enough money to do our regular, routine work, which as you know was well organized last year, and we believe was effectively executed. Personally, I do not see how we can make large contributions and run motorcades and entertain motorcades. Our highway funds will all be exhausted and more, after we entertain the Florida crowd in October. I doubt that we can organize a large motorcade for the Broadway of America this year. If a substantial contribution is to be made to the Broadway of America Association I am inclined to believe that it will have to be raised outside of the Club. Perhaps it can be done just by a few fellows such as yourself and some of those public spirited men that always support you. I would be willing to make an additional contribution. However, Mr. Birney would have to be satisfied with a small amount.

Now, Colonel, all of this may not sound very good to a man who is usually as optimistic as you are, but the funds raised by our Club are limited and we are called upon to do a big job. In other words, we are trying to do a \$100,000 job for \$40,000. Hence, I have got to sit on the lid at times at the risk of being called pessimistic and a conservative. However, I will say that we are not leaving a big deficit this year to pass on to the new Board.

On behalf of the Club I want to again express to you our appreciation for the assistance that you have rendered our Highway Committee during the past year, and I trust that we may continue to count on you for the coming year.

In reply to your letter of November 9 the control of San Diego Gas & Electric Company common stock is owned by Standard Gas & Electric Company and not by Byllesby & Company.

In order to comply with the Public Utility Holding Company Act of 1935, Standard Gas & Electric Company offered to its note and debenture holders, San Diego common stock for Standard notes. The first offer expired September 30, 1940; this date was extended to October 30 and again to November 30. They did not receive a sufficient number on this exchange to make the plan effective. In other words, the plan is not effective and Standard Gas still owns control of the common stock of the San Diego Gas & Electric Company.

Please do not get the above confused with the exchange of our new 5% preferred stock for the old 7% preferred stock and the sale of the 5% preferred stock not so exchanged. The exchange and the sale was a success and this plan was completed.
