this on the instructions of Mr. Henshaw.


There is no longer any necessity of having







All that portion of Rancho Valle de San Jose lying south of that portion of the County Highway between Stations 147 + 53.69 and 251 + 87.70 as the said Highway is shown and delineated upon the Map of San Diego County Highway Commission, Route 18, Division 5, between La Jolla Amago and Moretti's, containing 194 acres, more or less.

In reply to your letter of October 7th:

Not having heard from you in regard to the pipe line on the Los Coyotes Reservation, I had a survey made of both the pipe line and that portion of the boundary of the Reservation and find that the pipe line is not on the Reservation at all.

I enclose herewith a print showing our survey which was very carefully made. The original government corners were found at the center of Section 30 and at the Northeast corner of Lot 3 of Section 30 as well as at the Northwest corner of said Lot 3.

This being the case, I presume it is unnecessary to do anything further.
