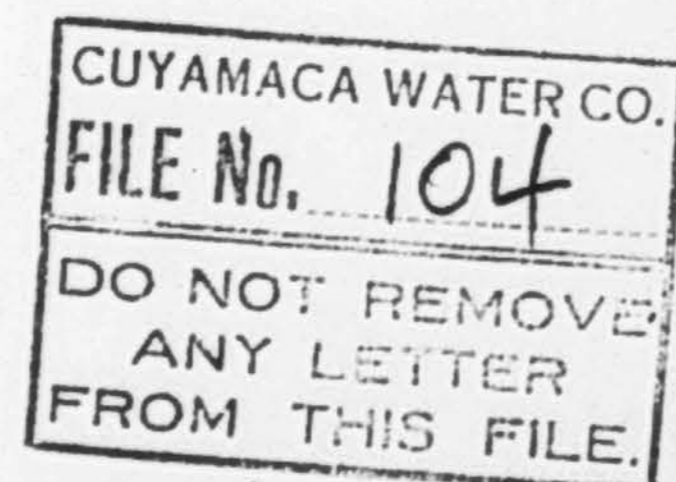
Answering your letter of August 11th, 1915,

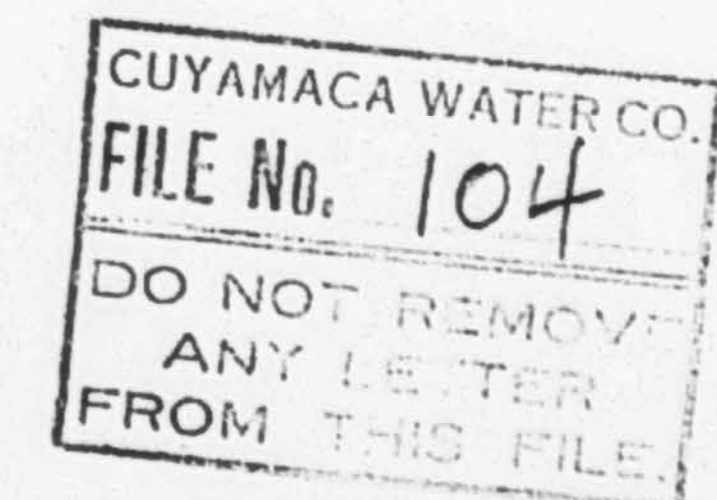
