My dear Colonel Fletcher:,

Your letter, containing the suggestion for an advertisement in the Los Angeles and San Francisco papers, concerning sale of the California Hot Springs, came while I was in the North with Helen, so it is somewhat late for me to be thanking you for what you have done for me.

I have not as yet put the advertisement in the papers, but shall' do so probably next week.

We have had a rather busy time over the holidays, though, as usual, the people left more or less in a company and the place seems quite deserted now. However, we still have a good many people in the cottages and more coming in. The weather is delightful at the 'Springs, - to me it is much finer than in the summer when the heat is so great, and I always think it is such a pity that people have to leave before the really pleasant weather begins.

I certainly appreciate your doing this for me, and I only hope that your client will think favorably of the place, if he can be induced to come up and look it over.


