### My dear Governor:

Under separate cover, I am sending you a copy of my Memoirs to the Children. It covers a lifetime of experience from the horse and buggy days to the atomic bomb, my personal contacts with five Presidents, the local water and land development and my connection with State and National highway activities. I was five years on the State Park Commission, twelve years in the State Senate, five years on the County Highway Commission and have done my part in public work, the result of which the people of San Diego put a lovely granite memorial in the public plaza in San Diego, opposite the Grant Hotel for my National highway work, etc.

I give you the above explanation for a particular reason.

Mrs. Fletcher and I are going to the Mediterranean and up into
the Northern countries of Europe, leaving on the 7th of May from
New York by boat. We are also going to Lisbon, Portugal as well.

One of my lively incidents with Governor Olsen was in connection with the Cabrillo Statue, now in the Cabrillo National Park on Point Loma. Governor Olsen accused me publicly of stealing the statue and putting it on Point Loma, where Cabrillo originally first landed in California. The statue is valued at \$50,000 and was donated by Portugal through its president, to California.

Commencing at page 418 of my Memoirs through page 431, inclusive, is a history of our experience, and I wish you would please take the time to read it. To the best of my knowledge, neither the Federal Government, the State of California or the City of San Diego have done anything in acknowledging the statue and thanking the government of Portugal, and particuarly the sculptor who created the Cabrillo statue - Alv. deBree.

Mayor Butler is arranging for a suitable plaque to present to the president of Portugal, as I understand it; also a letter of appreciation to deBree the sculptor, which I am taking with me on our trip to Portugal. If nothing more, I would like a letter to the president and a letter to deBree with the seal of California to present personally, representing the State of California.

Kindly let me know if you, as Governor of California, can write these two letters of appreciation, or you may have some other way you would like to express the appreciation of the State.


