RESOLUTION NO. 37173

WHEREAS, The City of San Diego is involved in litigation over the title to the waters of the San Diego River; and

WHEREAS, this Common Council is of the opinion that said litigation should be continued until a final determination is reached in the Supreme Court of the State of California, so as to determine for all time the rights of the City with respect to the waters of said river, although this Common Council is of the further opinion that the best interests of the City will be subserved by continuing in use certain portions of the waters of the river as they have heretofore been used beneficially; and

WHEREAS, this Common Council has been urged to compromise this litigation in order to provide for the immediate development of the waters of said river; and

WHEREAS, this Common Council is desirous of providing for such immediate development and securing additional water for the needs of this municipality and the inhabitants thereof, and at the same time of protecting the interests of the people of this City and of adjacent communities; and

WHEREAS, this Common Council is also of the opinion that if the right of the people of San Diego can be protected and the immediate development of the river accomplished by a compromise of the controversy now existing between the City and the defendant in the above mentioned litigation, that then a compromise would be advisable, NOW, THEREFORE,

BE IT RESOLVED By the Common Council of The City of San Diego, as follows:

That the Common Council of The City of San Diego is willing to enter into negotiations for the compromise of the controversy involving the use of the waters of the San Diego River with the Cuyamaca Water Company and the La Mesa, Lemon Grove and Spring Valley Irrigation District, upon the following conditions:

(1) That the litigation now pending between The City of San Diego and the Cuyamaca Water Company, Ed Fletcher, and the La Mesa, Lemon Grove & Spring Valley Irrigation District be continued until a decision is reached in the Supreme Court of the State of California.

- (2) That possession of the El Capitan Damsite be surrendered to The City of San Diego immediately, the price for said
 dam site to be fixed later either by the condemnation suit existing in Orange County, or by arbitration between the parties themselves.
- (3) A fair and equitable division of the waters of the San Diego River.

BE IT FURTHER RESOLVED that the City Clerk be, and he is hereby authorized and directed to send a certified copy of this resolution to the Cuyamaca Water Company, Ed Fletcher and the La Mesa, Lemon Grove and Spring Valley Irrigation District.

Acknowledging the receipt of your letter of the 11th inst., relative to 32nd and B streets, will state that we have no proceeding under way on either of these streets within the bounds you specify.

We find that back in 1926 a petition was presented by property owners for the grading, sidewalking and curbing of 32nd street, between B and F, and of B street, between 32nd street and the end of the pavement then in. The engineer's office reported on this petition that it was signed by but 22% of the property and recommended that a majority petition, at least, be required before plans were ordered. This suggestion was never followed by the interested owners, however. There is a pencil notation on the petition which would indicate that it had been handed to you by Charles Crouch for signature, but your name does not appear on it.
