another hearing, and your services will <sup>be</sup> paid for at that time.

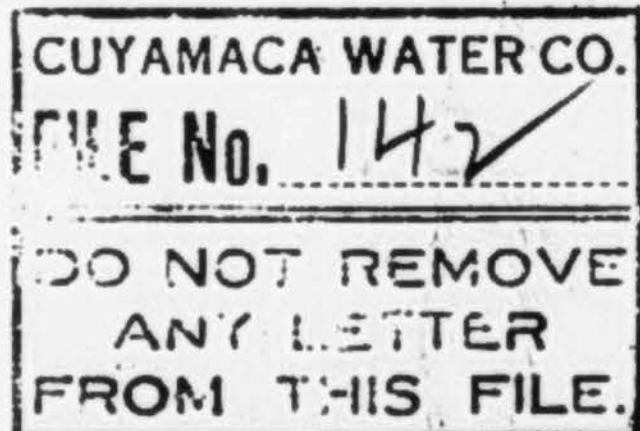
