Colonel Fletcher:

In my opinion, the only way to renew this thing, so far as getting the San Pasqual people to accept is to go carefully over the previous price, then put down what the city should and can pay, along with such conditions as the city thinks is fair and liberal, and then definitely submit these conditions and prices for their acceptance or rejection, instead of asking them what they are willing to do.

The following is what I think the city should pay and what I think the people will ultimately accept, however, at this time I can only approximate. I have not a list of the old prices at hand. They can be had later if these figures at all appeal to the city.

Starting from the East end of the San Pasqual Valley, I have taken up all the riparian owners in the San Pasqual Valley as follows:

Dear Col. Fletcher:

In consideration of \$1 and other considerations, the receipt of which is hereby acknowledged, we give you or your assigns, an option for one year from date to purchase certain water rights as it affects the 117 acres which we own in Sections 35 and 36, Township 12, 1 West, S.B.M., all as per legal description of agreement made with the City of San Diego for the purchase of same, the consideration to us to be \$17,500 cash.

We agree as follows:

- 1. To transfer all riparian and all water rights.
- 2. Give to you the right to divert the San Pazqual river water from the water shed by means of dams, pumping or otherwise.
- 3. An agreement to execute agreements or deeds of conveyance of some kind to the above containing words of conveyance approved by the City of San Diego. The final contract to be approved by the city attorney of the City of San Diego.
- 4. We reserve the right, when the water is available, to divert by gravity or pumping, water for use upon the lands included in this option, not to exceed normal use for domestic and irrigation purposes.

We agree to put all papers in escrow when the money is placed in any bank in San Diego and will pay for the continuation of the certificate of title, which the City of San Diego now has in its possession, showing the property will be free and clear of encumbrance at the time the money is paid and the agreements go on record.

I called on Hervey Johnson and his attitude seems to prevent any further consideration on the San Pasqual water rights. I have asked him to wait a week before making any report and I am asking you to write me fully what you think about it.

Johnson's opposition, so it is either to try to work out a plan with him that we can accept or else leave it entirely alone. He wants to put all the rightsout there at \$150,000, but I say to you that none of us will touch it under \$200,000. We might be able to get Hervey to come up \$50,000 but not another cent, so do you think we can do anything on the basis of \$200,000. That would make my rights about \$10,000 instead of \$17,500.00.

We are in desperate need of money and I will do most enything to see this thing go over. Will you reply to me as soon as possible on this subject.

My dear Chris:

Thanks for your letter of the 7th. Just let things ride. I can handle Johnson, I believe, as well as anybody. There will have to be some compromise and in a week or two I may fly down and spend a couple of days, trying to solve the problem with Johnson and the City, but I know I am making headway.

Would you take \$10,000 instead of \$17,500? If I could get a letter from you to that effect it would help me and I would go down the line, get the others to do likewise, and make the best showing possible. Don't do any talking on thesisde but write me a letter and tell me that, if the rest of the property owners will do likewise, you will take \$10,000 for your rights. I will never submit it to the City Council without your approval but it will help me get things started without loss of time and be a preliminary to my writing a letter to the 24 land owners that I represent, and will give me a chance to get their reaction.

You can mention the recent decision of the Supreme Court which changes the situation completely in your letter to me as the reason for your change in price. I know and you know that, irrespective of that decision, you have valuable rights to the complete use of all the water you need for your own lands, but I question whether you have very much else if the City wants to go ahead independently.

I am thoroughly satisfied that, with the building of Sutherland Dam, your underground water supply will not be affected. Probably your gravity supply would, but the dam ge you would get from the Court would be nominal because it would only be for the cost of pumping as against the loss perhaps of some of the gravity flow as compared to your normal supply.
