The undersigned, certifying upon information and belief, complains that in the County of San Diego, State of California, the Defendant(s) did commit the following crime(s):

COUNT - 1 FORCIBLE LEWD ACT UPON CHILD

On and between September 1, 1991 and October 15, 1991 [REDACTED] did willfully and lewdly commit a lewd and lascivious act upon and with the body and parts and members thereof of [REDACTED], a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) and the victim and did commit said act by use of force, violence, duress, menace, and fear of immediate and unlawful bodily injury on the victim or another person, (to wit: Defendant touched Victim's buttocks with his penis.), in violation of PENAL CODE SECTION 288(b).

COUNT - 2 FORCIBLE LEWD ACT UPON CHILD

On and between September 1, 1991 and October 15, 1991 [REDACTED] did willfully and lewdly commit a lewd and lascivious act upon and with the body and parts and members thereof of [REDACTED], a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) and the victim and did commit said act by use of force, violence, duress, menace, and fear of immediate and unlawful bodily injury on the victim or another person, (to wit: Defendant touched Victim's buttocks with his hand.), in violation of PENAL CODE SECTION 288(b).

COUNT - 3 LEWD ACT UPON A CHILD

On and between August 15, 1991 and September 15, 1991 [REDACTED] did willfully and lewdly commit a lewd and lascivious act upon and with the body and parts and members thereof of [REDACTED], a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) and the victim (Defendant inserted his penis into Victim's anus in the tunnel.), in violation of PENAL CODE SECTION 288(a).

And, it is further alleged [REDACTED] did have substantial sexual conduct with [REDACTED], a child under 11 years of age, in the commission of the above described felony of Lewd Acts On A Child, within the meaning of Penal Code section 1203.066(a)(8).

COUNT - 4 LEWD ACT UPON A CHILD

On and between August 15, 1991 and September 15, 1991 [REDACTED] did willfully and lewdly commit a lewd and lascivious act upon and with the body and parts and members thereof of [REDACTED], a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) and the victim (Defendant touched Victim's penis with his hand.), in violation of PENAL CODE SECTION 288(a).

And, it is further alleged [REDACTED] did have substantial sexual conduct with [REDACTED], a child under 11 years of age, in the commission of the above described felony of Lewd Acts On A Child, within the meaning of Penal Code section 1203.066(a)(8).

COUNT - 5 LEWD ACT UPON A CHILD

On and between August 15, 1991 and September 15, 1991 [REDACTED] did willfully and lewdly commit a lewd and lascivious act upon and with the body and parts and members thereof of [REDACTED], a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) and the victim (Defendant kissed Victim's buttocks in the tunnel.), in violation of PENAL CODE SECTION 288(a).

COUNT - 6 LEWD ACT UPON A CHILD

On and between September 1, 1991 and October 15, 1991 [REDACTED] did willfully and lewdly commit a lewd and lascivious act upon and with the body and parts and members thereof of [REDACTED], a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) and the victim (Defendant inserted his penis into Victim's anus in Defendant's apartment.), in violation of PENAL CODE SECTION 288(a).

And, it is further alleged [REDACTED] did have substantial sexual conduct with [REDACTED], a child under 11 years of age, in the commission of the above described felony of Lewd Acts On A Child, within the meaning of Penal Code section 1203.066(a)(8).

COUNT - 7 LEWD ACT UPON A CHILD

On and between September 1, 1991 and October 15, 1991 [REDACTED] did willfully and lewdly commit a lewd and lascivious act upon and with the body and parts and members thereof of [REDACTED], a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) and the victim (Defendant kissed Victim's buttocks in Defendant's apartment.), in violation of PENAL CODE SECTION 288(a).

COUNT - 8 LEWD ACT UPON A CHILD

On and between September 1, 1991 and November 30, 1991 [REDACTED] did willfully and lewdly commit a lewd and lascivious act upon and with the body and parts and members thereof of [REDACTED], a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) and the victim, in violation of PENAL CODE SECTION 288(a).

And, it is further alleged [REDACTED] did have substantial sexual conduct with [REDACTED], a child under 11 years of age, in the commission of the above described felony of Lewd Acts On A Child, within the meaning of Penal Code section 1203.066(a)(8).

COUNT - 9 HARMFUL MATTER SENT WITH INTENT OF SEDUCTION OF MINOR

On and between August 15, 1991 and September 15, 1991 [REDACTED] did, knowing a person was a minor and failing to exercise reasonable care to ascertain the true age of said minor, knowingly distributed, sent, caused to be sent, exhibited, offered to distribute and exhibit by any means, harmful matter as defined in Penal Code section 313 to a minor with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of that person and of the minor, and with the intent and purpose of seducing the minor, in violation of PENAL CODE SECTION 288.2(a). (Victim: [REDACTED])

COUNT -10 HARMFUL MATTER SENT WITH INTENT OF SEDUCTION OF MINOR

On and between August 15, 1991 and September 15, 1991 [REDACTED] did, knowing a person was a minor and failing to exercise reasonable care to ascertain the true age of said minor, knowingly distributed, sent, caused to be sent, exhibited, offered to distribute and exhibit by any means, harmful matter as defined in Penal Code section 313 to a minor with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of that person and of the minor, and with the intent and purpose of seducing the minor, in violation of PENAL CODE SECTION 288.2(a). COUNT -13 CHILD MOLESTING

On and between October 1, 1991 and December 20, 1991
[REDACTED] did willfully and unlawfully annoy and molest [REDACTED], a child under the age of eighteen years, in violation of PENAL CODE SECTION 647.6.

- 1) Known suspect and victims engage in a verbal conversation and during the conversation, the suspect lures the victims into his residence. Once inside the suspect's residence, the suspect forces the victim to have sex with him.
- 2) No physical evidence was obtained at the scene.
- 3) On 10-17-91 at approximately 2248 hours, I was dispatched to [REDACTED] reference a possible child molest.

Prior to my arrival, Dispatch advised that this would be an evaluation type call, as it was explained to them by the victims that the incident took place approximately one month or more ago.

When I arrived, I spoke with [REDACTED], the mother of one of the victims. [REDACTED] told me that at approximately 2130 hours, she was informed by a neighbor who lives directly behind her residence at [REDACTED], that her son, [REDACTED], had possibly been molested by one of their ex-neighbors who goes by the name of [REDACTED]. [REDACTED] stated the neighbor who told her this, [REDACTED], stated this might have possibly happened with her son also.

After hearing this, [REDACTED] immediately went to her son [REDACTED] to find out if what she had heard was true. [REDACTED] spoke with [REDACTED] and learned that apparently some time last month, in the middle of September, [REDACTED] was lured over to the next neighbor's house (currently lives off "H" Street somewhere) and was sexually molested. [REDACTED] went on to say that it happened so long ago that she wasn't sure what she could do about it, but she called the police because she felt it should be reported.

[REDACTED] told me that there are possibly two other boys involved besides her son [REDACTED]. One is the son of the mother who called her to inform her of the whole incident to begin with and a third boy, [REDACTED] [REDACTED] who lives

directly next door to them at [REDACTED] Having all three boys present at the time, I explained to [REDACTED] that I was going to interview each of the boys individually to obtain a good statement of what occurred and approximately how long. [REDACTED] agreed and gathered up several of the other family members who were in the living room with us at this time and took them into a back room of the residence.

I sat at the kitchen table with the first victim, [REDACTED] son [REDACTED] in an attempt to get a more quiet atmosphere for the interview. As I sat down with [REDACTED] at the kitchen table, along with my Reserve partner [REDACTED], I asked [REDACTED] if he knew the difference between right and wrong, and he stated, "Yes." I then asked [REDACTED] if he knew the difference between telling the truth and lying, and he stated, "Yes."

I then asked [REDACTED] if he was mad at [REDACTED] [REDACTED] for a reason and he stated, "Yes". I then asked him why he was mad at him and he stated, "Because of what he did to me."

At that time, I asked [REDACTED] what grade he was in and what school he went to. [REDACTED] stated he was in the 4th grade at [REDACTED]. [REDACTED] appeared to be a very bright young man with no problems understanding or speaking English. I asked [REDACTED] to explain to me what happened, the best he could.

[REDACTED] stated that some time last month (he wasn't sure of the date), he was in front of his residence with his friend [REDACTED] playing soccer against [REDACTED], who used to live in their small apartment complex in the back. [REDACTED] stated that [REDACTED] doesn't live there anymore but consistently comes over to play games with them and visit with them. As [REDACTED] and [REDACTED] played soccer with [REDACTED] they quickly became tired of the game. As they did so, [REDACTED] volunteered to buy both of the boys some pizza, but in order to do so, they had to go by his house and get some money from his bedroom.

[REDACTED] describes [REDACTED] as a Hispanic male juvenile or young adult, 17 to 18 years old, approximately 5'11", 165 to 170 pounds, with black hair and a black moustache.

As [redacted] talked the boys into going over to his house to get the money to buy pizza, they quickly got their bicycles and followed him over to his residence located at [redacted] (Prior to knowing this address, I asked [redacted] to describe the address of the location where [redacted] lived and he stated that it was an apartment type house, and the first one.)

Both [redacted] and [redacted] went over to [redacted] apartment and stopped at the front door. At that time, [redacted] invited both the boys inside but only [redacted] agreed. Apparently [redacted] joked with [redacted] saying, "He's going to do something to you." [redacted] laughed and went inside anyway. At that time, [redacted] told [redacted] to stay outside and that [redacted] and he would be outside in about a minute.

Once inside [redacted] apartment, [redacted] told [redacted] to go into his bedroom with him. At that time, I asked [redacted] to stop and elaborate a little further on the interior of [redacted] apartment.

[redacted] stated as they entered [redacted] apartment, he noticed the place looked like it was empty. [redacted] stated there was a small couch in the living room with no telephone and no TV, that he saw. [redacted] stated as they went past the living room into [redacted] bedroom, he noticed a Budweiser or similar type sign that lights up in the corner of [redacted] room.

As [redacted] walked into [redacted] bedroom with [redacted] following him closely behind, [redacted] made a statement to [redacted] saying that he saw both [redacted] and [redacted] in [redacted] house doing something nasty. As [redacted] was talking to [redacted] he locked the sliding glass door which apparently, according to [redacted] is the point of entry (front door or back door-wise) into the apartment itself. As [redacted] locked this door, he closed the large curtains (white in color) covering the glass doors to no one could see in or out. As he completed closing the curtains and locking the door, he teased [redacted] and asked him why he was doing it with [redacted] so hard. [redacted] replied that he wasn't doing anything and that he wanted to go.

At that time, [REDACTED] told [REDACTED] to pull his pants down and [REDACTED] replied, "No". [REDACTED] then grabbed [REDACTED] around [REDACTED] waistline at the top of his pants as [REDACTED] stood behind [REDACTED]. As [REDACTED] did grab [REDACTED] he pulled [REDACTED] pants and underwear straight down to [REDACTED] ankles. I then asked [REDACTED] if [REDACTED] made him take his shirt or pants all the way off. He stated, "No, he left them just like that."

[REDACTED] said [REDACTED] grabbed onto [REDACTED] shoulders from behind with [REDACTED] left hand on [REDACTED] left shoulder and his right hand on his right shoulder, forcing him onto [REDACTED] bed, which was, according to [REDACTED] a single mattress on the floor with no frame and no headboard. This put [REDACTED] in the face down position on [REDACTED] bed, leaving [REDACTED] buttocks and backside clearly exposed. At that time, Adolfo noticed [REDACTED] pulling down his pants and underwear to his knee caps, exposing [REDACTED] penis. I asked [REDACTED] if [REDACTED] ever touched his penis and he stated, "No". As soon as he pulled his pants down, he threw them on the bed.

[REDACTED] then said [REDACTED] once having his pants down, crawled on top of [REDACTED] placing his penis up against [REDACTED] buttocks. [REDACTED] attempted to scream for help hoping [REDACTED] would hear him, but apparently this was to no avail as nobody came to his rescue.

I then asked [REDACTED] if [REDACTED] penis was actually touching the skin of his buttocks. He stated, "Yes", [REDACTED] was trying to stick his penis in [REDACTED] butt but he would not let him because he was pinching his butt closed with his muscles as hard as he could. [REDACTED] stated that [REDACTED] penis was straight and hard, sticking straight out, and somewhat wrinkled. [REDACTED] went on to say that as [REDACTED] laid on top of him rubbing his penis on his butt, he began to go up and down in a thrusting type motion, still trying to get his penis into [REDACTED] rectum. [REDACTED] stated that [REDACTED] tried approximately two to three times, but then gave up as he noticed it was apparently taking too long to get anywhere.

██████████ said during the entire incident, he was screaming for someone to help him, but was unable to get anyone's attention.

I then asked ██████████ if he noticed if anything came out of ██████████ penis and he stated, "No." I asked him if he saw ██████████ wiping his penis with a rag or any other type of material and he stated, "No."

██████████ stated the entire time he was in there, the only thing he could think about was having ██████████ call the police. ██████████ went on to say as ██████████ started to get off of him, he stated, "That's what it feels like to do it with a guy." At that time, ██████████ stated that ██████████ told him that he has done it with guys before and to go ahead and pull up his pants and quit crying.

██████████ stated that ██████████ appeared real shaky as he noticed it when ██████████ grabbed onto his shoulders and forced him onto the bed. ██████████ tried to resist ██████████ as ██████████ forced ██████████ pants down to the ground, but it was not no avail as ██████████ was a superior person in strength.

I then asked ██████████ if he noticed anything unusual about ██████████. He stated that he wears a weird cologne similar to the one that I was wearing (comparing it with a Polo cologne).

██████████ stated as ██████████ got off of him getting dressed as well as ██████████ getting dressed, ██████████ went straight to the big sliding glass door trying to get out. ██████████ stated he could not get the lock to open and was unable to do so without ██████████ assistance. Once the door was opened by ██████████ ██████████ ran outside, getting onto his bicycle.

██████████ went on to say as he came outside, ██████████ invited ██████████ inside just to talk to him. ██████████ stated he really wasn't paying attention as he was scared and wanted to get home as fast as he could. As ██████████ started to leave the area, he noticed that ██████████ wasn't around and when he looked around, he saw a bike in front of ██████████ residence, but did not see ██████████. Minutes

later, [REDACTED] came outside [REDACTED] residence without [REDACTED] at which time both boys told each other what had happened. Both boys agreed not to say anything to each other's parents or to anybody else for fear of getting beat up by [REDACTED] or getting into severe trouble by their parents.

I then asked [REDACTED] how their parents learned today that this had occurred and [REDACTED] told me the following: While sitting at a Bible study meeting, a friend of theirs named [REDACTED] [REDACTED] who also lives at [REDACTED], read a part of the Bible that had to do with what had happened to them. As she did read this, [REDACTED] confessed to [REDACTED] what happened. [REDACTED] immediately told [REDACTED] [REDACTED] who was the person who informed [REDACTED] mother in the first place.

[REDACTED] stated that [REDACTED] has not come around the place since this occurred and hasn't bothered them since then regarding this similar type of incident.

At that time, I asked [REDACTED] if there was anything else or any other information he could provide to me regarding what had happened to him and he stated, "No", just that he wants [REDACTED] to get in trouble for what he did to him. I completed my interview with [REDACTED]

I interviewed the second victim, [REDACTED] [REDACTED] in the same room with [REDACTED] and me. [REDACTED] stated that they were playing ball in front of [REDACTED] house when [REDACTED] told them that h would buy them pizza, but in order for him to do so, they had to go by his house to get the money.

Once at [REDACTED] house, [REDACTED] went inside with [REDACTED] and was in there for a long time, approximately 5 to 10 minutes. As the time passed, [REDACTED] waited outside on his bicycle in the parking lot. [REDACTED] stated [REDACTED] came out and looked extremely scared and told [REDACTED] "Let's go." [REDACTED] stated as [REDACTED] was saying this, he was getting on his bike and riding away.

As [REDACTED] was just getting ready to follow [REDACTED] he was called to the front door of [REDACTED] residence by [REDACTED] who

was standing in the doorway. [redacted] asked [redacted] what he wanted. [redacted] stated, "Just come here." [redacted] asked twice with the same response from [redacted]. At that time, not knowing what had happened, [redacted] went up to [redacted] at the front door and went inside with [redacted] as [redacted] offered him a piece of bologna. As [redacted] came inside, [redacted] locked the door behind him and closed the curtains.

[redacted] pushed [redacted] away, saying, "No." [redacted] then told [redacted] that it would feel good to let him do it. [redacted] fearing something would happen to him, pushed [redacted] and ran to the glass sliding door. [redacted] stated after a few seconds of fumbling with the lock, he was able to get the door open, running outside and getting on his bicycle.

I asked [redacted] about what time this all occurred. He stated at approximately 7:30 p.m. at night, but it was still kind of light outside.

I asked [redacted] why didn't he tell his parents about this that night. He said he was scared and did not want to get spanked by his parents or [redacted] to get a hold of him and beat him up.

At that time I asked [redacted] if he was able to provide any further information regarding what happened and he stated, "No", but he did discuss what happened with [redacted] while he was in there and he was just as scared for him, hoping that it wouldn't happen to him any more. Both [redacted] and [redacted] rode home on their bikes, swearing to each other that they wouldn't tell anybody.

I then asked [redacted] how anybody found out. He stated they were at their Bible study when [redacted] told a friend of theirs, [redacted] what had happened to him, which subsequently got to a friend of their parents, [redacted]. I completed my interview with [redacted].

I talked to [redacted] who apparently has a son by the name of [redacted] who was possibly previously

approached by [REDACTED] and is subsequently an old neighbor of [REDACTED]. I then made a left turn onto eastbound "H" Street from Third, getting into the right hand lane. from. Once [redacted] felt comfortable talking with me, I asked him to tell me about his involvement with [redacted].

[redacted] said one afternoon, during a week day in September, [redacted] came over to the apartments on [redacted] Avenue to play with his friends, [redacted] and [redacted]. He said his mom was at work and a babysitter was watching him. [redacted] said [redacted] asked [redacted] and [redacted] to go to the park with him, and they left on their bicycles for about an hour. Detective ██████████ and I then drove to Chula Vista High School and briefly spoke with ██████████. I introduced us and told him that we needed to speak with him at the Chula Vista Police Department about some complaints we had received from several neighborhood boys who lived in the area of ██████████. ██████████ agreed to speak with us, but said he doesn't get out of school until 2:25 in the afternoon, and he does not always have a ride. When we asked [REDACTED] if he had ever been molested, he said when he was about eight years old, living in Mexico, one time, while he and his ten-year-old cousin were taking a shower together, his cousin tried to put his penis in his but. [REDACTED] said his cousin also tried to get him to touch his penis, but he did not, and told his mother about it. [REDACTED] said later, when he was about 12 years old, one of his male teachers also molested him. He said the molest included sodomy and it happened at the teacher's house while he and his cousin were there visiting. He said the teacher had offered them ice cream and later asked him to take off his clothes, in order to weigh him. [REDACTED] said after he took off his clothes, the teacher also took off his clothes, and asked him to go to the bedroom. [REDACTED] said when he refused, the teacher then started to touch his cousin, and after a while they left the teacher's house.

At this point we told [REDACTED] we had already talked with [REDACTED] and [REDACTED] who had told us he was doing the same things to them that he had just described being done to him by his cousin and later by his teacher. We told [REDACTED] that we needed him to tell us the truth. [REDACTED] then admitted to molesting the three boys. He said he has performed oral sex and anal sex on both [REDACTED] and [REDACTED]. [REDACTED] said he attempted to have anal sex with [REDACTED] but he was unsuccessful. He said he couldn't help himself, even though he knew what he was doing was wrong. [REDACTED] said it all started one day when he caught [REDACTED] and [REDACTED] playing with each other in [REDACTED]'s house and they did not have any clothes on. He said he asked them to let him in, which they did. [REDACTED] said he then sodomized them by putting his penis in their butts. [REDACTED] said this happened about three months after he had moved into the [REDACTED] address, while he was living with the [REDACTED] family. [REDACTED] said he, [REDACTED] and [REDACTED] did this approximately eight to nine times, and he usually ejaculated.

Mrs. [REDACTED] said about four months ago she left [REDACTED] at home with [REDACTED] and [REDACTED] while she went to pick up some Chinese food they had ordered. She said other than that, she never left her son unsupervised.

Mrs. [REDACTED] said about eight days ago, Tuesday, 10/29/91, [REDACTED] came around looking for her son. She said when the kids saw him coming, they ran inside. Mrs. [REDACTED] said when the boys did not answer the door, [REDACTED] went to the market down the street and called on the phone. She said when she spoke with him on the phone, [REDACTED] wanted to know why the boys were not outside. Mrs. [REDACTED] said when [REDACTED] came back and knocked on the door again, the boys turned the radio on real loud. She said [REDACTED] then went next door and talked with the neighbors at [REDACTED]. Mrs. [REDACTED] said after a while [REDACTED] left the area.

On Thursday, 11/7/91, I met [REDACTED] and [REDACTED] at Children's Hospital, along with their parents. The boys were interviewed and examined, and the interviews were video taped. [REDACTED] was interviewed by [REDACTED]. His interview was in English, which I witnessed. The interviews of [REDACTED] and [REDACTED] were done by [REDACTED] which were in Spanish. I also witnessed these interviews and afterwards Ms. [REDACTED] told me that both [REDACTED] and [REDACTED] had told her that they had also been molested by [REDACTED] on more than one occasion.
