About the 19th we will send you another notice of all those who have not made payment with the request that you turn off their water supply. For this service we are willing to pay to your Company 50 cents for each consumer who is turned off and later turned on.

I trust you can see your way clear to agreeing to this promosal as I believe it is for the best interests of both the Helix

shut off so that they can not take water which belongs to some one

July was the first month that I had anything to do with the work, and as Mr. Barry moved away with no instructions for me to go by, there were some who used more than their share of what water came to us, but I will keep close watch this month, and when a consumer has used what is due him, will close his meter and advise him that he has had the amount his due, and then if more is used, he must expect to pay you for the excess at the rate you charge. Anything I can do for you will be done cheerfully, and as well as I am capable of doing it, only, if my water must be shut off, please send someone else to do it.
