My dear Mr. De Faria:

Through my personal friend, J.L.Contente, I am enclosing copy of legislation passed by the last Session of the Esgislature of which I was the author. The State of California has recognized San Diego for the 400th Cabrillo Celebration and we are going to invite the Nations of the World, particularly Portugal, to be represented.

The question of the statue is an important one. Dr. J.C.Lopes last Friday claimed ownership and possession, stating that it came from Antonio Ferrio, when, as a matter of fact, the records show that there was an import duty for a large sum of money and that same was waived by the Governor of California, accepting the statue in the name of the State. If you will take the matter up with Senator Shelley, Mayor Rossi, Harold Boyd, City Controller, you will find that San Francisco is sympathetic to San Diego having the statue.

It is logical that San Diego should have the statue from the country of Portugal for it was Cabrillo who first discovered California and San Diego, and we want to dedicate it in 1942. Arrangements have all been made for the transfer of the statue without expense by the Santa Fe Railway to San Diego, and the State will be under no expense of any kind in connection with the orection of the statue. Dr. Lopes said he paid the freight from New York to San Francisco. I have offered to refund him the money so he will be out no expense.
