2. The Report is a brief one and I cannot understand why it has taken so long to be written and forwarded to me. The patrol ended on 13/9/63, the report is dated 31/10/63 and I received it today - 7/11/63; in other words 54 days have elapsed between the finish of the patrol and the receipt of the report. Mr. Cleary is being requested to furnish an explanation for this delay.

3. The work done on the road appears satisfactory but it will require frequent visits to maintain the enthusiasm shown, as reported, and to assist on the difficult PIONATAVE-HEGETURU section.

PATROL DIARY.

Monday 22nd July.

Moved from Lufa to Gono by vehicle, then, accompanied by Rev. Johnstone of Faith Mission walked to Agibu. Slept Agibu.

Tuesday 23rd July.

Walked from Agibu to Maiva, there, heavy rain set in. Slept Maiva.

Wednesday 24th July.

From Maiva to Guwasa, the last two hours in heavy rain. Set up camp at Guwasa rest house. Slept Guwasa.

Thursday 25th July.

Walked approximately one mile from rest house to area required as Mission and Pastoral Lease by Faith Mission carried out CI 235 investigation. Slept Guwasa.

Friday 26th July.

Walked for 6 hours to Mani rest house, stopped at Liborei rest house en route and settled small dispute dealing with damage to garden. Slept Mani.

Saturday 27th July.

Walked for 10 hours to Gono and returned to Lufa same night. Slept Lufa.

Sunday 28th July.

To Yagasa by vehicle then walked to Deikibi where set up camp to supervise construction of the Gono-Mengino section of the Gono-Arulai road. Slept Deikibi.

Wednesday 31st July to Friday 2nd August.

At Deikibi and surrounding area supervising road and bridge construction. Slept Deikibi.

Saturday 3rd August.

Work continued on the road. At 11.30 am vehicle arrived from Lufa. Returned to Lufa for weekend. Slept Lufa.

Monday 5th August.

Returned to Deikibi and continued supervision of road work. Slept Deikibi.

Tuesday 6th August.

Walked to Mengino to inspect work in that area. These people working more quickly than the Gono people. Returned to Deikibi the same day.

Slept Deikibi.

Wednesday 7th August.

Remained in the Gono section this day. Completed construction of ford over first big stream from Gono.

Slept Deikibi.

Thursday 8th August.

To Mengino again. Work progressing well on this section. Returned to Deikibi.

Slept Deikibi.

Friday 9th August.

Returned to Lufa to complete outstanding office work.

Slept Lufa.

Monday 12th August.

Departed Lufa for Arulai in order to advise local people of impending visit by Discom and Distriff on 14/8. Arrived Arulai 3.30pm.

Slept Arulai.

Tuesday 13th August.

At Arulai advising local people re abovementioned visit. Looked at work completed in this area.

Slept Arulai.

Wednesday 14th August.

Waited for plane to arrive at Arulai, however due to bad weather throughout Highlands unable to do so this day. A large crowd gathered. Advised by airdrop that plane would return on tomorrow.

Slept Arulai.

Thursday 15th August.

Plane arrived at Arulai at 9.15 am. A successful meeting held by Discom and Distriff with local headmen. I returned to Goroka with plane. Thence by road from Goroka to Lufa.

Slept Lufa.

Monday 19th August.

To Goroka by road, then, accompanied by A.D.O. flew to Arulai in order to survey and supervise the road in this area.

Slept Arulai.

Tuesday 20th August.

Walked to Hegeturu for inspection of road completed in this area. Hegeturu far behind all other lines as far as work completed. Returned to Arulai.

Slept Arulai.

Wednesday 21st August.

Selected site for a large bridge needed to span a river between Hegeturu and Lasiovitei. Supervised work in this area during the day.

Slept Arulai.

Thursday 22nd August.

Approximately 3 miles of road leading up to Agotu Lutheran Mission had not yet been surveyed. Completed survey and pegging of approximately half of this distance this day.

Slept Arulai.

Friday 23rd August.

Completed survey and pegging of road right to Mission boundary.

Slept Arulai.

Saturday 24th August.

Supervised the construction of road in the Arulai area.

Slept Arulai.

Sunday 25th August.

Observed - Slept Arulai.

Monday 26th August.

To Hegeturu to inspect progress on this section. Work very slow here due to stone face.

Slept Arulai.

Tuesday 27th August.

Returned again to Hegeturu to hurry up work on that ridge. Returned to Arulai pm.

Slept Arulai.

Wednesday 28th August to Saturday 31st August.

Concentrated on finishing the section of road from the Lasiovitei River to the top of the Arulai ridge.

Slept Arulai.

Sunday 1st September.

Observed - Slept Arulai.

Monday 2nd September.

Cessna made three runs from Goroka bringing much needed picks, shovels and crowbars. All this equipment distributed according to population and amount of work yet to complete.

Slept Arulai.

Tuesday 3rd September.

Began the journey home. Walked to Hegeturu this day and camped there, looked at work completed.

Slept Hegeturu.

Wednesday 4th September.

To Fiomatave. Met Medasst from Lufa en route. Slept Fiomatave.

Thursday 5th September.

Walked to Gono. Vehicle unable to meet us due landslide between Lufa and Gono. Faith Mission people generously transported us to Lufa.

Slept Lufa.

Friday 13th September.

Made a quick trip back to Arulai to see that work had not slackened off since my departure, was pleased to note that work had progressed well during my absence.
Slept Arulai.

Saturday 14th September.

Walked to Mengino, there met by vehicle and drove to Lufa.

END OF DIARY.

INTRODUCTION.

1. The main object of the patrol was to hurry up construction of the Gono-Arulai road, also to complete all outstanding land matters in the Labogai Census Division and to make a general follow up on the census patrol 3 months previous.

ROADS AND BRIDGES.

1. As previously stated the main object of this patrol was to supervise the construction of a road from Gono to Arulai. During the time spent in the area I estimate some ten miles of road was constructed. Taking the road in sections the degree of completedness would be approximately as follows :-

2. Gono-Mengino - 100% complete and open to traffic. There were no large hurdles to be overcome on this section. The distance is about 6 miles and consists of a bench cut into the side of the mountain for the whole of that distance. There are no big bridges on this section. This type of road is very susceptible to landslides which close the road at frequent intervals.

3. Mengino-Fiomatave - approximately 75% completed, the first 4 miles from Mengino are trafficable. This section follows the same pattern as the first section being a bench cut into the side of the mountain and being very susceptible to landslides.

4. Fiomatave-Hegeturu - Only about 30% of this section is completed. Unfortunately it is the most difficult section due to large tracts of stone, also the Hegeturu villages are about two hours walk from the road site making the job even slower due to the fact that four hours each day are spent walking to and from work. I plan when other sections are finished to bring in neighbouring tribes to help cut through the stone.

5. Hegeturu-Arulai - 70% completed. No real difficulties should be experienced here except the construction of one large bridge. The topography changes here from forest to grassland, as a result the going is much easier. The Arulai people have practically finished their work, the main part of the uncompleted work lies in the Hegeturu area.

6. The people have now been issued with sufficient equipment for them to finish this road before Christmas, which I believe will do, they are working constantly and are genuinely interested in getting the road through.

AGRICULTURE.

1. The Gono people, who have completed their part of the road are very anxious to get some cash crop going in their area. Within the next few weeks we hope to distribute maize seed among the Gono people. Quite a number of local Missionaries would be interested in purchasing the crop as fodder for their livestock.

LAW AND JUSTICE.

1. Minor disputes are many in this area, almost weekly there is a small fight over women, pigs or land this being particularly so in the Hegeturu area.

2. One case was heard where an Aid Post Orderly accepted a bribe to keep him from informing the authorities of the death of a woman who died in the village without being brought in for medical attention.

NATIVE AFFAIRS.

1. During the patrol I visited all areas in the south west of the Labogai census division while I was doing a land investigation at Guwasa. In this area the situation remains unchanged from the last patrol.


2. Although the census division is a large one and the population is spread out over a large area the people are becoming more and more bound together by Mission influence.

3. The village leaders at every centre try and impress on me that they have given up their old way of living and want the better things like roads and crops that they are seeing around the Lufe area.

4. Sorcery is still rife in the area and every unaccountable death is put down to a sorcerer.

CONCLUSION.

1. The patrol covered its main objects and I feel helped to maintain a satisfactory administrative situation in this census division.

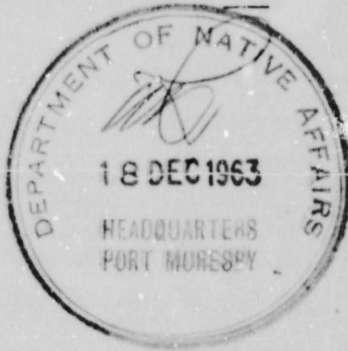

LUFA PATROL No. 2 OF 63/64.

... The abovementioned report submitted by Mr. K.W. Cleary, Patrol Officer Grade 1, is forwarded herewith.

2. The patrol appears to have been only partly successful and another officer will be obliged to visit the Yagaria Census Division before the House of Assembly Elections to ensure that election procedure is known to the Yagaria people.

3. Mr. Cleary was instructed to take his time with this patrol and to spend as much time as possible with the native people discussing House of Assembly Elections etc. The patrol has, in fact, occupied only nine days and it would appear that a very small portion of those days were actually spent with the people. Mr. Cleary has not bothered to state times in his patrol diary.

4. As Mr. Cleary had earlier received notice of his acceptance into the Department of Treasury he was obviously no longer interested in D.N.A. generally, and this could explain his apparent lack of interest during this patrol.

PATROL DIARY.

Tuesday 7th November.

Meeting held at Fore rest house, large gathering estimated at about 3,000 from Forapi, Fore and Hagaulo areas. Meeting also attended by various Kafe councillors.

Monday 11th November.

To Gotomi via land rover, full day spent here.

Tuesday 12th November.

To Nupuru, large gathering from Nupuru-Daginava area. Discussion held and H. of A. explained with help of Henganofi councillors.

Wednesday 13th November.

To Hairo where similar meeting held. Lufa people also attended.

Thursday 14th November.

To Garuka, meeting well attended by Garuka and Frigano people.

Tuesday 19th November.

To Higibabi, successful meeting held with aid of Henganofi councillors. Meeting attended by Kisavero and Koseto people as well as Higibabis.

Wednesday 20th November.

To Forapi for discussion and further lecturing on H. of A.

Thursday 21st November.

To Kogoraiparo for further talks with these people who had previously been present at the Garuka meeting.

Friday 22nd November.

To Kisavero for further talks with these people who had previously been present at Garuka.

All visits made to the above rest houses were made in daily trips by vehicle returning to Lufa each night.

End of Diary.

INTRODUCTION.

1. The patrol was mounted with its prime object being the dissemination of propoganda and education material with regard to the coming House of Assembly elections.

F

ROADS AND BRIDGES.

1. Throughout the patrol note was made of the condition of the Kami-Lufa road and of the bridges on that road. Two road gangs are now working full time on the road. Recently some 150 picks arrived and the work of levelling the road and renewing the drains will begin this week.

POLITICAL EDUCATION - HOUSE OF ASSEMBLY.

1. The pattern I followed at all meetings was a simple one, it consisted of stressing certain major points with regard to Government and the H. of A. and the meaning it held for these people. The following points were stressed at length :-

(a) That a Government of country is not one man but a group of men, in this case elected by the people who administer the country as a whole and not on an area basis. I found it necessary to stress this particularly that the H. of A. is a Territory wide Council as 90% of the Yagaria people are considering it as their own Local Council and are going about the task of choosing Councillors on a village basis. I believe now that they are beginning to realise the difference.

(b) The second point discussed was the right of the people to nominate themselves or any other person to stand as a candidate for the House. No real problems were met here I feel they did understand the procedure of nominations quite clearly, they readily understood the need for a nomination fee to be paid to keep every fool from nominating.

(c) Thirdly the rights and obligations of the people to vote were explained. The actual procedure of voting was not dealt with as I feel it is too early at this stage. The compilation of a common roll was brought to their notice and the fact that all people over the age of 21 could vote but were not compelled to was stressed. The advantages to be obtained by having everyone vote was explained and I do feel there will be 100% voting in this area.

(d) A most difficult point to get over to these people was the system of electorates. I touched only very briefly on the fact that there were two types of electorates. I felt that by this stage their minds were becoming confused enough without confusing the issue too much further, therefore I dealt in detail with the open electorate only. I explained how the electorates were arrived at on a population basis and that was the reason why they are linked with the Henganofi people in these elections.

(e) I rounded off with a brief summary of how, where and when the elections would be held; the reason why polling booths could not be set up in each village and gave each individual village the name of the place to which they will actually come and vote.


2. The above five points were the simplest form in which I could explain through an interpreter the meaning of the coming elections to these people.

3. Further to the above information given these people a projector and strip film have now, been received and an interpreter is on his way through the area again lecturing with the aid of the film strip to all who are interested in listening.

4. Missionaries in the area tell me that they cannot remember anything which has excited the interest of the people so much as the interest being shown them by the Administration in this matter, I know they are holding their own discussion groups on the subject daily and it is hoped that with further talk and time the elections will become clearer to at least some of them.

CONCLUSION.

1. The patrol was a very short one and concentrated 100% on political education with regard to the House of Assembly elections.

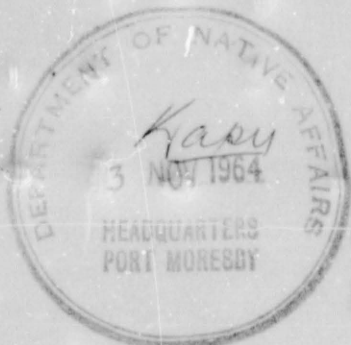

Tuesday, 5th May, 1964:

Departed LUFA and travelled by Landrover to NUPURU where met Mr. J.J. Nitsche of D.A.S.F. Problems of the Yagaris Progress Society discussed and brief patrol of the entire area covered by the society mapped out. Slept NUPURU.

Wednesday, 6th:

Meeting held at NUPURU with members of the society; main business being discussion of pig damage to gardens, peanut stealing and share capital.

Departed NUPURU 1330 hrs. with Mr. Nitsche and travelled to HOGUSA to inspect coffee plantings with view to installation of small fermentary. Returned NUPURU.

Thursday, 7th:

NUPURU to YAUGUSA by Landrover, arriving 1145. Carriers organized. Departed YAUGUSA 1145 and walked to DAGENAVA, arriving 1320. Set up camp. Meeting of local people and discussions concerning cash crops, especially pyrethrum. Slept DAGENAVA.

Friday, 8th:

Departed DAGENAVA 0825 and walked to KOGARAI-PARO, arriving 1005. Discussions re cash cropping. Slept KOGARAI-PARO.

Saturday, 9th:

Departed KOGARAI-PARO 0745 and walked to KISAVERO, arriving 0855. Set up camp. Meeting held with discussion on cash cropping and membership of the Yagaris Progress Society. Peanut and coffee gardens inspected. Slept KISAVERO.

Sunday, 10th:

Departed KISAVERO 0845 and walked to road, arriving 1025. Carriers paid off. Travelled to LUFA by Landrover.

Monday, 11th:

At LUFA. LUFA vehicle n/s and replacement vehicle arrived at night.

Tuesday, 12th:

Departed LUFA by Landrover 0730 for HIGIBABI. Set up camp and convened meeting of local people. Discussions held on general agricultural topics. Slept HIGIBABI.

Wednesday, 13th:

Departed HIGIBABI 0815 and walked to GURUKA, arriving 0920. Set up camp. Meeting held with emphasis on peanut and pyrethrum planting. Rain stopped meeting. Slept GURUKA.

Thursday, 14th:

Mornign at GURUKA; meeting continued. Departed GURUKA by Landrover 1120 and drove to HAIRO where meeting held and agriculture topics discussed. Returned GURUKA where slept.

Friday, 15th:

Departed GURUKA 0805 by Landrover and travelled to FORE where meeting held and agriculture topics discussed. Departed FORE 1330 and drove to KAMI, arriving 1730. Landrover broken down once more. Slept KAMI.

Saturday, 16th:

Discussions with local people at KAMI on agriculture. Departed KAMI 1005, arriving KOTOMI roadhead 1130. No carriers. Returned KAMI 1415. Departed KAMI 1420 to return Mr. Nitsche to GOROKA, arriving GOROKA 1510. Patrol temporarily stood down.

DIARY (continued)

Thursday, 28th:

Patrol resumed. Patrol party travelled to KOTOMI Rest House; Landrover from Lufa to turnoff on Lufa-Goroka road, thence 1½ hour walk. People warned of purpose of this patrol and told to prepare for census. Slept KOTOMI.

Friday, 29th:

Departed Rest House 0700 and walked to Luluai's settlement, arriving 0735. Census amended, Village inspected. Medical check carried out by A.P.O. OTOTA of KOTOMI Aid Post. Spent 2½ hours inspecting other scattered settlements of this group. Housing unsatisfactory and people urged to combine into two main settlements.

Moved on to LILOKA where census amended and medical check carried out. The two settlements of this group inspected; housing generally poor and instructions left regarding same. Departed LILOKA 1700 and arrived Rest House 1840. Slept KOTOMI.

Saturday, 30th:

Departed KOTOMI 0700 and walked to NUPAGAMANA, arriving 0830. Census amended and medical check carried out. The two settlements comprising this group inspected. Housing poor and instructions left.

Departed NUPAGAMANA 1200 and walked to SEGEYA, arriving 1300. Census amended and medical check carried out. Housing fair and village clean. Walked to Rest House, 15 mins. Slept KOTOMI.

Sunday, 31st:

After all religious meetings had concluded for the day, a meeting was held of the KOTOMI group. Mr. Ugi BIRITU, M.H.A., addressed the group for about one hour on matters concerned with the House of Assembly. The writer then addressed the group on subjects of cash crop marketing, road access, Aid Post maintenance and village housing and hygiene.

Monday, 1st June:

Walked to SOFASILUPA, 10 mins., and amended census. Medical check carried out. Both settlements inspected. Housing in poor repair and instructions given.

DIARY (continued)

Monday 1st June (continued):

Departed SOPASILUFA 1100 and walked to FIMO'A, arriving 1120. Census revised and medical check carried out. The three settlements comprising this group inspected. Housing poor and instructions given. Cultist type activity looked into. Returned KOTOMI where C.N.A. convened 1700 and continued until 2030. Slept KOTOMI.

Tuesday, 2nd:

Departed KOTOMI 0700, arrived at KAFETINA River where measured possible bridge site. Landrover waiting and conveyed patrol party to FORAPI village. Census amended and scattered housing inspected. People urged to combine into two settlements. A.P.O. IEMULI arrived in afternoon and carried out medical check. Slept FORAPI.

Wednesday, 3rd:

At FORAPI. Investigation into theft of money. C.N.A. convened in afternoon. Slept FORAPI.

Thursday, 4th:

Departed FORAPI and walked to LAGAIYU, 40 mins. Census amended and medical check carried out. New village in course of construction however some people still living in pig houses remote from the main settlement. These houses inspected and condemned for human habitation. Departed LAGAIYU 1500 and walked to FORE Rest House, arriving 1800. Slept FORE.

Friday, 5th:

Walked to KAMI, 5 mins. where census revised and medical check carried out. Housing inspected and pig houses condemned for human habitation. Returned FORE where census and medical. Housing inspected and pig houses condemned for human habitation. Slept FORE

Saturday, 6th:

Patrol party returned LUFA. Patrol temporarily stood down.

DIARY (continued)

Wednesday, 1st July:

Departed LUFA by Landrover and travelled to NUMUGO turn-off. 30 min walk to KEIFILE where census and medical inspection. Housing inspected and instructions issued re pig houses. 20 min walk to DISEVADONOTO hamlet of HAGA census unit. Census and medical for this hamlet. New housing under construction. 35 mins to FORAGA where census and medical. Housing inspected; poor; instructions issued. Walked to NUMUGO Rest House, 35 mins, arriving 1800. Slept NUMUGO.

Thursday, 2nd:

Departed Rest House 0700 and walked to KEWI hamlet of HAGAULO. Census and medical check. Housing inspected - instructions issued. Departed KEWI 1200 and walked to HAGAULO hamlet of KORO arriving 1245. Housing inspected; good. Departed KORO 1400 and walked to NUMUGO Rest House, arriving 1535. Census and medical of LITIPINAGA. Housing poor; instructions given. Meeting of NUMUGO group in evening with discussion of Aid Post maintenance, access road, education, cash cropping. Slept NUMUGO.

Friday, 3rd:

Departed Rest House, 0630 and walked to KEMASI, arriving 0655. Census and medical. New village under construction. Departed KEMASI 1100 and walked to FORE, arriving 1200. Met by Landrover in which proceeded to HIGIBABI Rest House. Census and medical of HIGIBABI. Slept HIGIBABI.

Saturday, 4th:

HIGIBABI housing inspected and instructions issued. Walked to HOGOBUA, 30 mins, where census and medical check. Housing inspected and found inadequate; instructions issued. One family group found who reside at No 1 WAIYAFAYUFA in the BENA BENA but travel to HOGOBUA for census. Walked to TAGAI'I, 20 mins, and census and medical check carried out. Housing inspected; new housing under construction. Returned to HIGIBABI Rest House, 15 mins, arriving 1815.

Sunday, 5th:

Sunday observed.

Departed HIGIBABI 0700 by Landrover and travelled to IAKAIYAVE turn-off. Walked 30 mins to LAKA: IYAVE where census and medical. A group of houses erected for the benefit of patrolling officers but not used by the people who all sleep in pig houses scattered over the area. These houses inspected and condemned for human habitation. People request Aid Post. Walked 15 mins to HIBO where census and medical. This group live in many small settlements all of which were not seen by the patrol. Luluai DUBULOEIVA/IVA deceased and OWANI/KUFUYABI to be recommended to replace him. Return to HIGIBABI by Landrover. C.N.A. convened. Slept HIGIBABI.

Tuesday, 7th:

Departed HIGIBABI 0720 and walked 5 mins to FORAPI where census and medical and inspection of housing. New village under construction but some people living in pig houses. These houses condemned for human habitation. Walked to BOIGETO, 35 mins. Census and medical. Housing inadequate; instructions issued. Returned to HIGIBABI, 40 mins. Slept HIGIBABI.

Wednesday, 8th:

Departed HIGIBABI 0705 and walked to LUFUGU, arriving 0745. Census and medical of this small group. Housing very poor; instructions given. Walked to IHABARAGA close by where census and medical. Housing poor and insufficient for population; instructions given re pig houses. Walked to HEGELO, 20 mins, where census and medical. Housing good. Slept at KOISETO Rest House close by. C.N.A. convened. Slept KOISETO.

Thursday, 9th:

Departed KOISETO and walked to HAGERO Rest House, inspecting housing en route. 1hr 30mins. Walked to KEPAFINAGA, 25 mins, where census and medical. Housing inadequate and orders given re pig houses. Walked to HABARU, 35 mins, where census and medical. Housing good but not used as populace sleeps in pig houses. All pig houses condemned for human habitation. Returned to HAGERO Rest House, 40 mins walk. Slept HAGERO, after census and medical of HAGERO village. Housing poor and instructions given.

Departed HAGERO Rest House 0700 and walked to NIPINAGAVI, arriving 0800. Census and medical. Housing and latrines inadequate. Instructions given. Walked 45 mins to YAGUSA where census and medical check. The four settlements of this group left until Monday to inspect en route to DAGENAVA. Walked to NUPURU Rest House, arriving 1845. Slept NUPURU.

7 mins to MOVEI where census and medical check. Housing grossly inadequate; a poor group with Luluai YAUSA not leading his group constructively. Luluai YAUSA does not have a house in the village but lives in a pig house. All pig houses condemned for human habitation. LABOSA/LUSEFAIYA to be appointed Tultul for BANANI'NE'E hamlet.

Writer returned to KOGARAIPARO Rest House then departed for HOMU (2 hrs) where met by Landrover. Writer returned to LUFA.

Mr. C.T. Davies, C.P.O., conducted census of NUPAIYUFA and HABARU villages, and returned to KOGARAIPARO Rest House.

Tuesday, 28th:

Mr. C.T. Davies conducted census of KURUGU and KAMATAI villages and returned to KOGARAIPARO Rest House.

Wednesday, 29th:

Mr. C.T. Davies conducted census of HUWA and NUPAGAMATA and returned to KOGARAIPARO Rest House.

Departed GURUKA Rest House 0700 and walked to MOMENTO, arriving 0830. Census and medical check. Housing good but not used as people live in pig houses. Pig houses condemned for human habitation. Walked to
