

## REMARKS TO PRESS CONFERENCE ON ILLEGAL ALIENS May 12, 1986

We are facing a problem that threatens to bankrupt county government. It is a problem that has been thrust upon us by the federal government, and it is time to do something about it. Everyone is talking about it, but is anyone doing anything about it?

We are being invaded by illegal aliens. From 1980 to 1985, 2.2 million illegal aliens from 72 different countries were apprehended crossing into San Diego. That is equal to the entire present population of San Diego County, and the problem is just getting worse.

Last month, 72,000 illegal immigrants were apprehended by the Border Patrol in San Diego. For every one who is apprehended, as many as 10 may get through.

Since 1965, the number of aliens apprehended crossing into San Diego has risen by over 6,400 percent! And that does not count the number that are stopped at the San Ysidro port of entry, which is the largest port of entry in the world. The I.N.S.

estimates that last year more than 200,000 people tried to enter the U.S. at San Ysidro using fraudulent papers. Calculate these 2 figures out and you have 1,064,000 - over one million in one year!

This illegal immigration problem that we face is not just the worst in California. It is not just the worst in the United States. It is the worst in the world.

San Diego County is the single most highly impacted area anywhere. It is costing local taxpayers an arm and a leg. It is time for us to do something about it. It is time to take action locally, because we're not getting any help from Washington, which appears to be incapable of formulating any type of workable immigration policy.

The time has come for Uncle Sam to pay the bill for all the uninvited visitors who have come to our county. And I just happen to have the bill right here.

This is an invoice from the County of San Diego for \$23.27 million. It is only a partial bill, but it is long past due.

This figure represents the costs we can presently identify for criminal justice and health and social services San Diego taxpayers must pay because of illegal aliens.

These costs are the result of a federal problem and a federal responsibility that is being borne entirely by one local community. Fairness is part of the American way and this is simply not fair, no matter how you look at it.

Our best guess is that the real figure is closer to \$100 million annually.

The exact figures will be determined by a SANDAG study hopefully to be completed over the next year through a grant from the National Institue of Justice.

In the meantime, tomorrow I am going to ask the Board of Supervisors to file a lawsuit against the federal government to seek reimbursement for the staggering costs we are presently having to pay. I've contacted other counties in Texas and Florida, and they have responded favorably.

Just to give you an idea of what we face, the Criminal Justice Council estimates that 25% of all people in the criminal justice system are illegal aliens. Police Chief Kolender recently attributed the rise in San Diego's crime rate to the massive influx of aliens. The Sheriff estimates that 61.5% of all rapes, 34% of the car thefts and 1/4 of the burglaries in our county are committed by aliens.

Last year the Sheriff and the San Diego Police Department arrested nearly 12,000 illegal aliens for criminal offenses in San Diego. This is not counting those arrested in the 15 other cities of our county. It costs us \$5,200 to prosecute each misdemeanor and \$10,000 to prosecute low grade felonies.

Because there is no tracking system presently in place, we don't know exactly how many of those who were arrested were actually prosecuted. In the bill that I am asking the Board to send to the federal government, we list only the 672 that we can presently document. But if the SANDAG study finds that all 12,000 went to trial, the prosecution cost alone could top \$60 million for the year.

On top of that there are detention costs, court costs and police costs. The City of Escondido estimates that 50% of their police time is spent on illegal aliens. If the average time spent was only 25% across the county, the total police cost would be about \$32 million.

If the federal government won't reimburse us for all these costs, they ought to at least house the prisoners. After all, the first offense these criminals committed - before being arrested for a burglary, car theft or rape - was a federal offense of illegally entering the country. Let them go to


Federal prison, not the county jail.

On top of the criminal justice costs, there are health costs. From 1980 to 1985, the county alone spent over \$16.5 million at University Hospital treating illegal aliens. The annual cost for this service has escalated by 96% since 1980. In fact, 85% of the cost of the County's third agreement with University Hospital goes to paying the cost of emergency care for illegal aliens.

In addition to hospital care, aliens are also using community clinics and local social service programs. Example for Point

Aliens can come here illegally, and know that they can go to a health clinic or social service program for help, and receive the same service that any taxpayer or legal resident receives.

This year, the County was forced to cut services for almost 40,000 people because of the loss of federal revenue sharing money. Those health, social service and Area Agency on Aging programs are all accessible to aliens. When combined with the revenue sharing cuts of \$12 million and the cuts of up to \$16 million that will result because of Gramm-Rudman, to total of \$28 million in cuts means the increased number of aliens using these services serves to deny access for legal residents to many of these programs. In the final analysis, non-citizens are taking a greater and greater percentage of the amount that is

allocated, and citizens are getting less.

And it is not just county run health and social service programs that feel the pinch. Over the last 8 months, Palomar Hospital wrote off \$800,000 in hospital costs that resulted from treating undocumented immigrants. And that figure represents only the hospital's direct costs - it doesn't include physician fees. This is just one hospital. What if all costs were tracked and added?

These health care costs, and similar ones at other hospitals throughout the county, have to be made up somewhere. Generally, it is through increased costs that are borne by county residents.

One of the problems in trying to determine the exact cost the County bears is that there is presently no tracking system in place. The proposal that I am bringing to the Board of Supervisors, besides calling for the lawsuit, will also call for a system of tracking the money we spend locally on illegal immigrants.

The bottom line is that local taxpayers are footing the bill for a <u>national</u> problem. Roads are going unfixed, sewers are overflowing and senior citizen programs and children's services such as child abuse are going under-funded because we don't have the money.

It's not fair. It's not right. And it has to change.

By billing the federal government, and suing them, maybe we can get the attention of Congress, and get some sort of relief from this massive invasion.

Somehow we must secure our borders, Adding to the incredible flood of immigrants, we now also have the spector of terrorists crossing into our country. The time has come for the federal government to act. We can wait no longer.

The Great Wall of China would pale by comparison. In fact, if you think about all the man-made barriers we've put up throughout society, there's only one so monumental, so darkly foreboding as to guarantee the <u>isolation</u> of people on separate sides. The <u>language</u> barrier. Tear <u>that</u> one down and at least you can start to work on all the others.

That's why it hit me as sadly ironic today, when efforts to make English this country's official language drew such a stinging response from the Chicano Federation. Said Spokesman Herman Baca, The effort is "...racist, demagoguery, a long-term assault on people trying to assimilate into American society."

Well, I can understand the sensitivity of Chicano leaders, if not their logic. But, it seems to me it's the <u>present</u> system that leads to racism and demagoguery. English may not be the <u>official</u> language, but it already <u>is</u> the language of mainstream America, of the economy, the only language of <u>hope</u> for breaking that cycle of poverty that's gripped immigrants to this country for two hundred years.

If they can't even speak the language, how can they <u>possibly</u> assimilate? What kind of decent jobs can they get, what kind of intelligent vote can they cast, even if the <u>ballot</u> did happen to be in their native tongue? It seems to me that doing everything possible to teach Americans the English language and encourage them to <u>use</u> it, is the most compassionate, <u>least</u> racist thing you can do for them.

Making English the official language would not stop bi-lingual education, wouldn't prevent our schools from offering special classes to teach Hispanics and others English, wouldn't stop the present requirement that all students learn a foreign language. The only thing it <u>might</u> do is encourage a kind of unity to help wipe out the problems of racism and poverty. But, that unity will never happen as long as some people are separated by that worst barrier of all, the language barrier.

I'm Michael Tuck, and that's my perspective.

# Border Patrol has record month in apprehensions

SAN YSIDRO — Immigration officials, announcing the third record month this year of apprehensions of undocumented aliens, lambasted Congress yesterday for failure to enact immigration reform including sanctions against knowing employers of undocumented workers.

Harold Ezell, regional commissioner of the Immigration and Naturalization Service, citing statistics that show 71,910 undocumented aliens were apprehended in the San Diego sector during April, branded Congress "do-nothing" and "ridiculous" for its failure to pass meaningful immigration legislation.

"We need desperately to have immigration reform," Ezell told a news conference. "... There must be a grass-roots movement similar to what the Mothers Against Drunk Drivers did to draw attention to the drunken driver problem ... These numbers are growing at a startling rate.

"Without immigration reform, we will never control these borders," he said. "We have to take away the jobs. We have to take that magnet away ... We just can't sit back and let the United States become another Third World country."

Ezell said illegal immigration drives up local crime rates and costs

taxpayers millions annually in medical, education and social service costs.

The 71,910 apprehensions in April marked the third monthly record this year in the San Diego sector. A daily arrest record of 3,460 was set April 6. The arrest total was 48 percent higher than last April's 42,803 detentions.

San Diego Chief Border Patrol Agent Alan Eliason said April marked the first time more than 100,000 undocumented aliens were arrested in the INS Western region, which includes Livermore, El Centro, San Diego County, and Yuma and Tucson, Ariz. The total of 103,594 apprehensions marked a 53 percent increase over April 1985.

For the first seven months of fiscal 1986, Ezell said, apprehensions in the Western region were up 41 percent from last year, to 508,877.

Eliason said his manpower has increased 30 percent since last year, but apprehensions have increased 68 percent.

Asked how many undocumented aliens made re-entries after being deported, Eliason said: "We simply don't have the capability to calculate that figure. We don't have the time to fingerprint and do a background check on every person we arrest, such as in a homicide investigation, because the volume is too great."

Eliason said his "gut reaction" is that of the 71,910 undocumented aliens arrested in his sector, only 40,000 to 45,000 were first-time arrestees.

Of the 71,910 arrestees, 1,473 had nationalities other than Mexican. Detainees came from Yugoslavia, Israel, Iran, India, China, Belize and South Korea. The number of non-Mexicans arrested was up 93 percent from April of last year, Eliason said.

Those arrested included 517 suspected alien smugglers. Border Patrol agents confiscated 254 smuggling vehicles, among them 71 cars and trucks that had been stolen.

# May alien arrests set third recor

SAN YSIDRO — For the third consecutive month, Border Patrol agents have arrested a record number of undocumented aliens in San Diego County.

Agents in May arrested 73,630 illegal immigrants. There were 1,708 from countries other than Mexico, including 148 Colombians, 730 El Salvadorans, and smaller numbers from South Korea, Turkey, Iran, Iraq and the People's Republic of China, said total by 55 percent. Border Patrol supervisory agent Ed Pveatt.

The arrest records, Pyeatt said, shows a continued increase in the number of non-Mexican aliens attempting to illegally cross into the United States.

With a 29 percent increase in line agents, he said, the Border Patrol is arresting undocumented aliens at a rate that will exceed the fiscal 1985

In fiscal 1985, 428,772 undocumented aliens were arrested. To date, during the first eight months of fiscal 1986, 416,000 aliens have been arrest-

"The monthly increase over May 1985 is a 79 percent increase, while arrests of aliens other than Mexicans were up 99 percent," Pyeatt said.

He noted there are many repeat arrests of illegals.

#### The Problem:

The U.S./Mexican international border which defines the Southern boundary of San Diego County is the most heavily impacted region in the United States in relation to the problem of illegal immigration. As the number of undocumented aliens from other nations flow across our border, existing systems and facilities become overburdened. Since 1980, the County of San Diego has spent over \$16 million alone in emergency health care for undocumented aliens and millions more in criminal justice costs.

The critical nature of the problem is heightened when we realize how many of our residents have been impacted by County services that have either been eliminated or drastically cut back that had been previously been funded by Federal tax revenues. year, when the County lost Federal Revenue Sharing money, nearly 40,000 citizens were impacted. Examples of these losses are: \$122,000 in programs for senior citizens, \$400,000 in cuts to community clinics affecting over 22,000 patients, and \$2 million in social service cuts which have impacted over 14,000 people. Add to this a possible \$16 million loss due to Gramm-Rudman.

Supervisor Golding's Proposal:

While studies indicate that taxes paid by undocumented aliens exceed the cost of local services (excepting public education) the fact is that very little, if any, of these revenues come back to the County to finance these services. Coupled with the fact that studies have shown that approximately 80% of undocumented workers do not file state or federal income tax returns a windfall in revenues flows to the state and federal government.

Immigration policy is a Federal responsibility, and I believe that we can wait no longer to approach the Federal government for reimbursement of costs borne locally - - costs which are not entirely the responsibility of local government, but costs which could be covered by the revenues generated by "undocumented taxpayers" of our own County.

My proposal will be to: (1) Investigate applying for Impact Assistance and/or special Federal legislation which reimburses the County for costs incurred for health programs relating to illegal immigration. (2) Establish a San Diego County International Border Commission. The purpose of this organization would be to work jointly with the Mexican government, U.S. Federal authorities, business and community organizations (assuring substantial representation of Hispanic interests), towards a better understanding and resolution of the shared concerns along our international border. (3). Direct the Chief Administrative Officer to develop a tracking and monitoring system in which the full cost of undocumented alien's impact on County services - including criminal justice programs - can be identified, taking great care not to do so in a discriminatory In addition, the CAO would be instructed to solicit the interest of other local jurisdictions similarly impacted by illegal immigration to join the County in litigation against the Federal government. (4) Direct County Counsel to prepare a litigation strategy which seeks full reimbursements from the Federal government for the costs absorbed by County government for health and programs as well as any other subsequent costs that may be identified through a tracking system.

I ask for your support in this proposal which, hopefully, will resolve an unacceptable situation that requires a few local communities to bear the cost of a national problem that is a Federal responsibility.



By now, you probably have heard of my proposal to seek cost recovery from the Federal government for the provision of County services to illegal immigrants.

While this proposal was initially dramatized and misinterpreted by some members of the media, it is a serious and thoroughly researched measure that I fully intend on presenting to the Board for approval.

Since 1980, the County of San Diego has spent over \$16 million on emergency health care for illegal immigrants and, undoubtedly, several million more in costs associated with other County programs and services.

This economic concern is even better comprehended when we realize how many residents have been affected as County services have either been eliminated or cut back as a result of reduced Federal funding. Last year, for example, nearly 40,000 citizens were impacted when the County lost Federal Revenue Sharing allocations. \$122,000 was cut from senior citizen programs, \$400,000 was slashed from community clinic budgets and \$2 million was eliminated from social service programs.

The U.S./Mexican international border, which defines the southern boundary of San Diego County, is the most heavily impacted region in the United States with respect to illegal immigration. At a time when publicly provided services are overburdened and under-financed for many reasons, we must address viable solutions to the economic impact placed on these services by illegal immigrants. We must do this in order to continue to supply these services to all County residents.

There is no question that health services must be humanely provided to all who are in need. And, it should also be obvious that our ability to supply services has been diminished for reasons other than the impact of illegal immigrants.

The questions I have raised -- the only questions that are being addressed with respect to the services provided by the county to undocumented aliens -- are; "who pays?" and "who benefits?" with regard to public costs and revenues.

Immigration policy is a Federal responsibility, and I believe that we must ask the Federal government for reimbursement of costs disproportionately borne by a few local communities while Federal public revenue accounts reap the benefits.

Studies have indicated that taxes paid by illegal immigrants exceed the demand such individuals make on local services. Unfortunately, the fact is that very little, if any, of these revenues are returned to the county to finance these services. Studies also show that approximately 80% of undocumented workers in the U.S. do not file income tax returns, thus allowing what could be termed a windfall in annual public revenues for the State and Federal government.

In a 1985 report entitled "Current and Future Effects of Mexican Immigration in California" the Rand Corporation made the following observation:

"Although immigrant's use of services appears to be increasing, their contribution to public revenues exceeds the cost of their service usage, with the exception of educational services. However, local jurisdictions with substantial concentrations of immigrants may well find that they are losing money on services to immigrants, while other parts of the state and nation enjoy an implicit subsidy."

A similar conclusion was reached by Wayne Cornelius, Leo Chavez and Jorge Castro from UCSD's Center for US-Mexican Studies. Taken from their report, "Mexican Immigrants and Southern California: A Summary of Current Knowledge", is the following:

"A major unresolved issue is which level of government should take responsibility for covering unreimbursed medical expenses of undocumented immigrants who lack insurance coverage and who

cannot pay all of their bills out-of-pocket. A strong case can be made for federal assumption of these costs, since the largest portion of taxes paid by the immigrants (nearly 60%) goes to the federal government and is not returned commensurately to the local and state governments most heavily impacted by Mexican immigration." Clearly, studies such as these indicate that illegal immigrants are contributing to our public revenues.

The Federal government benefits economically while San Diego County bears a majority of the cost and responsibility. I believe that some of the tax revenues paid by undocumented immigrants should be returned to the communities that must bear the costs of providing needed services.

To seek redress on behalf of county residents, I will soon be asking the Board of Supervisors to approve the following proposal:

- 1) Establish a San Diego County International Border Commission. The purpose of this organization would be to work jointly with the Mexican government, U.S. Federal authorities, business and community organizations (assuring representation of Hispanic interests), toward a better understanding and resolution of the shared concerns along our international border.
- 2) Investigate applying for Impact Assistance and/or special Federal Legislation which reimburses the County for costs incurred for health services and programs made available to undocumented immigrants.
- 3) Direct the Chief Administrative Officer, with the assistance of the Border Commission, to develop a tracking and monitoring system in which the full cost of County services provided to undocumented immigrants can be identified in a sensitive, confidential and nondiscriminatory manner.
- 4) Direct County Counsel to prepare a litigation strategy which seeks full reimbursements from the Federal government for the costs absorbed by County government for health programs and services made available to undocumented immigrants as well as any other subsequent costs for other programs and services that may be identified through a tracking system. This strategy would be implemented should other reimbursement methods prove unsuccessful, as they have in the past. Communities experiencing similar disproportionate costs, and considering similar methods of cost recovery, would be invited to join San Diego County in such litigation.

I ask for your support of this proposal which, hopefully, will resolve an unacceptable situation that requires a few local communities to bear the cost of a matter that benefits the Federal revenues and has been identified as a Federal responsibility. I also look forward to receiving any comments or additional recommendations you might have with regard to the proposal.

If you could relay your personal and/or organizational support in the form of a letter to my office, I will be certain to share those sentiments with my colleagues on the Board. Such an effort, on your part, will be greatly appreciated. If you would also be willing to make a statement to the Board, please, let my office know so that we can provide you with the date and time of the hearing.

Thank you for directing your attention to this time sensitive matter. I look forward to hearing from you soon.

- (2) Direct the CAO to establish a San Diego County Regional Commission on U.S. / Mexican Affairs. The purpose of this body would be to work jointly with the Mexican government, Federal authorities, local officials, academic representatives, and business and community organizations towards a better understanding and resolution of the shared concerns between our two regions. There would be local representation of Hispanic interests on the Commission. The CAO will submit the proposed composition of the Commission to the Board for its review and final approval.
- (3) Direct the CAO to develop programs to determine, in a nondiscriminatory manner, the full cost of County services provided to undocumented immigrants. The San Diego County Regional Commission on U.S. / Mexican Affairs would act as the advisory body on the development of such programs and would submit its recommendations to the CAO and Board of Supervisors.
- (4) Accepting the possibility that efforts to obtain impact assistance or legislation might not be successful, as has been the case in the past, direct County Counsel to begin preparation of a litigation strategy which seeks full reimbursements from the Federal government for the costs absorbed by local taxpayers for health programs related to illegal immigration, as well as any other costs that may be identified by the CAO.
- (5) Direct the CAO to solicit the interest of other local jurisdictions in the U.S. which may be similarly impacted by illegal immigration to join the County in litigation against the Federal government in the event Federal impact assistance or special legislation is not successful within a reasonable period of time.

I ask this Board for its support to resolve an unacceptable situation that requires a few local communities to bear the cost of a national problem that is a Federal responsibility.

The South Bay Political Association (SOPA) is an independent political association working in the San Diego County but based in the South Bay area. The large Mexican population in this region is affected directly by the border tensions and violence. We therefore see the urgent need to establish a new organization that can readily address the defense of this community. We recognize that our interests have historically been neglected by established government representatives, community-based organizations and other political franchises. ## County should sue U.S. for alien-care costs, Golding says

Saying the federal government is responsible for controlling immigration but cannot do so, Supervisor Susan Golding wants federal reimbursement for money the county spends policing and taking care of undocumented aliens.

"The time has come for Uncle Sam to pay the bill for all the uninvited visitors who have come to our county," Golding said yesterday in a press conference, "and I just happen to

have the bill right here."

With that, she waved what she described as an invoice for approxi-

mately \$23 million.

Golding said she will ask the Board of Supervisors to approve filing of a lawsuit seeking reimbursement from the federal government. She will also ask the county to begin a reliable method of tracking costs.

The \$23 million, she said, represents a partial list of estimated medical and criminal-justice costs. Health care at UCSD Medical Center for 1980 through 1985 accounted for \$16.5 million of the total. The remainder was made up of estimates from the Sheriff's Department, the district attorney's office and the Probation Department for jailing and prosecuting undocumented aliens for one year.

"A lot of these figures are very soft," Golding said, adding that the only statement she would attempt to defend about county costs is that

they are "extremely high."
County studies in 1977 and 1980 showed that undocumented immigrants return more to the county in taxes than they require in services. Studies in other California counties, by academic researchers and by the U.S. Select Commission on Immigration and Refugee Policy, make the same finding.

Golding said she did not attempt to compare the county's financial gains from taxes with the costs of services because data on the taxes were based on approximations and because no records exist to show how much of the total tax paid is returned to the county.

She said 12,000 undocumented aliens were arrested by San Diego police and the Sheriff's Department in 1985. If a study by the San Diego Association of Governments, expected to be completed next year, finds that all those were prosecuted, she said, the total prosecution cost would be \$60 million.

However, that figure is bigger than the combined current annual budgets of the county's municipal courts, the Superior Court, the district attorney's office and the public defender's office. Golding said she was justified nevertheless in using the \$60 million figure because the number of prosecutions is unknown.

Although Golding quoted estimates by local law-enforcement officials of the percentage of crimes committed by undocumented immigrants, she declined to defend the figures.

Golding said she had contacted counties in Florida, Texas and Arizona about the idea of a lawsuit and had found them supportive.

She said local agencies in the past had attempted similar lawsuits. Of those that have been litigated, she

said, all failed to gain a dime.
Golding could not estimate the cost of such a lawsuit.

care costs for undocumented aliens. Golding, in a telephone interview after the press conference, said she was unsure that a new lawsuit might succeed where the earlier one failed.

"Health cost is one issue and law enforcement is another issue," she said.

Detention of adult undocumented aliens at the county jails downtown and in Vista cost \$1.1 million last year, detention of juvenile illegal immigrants cost \$448,300 and health care \$16.5 million, plus court costs of more than \$1 million and prosecution costs of \$4 million, Golding said.

Over the last eight months, Palomar Hospital wrote off \$800,000 in hospital costs that resulted from treating undocumented aliens and that figure does not include physician fees, she said.

"This illegal immigration problem that we face is not just the worst in California," Golding said at the press conference. "It is not just the worst in the United States. It's the worst in the world.

"It is time for us to do something about it ... We're not getting any help from Washington, which appears to be incapable of formulating any type of workable immigration policy.

"Police Chief (Bill) Kolender recently attributed the rise in San Diego's crime rate to the massive influx of aliens. The sheriff (John Duffy) estimates that 61.5 percent of all rapes, 34 percent of the car thefts and one-fourth of the burglaries in our county are committed by aliens."

Noting that it costs \$5,200 to prosecute each misdemeanor and \$10,000 to prosecute low-grade felonies, Golding said the Sheriff's Department and San Diego police arrested nearly 12,000 undocumented aliens for criminal offenses in San Diego, not including those arrested in the 15 other cities in the county.

"(The federal government) ought to at least house the prisoners" she said. "After all, the first offense these criminals committed — before being arrested for a burglary, car theft or rape — was a federal offense of illegally entering the country. Let them go to federal prison, not County Jail."

In 1978 the county filed a claim against the government for \$1.8 million for health-care services over a three-year period that had been provided to undocumented aliens.

In 1979 U.S. District Judge Gordon Thompson Jr. dismissed the suit on the basis that the federal government could not be sued. The 9th U.S. Circuit Court of Appeals upheld Thompson's decision, and the U.S. Supreme Court refused to hear the case.

Deputy county counsel Philip Kossy, who handled the 1978 case, declined yesterday to discuss the possibility of the Golding suit succeeding where the other suit had failed.

## Golding says county should sue on aliens

Supervisor Susan Golding, warning that an "invasion" of undocumented aliens is bankrupting the county, yesterday proposed that the county sue the federal government for reimbursement of at least \$23.2 million.

Saying that illegal immigration is a federal problem, Golding announced that she will ask the Board of Supervisors today to approve filing a lawsuit to collect from the federal government money spent on undocumented aliens.

She said the \$23,2 million figure is an estimate of what it has cost the county since 1984 to detain and prosecute undocumented aliens involved in crimes and to provide them with health care and social services. The actual figure could be as high as \$80 million, she said.

"The bottom line is that as local citizens we are getting less and less, and the illegal immigrants are getting more and more," Golding said at a press conference. "Roads are going unfixed, sewers are overflowing and senior citizen programs and children's services such as child abuse are going underfunded because we don't have the money."

## Baca challenges remarks by supervisor Golding

A National City Chicano activist warned that remarks made earlier this week by San Diego County Supervisor Susan Golding could result in violence against Hispanics.

Herman Baca, chairman of the Committee on Chicano Rights, blasted Golding for making inflammatory remarks that "foment possible violence by bigots and racists against persons of Mexican ancestry."

Baca referred to Golding's call

for a lawsuit against the U.S. government to recover money spent by the county to arrest undocumented immigrants and to provide social services for them.

Among other things, Golding cited sheriff's department statistics stating 61.5 percent of all rapes, 34 percent of car thefts and one-fourth of the burglaries in San Diego county are committed by aliens. She later corrected that statement to apply to north county only.

"Supervisor Golding is one of a long list of drum beaters in putting out false propaganda, which includes the border patrol and the INS (Immigration and Naturalization Service)," said Baca. "If she is being contradicted here by her own sources, what is she going to do when she gets into the larger arena (court) where things are black and white?"

Golding said she cited several statistics to back her case and that those particular statistics were taken out of context.

Baca characterized Golding's remarks as "wild-eyed fabrications" that help foster an "atmosphere of hysteria" directed

against the "350,000 persons of Mexican ancestry who reside, work and pay taxes in San Diego."

"That was just one statistic of a seven-page report," she said "This is no different than Florida asking for aid from the federal government to deal with the refugees. The cost can't be borne by local government."

Golding said she sympathizes with the people of Mexico fleeing a near-bankrupt country to seek a better life. But the cost for providing health care, law enforcement and other social services

should be footed by the federal government rather than local tax-payers, she said.

She added that although studies show the state and federal government may benefit from taxes paid by undocumented immigrants, San Diego county does not. She warned that the problem of illegal aliens "threatens to bankrupt county government."

Baca disagreed with Golding's statements that undocumented immigrants are draining taxpayers' money.

"These people are keeping the Social Security system solvent

and the U.S. public from starving to death because no one else will do these jobs," he said. "Locally they keep our hotels clean for tourists. They are the busboys and cooks for restaurants and they clean the houses of some of the same people that are crying."

"If someone told you that 61.5 percent of rapes are caused by martians wouldn't you feel afraid of any martian?" Baca asked.



#### County to Dun U.S. for Illegal-Alien Expenses

San Diego County supervisors on Tuesday took the first step toward seeking reimbursement from the federal government for services the county provides to illegal immigrants.

In a series of votes, the board endorsed a broad-based plan by Supervisor Susan Golding to recover what she says are millions of dollars in costs for health, social and criminal justice services the county provides to illegal immigrants.

But the board stopped short of agreeing to sue the federal government to recover the funds, as Golding had suggested a month ago in a press conference that prompted widespread criticism of her in the Latino community

Instead, the board told county Chief Administrative Officer Norman Hickey to begin preparations for such a suit should all other efforts prove fruitless.

First, however, Hickey will seek from the federal government \$16 million that the county estimates it has paid in the last five years to give health care to illegal immigrants at UC San Diego Medical Center.

Hickey also was instructed Tuesday to develop a method of determining the full cost of all other county services provided to undocumented immigrants so that those costs, too, can be recovered.

Another Golding proposal—the creation of a Commission on U.S.-Mexican Affairs—was put off for a month to give Supervisor Brian—Bilbray time to talk with San Diego Mayor-elect Maureen O'Connor about establishing a joint city-county border commission.

In her presentation to the board, Golding took pains to avoid the kind of language that prompted some local Latino leaders to brand her approach to the problem a month ago as "hysterical."

Golding pointed out that she believes Immigration and Naturalization Service arrest statistics are not an accurate measure of the number of people crossing the border, and she conceded that arrest reports from local police departments are often subjective because officers frequently guess

whether a person is in the United States legally.

She said the federal government has an obligation to reimburse local government for services to illegal immigrants, just as it did for Vietnamese refugees after the fall of the U.S.-backed government there.

"I believe the principle is the same, and similar aid is needed today to offset the cost we are bearing for this illegal immigration into this country," Golding said.

Her proposal won the backing of the San Diego Chamber of Commerce, the San Diego County Medical Society and the Mexican-American Business and Professional Assn. But the Chicano Federation remains opposed, said Jess Haro, chairman of the federation's board.

"What you are doing here is raising false hopes and inflaming passions," Haro told the supervisors. "What you've done is point your finger at one group, singled out that group and blamed them for the problem of the loss of revenues."

## Golding gets an OK to seek funding for immigrant services

Apologizing for misstatements in her original proposal, Supervisor Susan Golding has won approval of cautious efforts to seek federal reimbursement for county government's costs for services to undocumented immigrants.

Golding was refused, at least for the present, creation of a regional commission on U.S.-Mexican affairs. The rejection came after Supervisor Brian Bilbray said his yearlong effort to establish such a group was about to pay

The views of public speakers varied widely. One praised the proposal for a commission as a way to increase understanding. One wanted to sue to force

the federal government to place the military along the border to guard

against an invasion.

Others said they feared that any effort to track costs would lead to intrusive questioning of all Hispanics, citizens or not. Some said that reimbursement for costs to all medical institutions, not just UCSD Medical Center, should be sought, and that Golding's proposal arose from a "personal agenda" instead of humanitarian concern.

Bilbray said Golding's proposed commission would begin from the wrong place because, with the immigrants, "the greatest problem is not dollars and cents but human misery.'

After meeting with Deputy Mayor Ed Struiksma and arranging for meetings with Mayor-elect Maureen O'Connor, Bilbray said, he believes that agreement on a joint city-county commission is very near.

He asked for 30 days to complete his talks, and the supervisors unani-

mously approved.

Golding set off a storm of community and editorial protest last month when she made erroneous statements about the percentage of crimes attributable to undocumented immigrants and said the county's costs threatened bankruptcy.

I'm sorry that the mistake was made," Golding said vesterday. "If I have learned nothing else, I have learned that this is a very complex. complicated issue and there are no easy answers."

Nevertheless, federal reimbursement should be sought, she said, because undocumented immigrants are a federal responsibility, not the coun-

The county's federal assistance when large numbers of Southeast Asian immigrants settled in San Diego after the Vietnam War are a precedent for reimbursement, she

Rep. Bill Lowery has agreed to carry a bill, separate from pending immigration legislation, to repay the county for its costs, Golding said. She asked that Chief Administrative Officer Norman Hickey also be directed to investigate repayment.

lems of lost revenue," said Jess Haro, chairman of the Chicano Federation.

"The reality is that this (federal) administration has set a very low priority on the problems of the poor and has deliberately and consciously set out to reduce the funding received by both cities and counties throughout the United States," Haro said.

"Whatever policy you decide, do not permit you employees to become an arm of the INS," Ralph Pesquiera, of the Mexican American Business and Professional Association, told supervisors.

Pesquiera, also representing the Chamber of Commerce, noted that both organizations support Golding's efforts to "recover whatever funds are necessary to offset the tremendous amount of expenses that have

taken place in the county and city of San Diego.

"However, in order to come up with the statistics, a great deal of harm can be made," said Pesquiera. "And this is where the greatest sensitivity must take place."

Objections to Golding's proposal surfaced when it was originally unveiled last month and she cited statistics that inaccurately suggested undocumented immigrants were responsible for a large number of rapes, burglaries and car thefts countywide.

Golding quickly acknowledged the statistics were in error but not before they led to sharp criticism of her proposal until its formal introduction yesterday.

"I am sorry that the error was made," Golding said yesterday, "but it was corrected within an hour or so and has not been made again."

Golding added that a commission on U.S/Mexican Affairs could help develop accurate statistical information on the local costs and services associated with immigration. Thus far, she said, county officials have identified \$16 million in emergency health care costs alone since 1980.

But while agreeing to seek legislation and consider litigation to recover the county's costs, the other supervisors postponed a decision for 30 days on whether to form a new county commission, which could cost more than \$100,000 for staffing.

The delay was requested by Supervisor Brian Bilbray, who said the county should first talk with San Diego city officials about joining their recently formed commission studying border issues.

Supervisor Susan Golding proposed Monday that San Diego County sue the U.S. government to recover millions of dollars spent by the county to arrest illegal aliens and provide social services for them.

Golding said she will ask for the board's approval for the lawsuit todav.

To show the financial impact that illegal aliens have on county government, Golding presented a dizzying array of figures, although some of them were later disputed. She said she had discussed the idea of such a lawsuit with county

Florida, who are also beset by problems brought on by illegal aliens and may join San Diego County in suing the federal government.

She said it is appropriate to sue the U.S. government because enforcement of immigration laws is a federal responsibility, and the Immigration and Naturalization Service should be doing more to stop the flow of "uninvited visitors" to the county.

According to Golding, county taxpayers are "footing the bill for a national problem." She claimed

officials in Arizona, Texas and that roads are going unfixed, sewers are overflowing" and community programs are being cut because county money is being spent to halt crime committed by aliens and to provide social services for their families.

In an attempt to dramatize the costs, Golding waved an "invoice" for \$23 million allegedly representing funds paid by the county because of illegal aliens during the past five years. that the true cost could total \$100 million.

Some of the statistics Golding offered were later questioned by

law enforcement agencies.

For example, Golding said the San Diego County Sheriff's Department estimated that 61.5% of all the rapes in the county are committed by aliens. But sheriff's spokesman John Tenwolde said that Golding took that and other figures out of context. Tenwolde said the department gave Golding some crime figures in March, but the rape statistic she quoted applied only to the sheriff's substations in Fallbrook and Vista, and were accumulated during the fiscal year 1984-1985.

"Those figures should've been qualified," Tenwolde said. "In fiscal year 1984 and 1985 there were 13 rape arrests in those two substaions and of these 13 arrests, eight were illegal aliens. That accounts

or 61.5%.

Golding painted a gloomy picture of what she said could happen if the federal government does not step up its enforcement of immigration laws and if federal funds used to pay for health and social services are cut.

"In the final analysis, non-citizens are taking a greater and greater percentage of the amount that is allocated, and citizens are

getting less," Golding said.

However, she said that she does not know how many aliens are currently benefiting from county services. Golding acknowledged that the possibility of successfully suing the federal government is slim, but she vowed to press forward anyway.

"By billing the federal government, and suing them, maybe we can get the attention of Congress, and get some sort of relief from this massive invasion," Golding said.

Golding's colleagues on the board said they have not seen her proposal. Board Chairman George Bailey said he favors sending a bill to the federal government "but I don't think we'll get anywhere with a lawsuit." Bailey said both El Paso, Tex., and Los Angeles have billed the government for services provided to aliens, but those claims were rejected.

Supervisor Brian Bilbray said the proposed suit would have to be discussed and studied carefully

## Golding's remarks on aliens could spark racial violence, Baca warns

Statements made earlier this week by San Diego County Supervisor Susan Golding could lead to violence against people of Mexican heritage, says a San Diego Chicano leader.

Herman Baca, chairman of the Committee on Chicano Rights said yesterday at a National City news conference that Golding is "fomenting possible violence by bigots and racists against persons of Mexican ancestry with her irresponsible statement."

Baça said the Mexican-American community "must now look to itself to protect its rights, families and property."

Golding was quoted as saying Monday that crimes committed by undocumented aliens were costing county taxpayers millions of dollars each year. She has been urging the county file a lawsuit against the federal government seeking reimbursement of money that the county government spent on the aliens.

Golding said a suit against the fed-

eral government could be based on the fact that the federal government has responsibility for enforcement of immigration laws. She said the Immigration and Naturalization Service has not done enough to stop "uninvited visitors" from coming into the country.

Golding quoted figures from the county sheriff's department showing

that 62.5 percent of the rapes, 34 percent of the car thefts and 25 percent of the burglaries could be attributed to aliens.

Golding said the issue is the responsibility of the federal government to carry out an immigration policy — and the impacts on the county and its residents if the policy isn't properly enforced.

## Duffy feeds bad data to Golding

Supervisor Susan Golding moved quickly to patch up feathers she ruffled in the Chicano community last week. Golding had held a press conference to announce a plan for the county to sue the federal government for reimbursement of more than \$23 million annually that the country incurs in providing social services to undocumented workers. There was no real problem with that. Immigration is acknowledged to be a federal issue and in other situations the U.S. government has long provided offset aid to locales like San Diego where federal installations (like the Navy) take property off local tax rolls. But the problem came when Golding cited statistics attributing virtually all of the increase in crime in San Diego to undocumented workers. The statistics were flat out wrong. They had come from Sheriff John Duffy's office and, as it turned out, applied only to some small section of north county. (Duffy, of course, has been waxing demagoguic on this issue for years. At one point he tried to get all the county's cab drivers to refuse fares from people they thought were here illegally. Just recently, he called on the federal government to station Marines at the border.) In any event, Golding's statistics prompted an immediate outcry from Chicanos who felt they were being scapegoated and such statements by public officals contribute to a climate of fear and discrimination against all

people with brown skin. And, to Golding's credit, as soon as she found out the statistics were wrong, she publicly retracted them, taking to the radio waves to apologize. Then, last Wednesday, in a meeting with Chicano leaders she was even more contrite. She flat out said she was sorry and that she regretted the misstatements of fact. She said that she would do whatever it took to correct the public record on the issue-that while she still wanted to pursue the lawsuit itself and gain reimbursement to the county, she'd be real careful in the future about any statistical references linking undocumented workers to crimes in the community. But while Golding's original statements made headlines, her apology and clarification didn't seem to interest the Union or the Times to the same degree. In addition, La Prensa, a throwaway published by a racist and an anti-Semite named Dan Munoz, responded with a vitriolic cartoon against Golding, who happens to be Jewish, showing her wearing a Jewish star and blaming a group of undocumenteds for all the nation's ills. The Chicano leadership responded swiftly and negatively to Munoz' demagoguery, disavowing it in a letter to him and asking that he apologize for his cartoon.

## Man Seeks Help Finding Deaf Wife INS Put on Bus

LOS ANGELES-Maria Arevalos is missing.

She may be in Los Angeles but, if she is still alive, she almost certainly does not know where she is.

Arevalos cannot tell anyone her plight, cannot ask for help, because the 34-yearold Mexican national is almost totally deaf and can speak only a few words in Spanish. She cannot read write or use sign language. She carried no identification papers, and had only \$5 in her pocket when she vanished two weeks ago.

Jose Herrera, her 48-year-old common-law husband, said Wednesday that he has been searching since May 1, when two Immigration and Naturalization Service agents took Arevalos off a train at Oceanside for questioning.

Herrera said he tried to tell the agents that she could not talk, but they did not seem to understand. He said he did not Jearn until much later that Arevalos was taken to San Clemente and then, after she failed to respond to questioning from INS agents, she was given a ticket and put on a bus for Los Angeles.

"I think something bad happened to her." Herrera said.

Then, hopefully, he added: "Or maybe

she met somebody at the bus depot in Los Angeles, a kind and good person who is taking care of her. If someone took her in, I want them to communicate with me . . . I am very worried . . . She is very timid, very shy."

Speaking through an interpreter at the Los Angeles office of the National Center for Immigrants' Rights, Herrera asked that anyone with any information about his wife telephone him at (213) 232-8281, the number of the Los Angeles home of the missing woman's sister, Margarita Recendos. Herrera, who has lived and worked in Fresno for the last five years, holds a green card work permit and is in this country legally. He admitted that Arevalos was entering the United States illegally.

"She was going to come live with me in Fresno," he explained.

When the plainclothes agents took her from the Amtrak passenger train. Herrera said, he expected that she would be sent back across the border at Tijuana, where their journey had begun.

Instead, as an INS spokesman said Wednesday, she was taken to the agency's assistant chief of the agency's San Diego identification," he said. "I think under the Sector, said the agents who questioned circumstances as they were related to

Arevalos thought she was only pretending to be deaf. He said that at one point she made a rocking motion with her arms and, apparently by pointing northward, caused the agents to believe she had a baby in Los Angeles.

Mehlos said the INS could neither prove nor disprove that she was an illegal alien and so she was released and put on the Los Angeles-bound bus.

Mehlos said the INS did not realize she was an illegal until Herrera showed up at their Chula Vista headquarters and told them his story.

Robert Schey, executive director of the Center for Immigrants' Rights, said that the INS has been "reasonably cooperative" since Herrera contacted his organization earlier this week and he and his staff began making inquiries. But, he said, checks with the six alien detention centers in Southern California turned up no trace of the missing woman.

Schey believes Arevalos should not be missing at all.

"I think it should have been evident that she had significant disabilities, that she was San Clemente facility. Marshall Mehlos, without funds and without any form of

me-that she was put on a bus and left to her own resources-that it was an improper course of action."

Herrera said that Arevalos did not have her sister's Los Angeles address and because of her hearing and speech disabilities, could not communicate with anyone.

'She can hear me if I talk real loud." he said, "and she can say about 20 words, but not consecutively."

Herrera, a seasonal farm worker presently employed at a Fresno tortilla factory. said he first met Arevalos five years ago. and has considered her his wife for the past 21/2 years, although they are not legally married.

He described her as 5 feet 3 inches tall. weighing about 145 pounds, with dark eyes and long dark hair. When he last saw her, she was wearing a red sweater, a blue blouse, blue leans and black shoes. He said she trembles visibly when she is nervous or upset.

"I fear for her life, of course," he said If she is alive, he said, "she probably is very confused . . . if she did get to Los Angeles, she would probably go with the first person who showed her some kindness."

commit crimes. In addition, Golding charged that the county is spending millions of dollars on health services provided to aliens and their families.

She proposed suing the federal government for \$23 million to recover funds paid by the county because of illegal aliens during the last five years. However, Golding's proposal came under immediate attack from some Latino community leaders and groups, many of them charging that the lawsuit and the rhetoric behind it were racist.

On Monday, Golding said that she had discussed her proposal with several groups and individuals, including Latinos, before announcing it last week. According to Golding, the people she talked to were supportive of the idea. But she declined to name them.

As part of her new strategy. Golding said that she will meet with more community groups, including the Chamber of Commerce, local taxpayer groups and Latino leaders to further discuss the possibility of filing a suit.

Golding complained about the negative publicity that the proposal has brought her, which resulted in part from some incorrect statistics that she used in proposing the suit. Despite the publicity, Golding said

that she has received about 100 calls about the lawsuit, only two of them opposing it.

"I don't think that I'm asking for anything unreasonable. I simply want the federal government to adopt responsibility for the county's law enforcement and health costs in dealing with undocumented aliens," Golding said.

She added that her biggest complaint is that the county does not benefit directly from taxes paid by illegal aliens to the federal govern-

"The tax money we get from the

federal government is not directly. or for the most part indirectly, for the county's law enforcement or health costs. . . . I know that undocumented aliens contribute to the economy through the service industries and agriculture and pay taxes. But we're not seeing this tax money," Golding said.

Last week, Golding rejected three county studies done in recent years that show illegal aliens paying more in taxes than they get in local services. She argued that the studies are outdated because of a sharp increase in the number of aliens living in the county.

# Golding drops bid to sue U.S. over expenses on aliens

Supervisor Susan Golding yesterday withdrew a politically volatile proposal that the county sue the U.S. government to recover millions of dollars spent on undocumented aliens.

But Golding said her decision to postpone a debate by the Board of Supervisors on her proposal had nothing to do with the controversy it has generated, particularly among Hispanic leaders.

Rather, Golding said she needs a week or two to develop a legal strategy for the lawsuit and to talk to more people about her proposal. Finding a winning legal strategy could be difficult, since a similar suit by the county in 1978 was rejected by both the trial court and appeals court.

The supervisor did not specify who would be contacted but said she "would talk to anybody" interested in the proposal.

Golding said her office has received nearly 100 telephone calls about her proposal since it was unveiled May 12 at a news conference. Only two of the calls, Golding said, have been from people opposed to her proposal.

"The rest of the people are basically saying they agree that the federal government" should reimburse the county for health care, social services and law-enforcement costs associated with undocumented aliens, Golding said.

The supervisor has placed the cost of those services since 1984 at a minimum of \$23.3 million and said they represent "a problem that threatens

to bankrupt county government."

But Golding's proposal was quickly challenged after it was revealed that she used the wrong statistics to bolster claims that undocumented aliens are responsible for a large number of crimes.

The Sheriff's Department clarified after her news conference, for example, that undocumented aliens did not commit 61.5 percent of the rapes in the county, as Golding had claimed.

That figure, according to the department, was drawn from fiscal 1984 and 1985 statistics at sheriff's substations in Vista and Fallbrook, when eight of the 13 people arrested for rape were undocumented aliens.

The use of the wrong crime statistics was not the issue, Golding said yesterday. "The real issue is the cost or the services and that is what should be talked about," she said.

But Golding's sentiment and statistics have come under attack by community activists, including Herman Baca, chairman of the Committee on Chicano Rights, who called her proposal slanderous and inaccurate.

At a news conference two days after hers, Baca said said county studies in 1977 and 1980 showed aliens paid more money in sales taxes and other levies than they received in public services.

In recent days, several county officials have speculated that Golding might withdraw or significantly alter her proposal.

"My guess is that she withdrew the proposal because she was getting some much heat," said one county official who asked not to be identified.
