Confirming our conversation of August-13th and of Sunday, August-12th, we will agree to pay to the Volcan Land and Water Company, or whatever corporation may build and operate the powers commonly known as Warners Ranch and Sutherland powers, 6 mills per KWH measured at the point of delivery to us in such power plant or plants, for all electric energy which they can furnish us up to approximately 4000 continuous RMH or such other . quantity as we may agree upon.

The term of the contract or lease shall be fifty years from the date power is first furnished. The Volcan Company shall build these powers completely, including the necessary machinery and apparatus, and maintain and operate them. The plant shall have an installed capacity of 10000 KW with standard overload ratings.

This power shall be furnished to us at approximately a uniform daily rate or in other words, approximately a uniform number of KWH shall be delivered each day, and during each day this power shall be delivered to us at the times and in the manner in which we can most conveniently and economically use it; provided, at any time by mutual consent this arrangement be changed so that a larger amount of power may be furnished during any period of any year and a correspondingly small amount at another period with the understanding however that in any one year no more than the average amounts mentioned or agreed upon be furnished. This company will agree to take this power at the end of 12 years from date of receipt of written notice from the Volcan Company that it will be ready to furnish such power, such notice however is not to be given until the expiration of 12 years from the date of the contract or lease to be entered into. Ed Fletcher will probably deliver this letter to you and at the same time ask you to draw up a contract between William G. Henshaw and San Diego Consolidated Gas & Electric Company covering the following points:

- 1. Henshaw is to agree to deliver to the San Diego Consolidated Gas & Electric Company a lease for all the power sites on the Volcan System for a period of 99 years.
- 2. Consideration for the lease will be a sum named by Fletcher and confirmed by me by wire or telephone, not in excess of \$75,000.
- 3. Henshaw is to make this lease only upon but immediately upon the sale of the Volcan System to a district including all or part of the City of San Diego. The lease is to be given us when this sale is assured, which in my judgment would be after the bonds are voted.
- 4. This company agrees to pay such district for the use of the water at rates fixed by the California Reilroad Commission. The district must agree to run through the power house each day a minimum quantity of water which should be equal to the daily available supply from the Warners Dam, or, in other words, the daily safe net yield. This quantity should be as large as possible but not under any circumstances less than 20,000,000 gallons per day.
- 5. The San Diego Company shall agree to build the power house located just above the Pamo Dam site and have it in readiness to operate and use the water soon after the completion of the Warners Dam and the water is made available.

This contract should be as brief as possible. You will probably want additional information that you can get from Fletcher and which I will be glad to confirm over the phone.



#### First Step of Kind by Big Systems. Washington, D. C., June 14 (AP).-

Standard Gas and Electric company told the securities commission today that it was prepared to combine compliance with the "death sentence" clause of the holding company act with a program for reduction of its funded debt, and asked permission to go ahead immediately. It was the first step of its kind taken by any of the nine big hold-ing company systems against which

orders concerning geographical integration of utility assets have been issued. Standard Gas, controling around a million dollars in such assets, said that its program would:

Eliminate six utility companies operating in six separate areas.

Cut in half the number of states in which its subsidiaries operate.

Reduces Funded Debt. Reduce the funded debt and make

easier a readjustment of the Standard Gas capital structure.

Eliminate unnecessary nonutility companies. The major companies in which Standard Gas would divest control

are: San Diego Consolidated Gas and Electric company, California Oregon Power company, Mountain- States

Power company, and Southern Colorado Power company. Standard Gas, San Diego Consoli-

dated, and California Oregon Power sought permission to reclassify the common stock of the latter two companies in preparation for offering it on an exchange basis to holders of Standard Gas notes and debentures.

Standard Gas holds 60.88 per cent

of the voting stock in San Diego and 56:20 per cent in the California Ore-Upon confirmation of the exchange, however, the two operating companies would no longer be subsidiaries of Standard Gas. Would Remain in Two Areas.

This company would control utilities in two major areas built around three companies upon final comple-

company,

tion of the integration program. These would be Philadelphia which controls utilities in the Pitts-

burgh area, and Northern States Power company and Wisconsin Pub-

lic Service corporation, which control utilities in the Minnesota-Wisconsin All of these assets, the company said, are physically interconnected or capable of interconnection. The utility assets to be retained in the Pittsburgh area, it explained, would consist of electric generating plants, transmission lines, and distribution facilities in and around Pittsburgh, and the system of coordinated
