Answering your inquiry as to the actual cash invested, or cost of Mr. Henshaw's interest in the Cuyamaca System, herewith enclosed find statement certified to by our secretary, Mr. Mathews, and is a matter of public record with the Railread Commission, showing that Mr. Henshaw's investment in the Cuyamaca System, plus 6 percent interest to be \$109,347.43 as of Oct. 31, 1922; and in addition, he owed to the Cuyamaca Company on voluntary assessments the sum of \$22,955.34, making the total cost of Mr. Henshaw's interest as of Cot. 31, 1922 \$132,502.77, including 6% interest.

T purchased Mr. Henshaw's interest last week for 90,000, and assumed the \$22,955.34 obligation to the company making the total cost of Mr. Henshaw's one-twelfth interest to me \$112,955.34 or practically \$115,000. On this basis the Cuyamaca system today is worth \$1,356,000.00.

The Board of Directors of the La Mesa Irrigation District on Monday night unanimously approved the report of the engineer which recommended the purchase of the Cuyamaca System, and it has now gone to the state engineer or the State Bonding Commission for final approval. This means that an election will be called at an early date by the district.

Over 5,000 acres in El Cajon Valley have already signed up to join the La Mesa Irrigation District - the lands along the flume that have been getting vater - and I understand the City of El Cajon will also join the La Mesa District, taking practically every consumer east of East San Diego city line into the district.

I am leaving for Los Angeles Tuesday night, but I do hope you will take this matter up in good earnest immediately, keeping in mind that the City can get No. 3 at any time by compromising with the district. Already the District and the Cuyamaca Company control nearly 1,000 acres out of 1330 that will be flooded by the building of a dam in Mission Gorge No. 3, and I will help in a quiet way for you to get all the other lands that will be flooded.

Mayrhofer told me that Klauber and Hayer Bacon have been working on Dowell, and that he was for Mo. 2. Mayrhofer wanted me to talk to Dowell, so I told him all right, and Dowell sport an hour and a half with me Honday morning.

I showed him Jorgenson's letter and plan, showing that a single arch type of dam can be built for \$1,180,000, to the 350 ft. contour, holding 28 billion gallons at Ho. 5.

a gravity arch type.

I convinced him that Ho. 3 was an ideal location for a single arch, and he was satisfied that Ho. 3 with a single arch dam to the 35oft. contour is just as good for the city as a gravity arch at Ho. 3 to the 365 ft. contour.

Regarding acreage flooded. I showed him that it would be cheaper lands in Humber 3, and 500 or 600 acres less evaporation surface as compared to No. 2, saving more than a million gallons a day evaporation in favor of No. 3, with the difference in elevation, when both dams are full, of only 15 feet.

I am convinced that Dowell is sold on No. 5 because there are 12 additional square miles of watershed, as well, which No. 5 gets which No. 2 does not get. It saves \$200,000 in cost of pipe line in favor of No. 5 as compared to No. 2.

The only thing that sticks in his craw is this - he does not believe that a dem to hold 15 billion gallons at No. 5 or No. 2 is of sufficient size, and thinks it should be increased to 28 or 29 billion, ic; the 550 ft. contour in No. 5 or 365 ft. contour in No. 2, even if Pletcher dem is built.

You have asked us to make a price on the cost of our distribution lines in East San Diego, Normal Heights and Kensington Park, in case the city enters into an agreement with the La Mesa District relative to the waters of the San Diego River.

In reply will say, that I am willing to leave the question of value of our system to the city manager, Mr. Fred A. Rhodes, and I will recommend to Mr. Stern, my partner, that he accept the valuation made by Mr. Rhodes.

If the valuation made by Mr. Rhodes is not satisfactory to Mr. Stern, Inam sure he will be glad to leave the question to arbitration in the usual manner, the decision of the Board of arbitrators to be final and binding on all parties in interest.

If the city does not care to issue bonds in payment thereof, and is not in a position to pay cash from the present funds of the city, an arrangement can be entered into covering a five-year period, for the total cost of the distribution lines above mentioned, which I am sure will be satisfactory to the city, the interest being 5 percent.

Believing that you would be interested in water developments in San Diego County, I want to give you below certain facts which, while brief, may give you some idea of the situation.

Several meetings have been held with representatives of the La Mesa, Lemon Grove and Spring Valley Irrigation District, and at a meeting held yesterday, which was attended by Gity Manager Fred A. Mhodes, we practically reached an agreement satisfactory to all parties, there being only one or two items yet to be definitely determined.

In the agreement it is proposed that the District sell to the City of San Diego, the Furray Dam and pipeline to the Easterly city limits of East San Diego, for a consideration of \$400,000.00.

The District are reluctant to agree to this until they know where another dam might be constructed to replace same. I believe it is important that Colonel Fletcher take steps at once to locate such a site satisfactory to the District.

The other matters are of more or less minor importance, one being the question of net safe yeald of the proposed dam at Flotcher site, to be built by the District, which City Manager Rhodes is insistent upon imowing. The other is the question of additional land in the El Capitan Reservoir
