Dear Louise:

Enclosed you will find a copy of a letter which I wrote to your father, in order to bring the "negotiations" to as constructive a conclusion as possible. The letter is written in all sincerity, but I felt that it would be improper for me to make any reference to Brandeis University.

Since, however, you and I have discussed Brandeis time and again and since you are not involved in the "negotiations," I might as well add the following:

I have come to understand the course of events that led to Dr. Sachar's visit to your father and I know now that I have no right to feel hurt. I also think that you need not be concerned that money given to Brandeis for the purpose of financing a research unit might be used for the general purposes of the college.

I have no official connection with Brandeis at present, but Dr. Sachar knows, of course, that he can turn to me for help. He may or may not do so.

If a sound program can be developed, the chief headache will be the staffing of this unit. How successfully this can be accomplished cannot be predicted until it has been tried.

If Brandeis were a young and growing medical school, rather than a liberal arts college, recruiting an outstanding staff would be no problem at all. The reason for this is simple enough. The kind of men who are good at this kind of research would be greatly attracted by the chance of becoming ultimately members of the regular teaching staff of a medical school.

I hope that you will decide to take a continuing personal interest of the operations of the research unit, if such a unit is set up on the Brandeis Campus.

Dear Leo:

In regard to your letter of March 18th, I regret to say that my company is not in a position to either buy "rights" from you or to guarantee you a substantial minimum royalty either from ourselves or from a distributor.

It is not possible at this time, from us or other people to anticipate a potential distribution of an album exceeding 5,000 in number.

It was my understanding that, due to my contacts with the New York City Center, you would be willing to speculate and make a tape record performance in a first-class studio together with all the professional expertees that this would require; and with a guarantee to you of 5% of the retail sales price of any records or albums produced thereby.

I look forward to hearing from you in this matter, as well as whether or not your contract for the book leaves you free in so far as records are concerned.
