

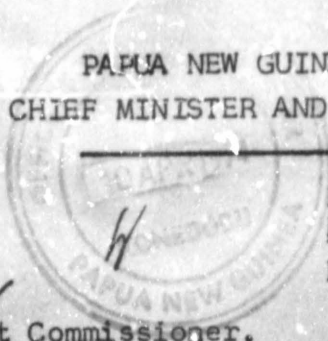

My observations are:

The need of some groups for agricultural advice is noted. In this connection, field staff should recall the instructions of the Chief Minister that all public servants should be prepared to take a broad view of their responsibilities. In this instance, it would be most valuable if the D.D.A. officer had acquired the knowledge to assist the people with tasks like coffee pruning, and had applied it. Technical departments often lack the staff to give sufficient coverage to a District.
