SPECIAL PATROL REPORT NO. 10 OF 1970/7 of JIWAI AREA

I am attaching Special Report as above and overing comments from the District Local Government Officer for a patrol of the Siwai area which was carried out for pre-election purposes.

- 2. I agree with the comments made by the District Local Government Officer in that the situation financially in the Siwai Council is not very satisfactory. However, the Council is now under new leadership. Mr. Tom Sipana is one of the older group, and member of the District Advisory Council and a very stable personality, and he has been elected president of this Council.
- 3. Without denigrating any particular officer, I am not sure that the financial overexpenditure incurred by the Siwai Council is not due to superficial or inadequate supervision. However, the District Local Government Officer has taken steps to remedy this. The Council previously employed two clerks for a job which barely required the services of one. One clerk has now been transferred to the Boku Council. Mr. Gus Schweinfurth is now carrying out general field duties in the patrol area and Council Advisory duties are being provided by Mr. T. Barryt.

Attached are copies of the Siwai Report, as above, submitted by Mr. G. Schweinfurth, Patrol Officer and at the time Council Adviser.

The object of the Patrol was to conduct a Pre-Election Patrol prior to the Siwai General Elections to be held in June, 1971.

The opening statement that Local Government in the area is generally satisfactory is misleading. The Council is prone to passing resolutions outside the scope of the Local Government Ordinance. They take very little advice from their Maviser and have little comprehension of estimates and their capabilities.

The Council has passed Resolutions in the year 1970/71 for the imposition of Income Tax and a taxation on the sale of traditional currency which will probably be termed as an Import Duty.

They have passed Motions for the purchase of bull-dozers, for donations of money to a community hostel at Arawa, to provision of money for the Morotana/Panguna Road.

The sum total of their year's efforts resulted in an

Overdraft of over two and a half thousand dollars being required to maintain the Council services at a bare minimum.

Mr. Schweinfurth points out in his Report, and I quote "that most of the Siwai Councillors are not filling their proper function of Councillor and never advise the people of what is going on after coming from their Monthly Council Meeting. That is the main factor which makes the Siwai Council not very popular or effective".

The object of their Patrol was a Pre-Election Patrol this was chieved. However, the Patrol Report is marred
by the fact that it was not received in Kieta until the
19th July and the Siwai Elections were completed on the
2nd July. There is no accompanying map of the route of
the Patrol nor installations as required by letter LG 39/
1/30 of 12th February, 1971 which stated "Patrol Report
maps should show Council installations such as trade posts,
schools, tanks, etc. This will allow ultimate compilation
of the map of Bougainville".

SITUATION REPORT

TOCKL GOVERNMENT: Local Government in the area is generally This patrol was conducted to cover the whole Siwai Local Government Council area to hold talks and general discussions on the general Council Elections. As per the patrol diary people from all villages in the Siwai Council area were seen and the whole area new of the coming of the General Elections and what they had to do to prepare for it. The importance of the general elections was fully discussed at each ward and the people showed general interest in the actual discussion. It was pointed out that it is important for a full attendance to be present at the time of the actual polling and that it was up to the people to powing to their candidate and councillor.

The manner of the election was explained and discussed as was the method of voting and nomination. The Electoral Provisions and the Local Government ordinance was explained to the people also and their was quite a deal of interest shown.

Some of the people were keen to elect a new council:

-lor as they wanted someone with a keen attitude and not a slow and ineffective attitude as some of them stated of their own councillors.

Even some of the women showed interest by joining Even some of the women showed interest by joining

in the discussions over the elections.

The importance of electing a good councillor was discussed as a few of the people always voted for someone who would not make them work or do any thing in their wards. As a lot of people liked this for then they could do what they wanted to and not look after their village.

Another factor brought out was the fact that most of the Siwal councillors were not doing their proper function of councillor and never advising the people of what is going on after coming from their monthly council meeting. This is the main factor which makes the Siwai council not very popular of effective. Most councillors it was explained to the People never take any of their people to court over any matters under which the council has made a Tule. The people fully agreed and spoke freely about this matter as quite a number of villages were not even aware that the Siwai Council had two council clerks. With the assistance of small blackboard it was explained and shows to the people how to east their votes and the way ballot papers were filled out and signed.

The people I feel show a reasonable interest in the General Elections as they were quite concerned in getting a proper councillor elected in order to get their council properly effective and not as it has been. Some of the people realised that it was up to them to find a proper respectable and conscientous councillor and not instrument they can push around and use and isnore them to find a proper respectable and conscientous councillor and not just someone they can push around and use and ignore.

However some of the wards are quite happy to again vote for someone who will do little to better their area.

LOCAL GOVERNMENT COUNCILLORS: Most of the present councillors are satisfactory due to various talks and discussions amongst them and only a few are still completely innefective in their area. But this is only if one regularly checks on their wards and general work.

In the next general election the people stated that they will bry their best to elect someone who will help them and do his job. However this remains to be seen once the new councillors are in Attendance was quite good at all the wards with interest being taken by all present.

HOUSE OF ASSEMBLY: The general running of the House of Assembly was outlined and explained to the people and it was compared with that of the Sivai Council. The people showed interest at its similarity and some were quite surprised. The Regional Memebr Mr.J.Lue is also from Amio village in the Siwai areaand although not too popular does hold meetings and explains items brought up at the House of Assembly. Most of the people show very little interest in Mr.Lue when he returns from the meetings of the House of Assembly but they do consult him in a number of local matters. However Mr.P.Lapun the Member for South Bougainville is more approached in regards to land problems and general problems at village level especially problems concerning sorcery and poison. HoweverMr.Lapun rarely goes and attends council meetings or holds meetings in any of the wards unless some specific problem arises.

POLITICAL EDUCATION: The last Political Education course was held in May this year and only a small number of councillors attended after in was well broadcasted over radio Bougainville and through the local people. Most matters concerbing political matters is refered to their members of the House of Asembly or the Kiap.'

ROADS: Roads in the area are generally quite good with all being trafficable in the dry weather. Only a few are impassable in the wet we weather but the people are working voluntarily on three different roads in the area and with the assistance of an administration truck and the council tractor the roadwork is progressingslowly. Some of the roads in the area are neglected by the people but this is because of the lazy attitude of some of the councillors. However this is hoped to be changed after the general elections.

GENERAL RURAL DEVELOPMENT: Rural Development in the area is slow at this stage as all the revenue has been spent on roads in the area and once the New financial year is under way further road projects will be started. All work this financial year was satisfactorily completed.

Tonu airstrip is also now officially approved as a commercial airstrip and the Siwai council done the job well and revenue could also be raised through the building of toilet facilities and a small store in order to create extra revenue for the council as quite a lot of people use the airstrip.

PROCESSING AND MARKETING: All produce in the area is handled either through the Siwai Society or privately through various local businessee-men. The produce is all sent to Buin and sent out by shipmed. Now that the Moratona to Jaba river road is underway it is hoped that with support from the Siwai and Buin councils the Bana council can complete this major roadlink which will open up the whole Buin Sub-District and create a good wharf and shipping point for all prod--uce.

NON INDIGENOUS DEVELOPMENT: There is no non indigenous development in the Siwai Area.

SOCIAL:
EDUCATION: All people in the Siwai area are in the council area and all school children are liable to be in trouble if they do not attend school. This is due to the council's trusncy rule which is in use and enforced by the councillors and education committee.

Land for a new day High School has been made available in the Siwai area and it is hoped to be started soon with assistance from the Siwai and Bana people as it will serve students from both areas.

HEALTH: Health in the area is generally good as the people are centrally situated and served by a mission hospital and Monoitu and also by the Administration run Rural Health Centre at Konga. With the regular clinics in the villages and aid posts in the area the people are quite lucky. Quite a number also visit Moratona Hospital in the Boku area for treatment and thus all difficult cases go to Kieta hospital or to Moratona.

LAW AND ORDER: Only a few minor complaints were received regarding council enforcing of the pig rule and those concerned were spoken with. The general situation is good in regards to law and order.

MISSIONS: There are two mission stations in the area Catholic at Monoitu and Methodist at Tonu. Haisi Catholic Mission also serves the Siwai people and it serves people in the Boku area also.

CULT AND UNREST: There is no cult or unrest in the area.

WOMEN'S CLUB: Siwai council has two womens club assistants who patrol villages regularly and hold course with the assistance of the Mission sisters at Monoitu and Tonu.

YOUTH ACTIVITIES: There is a weekly soccer and basketball competeition at Konga in the Siwai area and it is quite popular and locally organised.

MISCELLANEOUS: Nil

CONCLUSION: The pre election patrol went generally quite well and with the people showing some interest and concern in their local council and councillors to be elected. Attendance was good with men and women showing interest alike.

The results however remain to be seen after the election

returns are at hand.

The general situation in the area is good and with regular patrols and liaison with the councillors and people the Siwai council should greatly improve.
