Dear Sir:

On October 39, 1930, we received your check for \$43.57 for water furnished to your tract during the month of September 1920, while your September bill as rendered was \$58.60. Inasmuch as the Railroad Commission rendered its decision authorizing us to collect the new rates from September 1st, 1920, it will be impossible for us to accept your check in full payment of the bill. We would ask that you kindly send us another check for the full amount of \$58.60, whereupon we shall be very glad to stamp your bill "paid in full". If possible, we would like to receive this before the close of the year to close the account. In this connection, we might state that practically all of our consumers have paid up their accounts for September water -- a great many stamping their bills and checks "Paid Under Protest". You can do this, both on your check and on your bill, if you so desire.
