A. STATEMENT OF WORK DONE ON CERTAIN SECTIONS OF HIGHWAY.

1. In accordance with verbal instructions this writer proceeded to H.M.S.D. East House in the S.M.D. Area Division on the 3.12.52 for work concerned with the replacement of wooden bridges and culverts with 44 gall. drums. Work was also done on certain sections of the main highway.

2. Drums were sufficient for the area of road between the H.M.S.D./G.M.S.D. boundary and H.M.S.D. East House. In this area approximately 30 wooden bridges and culverts were replaced with 44 gall. drums.
